LAND MOVEMENT UPDATE



The rainy season may be over, but the impacts of rainfall on the City's ancient landslides are felt weeks and months after the fact. Accelerated movement in the Portuguese Bend Landslide Complex has now expanded to about 675 acres, impacting homes and infrastructure, and resulting in the temporary closure of about 8 miles of trails and the closure and disassembly of the historic Wayfarers Chapel.

The City continues to closely monitor the movement and implement mitigation measures to slow the sliding and address its impacts. This includes the planned installation of two emergency dewatering wells — called hydraulers — to remove water

trapped underground, the long-term Portuguese Bend Landslide Remediation Project, and the planned regrading of the steep dip on Palos Verdes Drive South known locally as the "ski jump."

Regrading the ski jump will require a temporary closure of Palos Verdes Drive South. With about 16,000 vehicles using this road daily, the City aims to minimize the closure as much as possible. A project timeline is not yet available, but advance notice, including a construction schedule and detour information, if needed, will be widely shared with the community. Updates will be available on the City website at rpva.gov/landmovement, the City's listservs (sign up at rpva.gov/notify), and social media, as well as Alert SouthBay alerts, physical signs, and message boards.

HOUSING ELEMENT ADOPTED



Housing Element Update

The City of Rancho Palos Verdes' Housing Element Update was developed to ensure the City is prepared to meet future housing needs from 2021 to 2029.

All cities in California are required to adopt a comprehensive General Plan to guide land use planning decisions. A key part of the City's overall General Plan is the Housing Element, which has been a mandatory portion of local general plans in California since 1969. Providing housing for all Californians is considered by the State Legislature to be of vital statewide importance. A housing element provides an analysis of a community's housing needs for all income levels and strategies to provide for those housing needs. State law establishes that each city accommodates its fair share of affordable housing as an approach to distributing housing needs throughout the state. State housing element law also recognizes that in order for the private sector to address housing needs and demand, local governments must adopt land-use plans and implement regulations that provide opportunities for, and do not unduly constrain, housing development by the private sector.


On April 16, 2024, the City Council adopted the City's Revised Final Housing Element, associated environmental analysis and implementation measures, including but not limited to a Mixed-Use Overlay District (MUOD), Residential Overlay District (ROD), and the rezoning of two residential properties to higher density. The adopted Housing Element provides the policy framework for the City to accommodate its regional housing need of 647 new housing units in various income categories.

The adoption of the Revised Final Housing Element comes after a 2.5-year process that involved a comprehensive outreach effort, City Council and Planning Commission joint-workshops, and extensive discussions with state officials. City Staff is currently working with the California Department of Housing and Community Development on a review of the adopted Housing Element for compliance with State housing law.






GO WITH THE FLOW

WESTERN AVENUE TRAFFIC FLOW IMPROVEMENTS

During the May 21, City Council Meeting, Staff presented the Traffic Safety Committee (TSC) recommendations and results of a comprehensive traffic study for the Western Avenue Corridor from West 25th Street to Palos Verdes Drive North. Staff presented recommendations for improvements to traffic signal timing, turn lanes, access to developments, and safety. The recommendations are subject to approval from Caltrans (who owns and operates Western Avenue).

The City Council unanimously approved the TSC and Traffic Study recommendations which will be used in the development of construction plans, specifications, and estimates for permitting through Caltrans, construction bidding and ultimate project construction.

As a child, I was surrounded by recreation programs, facilities, and camps, which helped me develop an appreciation for the impact of recreation on individuals and communities.

Driven by this early exposure, I decided to embark on my own path in the world of recreation. I studied Recreation Administration at CSUDH, before joining the City of RPV in 2009 as a part-time Recreation Leader.

PVIC is a popular destination with an active docent program, dozens of weddings, numerous school tours, hundreds of thousands of visitors and thousands of gray whales cruising by each year. What qualities are needed to effectively manage such a well-used and well-loved facility?

Managing one of the most popular destinations in the City requires a combination of organizational, interpersonal, and leadership skills. Most importantly you need to have a good team that can help support the vast number of activities that happen at the site.

You have overseen many, many special events during your time in RPV, including the annual Whale of a Day which draws 1000s of people. What helps make a special event special?

Bringing the community together and fostering a sense of connection is a key ingredient in making special events truly memorable. Attention to detail is imperative and helps to ensure that every aspect of the event is carefully planned and executed.

Being adaptable and quick on your feet is crucial for handling any unexpected challenges or changes that may arise during the event. Whether it's adjusting schedules, addressing logistical issues, or responding to feedback from attendees, the ability to make quick decisions and implement solutions ensures that the event remains enjoyable for everyone involved.

Introducing new entertainment or activities keeps the event fresh and encourages repeat attendance.

PVIC has had its share of challenges including floods and the COVID shutdown. What was it like dealing with these situations?

Dealing with the challenges posed by both the COVID shutdown and the flood was undoubtedly one of the most demanding periods in my career. When the pandemic hit, we had to swiftly close the parks down completely and then transition to a reopening with modified operating procedures in compliance with LA County Health guidance for museums.

This meant introducing new measures such as limiting the number of visitors through a reservation system, implementing social distancing

markers, and setting up a satellite check-in kiosk outside of the facility. These changes completely transformed the way we managed the museum and our event rental space.

Similarly, dealing with the aftermath of the flood, which thankfully didn't damage any of our exhibits or artifacts, required massive coordination to ensure continued operations. We relocated our gift shop into the Sunset Room and operated solely from there and one other office, as the remaining offices and part of our lobby were affected.

The resilience demonstrated by both the PVIC Staff and the Los Serenos de Point Vicente volunteers was truly remarkable. Despite the obstacles, we remained committed to finding ways to operate in some capacity for the community.

What do you enjoy most about your job?

What I enjoy most about my job is the variety of things I get to be involved in. When I envisioned my career in Recreation, I never anticipated overseeing a museum and such a stunning facility. I am really blessed to be where I am. I deeply care for RPV not only because I work here but I also live here.

Can you share any upcoming new events or exhibits coming to PVIC?

We're in the preliminary stages of developing an exciting new exhibit at PVIC, focusing on the whales and dolphins seen off our coast. This project has been in the works for many months, with dedicated effort from both Los Serenos docents and City Staff. While the timeline for completion is still being determined, we've taken a significant step forward by meeting with a design firm. We're eager to share more details as the exhibit progresses.

What would you like the residents of RPV to know about you?

Outside of working, I spend most of my time playing, watching, and organizing Rugby matches. I have played the sport for twenty years. This year I wanted to do something special to help continue to grow the sport, so I started a women's team with the Los Angeles Rugby Club. We had an undefeated regular season and won the Southern California Rugby Championship in April. Rugby has always been something I have been very passionate about not only as a player but as an administrator dealing with all the logistics and operations. It's blessed me with my closest friends, some of whom I met playing for the San Pedro Red Rhinos in high school. We have an unbreakable bond. In addition to loving rugby, I have varied tastes in music ranging from Celia Cruz and Juanes to Van Morrison and The Righteous Brothers.

TAKE YOUR FOOT AND HAND OFF THE GAS

GAS-POWERED LEAF BLOWERS PROHIBITED IN ALL RESIDENTIAL NEIGHBORHOODS

The use of gas-powered weed and debris blowers are prohibited in all residential neighborhoods in the City.

Only standard electric-powered blowers — hand-held, corded, and cordless — are allowed.

The City also prohibits any person from using a blower to blow cuttings, refuse, or debris onto a neighboring property or into a street, gutter, or drain. The City is not issuing citations for violations, but is requesting voluntary compliance.

Electric-powered blowers are permitted:

- Monday – Friday between 8 am-5 pm
- Saturdays between 9 am-4 pm

Electric-powered blowers are NOT permitted on Sundays or legal holidays.

Summer Crime Safety Tactics: Keeping Your Community Safe


As temperatures rise and people spend more time outdoors, the summer season can sometimes see an uptick in certain types of crime. By adopting proactive measures and staying vigilant, communities can enjoy a safer summer.

Home Safety:

- ✓ **Lock It Up:** Always lock doors and windows, even when you're at home. Install deadbolt locks for added security.
- ✓ **Alarm Systems:** Invest in a reliable home security system. Many modern systems offer smartphone alerts and remote monitoring.
- ✓ **Outdoor Lighting:** Use motion-sensor lights around your property. Well-lit exteriors can deter potential intruders. Don't forget your back and side yard too!
- ✓ **Smile: You're On Camera:** Apply for a Public Safety Reimbursement Program. The City offers individual and neighborhood camera reimbursement programs. Apply online at publicsafety@rpvca.gov to secure your home today.
- ✓ **Neighborhood Watch:** Did you know RPV has a robust Neighborhood Watch Program? Connect with your local block captain and attend neighborhood watch meetings. Regular communication with your neighbors can help everyone stay informed about suspicious activities.

- ✓ Tell your neighbors so they can keep an eye out for suspicious activity.

TRASH & STREET SWEEPING SCHEDULE

June 2024: Regular schedule.
No changes.

July 2024: There will be no trash/recycling collection or street sweeping on July 4, and a one-day delay for trash service for the remainder of the week. For streets swept on the 1st Thursday of the month, those streets will be swept on July 3.



August 2024: Regular Schedule. No Changes.

Leave all containers at the curb no later than 7 am on collection day and remove empty containers by no later than 10 pm on collection day.

Regulations for Hours for Trash Cart/Can Placement: The City has regulations on when trash, recycling and green waste carts can be left at the curb for collection. Carts can be placed at the curb after 4 pm the day before collection day and empty carts must be removed no later than 10 pm on collection day. Empty carts cannot be left on the street overnight. Carts need to be stored on the side or back of the property, at a location that is substantially screened from view. Please help keep your neighborhood attractive and clean.

BACKYARD SERVICE: EDCO provides backyard service to customers at an additional monthly charge. If you have temporary or permanent physical or medical limitations or travel frequently, call EDCO and inquire about this service. Questions? Call EDCO at 310.540.2977 or visit www.rpvrecycles.com.

DISCOUNTS AVAILABLE!

EDCO offers various discounts to customers: 1) Customers 65 and older are eligible for a 10% senior citizen discount (a one-time only application is needed for a new senior citizen customer). 2) If you pay for trash services a year in advance (discount available only with the July-Sept invoice) you are eligible for a 5% annual pre-payment discount. 3) Low-income customers may qualify for 5% discount (same household income criteria as CARE). 

FATAL FRUIT ATTRACTION



SAVE YOUR COMMUNITY'S CITRUS

Citrus can be dangerous, and I don't mean a drive-by-fruitting. A fatal tree disease called Huanglongbing (HLB) has been discovered in California. Spread by an insect called the Asian citrus psyllid, HLB kills trees and there is no cure. That said there are a number of things you can do to help stop the spread.

Don't move citrus in or out of quarantine areas or across state or international borders.

Inspect your trees monthly and when watering or pruning look for signs of HLB.

Plant responsibly-using trees from licensed nurseries

Talk to your local nursery-and ask about products to stop the Asian citrus psyllid.

Be mindful of clippings-dry or double bag plant clippings prior to disposal.
