Update on Landslide Emergency and Utility Impacts

Potential SCE Power Shutoff Information

The City of Rancho Palos Verdes knows many of our residents are concerned about whether additional utility services may be discontinued in the landslide area since yesterday's SoCalGas shutoff in the Portuguese Bend community. This evening, Southern California Edison (SCE) [issued a notification](#) to customers in the landslide area "to advise that Southern California Edison's service to [their] property may be discontinued if conditions warrant."

No shutoffs are currently in effect. The City remains in communication with SCE to ensure advance notice of any potential de-energization in the landslide area is provided to residents.

SCE has created a dedicated webpage with updates and resources at sce.com/rpv.

The City is in continual discussions with SCE and all other utilities (Cal Water, L.A. County Sanitation Districts, L.A. County Public Works) and public safety partners to stay apprised of the dynamic situation.

Potential utility shutoffs would impact not only residents, but City services. We are making every effort to be prepared for a range of scenarios, and you should, too. In addition to keeping an [emergency supply kit](#), [evacuation packing list \(PDF\)](#) and [having a plan](#) for your family, make sure you are signed up for Alert SouthBay emergency alerts by texting "alertrpv" to 888-777 or registering at AlertSouthBay.com. Get familiar with the Peninsula cities' Know Your Zone evacuation information platform. Go to PVPready.gov to find your zone number, then save it in your phone or write it down and keep it somewhere that's easy to find in an emergency, such as on your refrigerator

or near the front door. In an emergency, such as a landslide or wildfire, check the [zone map at PVPready.gov](#) to see if your zone is under an evacuation warning or order.

SoCalGas Shutoff Resources and Information Booth

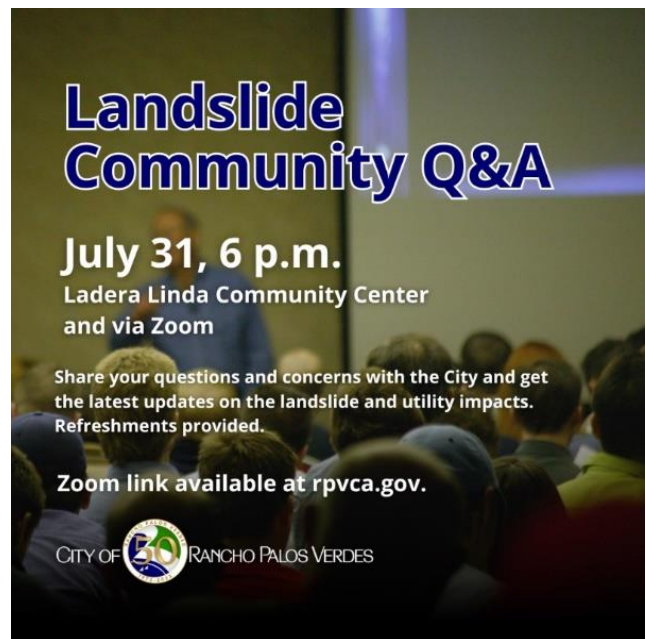
SoCalGas has shared that it will continue to staff an information booth for residents impacted by shut-offs in the Portuguese Bend Community at the intersection of Narcissa Drive and Fruit Tree Road, from 8 a.m.-6 p.m., through at least Thursday, Aug. 1. SoCalGas has created a dedicated website for this incident at socalgas.com/rpv with more information.

SoCalGas reminds impacted residents ***to please NOT attempt to restore service or to connect alternative fuels like propane to your natural gas meter.*** Doing so is unsafe.

Please note that this week's RPV Landslide Complex Working Group meeting scheduled for today, July 31, is canceled due to the Q&A.

City Resources and Property Inspections

The City is working swiftly to implement contingency plans to support residents impacted by land movement, including securing agreements for temporary housing accommodations and continuing to request state and federal financial assistance for individuals. We are also finding temporary solutions to help homeowners stabilize and level their houses through this emergency. This includes bridging separating rooflines and providing alternative foundations that may move with the shifting land. Additionally, the City is exploring expanding the permissible use of temporary housing, such as manufactured homes, in the landslide area while repairs are made to permanent homes so they can be salvaged. More information will be provided when it is available.

On Thursday, August 1, the City will begin conducting windshield surveys in the landslide areas of Seaview, Portuguese Bend Community, and Portuguese Bend Beach Club to determine the initial conditions of structures. Based on the windshield survey, properties identified as possibly experiencing structural stress will be contacted, in writing, to ask for homeowners' permission to access their property to affirm if any signs of structural stress or damage is occurring, so they can ensure their safety. The City's objective is to work with property owners to ensure their safety. If our inspectors see any concerning signs of damage or structural stress, they will work with homeowners to identify strategies to save structural integrity and prevent further damage, with the public's health and safety being paramount.

The City also remains in communication with the L.A. County Fire Department about the impacts of the landslide on emergency access and response times. The Fire Department is committed to serving, at all times, the entire City, including the landslide area, and has purchased equipment to help access areas that have become more difficult to reach. Despite those efforts, the Fire Department has indicated that properties impacted by the landslide may experience a delay in emergency response times.

The City will continue to provide regular community updates at rpvca.gov/landmovement.

Ongoing Requests to State and Federal Officials for Financial Assistance

The City continues to plead with our state and federal officials for financial assistance to help individuals impacted by the landslide emergency and to help the City cover skyrocketing costs to maintain critical infrastructure.

Today, City Staff sent letters to the Federal Emergency Management Agency (FEMA) and the California Governor's Office of Emergency Services (Cal OES) urgently requesting individual financial assistance, and to the Federal Highway Administration (FHWA) seeking financial assistance for the repair and maintenance of Palos Verdes Drive South. Both letters are attached to this report.

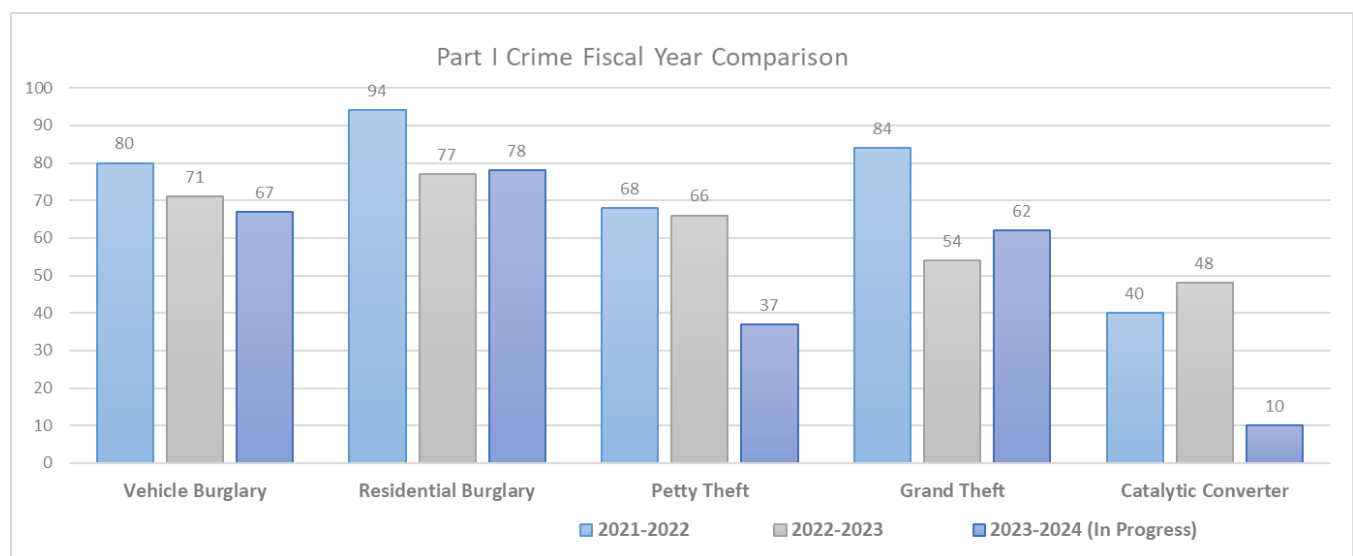

Quarterly Home Sales History – 2nd Quarter 2024

California

California home sales remain stagnant due to high mortgage rates. However, the housing market is poised for a rebound in the second half of the year as interest rates have decreased to their lowest levels since earlier this year. In June, the statewide median home price was \$900,720, surpassing the \$900,000 mark for the third consecutive month. Although the median price fell by 0.8% from May, it increased by 7.5% compared to a year ago. Further details on statewide activity can be found in Table 1 below.

City of Rancho Palos Verdes

The median sales price for detached single family homes in the City of Rancho Palos Verdes rose to \$1.85 million at the end of June, up by \$100,000, or 5.9%, from quarter ending March 2024. The increase in median sales price follows a previous decline of 4.1% recorded in the 1st quarter. Despite fluctuations over the past year, the median sales price remains unchanged compared to the same period one year ago.

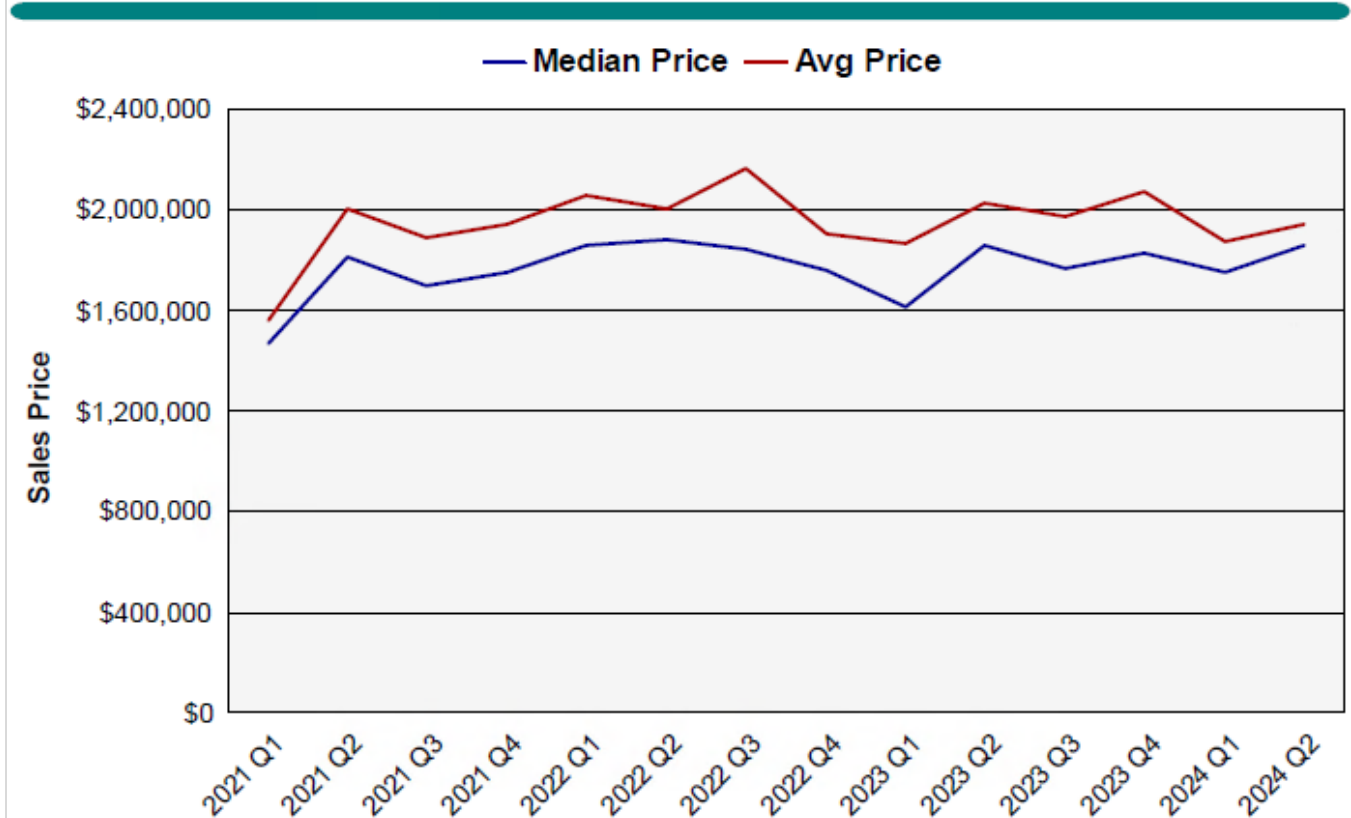

The average sales price in the City also increased in June, ending the quarter at \$1.94 million, rising by roughly \$65,000, or 3.5%, since March. Compared to the quarter ending June 2023, the average price fell by \$86,000, or 4.2%. Additionally, the sales volume in Rancho Palos Verdes rose to 96 for the quarter, reflecting an increase of 88.2% when compared to the number of homes sold in the 1st quarter. This marks the highest number of home sales since the 2nd quarter of 2022. Quarterly changes since 2021 are highlighted in the table and chart below.

No Trucks Over 2 Axles on Palos Verdes Drive South

This week, a letter was sent to local businesses along Palos Verdes Drive South and Palos Verdes Drive West asking them to notify their delivery vendors that trucks over 2 axles are prohibited on Palos Verdes Drive South between Schooner Drive and Seacove Drive. The letter stated that trucks traveling to businesses west of Seacove Drive should use Hawthorne Boulevard, while those traveling to businesses east of Schooner Drive should use Western Avenue. Portuguese Bend Landslide Remediation Emergency Hydraugers Project Update

On May 21, 2024, the City Council approved the Portuguese Bend Landslide Remediation Emergency Hydraugers Project, which consists of the installation of two hydraugers with five drain arrays each. The hydraugers will be used to extract and/or intercept groundwater from the landslide area as an emergency stabilization measure to reduce movement in the Portuguese Bend Landslide. Following are the most recent activities:

- Drilling of the vertical boreholes landward of Palos Verdes Drive South (PVDS) for Emergency Hydrauger E-1 is complete.
- Drilling of the first of four boreholes seaward of PVDS for Emergency Hydrauger E-1 began on Saturday and is ongoing.
- Instrumentation to gauge land movement and further validate the final hydrauger

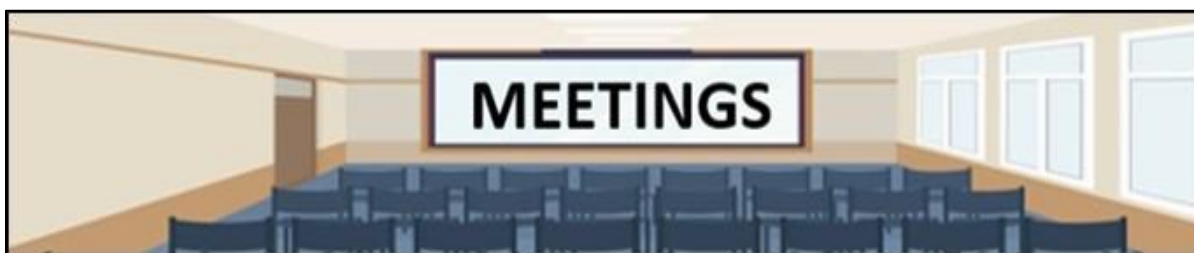
design continues to be installed in each borehole.

- Environmental monitoring is being conducted in conjunction with construction activities.
- Drilling of ten boreholes for Emergency Hydrauger E-2 is being scheduled.

Minor traffic delays are to be expected over the course of the next several weeks as construction materials and equipment deliveries continue to arrive at the Gateway location. If you must drive through this area during this time, please proceed slowly, yield to workers, and obey traffic control at the site. Thank you for your patience. 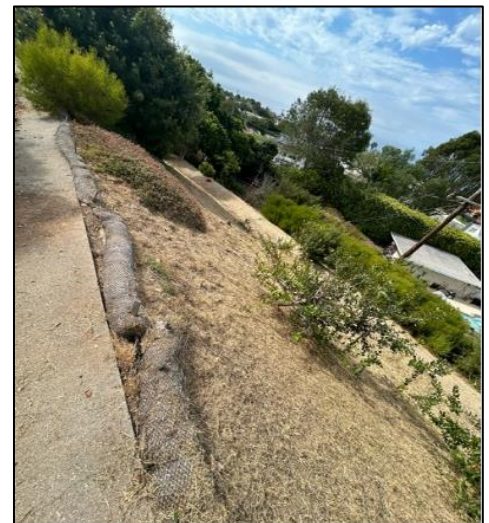


Maintenance Activities

 - Lorraine Drive

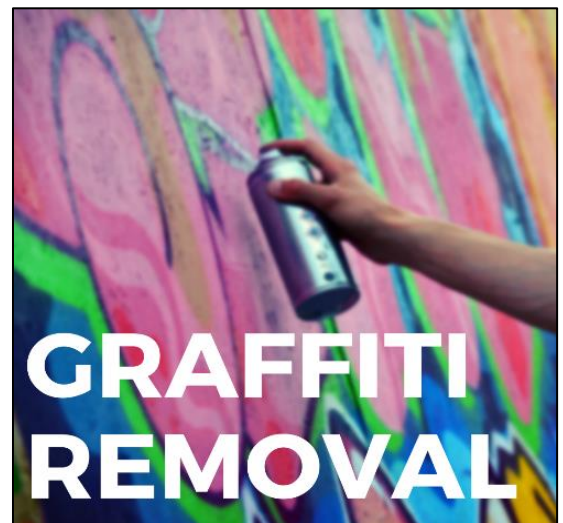


- Crews repaired the sidewalk deviations and installed an asphalt ramp over the uneven areas that could not be sufficiently smoothed out at Monero Drive and San Nicolas Drive.
- Installed temporary "Dip" signs on Hawthorne Boulevard near Vallon Drive. The City is currently in the process of scheduling repairs.
- Installed a thermoplastic pavement marking for the newly installed "Stop" sign at intersection of Shorewood Road and Indian Peak Road.
- Installed two new advanced street signs on Palos Verdes Drive South.
- Painted new red curb zones on Longhill Drive.



Graffiti Removal

- **21** graffiti incidents were reported and removed this week.
- Residents can help keep RPV looking great by downloading the **RPV Clean** app to report graffiti to City staff.





Emergency Response

This past weekend, Public Works received several calls related to sewer leaks at the following locations:

- 16 Narcissa Drive: Crews were alerted that a galvanized pipe sheared off due to land movement. A Public Works contractor made repairs.
- 22 Narcissa Drive: The main lateral line burst due to a pinch of galvanizing pipe in the roadway that connects to the main line. Public Works crews re-routed the lateral line.
- 9 and 16 Cinnamon Lane: Crews found the ground saturated and discovered the galvanized lateral line had separated due to land movement. A temporary repair was completed.
- 35 Narcissa Drive: Crews found a galvanized lateral line had separated due to land movement and implemented a temporary repair.
- 2 Figtree Road: On Sunday night, a 2 ½ inch galvanized sewer lateral at the union joint separated. Public Works installed a temporary repair, with a permanent repair scheduled for this week.



- Public Works were notified of a broken branch from a tree. Crews removed the branch and will schedule an inspection for the general health of the tree.

Los Angeles County Department of Animal Care & Control - Animal Noise Complaints

Animal noise complaints, including those related to barking dogs can be filed with the Los Angeles County Department of Animal Care

& Control (DACC). DACC provides animal care and control services throughout Los Angeles County including the City of Rancho Palos Verdes. DACC understands that continuous animal noise can adversely affect the quality of life and is dedicated to helping to work with animal owners to resolve such situations. Complaints can be

REMINDER - Short Term Rentals (STRs) Prohibited

In 2017, the City Council adopted regulations affirming the City's prohibition of and advertisement of STRs in the City's residential zoning districts. An STR is a rental of a dwelling unit or part of a dwelling unit to visitors where lodging is furnished for compensation for a period of less than 30 days, except as allowed by



Section 17.76.140 (Bed and Breakfast Inns) of the Rancho Palos Verdes Municipal Code.

SUBJECT: Request for Individual Assistance for Residents Impacted by Accelerated Movement in Portuguese Bend Landslide Complex

Dear Director Criswell and Director Ward,

The City of Rancho Palos Verdes, California thanks you for your attention to our community's ongoing crisis in the Greater Portuguese Bend Landslide Complex following California's recent heavy rainy seasons, including severe winter storms from January 31-February 9, 2024 (Disaster No. DR-4769-CA).

As you know, heavy stormwater infiltration from these severe storms has fueled the landslide, which is accelerating at an unprecedented rate of 9 to 12 inches per **week** (depending on the location). This crisis has damaged homes, roads, and utilities, and resulted in the closure of over 10 miles of popular trails, two public beaches, and the emergency disassembly of Wayfarers Chapel, a National Historic Landmark.

Most notably, on July 29, 2024, gas line damage in the Portuguese Bend Community of Rancho Palos Verdes required SoCalGas to indefinitely shut off natural gas service to approximately 135 homes and with fewer than 3 days' notice. Other utilities ranging from SCE to CalWater are also experiencing significant infrastructure damage in a landscape that shifts from day to day. On July 30, 2024, SCE notified residents that there may be a potential to cut off service to approximately 525 homes in 3 neighborhoods. The sheer scale of this landslide and the damage it is inflicting on hundreds of homes and thousands of residents is best understood with a site visit. Therefore, we wish to invite your office, as well as the Governor, to tour the site with us at soon as possible.

In response to Disaster No. DR-4769-CA, the Federal Emergency Management Agency (FEMA) made its Public Assistance Program available to the City and two geological hazard abatement districts to help their efforts to slow down the landslides. Additionally, the U.S. Small Business

Administration offered low-interest loans to homeowners, businesses, and nonprofits that suffered property damage or economic loss.

While the City greatly appreciates this support, we are writing today to urgently request individual assistance, in the form of grants, be made available to the hundreds of homeowners whose properties are increasingly threatened by this disaster.

Since the storms, the landslide complex has expanded from 380 to 680 acres in recent months — a 79% increase. Over 1 square mile of land is sliding toward the ocean. Since June 2023, two homes in the landslide complex have been deemed uninhabitable. However, an untold number are experiencing significant damage. Roadway access is becoming increasingly difficult in some neighborhoods. As a result, the City anticipates additional properties may be deemed uninhabitable in the coming weeks and months, which would displace residents.

The City is finding temporary solutions to help homeowners stabilize and level their houses through this emergency. This includes bridging separating rooflines and providing alternative foundations that may move with the shifting land. We are exploring expanding the permissible use of temporary housing, such as manufactured homes, in the landslide complex while repairs are made to permanent homes so they can be salvaged. Additionally, the City is identifying emergency sheltering options, if needed.

Residents in the landslide area need all the help they can get from every branch of government, and they need it quickly. Given the urgency of this worsening situation, we request FEMA make additional individual assistance, such as the Individuals and Households Program (IHP), and/or any other possible options, available as soon as possible. We also request collaboration with the California Governor's Office of Emergency Services (Cal OES) to identify state resources to bolster individual assistance, such as grants.

We need your support now to help residents whose lives are being upended by this evolving emergency.

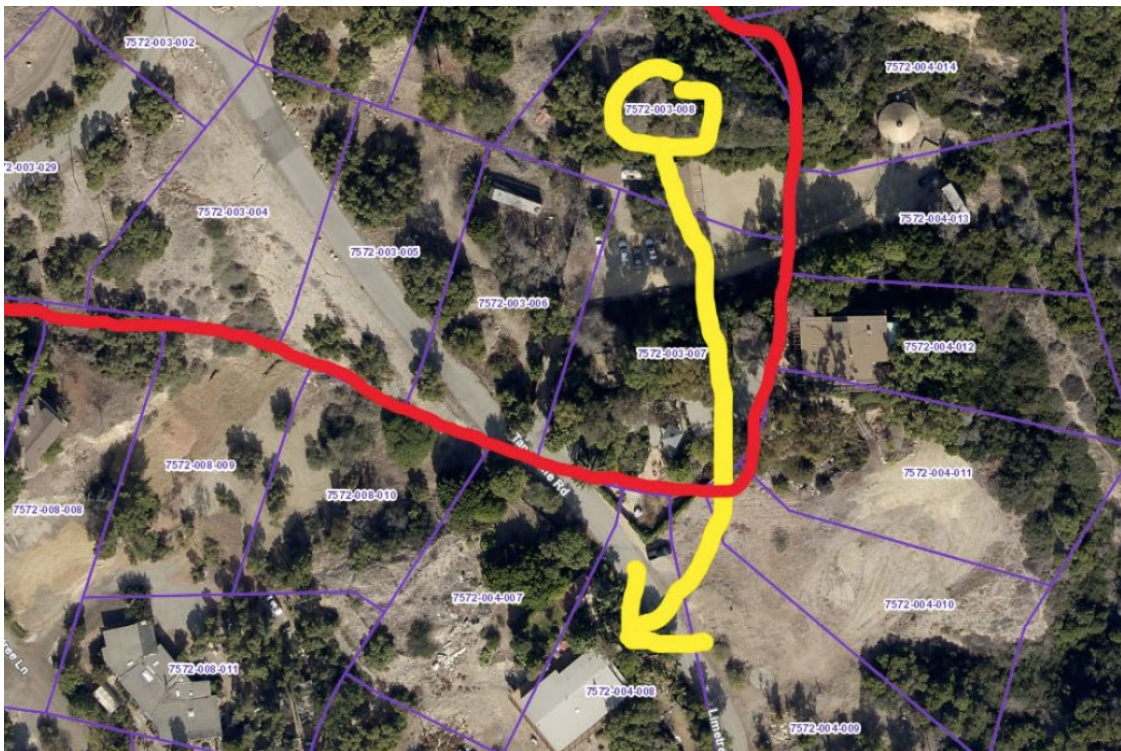

SUBJECT: Request for In-Kind and/or Financial Assistance for Repairing Landslide Impacts to Palos Verdes Drive South

Dear Director Bhatt,

The City of Rancho Palos Verdes, California, is a coastal community in the South Bay of Los Angeles County. Record rainfall in 2023 and 2024 has accelerated land movement of the ancient Greater Portuguese Bend Landslide in our City, averaging 9-12 inches per week (depending on the location), causing major damage to our community. On behalf of the City Council and our 42,000 residents and business owners, I am writing today to bring your attention to this ongoing emergency and to seek your agency's assistance in assisting with and funding critical repairs to a major transportation route whose integrity is threatened by land movement.

The Portuguese Bend Landslide is one of the largest continuously active landslides in the United States. Reactivated in 1956, the ancient Greater Portuguese Bend Landslide Complex, comprised of five sub-slides that, together, have been slowly moving for decades, damaging homes, utilities, and roads. The movement picks up in speed in years with heavier rainfall due to the bentonite soil condition, which becomes slippery with water infiltration. Following the 2022-23 rainy season, which was approximately 200% of the historical average rainfall, movement in the landslide complex significantly accelerated, resulting in the formation of landslide fissures, grabens (i.e. pull-apart zones), thrust features, tensional cracking, and shear zones. These phenomena, along with land subsidence, have been particularly pronounced on Palos Verdes Drive South, a major arterial traversed by about 15,000 commuters daily. The regional roadway connects the Los Angeles Harbor Area to the Palos Verdes Peninsula and the South Bay beach cities. Palos Verdes Drive South is also an evacuation route for the fire-prone Peninsula and is home to an above-ground sanitary sewer trunk line serving thousands of residents and our local business community.

A 1-mile stretch of Palos Verdes Drive South runs through the landslide area. When the City of Rancho Palos Verdes was incorporated in 1973, it inherited the landslide and became

responsible for regularly repairing damage to the roadway. In typical years when the land movement can be measured in as a little as inches, repair and maintenance of Palos Verdes Drive South is performed every few months or so. Under the current conditions, with the land moving as much as 9-12 inches per week, the road needs repaving about every 2-3 weeks. The City spent over \$2.2 million on repairing and maintaining Palos Verdes Drive South in FY 2023-24. The City anticipates spending significantly more in FY 2024-25, which began with a major rehabilitation project on Palos Verdes Drive South estimated to cost upwards of \$500,000.

The City is solely responsible for ensuring the road is accessible at the skyrocketing costs of repairing this regional transportation route. While we are pursuing possible reimbursement under the federal disaster declaration issued in April in response to California's severe winter storms (Disaster No. DR-4769-CA), we are urgently requesting any possible in-kind and financial assistance from the Federal Highway Administration and the Army Corps of Engineers. The City is implementing short- and long-term engineering strategies to slow the land movement, including surface fracture infilling, surface water drainage improvements, and groundwater extraction.

The preservation of Palos Verdes Drive South is critical for regional transportation and the health and safety of the public and our first responders. We need your help in identifying any potential in-kind and financial assistance available from FHWA as we navigate this crisis.
