August 6, 2024, City Council Meeting Highlights

Highlights from the August 6 City Council meeting:

- Following last week's gas shutoffs in the Portuguese Bend community due to land movement, the City Council voted to declare a local state of emergency due to a sudden and severe energy shortage.
- With the local emergency now declared, the Council is also urging Governor Gavin Newsom to declare a state of emergency for the gas shutoffs to make public and individual financial and in-kind assistance available to the community. The Council is also urging the State to submit a request to President Biden to make a federal declaration of emergency as well.
- City staff gave an update on windshield property assessments that were completed last week in the Portuguese Bend Community Association, Portuguese Bend Beach Club, and Seaview neighborhoods. If a follow-up with a homeowner is needed due to signs of potential structural stress, City staff will reach out via advisory letter requesting a voluntary inspection be scheduled.
- The City's objective is to work with property owners to ensure their safety. If inspectors see any concerning signs of damage or structural stress, they will work with homeowners to identify strategies to save structural integrity and prevent further damage, with the public's health and safety being paramount.

Land Movement Updates



Rancho Palos Verdes City Council Urges Governor Newsom to Declare State of Emergency for Gas Shutoffs

Days after SoCalGas abruptly discontinued natural gas service to approximately 135 homes in the Portuguese Bend community due to land movement, the City of Rancho Palos Verdes is urging Governor Gavin Newsom declare a state of emergency to help impacted residents.

On August 6, the City Council voted to declare a local state of emergency due to a sudden and severe energy shortage, as defined in the California Emergency Services Act. For over one week, residents in the Portuguese Bend Community Association have been scrambling to find alternate means of heating water, cooking meals, and warming homes in preparation for a potentially rainy winter season. The day after gas service was cut, Southern California Edison put even more customers in the wider landslide area on notice that, due to land movement, it may discontinue electricity in the future, if conditions warrant. The City now faces two emergencies: the ongoing landslide and mass utility shutoffs.

In a [letter \(PDF\)](#) to Governor Newsom, Mayor John Cruikshank requested a state of emergency be declared to make public and individual financial and in-kind assistance — such as from the U.S. Army Corps of Engineers — available to the community. The letter requested permitting requirements be waived or suspended for projects to help impacted residents. In addition, the letter urged the Governor to submit to the President of the United States a request to declare a federal emergency.

At last night's meeting, the Council also voted to extend the City's existing local emergency in the landslide area. Both local declarations must be renewed every 60 days to remain in effect. City Council Requests Financial Assistance for the Landslide

Following the July 29 SoCalGas shutoffs, Staff prepared [two requests for assistance](#):

- **FEMA/CalOES:** Request to access FEMA's Individuals and Household Program (IHP), which provides financial and direct services to eligible households affected by a disaster. Additional request for in-kind or other available State resources to residents.
- **FHWA:** Request for financial and in-kind assistance from FHWA to help repair rehabilitate Palos Verdes Drive South, which is significantly affected by landslide movement.

Due to the urgency, the City Manager signed/sent both letters on July 31 and City Council ratified them on August 6. Since July 31, the City has held initial conversations with FHWA and Army Corps of Engineers, and is scheduling an upcoming meeting with CalOES.

Funding Request for Portuguese Bend Landslide Remediation Project

On August 5th, the City submitted a letter to Supervisor Janice Hahn's office in response to their request for an overview of the funding allocation details for the Portuguese Bend Landslide Remediation Project. The City expressed its deep appreciation for the \$5 million funding pledge announced at the February 20, 2024 City Council meeting. The letter also emphasized the critical role of the \$5 million pledge in maintaining project momentum and addressing the funding gap.

In response to accelerated land movement worsened by winter storms, the City initiated the Emergency Hydraugers Project, which includes the installation of two hydraugers at a cost of approximately \$10 million. These efforts are critical and separate from the main Portuguese Bend Landslide Remediation Project, making BRIC grant funds inapplicable for this emergency work. The total estimated expenditures for the remediation project since FY 2023-24 and projected over the next three years amount to \$41.2 million, with a current funding gap of \$14.4 million. Recent utility shutoffs affecting approximately 135 households by SoCal Gas and potentially 500 households by Southern California Edison highlight the urgency of this funding.

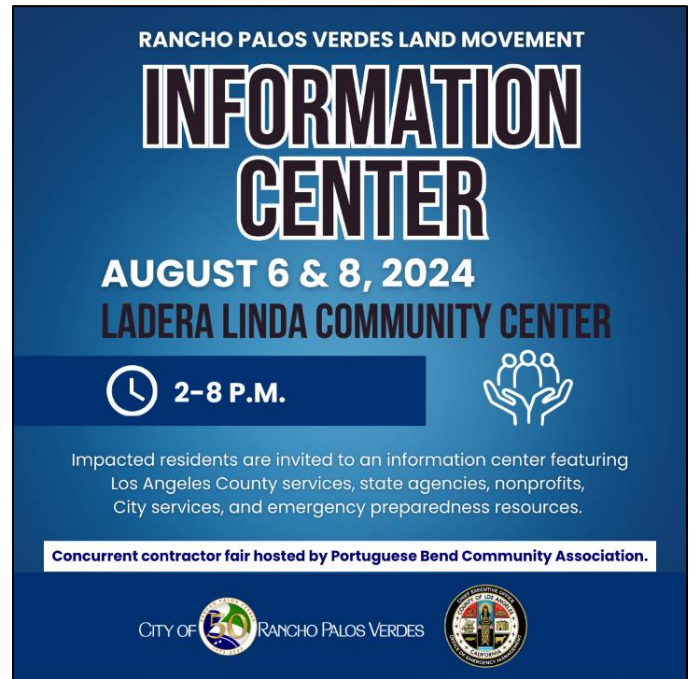
The City Council and approximately 42,000 residents of Rancho Palos Verdes, including the 400 households directly impacted by land movement, are grateful for this funding opportunity. All involved look forward to the approval and expedited release of these funds to ensure the continued safety and well-being of the community.

Please know that the City is exploring every avenue to slow the land movement and to assist residents impacted by this crisis. We are #RPVtogether.

The City will have a station with information on permits for gas conversion and solar projects, as well as Public Works requests.

Concurrently, the Portuguese Bend Community Association will host a fair with contractors and professionals who provide services for these and other projects that may be needed.

SoCalGas Work in Seaview Neighborhood

On August 2, SoCalGas began work to install a series of isolation valves in the Seaview community. If it becomes necessary, these valves would allow SoCalGas to safely turn off natural gas to individual streets most impacted by the land movement, potentially reducing the impact to surrounding streets. This work is not expected to disrupt service to customers in the Seaview community. Read the latest update from SoCalGas at socalgas.com/rpv.

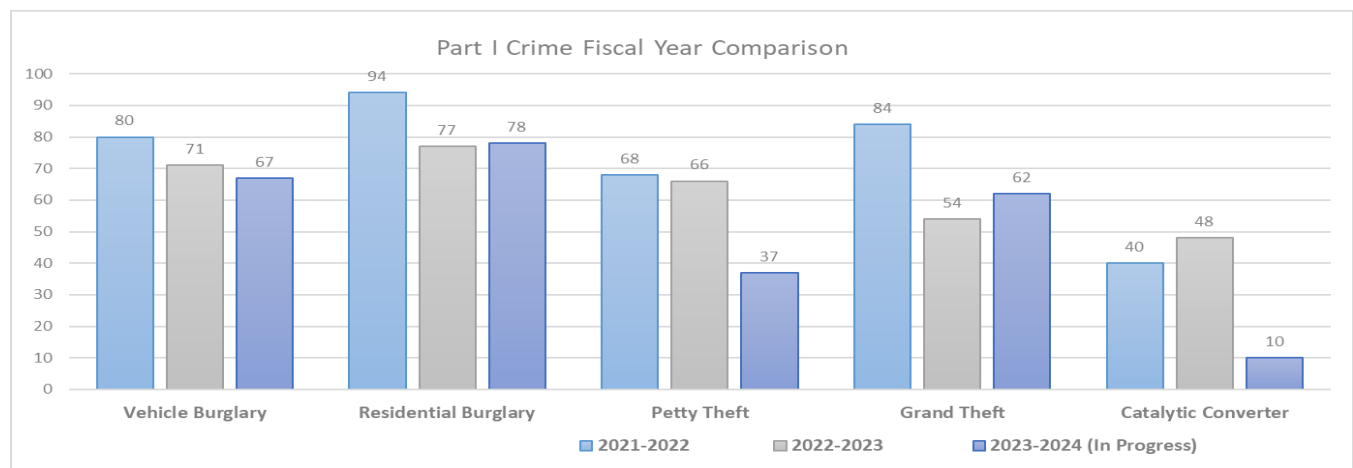

Are You Earthquake Ready?

Did you feel it? Last night's magnitude 5.2 earthquake near Bakersfield is a reminder to always be prepared. The Los Angeles County Office of Emergency Management presents [this video](#) about what to do before, during, and after an earthquake. In addition, consider downloading the "My Shake" app on your phones to receive advanced warning (of at least a few seconds) of larger magnitude earthquakes in your area. While the app is still a work in progress, it strives to provide users with time to seek cover and stay safe.

In addition, having an emergency kit is critical in the event the "big one" hits and both utilities, supplies, and medical attention may not be readily available. [This video](#) provides an overview of what you should include in your emergency kit.

10 Essential Earthquake Survival Supplies

1. Water for 3-10 days
2. Food for 3-10 days
3. First aid kit
4. Flashlights
5. Radio
6. Medications
7. Cash and important documents
8. Clothing and sturdy shoes
9. Tools
10. Sanitation and hygiene supplies

No Trucks Over 2 Axles on Palos Verdes Drive South

Last week, a letter was sent to local businesses along Palos Verdes Drive South and Palos Verdes Drive West asking them to notify their delivery vendors that trucks over 2 axles are prohibited on Palos Verdes Drive South between Schooner Drive and Seacove Drive. The letter stated that trucks traveling to businesses west of Seacove Drive should use Hawthorne Boulevard, while those traveling to businesses east of Schooner Drive should use Western Avenue. Portuguese Bend Landslide Remediation Emergency Hydraugers Project Update

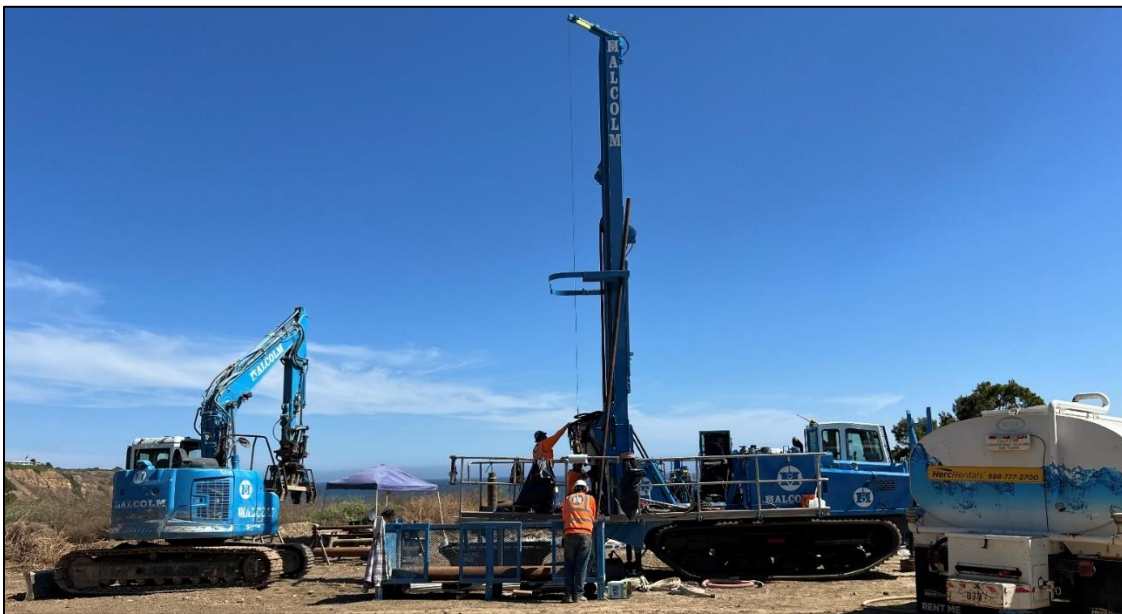
On May 21, 2024, the City Council approved the Portuguese Bend Landslide Remediation Emergency Hydraugers Project, which consists of the installation of two hydraugers with five drain arrays each. The hydraugers will be used to extract and/or intercept groundwater from the landslide area as an emergency stabilization measure to reduce movement in the Portuguese Bend Landslide. Following are the most recent activities:

- Drilling of the vertical boreholes landward of Palos Verdes Drive South (PVDS) for Emergency Hydrauger E-1 is complete.
- Drilling of the second of four boreholes seaward of PVDS for Emergency Hydrauger E-1 began on Saturday and is ongoing.
- Instrumentation to gauge land movement and further validate the final hydrauger

design continues to be installed in each borehole.

- A [bathymetry](#) survey is being scheduled to obtain more information about the lower section of the landslide located along the coast.
- Environmental, archaeological and paleontological monitoring is being conducted in conjunction with construction activities.
- Drilling of ten boreholes for Emergency Hydrauger E-2 is scheduled to begin within the next two weeks.

Minor traffic delays are to be expected over the course of the next several weeks as construction materials and equipment deliveries continue to arrive at the Gateway location. If you must drive through this area during this time, please proceed slowly, yield to workers, and obey traffic control at the site. Thank you for your patience. The City is committed to continuing its efforts to ensure we have a sustainable community by inspecting and educating restaurant operators about stormwater pollution prevention, sewer overflow prevention, waste reduction, and water conservation, among other environmental practices required for this certification. Restaurants typically handle a substantial amount of waste and if handled improperly can have a profound impact on our natural environment, our health and well-being, and quality of life.

Over the last few months, the City’s contracted inspectors (John L. Hunter and Associates) have certified restaurants that meet a rigorous set of criteria aimed at preventing pollution and promoting sustainability. This year, we applaud the environmental stewardship of 35 restaurants in our City and thank them for making a difference in the health of Santa Monica Bay.

- The TSC recognized and welcomed three new members of the Traffic Safety Committee (TSC): Kit Song, Hiromi Namikawa and Jeanne Min. The newly appointed members will join current TSC Chairman John Tye and member Mark Crossman.
- The TSC provided input on a proposed citywide E-Bike ordinance. PW staff will

coordinate with the city attorney to address comments from TSC, coordinate with other South Bay cities, and present the revised ordinance to the City Council for consideration.

- The TSC provided comments on a Draft Traffic Request Framework. The proposed draft Framework provides a roadmap for the TSC and PW staff to receive, evaluate, process and resolve RPV constituent concerns and requests in a responsive and timely manner with excellent customer service.



In addition to regularly scheduled maintenance and repairs, Public Works performed the following:

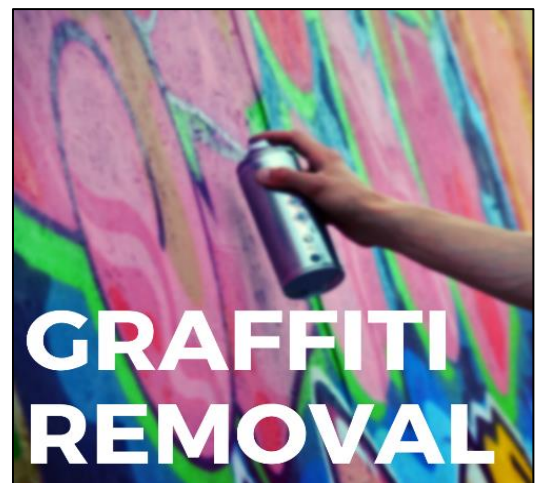

LA County representatives presented a design scenario that involved modifications to the 15th green of the Los Verdes Golf Course that would alleviate errant ball concerns and result in the removal of some of the recently installed poles. Residents reviewed preliminary plans and provided feedback, which was generally receptive of the presented design. LA County Representatives indicated that additional public outreach would be conducted as part of the project environmental review process. Additional updates will be provided as more information becomes available to share.

Planning Division Monthly Activity Report

The Planning Division's Monthly Activity Report for July 2024 summarizes the division's activities during this past month regarding new applications received and Staff, Planning Commission, and City Council decisions rendered. As indicated in the attached report, the division received 55 new applications and rendered decisions on 47 applications for July 2024.

Building and Safety Division Monthly Activity

The Building and Safety Division's Monthly Activity Report for July 2024 reports on 1) a summary of the new cases received delineated by application type; 2) the number of permits issued; 3) the amount of fees collected; 4) the number of inspections performed; and 5) the number of new plan checks submitted. As indicated in the attached report, the division issued 185 permits and performed 765 inspections.

View Restoration Division Monthly Activity

The View Restoration Division's Monthly Activity Report for July 2024 and year-to-date information on 1) new view cases; 2) pre-application meetings; and 3) cases resolved by

mediation. As indicated in the attached report, the division received 14 new cases.

Code Enforcement Division Monthly Activity

The Code Enforcement Division's Monthly Activity Report for July 2024 reports on 1) violations by category; 2) the number of closed cases by violation with median processing times; and 3) illegal sign abatement. As indicated in the attached report, the division conducted 221 field inspections and brought 74 cases to closure.
