CITY MANAGER'S OFFICE

September 17, 2024, City Council Meeting Highlights

Highlights from the September 17 City Council meeting:

- The Council approved guidelines for a new program that will provide small matching grants to businesses and property owners along Western Avenue for the completion of storefront improvements.
- Grants will range from \$5,000 to \$20,000, depending on the project, with a 50% match. Examples include new exterior paint, lighting, landscaping, signs, awnings, entry doors, outdoor seating, and resolving code violations.
- Check the City website in the coming weeks for more information on how to apply.
- Staff provided a first-quarter update on City Council Goals across policy areas ranging from quality of life and infrastructure, to citizen engagement and public safety.
- The Council approved holding a tree and menorah lighting ceremony this holiday season at the Ken Dyda Civic Center with a weekend of roller skating.

Land Movement Updates



Dewatering Wells Update

In May, the City Council approved the installation of two hydraugers in the Portuguese Bend Landslide complex as an emergency measure to remove water underground that is contributing to accelerated movement. Borehole samples revealed a deeper slide plane that is moving at a much faster rate than the shallow slide plane. This discovery meant the City's project team had to change its landslide remediation strategy to prioritize the deeper slip plane over the shallow plane targeted by the horizontal hydraugers.

In August, the City Council authorized City staff to proceed with a pilot program drilling deep vertical dewatering wells at the toe of the Portuguese Bend Landslide to provide immediate relief from water pressure.



Over the past week, the first two wells were installed along the shoreline between the South Bay Archery Club and the Portuguese Bend Beach Club. Both wells, energized using generators, are now operational and pumping a combined approximately 200 gallons of water per minute. Three more deep dewatering wells are anticipated to be installed and operational by the end of next week. Underground instruments are being installed and GPS surveys are being taken to measure the effectiveness. While these wells will be sheared over time at the deep slip plane, City staff anticipates they can be re-drilled quickly and efficiently until movement slows to the point that they will last longer.

How to Get a Permit for Your Alternative Utility Service

The City of Rancho Palos Verdes reminds residents in the landslide area who have lost gas and/or electricity service that permitting for generators, propane conversions, and solar projects is **free**, **expedited**, and **required with safety in mind**.

It is critical for the safety of your household and your neighborhood that alternative utility services — especially generators and propane tanks — are properly installed by a licensed professional and inspected by the City. Improperly installed equipment may cause fire, electrocution, or other health and safety threats.



The Building and Safety Division is here to help. Our inspectors will work with you to ensure your safety and secure a permit. Schedule an appointment today by calling 310-544-280 or emailing BuildingSafety@rpvca.gov.

As a reminder, portable generators do not require a permit or inspection. Please refer to the equipment's manufacturer list of operational requirements for additional information. **NEVER** run a portable generator indoors or close to windows and doors. For all generator systems, keep a fire extinguisher on site and easily accessible, and make sure you have carbon monoxide alarms on all levels of your home.

What is Know Your Zone?

In May 2023, the four cities of the Palos Verdes Peninsula began using the Know Your Zone evacuation platform, which is available at [PVPready.gov](https://pvpready.gov). This website features a map with preestablished evacuation zones across the Peninsula. Please note that the term “evacuation zones” does not refer to evacuation centers. Rather, the zones are a way to identify neighborhoods with unique numbers, so authorities can more easily notify them with real-time information about an emergency in their zone, such as a wildfire or earthquake.

How to Use Your Zone
Become familiar with your evacuation zone on PVPready.gov

Locate Routes
Walk or drive around your zone and locate the fastest routes to nearby freeways to ensure you are familiar with the various ways of getting in and out during an emergency.

Find Your Way
Be able to find your way out of your area without access to a map/GPS or if you lose internet access.

Find Your Zone
On PVPready.gov, click Find Your Zone and type your address into the search bar.

View Zone Info
After inputting your address, view Zone Information. There, you will see the boundaries of your zone listed as north of, south of, east of, and west of certain streets.

Learn Exits
Take a screenshot of your zone and its surrounding area, print it out, and draw multiple potential exits that you can reference in the event of a disaster.

The City encourages all residents of the Palos Verdes Peninsula to go to [PVPready.gov](https://pvpready.gov) to learn your evacuation zone and save it in your smartphone or write it down and keep it somewhere that’s easy to find in an emergency, such as your refrigerator or front door. Knowing your zone can help you evacuate more quickly, which can save your life in an emergency. At [PVPready.gov](https://pvpready.gov), residents can also learn more about making an evacuation plan and preparing supplies.

Please note that while the intent of the Know Your Zone platform is to assign residents with set zones that can help them better prepare for and stay safe during emergencies, depending on the nature of any future emergency, zone numbers may change or be divided to better support a response to an emergency. For this reason, you should always check [PVPready.gov](https://pvpready.gov) for the most up-to-date information and real-time updates.

Applications Now Available for Home Stabilization Projects in Landslide Area

The City of Rancho Palos Verdes has established regulations and procedures to help homeowners in the landslide area stabilize and level their houses.

Temporary solutions include placing homes on cargo structures and other leveling systems, such as I-beams, installing alternative foundation systems, and using temporary modular housing and storage while repairs are made.

Permit applications for these projects are now available on the City website at rpvca.gov/building. Fees are being waived during the emergency.



MAKE AN EMERGENCY PLAN

- If a wildfire is in your area, you do not have a lot of time to get to safety.
- Know your local evacuation plan and make sure everyone in your household knows what to do.
- Don't forget to account for your pets and children, and make plans for family members who may be away from your house, such as those who go to work or school.
- Be financially prepared.

KNOW YOUR EVACUATION ZONE

- Visit [PVPReady.gov](https://www.pvpready.gov) for local emergency information.
- Type in your address to see your Neighborhood Evacuation Zone.
- In case of an emergency in your zone or neighboring zone, your zone number and emergency instructions will be sent to you via the Alert South Bay Emergency Messaging system.

STAY UPDATED WITH LOCAL EMERGENCY ALERTS

- Subscribe to [Alert South Bay](https://www.alertsouthbay.com), RPV's Emergency Alerting System. Text AlertSB to 888-777 and receive PV Peninsula alerts to get the latest information regarding emergencies in your area.

STRENGTHEN YOUR HOME AGAINST WILDFIRES

- Keep flammable debris, like dead leaves, at least 30 feet from your house. If you're building or renovating your home, use fire-resistant materials.
- Review [Home Hardening and property safety tips](#) to protect your home.

CREATE A WILDFIRE EMERGENCY KIT

- Gather supplies like medications, a first aid kit, water, and portable chargers in case of evacuation. N95 masks are helpful to have on hand to protect yourself from inhaling smoke. Keep the kit in your car for an even quicker getaway during a wildfire.





Average Energy Prices, Los Angeles – August 2024


The U.S. Bureau of Labor Statistics recently reported that gasoline prices averaged \$4.616 a gallon in the Los Angeles-Long Beach-Anaheim area in August 2024. At this price, Los Angeles area consumers paid 26.5% more than the \$3.648 national average. A year earlier, consumers in the area paid 30.4% more than the national average for a gallon of gasoline. The local price per gallon has ranged from 26.5% to 40.6% above the national average in the month of August during the past five years. (See chart 1.)

Chart 1. Average prices of gasoline – August 2020 - August 2024




Los Angeles area households paid an average of \$0.28 per kilowatt hour (kWh) of electricity in August 2024, similar to the \$0.28 price per kWh paid in August 2023. The price paid for electricity in August 2024 was 59.3% more than the nationwide average of \$0.17 per kWh. Since August 2020, prices paid by Los Angeles area consumers for electricity exceeded the U.S. average by 46.0% in August. (See chart 2.)

Chart 2. Average prices of electricity – August 2020 - August 2024



The average cost of utility (piped) gas at \$1.630 per therm in August was lower than the \$1.909 per therm spent last year. Prices paid by Los Angeles area consumers for piped gas, commonly referred to as natural gas, were 16.3% more than the national average in August 2024. A year earlier, area consumers paid 36.2% more per therm for natural gas compared to the nation. Over the past five years, the per therm cost for natural gas in August has varied between 16.3% and 42.2% above the U.S. average. (See chart 3.)

FAC Meeting Recap

In the latest meeting of the Finance Advisory Committee (FAC) held on September 12, various key items were discussed. One key item from the agenda was to initiate a periodic review of the City's current debt policy. A review of this item demonstrates good business practices by ensuring that the City's financial policies remain up to date. The Committee presented this review as an opportunity to identify lessons learned from past experiences to safeguard the City's financial position. Additionally, the FAC received a quarterly presentation of the Treasury Report, which included an overview of the City's investment portfolio.

Portuguese Bend Landslide Remediation Emergency Hydraugers Project Update

On May 21, 2024, the City Council approved the Portuguese Bend Landslide Remediation Emergency Hydraugers Project, which consists of the installation of two hydraugers with five drain arrays each. The hydraugers were preceded by test boreholes to better understand underground conditions. Those boreholes revealed a deeper slide plane that is moving at a much faster rate than the shallow slide plane.

The unprecedented rate of movement of the deeper slide plane changed the landslide remediation strategy to first address the deeper slide plane. This will be done by installing vertical deep de-watering wells to penetrate the deeper slide plane and relieve water pressure.

Two deep dewatering wells have been installed, both of which are pumping out water at a combined rate of approximately 200 gallons per minute. Drilling of the third dewatering well has started and is expected to be complete by this Friday or sooner. Three boreholes with instruments to measure water pressure are being installed near the dewatering wells to collect data on water pressure reduction. Drilling of the first instrumented borehole started this week and is expected to be completed by the end of this week.

Hawthorne Blvd and Crest Road Street Name Sign Upgrade

On September 18, 2024, new street name signs were installed at the intersection of Hawthorne Blvd and Crest Road. This installation is part of a citywide illuminated street name sign (ISNS) upgrades to replace broken and faded street name signs.

The street name signs replacement project features new easy to maintain signage assemblies, energy efficient internal LED lighting and City logo and approved color palette.



Neighborhood Beautification Grant Program Accepting Applications through September 30

Applications for the neighborhood beautification projects will be accepted beginning August 12, 2024 through September 30, 2024. Beautification projects must be visible from arterials or collector streets to receive a reimbursement for 50% of the project costs, up to \$5,000.

- Weekly landscape maintenance at all City parks.
- All city irrigation systems have resumed their regular watering schedules following the recent repairs aimed at enhancing efficiency. This week's irrigation work included the following:
 - Repaired a lateral line break at Eastview Park.
 - Repaired a lateral line break at Point Vicente Interpretive Center.
 - Adjusted the irrigation line at Palos Verdes Drive West.


- Until permanent repairs can be made, staff replaced the cones near the damaged guardrail with water-wall barricades at Palos Verdes Drive South near Bronco Road


Solar Power Light Poles Placed in Neighborhoods Impacted by Power Shutoffs

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The

presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

Closed Session:

Please be advised that, pursuant to the Ralph M. (Gov. Code § 54963(a).) "[C]onfidential information" means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in Closed Session . . ." (Gov. Code § 54963(a).) Please be further advised that any "violation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law, including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury." (Gov. Code § 54963(c).)
