October 1, 2024 City Council Meeting Highlights

Highlights from the October 1 City Council meeting:

- The Council approved an emergency financial assistance program that will provide \$10,000 to property owners impacted by indefinite utility shutoffs in the landslide area using \$5 million in relief funds from the office of Los Angeles County Supervisor Janice Hahn.
- Information on how eligible property owners can apply will be shared with their homeowners' associations in the coming days.
- The remaining funding will go toward the City's ongoing efforts to slow the landslide, including adding more deep vertical dewatering wells to relieve water pressure from two heavy rainy seasons that is fueling the unprecedented sliding.
- The latest geological data shows that since August, the overall average rate of movement in the landslide area has decelerated by 13% to 8 inches per week, with a range of 1% acceleration to 27% deceleration, depending on the area.



- Six new dewatering wells recently installed by the City on the coastline between the South Bay Archery Club and Portuguese Bend Beach Club are pumping out 720 gallons of water trapped deep underground per minute, or about 1 million gallons per day. These wells are already showing positive results.
- The Council extended the City's local emergency declarations that were put in place to bolster the City's response to the land movement and utility shutoffs through November 30.
- In an effort to reduce crowding in animal shelters and to be consistent with county regulations, the Council introduced an ordinance increasing the number of dogs allowed per residence in the City from three to four, and cats from three to five, consistent with Los Angeles County.

Noel has played a lead role in the successful development of Lower Hesse Park and continues to care for his neighbors and the natural environment we all live in.



In honor of his commitment to the Rancho Palos Verdes community, the City Council presented a proclamation to Noel on October 1, 2024 in recognition of his many years of service to the City.

Land Movement Updates



Rancho Palos Verdes City Council Allocates Emergency Relief Funds for Residents Affected by Land Movement and Utility Shutoffs

On Oct. 1, the Rancho Palos Verdes City Council unanimously approved an emergency financial assistance program that allocates \$5 million in landslide relief funding from the office of Los Angeles County Supervisor Janice Hahn to deliver immediate aid to City residents impacted by land movement and utility shutoffs.

The Council's vote authorized the City to provide up to \$10,000 to each affected property owner, with an estimated total of \$2.8 million allocated for up to 280 eligible homeowners. The funds may be used to cover critical expenses such as purchasing supplies, home repairs, temporary housing and other related costs due to land movement or utility interruptions. The remaining \$2.2 million will be deployed to bolster the City's ongoing landslide response and stabilization efforts.

"Our community has faced unfathomable challenges in the face of this landslide disaster, and it's critical that we swiftly deploy this funding to support our residents who have been most impacted," said Rancho Palos Verdes Mayor John Cruikshank. "These emergency grants will deliver long-overdue immediate assistance to those whose lives have been upended by land movement and utility shutoffs, helping them cover essential costs like home repairs and temporary housing. We extend our gratitude and appreciation to Supervisor Hahn for helping secure this vital funding for our community."

Individual grants will be made available to homeowners in the Portuguese Bend Community Association, Seaview and Portuguese Bend Beach Club neighborhoods. To date, an estimated 280 households in these areas have indefinitely lost electricity and/or natural gas service or suffered damage due to the landslide. To ensure program accountability, recipients of the grant must provide documentation for eligible expenses. The City's Finance Department will oversee the program, and once applications are approved, residents can expect to receive reimbursement within a week. Information on how to apply will be shared with property owners in the coming days via their homeowners' associations.

The City continues to advocate for more local, state and federal assistance to mitigate the skyrocketing costs of the landslide response and the devastating impacts felt by individual residents and homeowners. The Council voted unanimously on Oct. 1 to extend through Nov. 30 its two local emergency declarations related to the landslide and utility shutoffs, and the City will continue to pursue all potential avenues for financial support.

The City Council also [received an update](#) from staff on City efforts to stabilize the landslide. In recent weeks, the City has successfully drilled six new deep dewatering wells that are now collectively pumping out 7.2 million gallons of water — the equivalent of 11 Olympic-sized swimming pools — per week. The wells are located at the toe of the landslide along the shoreline, helping relieve built-up water pressure that is fueling the slide. The emergency project represents a shift in strategy away from the horizontal hydrauger well project, a change driven by the discovery of the deeper and faster-moving Altamira Landslide.

Early indications are that the deep wells are having a positive effect on slowing the rate of land movement. On Oct. 1, the Council voted to allocate \$6.1 million to continue emergency work, up to \$4 million for additional critical dewatering wells, and \$4 million for winterization efforts to prepare for the next rainy season. This includes lining canyons and filling fissures and grabens to prevent water from percolating underground and worsening land movement. While using a combination of Supervisor Hahn's relief funds, excess reserves, emergency reserves, and American Rescue Plan Act funds for this investment, the City will continue to pursue all avenues for potential financial assistance from the county, state and federal governments.

Recent landslide data presented to the City Council on Oct. 1 shows a continued slowing trend across the landslide complex. Between Aug. 1 to Sept. 4, the average movement velocity decelerated by 13%, with an overall movement of 8 inches per week. Land movement remains 80 times faster than in October 2022, and it continues to severely impact public and private roads, private property, including hundreds of residential structures, utility infrastructure and trails and open space areas.

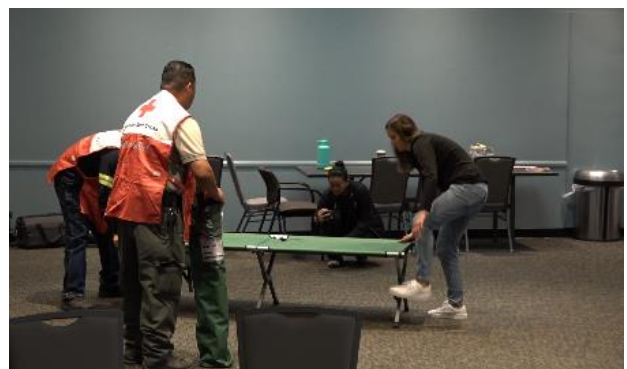

Thanks to the support of the American Red Cross and the commitment and dedication to public service, we as a peninsula are now more prepared to support our communities during a catastrophic emergency.



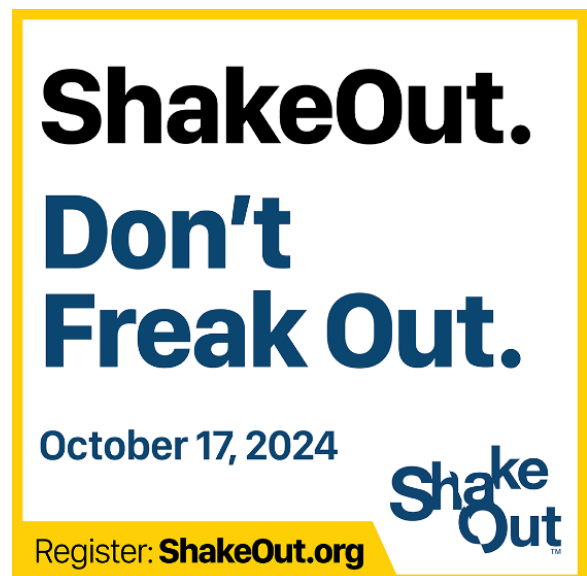
DROP! COVER! and HOLD ON!

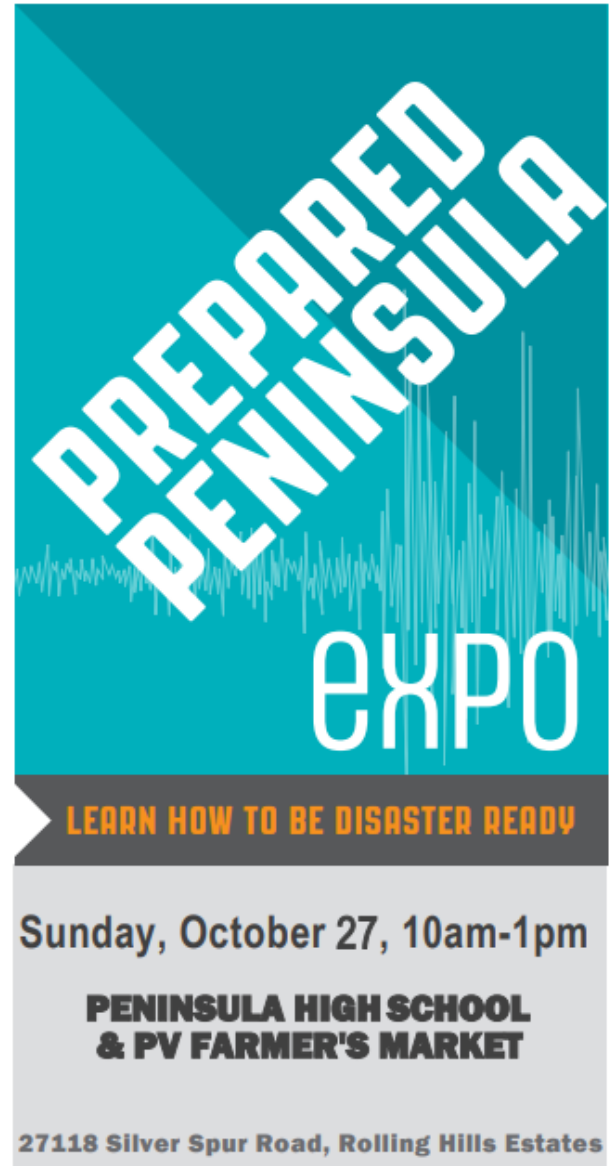

Finance Advisory Committee Meeting (Cancelled)

Case-Shiller Home Price Indices – June 2024

Last week, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for July. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indices.

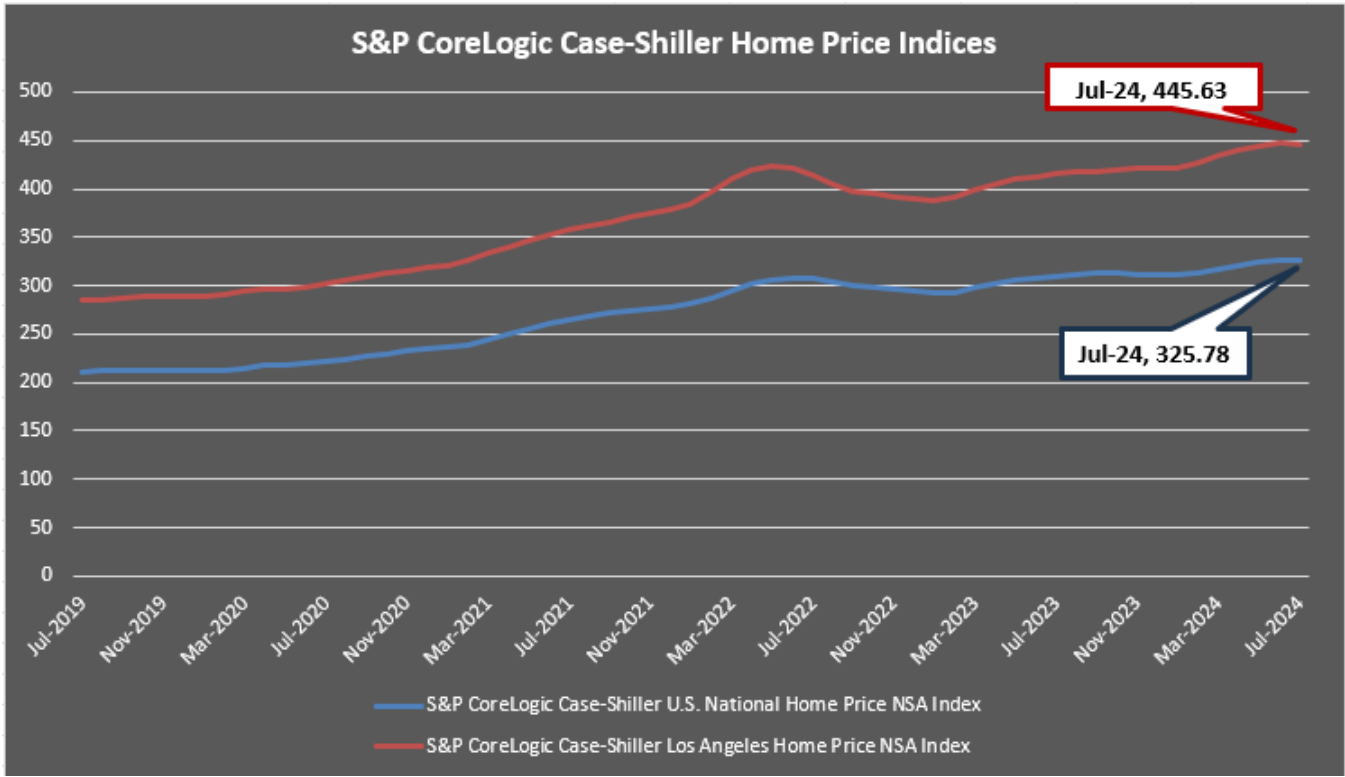
Month-over-Month

The upward trends continued to decelerate from last month, with the National Index posting a month-over-month increase of 0.1% in July, before seasonal adjustments. Home prices in the Los Angeles area fell by 0.2%, compared to prior monthly modest gains.

Year-over-Year

The National Index reported a 5.0% annual gain in July, from a 5.5% annual gain in the previous month. The annual gain for Los Angeles was at 7.2% and continues to remain above the national average. California, with the nation's most expensive high-price tiers, saw indices outperformed on a one- and three-year basis

Portuguese Bend Landslide Emergency Stabilization Project Update

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City has been installing deep vertical dewatering wells to penetrate the deep slide plan and relieve water pressure.

Six deep dewatering wells have been installed, with a combined dewatering rate of approximately 720 gallons per minute. The deep dewatering wells are preceded by test boreholes to determine the exact soil conditions, as well as monitoring wells to measure the water pressure relief rates.

Test boreholes in advance of a seventh and eighth deep dewatering well are currently in progress- adjacent to PVDS near the entrance to the South Bay Archery Range and the toe of the "Ski Jump". The test boreholes are expected to be complete by the end of this week, and the deep dewatering wells are expected to be complete by the end of next week.

On October 1, 2024, the City Council authorized the installation of additional deep dewatering wells with their associated test boreholes and monitoring wells. These deep dewatering wells will be located in the area of Sacred Cove and/or Abalone Cove, as advised by geologists.

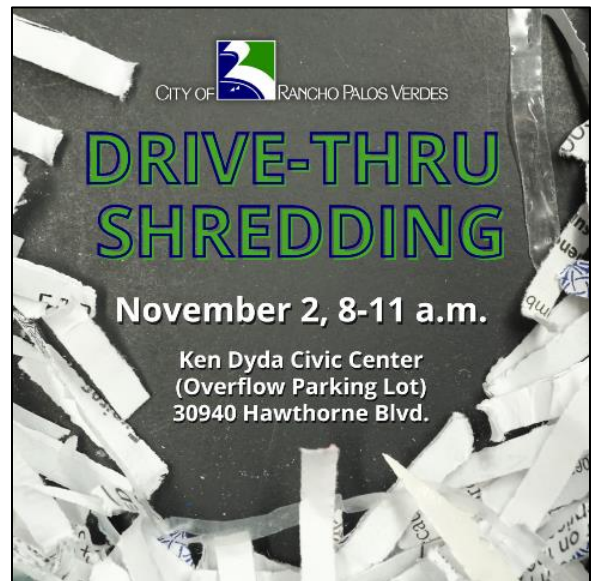
On October 1, 2024, the City Council authorized emergency winterization measures in the form of filling fissures, especially in the canyons, to re-establish drainage to the

ocean. The emergency winterization will include filling fissures in Altamira, Klondike, Portuguese, Ishibashi, and Paintbrush Canyons. Additionally, the grabens at the intersection of Exultant Drive and Dauntless Drive, on Exultant Drive, and on Admirable Drive will be included in the winterization work. Crews are expected to mobilize and begin this work next week.



Next Paper Shredding Event, November 2

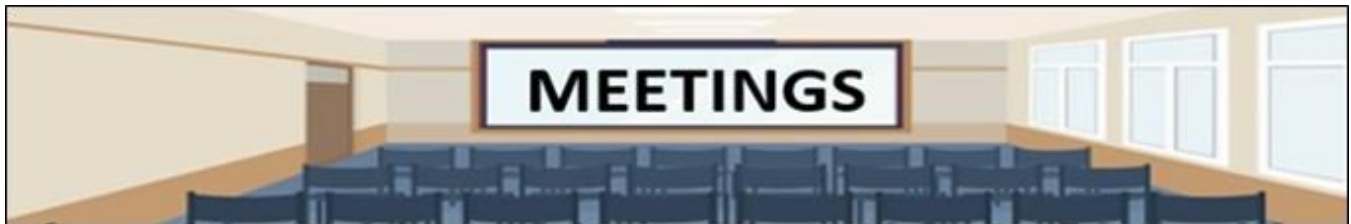

Planning Commission to Conduct Appeal Hearing

On October 8, 2024, the City's Planning Commission will consider an appeal of the Director of the Community Development Department's determination that the proposed project at 5323 Ironwood Street, which includes 482 units (1,173,927 square feet) does not qualify for SB35/423 ministerial review. The proposed project would then require the following entitlements: General Plan Amendment, Zone Change, Certificate of Compliance, Major Grading Permit, Variance, Environmental Review and Major Site Plan Review as required by the Rancho Palos Verdes Municipal Code. The appeal is brought pursuant to Rancho Palos Verdes Municipal Code Section 17.80

Building and Safety Division Monthly Activity

REACH Update

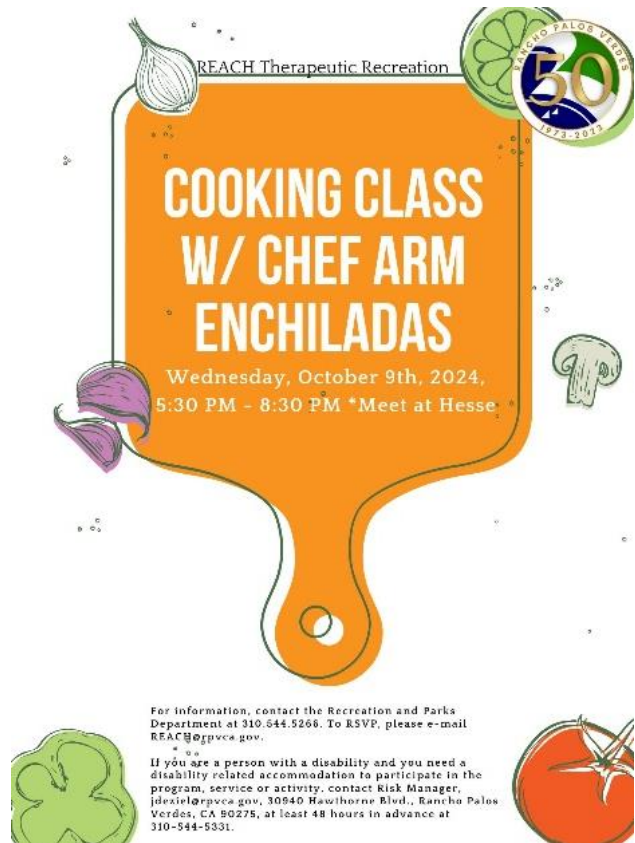
The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

Dear President Reynolds,

I am writing regarding the unprecedented utility service shutoffs in my district. Amid the rapid acceleration of the land movement in Rancho Palos Verdes and Rolling Hills, Southern California Edison (SCE) and the Southern California Gas Company (SoCalGas) have chosen to indefinitely shut off essential electric and gas services to hundreds of homes with little notice.

These mass utility shutoffs have sent these residents reeling and, in some neighborhoods, they have been more disruptive than the land movement itself. Residents have struggled to connect their homes to alternative power sources and some families have been forced to move out because the shutoffs have made their homes unlivable.

The utilities have cited the potential that land movement may cause gas leaks and spark fires with downed power lines. Those concerns are legitimate and should be taken seriously. But right now, the utilities have little incentive to invest in mitigation or help their customers adapt.

These utility companies are monopolies. They have profited off these residents for decades as the chosen utility providers for this region. **Given that, these utilities should be responsible for providing alternative sources of power to their customers on the Palos Verdes Peninsula when they choose to shut off service.** Furthermore, land movement in this area is the new normal and SCE and SoCalGas are going to need to reevaluate their infrastructure to allow for their customers to receive power. To say they will restore service when the land stops moving is unrealistic.


I understand that both SCE and SoCalGas have contributed fifty thousand dollars to a relief fund for residents. That may have been helpful funding in the early days of this crisis when just a few dozen residents were impacted, but with hundreds of homes without

power, these funds are insufficient. Furthermore, SoCalGas provided one-time payments of twenty-five hundred dollars to the first homes to lose service but has not extended the same benefit to the homes in other neighborhoods impacted by subsequent shutoffs.

As the regulatory body entrusted with ensuring that utility providers meet their obligations to consumers, the CPUC can play a critical role in ensuring that SCE and SoCalGas adequately respond to this crisis. **I urge the Commission to compel both SCE and SoCalGas to provide further assistance.** More robust financial assistance programs are needed to support displaced residents and those suffering from indefinite service outages.

My office continues to hear concerns from residents who feel abandoned by the utility companies they relied upon. The residents of Rancho Palos Verdes and Rolling Hills deserve immediate relief and I encourage the CPUC to act to ensure these utility providers deliver the necessary assistance. This Monday, October 7, I will be meeting with CPUC Commissioner Darcie L. Houck and Rancho Palos Verdes and I look forward to a productive discussion about a pathway forward. Thank you for your attention to this urgent matter.

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and

includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.
