Land Movement Updates



Financial Assistance Grant Program – Grant Support Center

The City of Rancho Palos Verdes is administering an emergency financial assistance program that allocates \$2.8 million in landslide relief funding from the office of Los Angeles County Supervisor Janice Hahn to deliver immediate aid to City residents impacted by land movement and utility shutoffs. Through this program, the City can provide up to \$10,000 to each eligible affected property owner, with an estimated total of \$2.8 million allocated for up to 280 eligible homeowners.

Eligible property owners residing in:

- Portuguese Bend Community Association, including surrounding properties
- Seaview
- Portuguese Bend Beach Club

- Grant Support Center will be available on October 9 and 16 from 1:00 p.m. to 7:00 p.m. at the Ladera Linda Community Center. The Finance team will be available to answer questions, respond to inquiries, and assist with the application process. Residents may also make appointments if preferred.

As of October 9, 2024, the City has received approximately 90 applications and expects to disburse payments for completed and verified applications on Friday, October 11, 2024.


The Annual Prepared Peninsula Expo

Portuguese Bend Landslide Emergency Stabilization Project Update

In response to unprecedeted movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City has been installing vertical deep de-watering wells to penetrate the deep slide plane and relieve water pressure.

On October 1, 2024, the City Council authorized the installation of additional deep dewatering wells with their associated test boreholes and monitoring wells. These deep dewatering wells will be on City-owned property in the area of Sacred Cove and/or Abalone Cove, as advised by geologists. Additionally, the City Council authorized emergency winterization measures in the form of filling fissures, especially in the canyons, to re-establish drainage to the ocean. The emergency winterization will include filling fissures in Altamira, Klondike, Portuguese, Ishibashi, and Paintbrush Canyons. Additionally, the grabens at the intersection of Exultant Drive and Dauntless Drive, on Exultant Drive, and on Admirable Drive, will be included in the winterization work. Crews are expected to mobilize to begin this work next week. To date:

- 14 instrumented vertical test boreholes to characterize subsurface conditions and support the execution of dewatering operations have been installed.
- Six deep dewatering wells (DDWs) have been installed west of the Portuguese Bend Beach Club Community. The DDWs are currently discharging water at a combined rate of approximately 560 gallons per minute.
- Three instrumented monitoring wells have been installed to gauge dewatering well performance. Data from the monitoring wells shows that there are

significant reductions in water pressure.

- Deceleration of land movement in the areas of the installed DDWs continues to be observed, based on a sampling of points from GPS monitoring data.
- The installation of a seventh DDW is in progress and expected to be completed by this week.
- The drilling of an additional instrumented vertical test borehole to site an eighth DDW is in process and expected to be complete by the end of this week.
- Crews have mobilized for the winterization of Altamira Canyon, which is expected to take approximately six to eight weeks.
- Crews are preparing to mobilize for winterization of Portuguese, Ishibashi and Paintbrush canyons. A schedule for completion is being prepared.
- The winterization of three sections of the Seaview community is expected to commence next week and be completed within two to four weeks.
- Environmental and cultural monitoring is being conducted in conjunction with construction activities.

Avenida Classica Traffic Circles Pilot Project Scheduled for Installation in October


On October 3, 2023, the City Council approved installation of traffic circles at Avenida Classica as a pilot project. Installation of the Avenida Classica Traffic Circles Pilot Project is tentatively scheduled to begin on October 10. Notice letters were sent, and message boards were deployed to notify area residents about the upcoming installations.

The traffic circle pilot project is the culmination of a process beginning with requests from area residents to investigate traffic conditions on Avenida Classica between Crest Road and Los Verdes Drive. Residents reported concerns about speeding, cut-through traffic, and erratic driving along Avenida Classica and surrounding roadways. In response to these concerns, the Traffic Safety Committee (TSC) held a public meeting on July 24, 2023 to consider traffic calming measures recommended in a traffic study. The TSC recommended that the City Council consider a traffic circle at the intersection of Avenida Classica and Avenida Esplendida as well as Avenida Classica and Avenida Celestial.



Next Paper Shredding Event, November 2

Mark your calendars! Our next paper/document shredding event will be on November 2 from 8-11 a.m. The event will be held at Ken Dyda Civic Center overflow parking lot and will be free to all Rancho Palos Verdes residents. During the event, electronic waste will be collected for recycling, and mulch will be available to residents.



Prepare for the Citywide Brush Clearing

The fall season brush-clearing event began on Saturday, October 5 and will continue for four consecutive Saturdays. Each week a different area of RPV is serviced. The goal of the event is to assist homeowners' dispose (free of charge) excess brush, shrubs, hedges, tree branches, and bushes to comply with the Los Angeles County Fire Department's fire safety guidelines. 

Apply for a Western Avenue Storefront Improvement Grant Starting October 15

Businesses and property owners in RPV's Western Avenue Commercial Corridor are invited to apply for a storefront improvement grant from the City!

Grants of \$5,000-\$20,000, requiring a 50% match, are available for eligible projects that enhance or restore the physical condition or appearance of the building (must be visible from the street). Examples include new exterior paint, lighting, landscaping, signs, awnings, entry doors, outdoor seating, and resolving code violations.

Storefronts must be located along Western Avenue within the boundaries of the City of Rancho Palos Verdes (NOT in the City of Los Angeles). The grant application window opens on **October 15, 2024**.

No Construction on Monday, October 14 (Legal Holiday - Columbus Day)

Pursuant to Section 17.56.020(B) of the Rancho Palos Verdes Municipal Code, it is unlawful to carry on construction, grading, or landscaping activities, or to operate heavy equipment except between the hours of 7:00 A.M. and 6:00 P.M. Monday through Friday, and between the hours of 9:00 A.M. and 5:00 P.M. on Saturday. No such activity

shall be permitted on Sundays, or the legal holidays (within the City's permitted construction hours), unless a Special Construction Permit is approved by the Director of Community Development. Swale Maintenance

Swales tend to become filled with leaves, overgrown vegetation, and debris over the course of the year. As a reminder, it is a property owner's responsibility to maintain a drainage swale so that it functions properly. Improperly maintained drainage swales interfere with proper drainage flows that can result in property damage caused by slope failure, erosion, or excess storm-water runoff. As we fast approach the rainy season, now is the time to clean your swales.

As an additional reminder, the City's Municipal Code does not permit the construction of any structure within or above a drainage swale or on a slope on or equal to 35% or greater. This includes decks, stairs, or structures of any kind. Please keep this in mind if

The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.


