November 19, 2024 City Council Meeting Highlights

Highlights from the November 19 City Council meeting:

- The Council received an update on the Voluntary Property Buyout Program in the landslide area, which received 85 applications.
- City Staff and Cal OES are reviewing the applications for eligibility with FEMA's program requirements, giving priority to damaged properties that have been red- or yellow-tagged. The review and selection process is expected to take at least several months.
- Of the 85 applications, 20 properties have been red-tagged and 37 have been yellow-tagged.



- Fourteen property owners submitted applications but have not requested an inspection.
- The City's geologist presented the latest land movement data showing continued deceleration across the landslide complex to an average of 3.3 feet per week. While movement has slowed by 76% since September, the land is still sliding 25 times faster than it was two years ago.
- City staff presented a comprehensive look at the costs of responding to the landslide emergency, projecting that by the end of this fiscal year in June 2025, the City's landslide response will reach an estimated \$43.6 million since October 2022.
- The Council extended the local emergency declarations that were put in place to help the City respond to the land movement and utility shutoffs through January 18, 2025.
- City staff gave an update on aesthetic and traffic improvement projects along Western Avenue.
- Based on updates from Caltrans and the City of Los Angeles, the Western Avenue Beautification Project team is adjusting plans for enhancements aimed at beautifying Western Avenue from Peninsula Verde Drive to Summerland Street.
- Meanwhile, applications for the Western Avenue Storefront Improvement Program are due on December 1. Grants of \$5,000-\$20,000, requiring a 50%

match, are available to businesses and property owners for eligible projects that enhance or restore the physical condition or appearance of the building.

- Staff anticipates construction on traffic flow improvements along Western Avenue could begin as early as November 2025 and take one year to complete. Funded by a Metro grant, these measures include upgrading 13 key traffic signals with synchronization technology, modifying traffic signal phasing, adding turn lanes, extending turn pockets, and prohibiting left turns when exiting two shopping center driveways.
- Finally, the Council received an update on efforts to potentially acquire the Point Vicente Lighthouse and Battery Barnes properties from the U.S. Coast Guard.
- While the Coast Guard has indicated that acquisition is unlikely at this time due to an ongoing lengthy divestiture process for Base Los Angeles/Long Beach, a joint-use agreement with the Coast Guard may be a short-term solution while the City pursues acquisition.
- City staff is exploring whether there is potential for Wayfarers Chapel, the National Historic Landmark that was dismantled earlier this year due to damaging land movement, could potentially be reassembled on either site.

December 3 City Council Meeting Canceled; Special Meeting Scheduled for December 11

The December 3 regular City Council meeting has been canceled due to the pending certification of the November 5 General Municipal Election results. Instead, the Council will hold a special meeting on Wednesday, December 11 to recognize outgoing Mayor John Cruikshank and Mayor Pro Tem Eric Algeria, swear in the new Councilmembers, and select the Mayor and Mayor Pro Tem for 2025. The meeting will take place at 6 p.m. in McTaggart Hall at Hesse Park. The meeting agenda will be available on the City website at rpvca.gov/agendas.



Land Movement Updates



November 19 City Council Meeting

At last night's meeting, the City Council received the latest updates on land movement data in the Portuguese Bend landslide area, the City's deep dewatering and winterization efforts, the financial impacts of the landslide response, and the Voluntary Property Buyout Program.

City staff provided an updated tally of damaged properties that have been red- and yellow-tagged and whose owners are seeking buyouts. Of the 85 applications, 20 properties have been red-tagged, 37 have been yellow-tagged, and 14 were deemed to be in good condition. Another 14 property owners who submitted applications have not requested inspections, but may still do so by contacting the Building and Safety Division.

City staff also clarified what is included in the buyout program's cost share formula, with 75% of eligible costs being covered by FEMA and 25% covered by the property owner via a reduction in sales price. FEMA Acquisition and Demolition Program Cost Share Example

Hypothetical Case: Property Value \$3.5 million

Eligible Costs a. property value w/ improvements appraised at \$3,500,000

- FEMA share (75%) = \$2,625,000
- Property Owner share (25%) = \$875,000

Eligible Costs b. through i. estimated at approximately \$180,000

- FEMA share (75%) = \$135,000
- Property Owner share (25%) = \$45,000

-Property owner share of Eligible Costs b. through i., will be reduced from the value of the property so owner does not have to pay up front

-Homeowner's share of all Eligible Costs a. through i. = \$920,000

-Homeowner will receive \$2,580,000 at closing

- $(\$3,500,000 * .75) - \$45,000 = \$2,580,000$

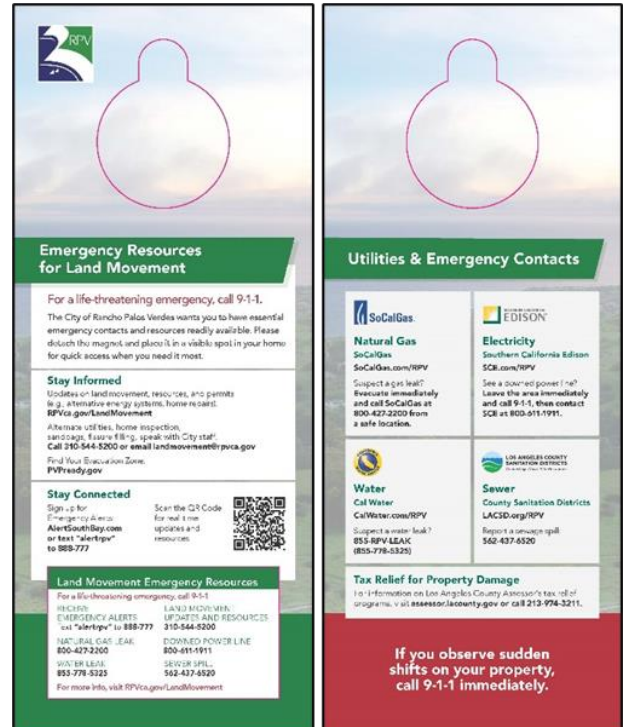

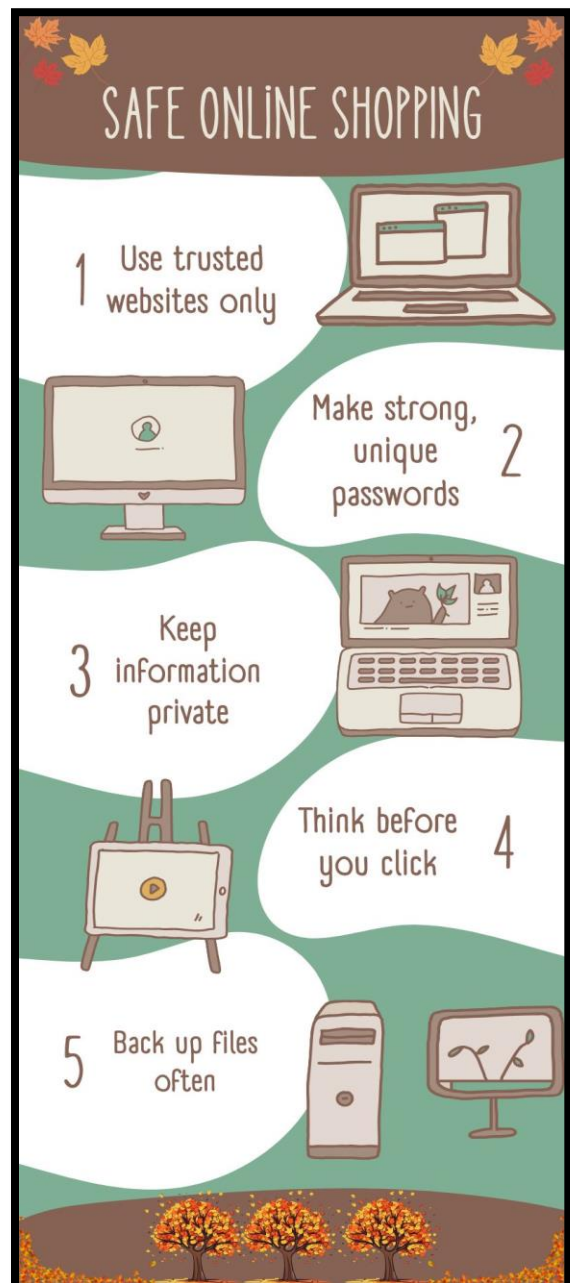

Protect Yourself Against Cyberattacks this Holiday Season

- Limit the personal information you share online. Change privacy settings and do not use location features.
- Keep software applications and operating systems up-to-date.
- Create strong passwords by using upper and lower case letters, numbers and special characters. Use a password manager and two methods of verification.
- Watch for suspicious activity that asks you to do something right away, offers something that sounds too good to be true, or needs your personal information. Think before you click. When in doubt, do NOT click.
- Protect your home and/or business using a secure Internet connection and Wi-Fi network. Change passwords regularly.
- Check your account statements and credit reports regularly.
- Be cautious about sharing personal financial information, such as your bank account number, Social Security number or credit card number. Only share personal information on secure sites that begin with <https://>. Do not use sites with invalid certificates.



- Use a Virtual Private Network (VPN) that creates a more secure connection.
- Use antivirus and anti-malware solutions, and firewalls to block threats.
- Back up your files regularly in an encrypted file or encrypted file storage device.
- Do not click on links in texts or emails from people you don't know. Scammers can create fake links to websites.
- Remember that the government will not call, text or contact you via social media about owing money.
- Keep in mind that scammers may try to take advantage of financial fears by calling with work-from-home-opportunities, debt consolidation offers and student loan repayment plans.

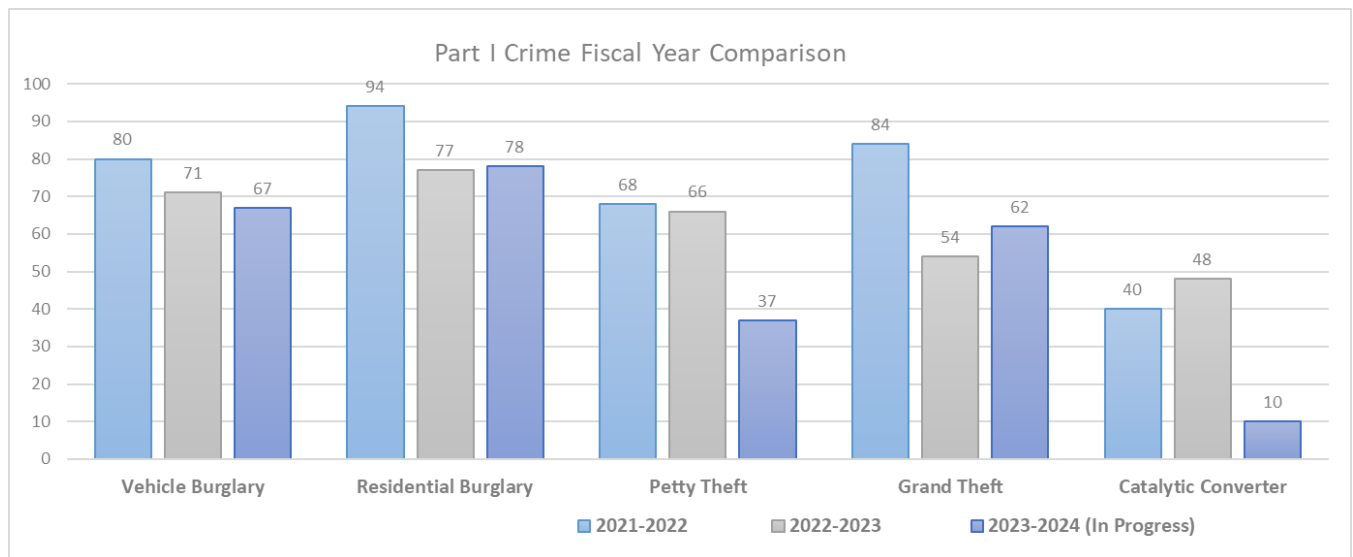

FAC Meeting Recap

In the latest meeting of the Finance Advisory Committee (FAC) held on November 14, various key items were discussed. One key item from the agenda was to receive an annual valuation report for the City's pension plans from the California Public Employee' Retirement System (CalPERS). As part of FAC's Work Plan in FY 2024-25, a subcommittee was formed to continue to review the City's unfunded accrued liability and to potentially develop a payment schedule aligned with the City's Pension Guidelines. Discussions will continue with City staff over the next few months, with a goal of submitting a recommendation for the City Council's consideration in the next budget cycle.

The FAC also received a staff report on a survey of existing policies in surrounding municipalities related to City-issued loans. The Committee requested this information as a review of the City’s recent approved loans to the ACLAD and KCLAD districts. Additionally, the FAC received a Treasury report presentation and the fiscal impact for the emergency and stabilization measures in response to the acceleration of the Greater Portuguese Bend-Ancient Altamira Landslide Complex.

Consumer Price Index – October 2024

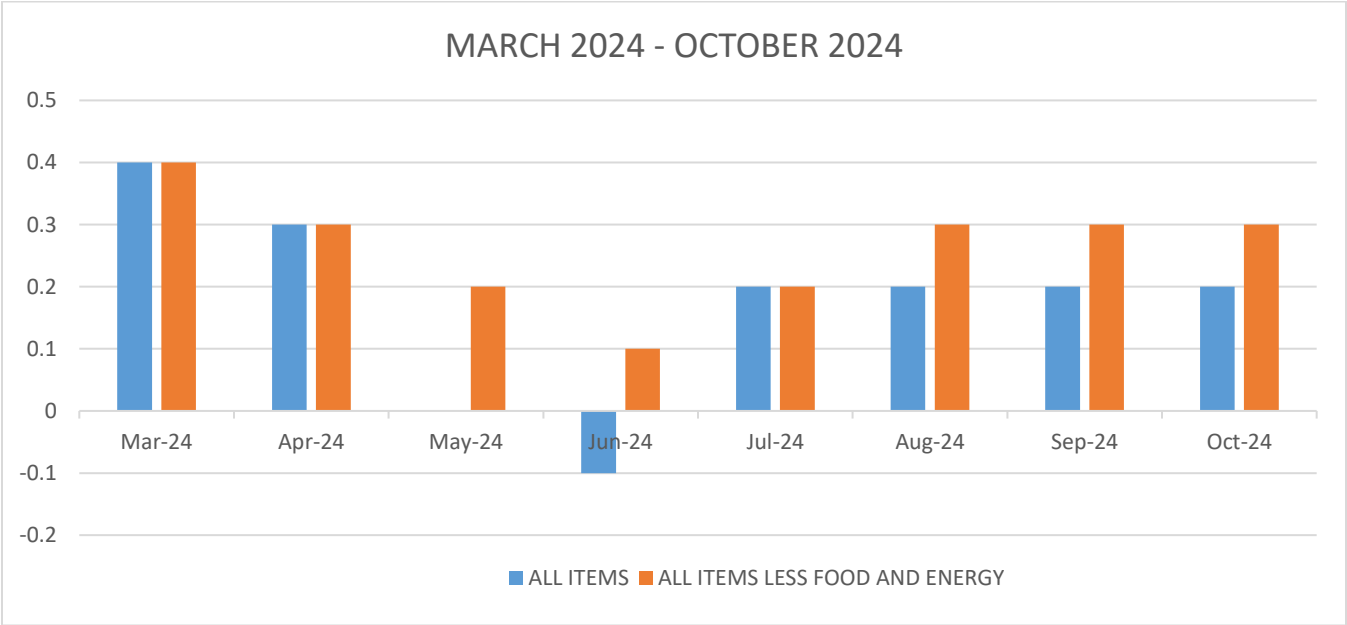
Consumer Price Index (U.S.)

On a seasonally adjusted basis, the Consumer Price Index (CPI) increased by 0.2% in October, the same increase as in each of the previous three months. On an annual basis, the CPI for all items rose by 2.6% before seasonal adjustments.

The index for all items less food and energy (core inflation) rose by 0.3% in October, the same increase as measured in September and August.

Charts 1 further illustrates the monthly percent changes in CPI for both headline and core inflation.

Chart 1. U.S. One-month Percent Change in CPI (seasonally adjusted)



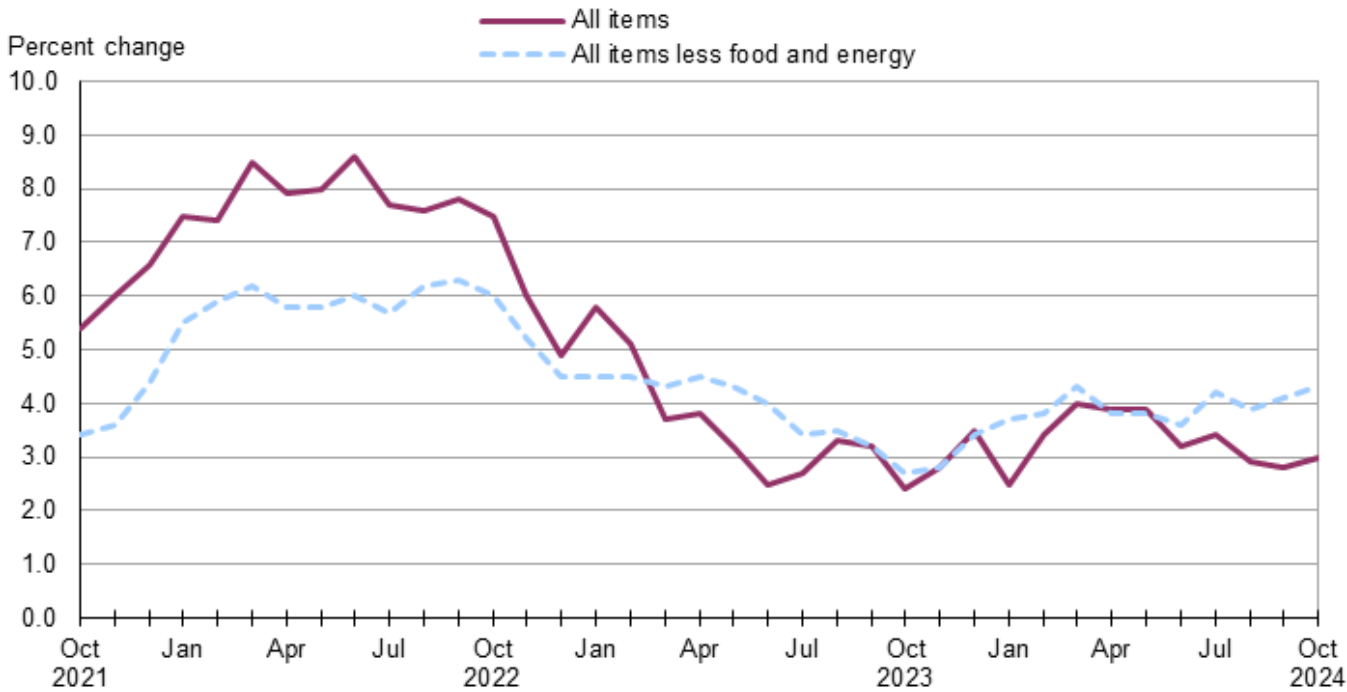

The index for shelter rose by 0.4% in October, accounting for over half of the monthly all items increase. The index for food also increased by 0.2% in October. Other indexes that increased in October included: used cars and trucks, airline fares, medical care, and recreation.

Consumer Price Index (Los Angeles)

Prices in the Los Angeles area, as measured by CPI, were unchanged in October. Compared annually, prices have risen by 3.0% from a year ago. Although food prices increased by 3.5%, energy prices declined by 12.4%.

Portuguese Bend Landslide Emergency Stabilization Project Update

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City has been installing vertical deep de-watering wells to penetrate the deep slide plane and relieve water pressure.

Additionally, the City has been performing emergency winterization measures in the form of filling fissures and lining canyons including Altamira, Kelvin, Portuguese, Ishibashi, Paintbrush, and Klondike Canyons. The City will be lining the graben at the intersection of Exultant Drive and Dauntless Drive, and filling the fissures on Exultant Drive, Admirable Drive, and Palos Verdes Drive South Service Road.

The following work has been complete to date:

Deep Dewatering Wells

- 17 instrumented vertical test boreholes to characterize subsurface conditions and support the execution of dewatering operations have been installed. Installation of an additional test borehole with an approximate depth of 450-feet located in the upper region of the Portuguese Bend Reserve will begin within the next two weeks and take approximately 10 days to complete. This will be the deepest borehole drilled in the landslide and will provide information to better characterize the deeper slide surface within the higher elevations of the landslide complex.

- Six deep dewatering wells (DDWs 1-6) have been installed west of the Portuguese Bend Beach Club community (PBBC) and are currently discharging water at a combined rate of approximately 560 gallons per minute (GPM).
- Two DDWs (DDWs 7 & 8) have been installed near Palos Verdes Drive South- one east of Peppertree Drive and one near the entrance to the South Bay Archery Range, with a combined discharge rate of approximately 110 GPM.
- Two DDWs (DDWs 9A & 10) are operating along the coast of Abalone Cove. DDW 9A (a replacement for de-commissioned DDW9) was installed last week. The two wells have a combined discharge rate of approximately 215 GPM.
- The total combined water extraction rate of the 10 operating DDWs is currently over 875 gallons per minute or approximately 1.25 million gallons per day.
- Since the start of the DDW program; approximately **50 million gallons**, or approximately 155 acre-feet, of water have been extracted from certain locations of the toe of the Landslide Complex.
- Access is being developed for a third DDW (DDW 11) in the Abalone Cove area. Drilling of the well is expected to begin by the end of this week.
- Deceleration of land movement in the areas of the installed DDWs continues to be observed, based on a sampling of points from GPS monitoring data.
- Four sample points in the Seaview and PBBC neighborhoods have shown no movement for five consecutive surveys (October 13, 2024, October 20, 2024, October 29, 2024, November 5, 2024 and November 13, 2024).

Winterization

- Fissure filling of Altamira Canyon and nearby areas, including the installation of a protective pond liner at the base of Altamira Canyon was completed this week.
- Fissure filling and lining of Klondike Canyon downhill of the existing gabion wall is complete and a protective pond liner is being installed this week. Fissure filling above the gabion wall will begin next week.
- Fissure filling and lining of Kelvin Canyon has started and is expected to be completed by next week.
- Winterization of the Portuguese, Ishibashi, and Paintbrush Canyons will begin in succession with the above winterization work completing and is expected to take two weeks to complete.
- Grading and paving of sections of Exultant Drive in the Seaview Neighborhood is complete. Grading and paving of sections of Admirable Drive has started and is expected to be completed next week. Winterization of the Exultant Drive and Dauntless Drive intersection has started and is expected to be completed by early December.
- All winterization work is expected to be complete by the end of December.

Environmental and cultural monitoring is being conducted in conjunction with the above construction activities.

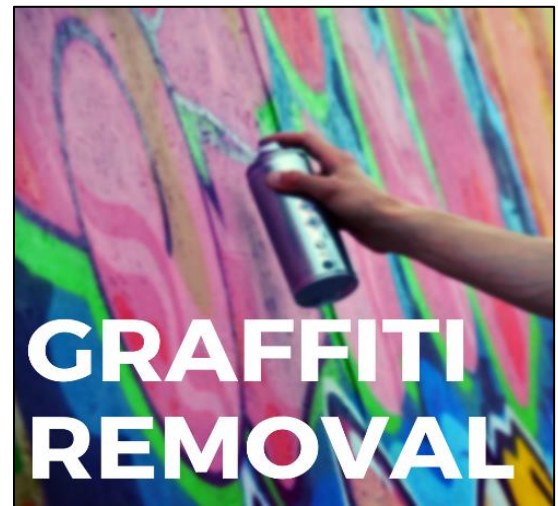


- Repaired and reinstalled a downed street sign on Island View Drive.

Draft Revisions to the City's 2021-2029 Housing Element Now Available

On November 20, 2024, draft revisions to the document were posted on the City's [website](#), which incorporate the City Council's direction. The draft revised Housing Element must be posted on the City's website and made available to interested parties 7 days before it can be submitted to the State's Department of Housing and Community Development (HCD). City Staff expects to submit this draft for formal review by HCD on November 26, 2024. HCD has 60 days to provide feedback on the draft in the formal review process. As soon as City Staff receives feedback from HCD, it will be shared with the City Council for next steps. New PVIC Exhibit Opens to the Public

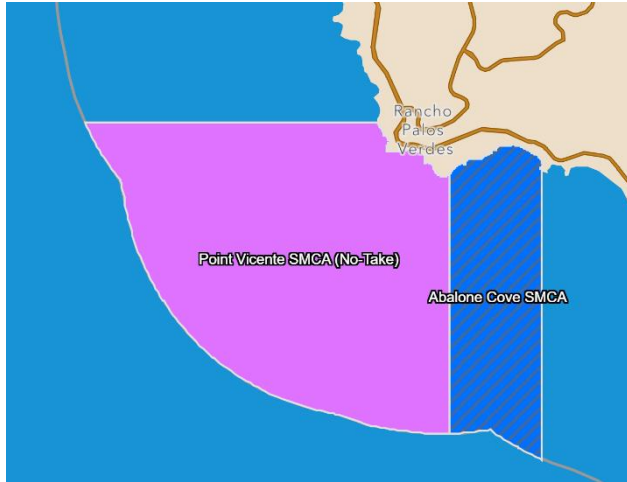

Filiorum Reserve

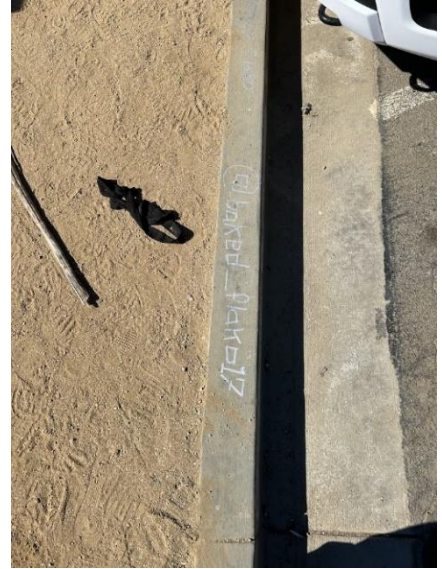

Re: Marine Protected Area Regulation Change Petitions Submitted to the California Fish and Game Commission

Dear honorable coastal elected officials and agency leadership:

On behalf of the California Fish and Game Commission, I am writing to share with you information about potential changes to California's network of marine protected areas (MPAs) that have been proposed by the public, non-governmental organizations, and other agencies.

Importantly, some agency officials have inquired about the best way to engage in the petition review and evaluation process, especially for proposals that overlap or border areas under local government jurisdiction. This letter provides background information, specific ways to become involved in the petition review and evaluation process, and who to contact for more information.

Background

In early 2023, the first comprehensive [decadal management review](#) of [California's MPA network](#) and [MPA management Program](#) was completed. The review resulted in 28 recommendations for adaptively improving the program over the next decade. One recommendation was to apply the review's findings to support potential changes to the MPA network and management program. Recognizing stakeholder interest in proposing specific changes, the Commission agreed to receive petitions for changes to the MPA network.

In December 2023, the Commission received 20 petitions from the public proposing over 80 individual changes to existing MPAs or proposing new ones. The Commission is still in early stages of reviewing the petitions; in February 2024, all petitions were referred to our sister agency, the California Department of Fish and Wildlife (CDFW), for evaluation and recommendations. The petitions and evaluations are being discussed at meetings of the Commission and its Marine Resources Committee; the most recent discussion occurred at the November 6-7, 2024 Marine Resources Committee meeting ([item 2 of the meeting materials](#)).

How to Get Involved

Your input to and engagement with the review and evaluation process is important; there are multiple pathways for you to engage in the review and evaluation process.

Review Petitions and Contact Petitioners

If you have not already, we encourage you to familiarize yourself with petitions in your area using CDFW's interactive [MPA Petitions StoryMap](#), or via the Commission's online list of [MPA petitions](#). We encourage you to consider reaching out to the petitioner(s) directly. Commission staff can help connect you to petitioners if contact information is redacted (fgc@fgc.ca.gov).

There are multiple pathways for you to engage in the review and evaluation process, including meetings of the Commission, discussions at Marine Resources Committee meetings, submitting written comments, and community engagement through your local [MPA Collaborative](#).

As the Commission begins the evaluation process, you can learn more about the considerations used for [organizing or "binning" petitions](#) (how the petitions were sorted for near-term versus long-term review) and [draft recommendations for the first, near-term, bin of petitioned actions](#) that will be presented to the Commission in December.

Provide Input

During the review and evaluation of petitions, the Commission welcomes your input on feasibility, potential impacts, and other factors related to specific proposed changes important to your communities. You can submit written comments, give verbal comments at Commission meetings, or participate in Marine Resources Committee meetings where a more detailed dialogue takes place among stakeholders and up to two commissioners; ultimately, the committee makes recommendations to the Commission for potential action.

Stay Informed

Visit the Commission website for a schedule of upcoming Commission and committee meetings, and instructions on submitting written or verbal comments (www.fgc.ca.gov/meetings). All meetings take place in a hybrid format, so you may join in person or via Zoom. We invite you to [join our electronic mailing list\(s\)](#) to receive meeting agendas and announcements.

To become more involved in local MPA management and stewardship in your county, you may visit www.mpacollaborative.org to connect with your county or regional MPA collaborative and/or sign up to receive meeting announcements and other information. The collaboratives are also a great resource for questions about your local MPAs.
