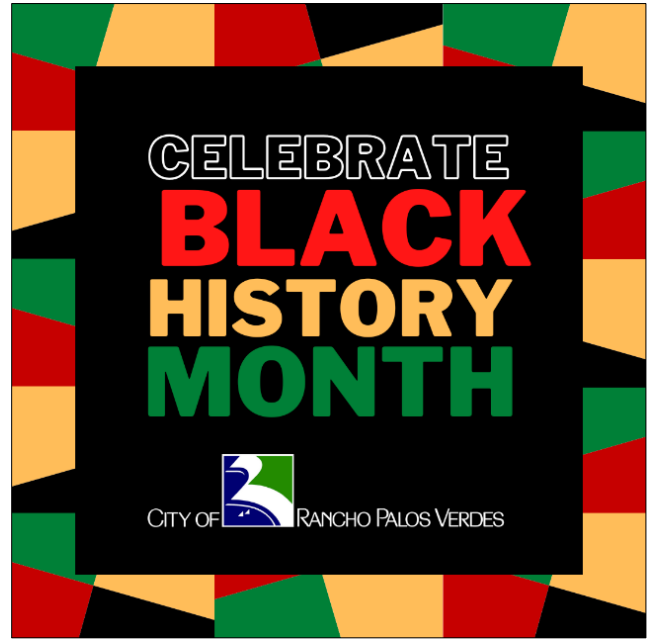

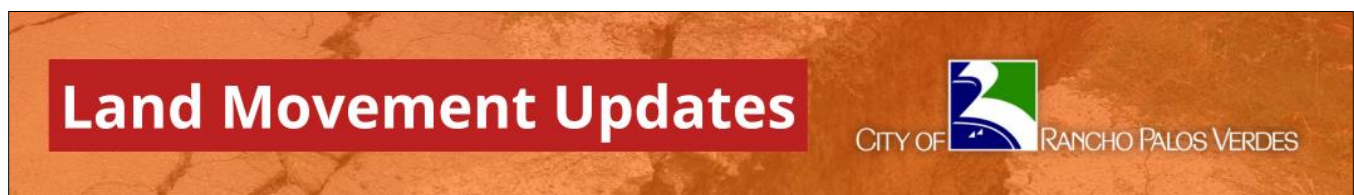
February 4, 2025 City Council Meeting Highlights

- The Council extended by 60 days the temporary prohibition of bicycles and motorcycles along a two-mile stretch of Palos Verdes Drive South in the Portuguese Bend landslide area due to land movement.
- The Council affirmed the use of a \$1.6 million financial assistance loan from the City to the Abalone Cove Landslide Abatement District (ACLAD) for its conceptual plan to drill 8-10 new deep dewatering wells in its boundaries.
- Additional financial assistance that may be needed by ACLAD could be considered at a future meeting when more information on the deep dewatering wells output, costs and the project timeline is available.



- Both local emergency declarations in the landslide area were extended for 60 days.
- City staff gave an update on the launch of the new Public Safety Division, which will supplement Sheriff's Department services in RPV.
- Newly hired staff is building relationships with the Lomita Sheriff's Station, homeowners associations and Neighborhood Watch, and has begun implementing community outreach initiatives.
- As part of this effort, a community survey will be issued in March gauging residents' top three public safety concerns in the community.
- The Council adopted the 2025 Legislative Platform encompassing crucial areas such as landslide remediation, civic center planning, housing, public safety, community services, environmental quality, and government transparency.
- Key updates include:
 - Identifying outside funding sources for landslide remediation and civic center planning.
 - Supporting legislation that recognizes landslides as a disaster constituting a state of emergency under the Emergency Services Act.
 - Prioritizing the emergency services components in the Civic Center Master Plan.
 - Working with Wayfarers Chapel to potentially rebuild at the Civic Center.
 - Seeking support from federal lawmakers to acquire or jointly use the U.S. Coast Guard's Battery Barnes and Point Vicente Lighthouse properties.
 - Opposing housing legislation that requires high-density housing in areas within Cal Fire's Very High Fire Hazard Severity Zones.

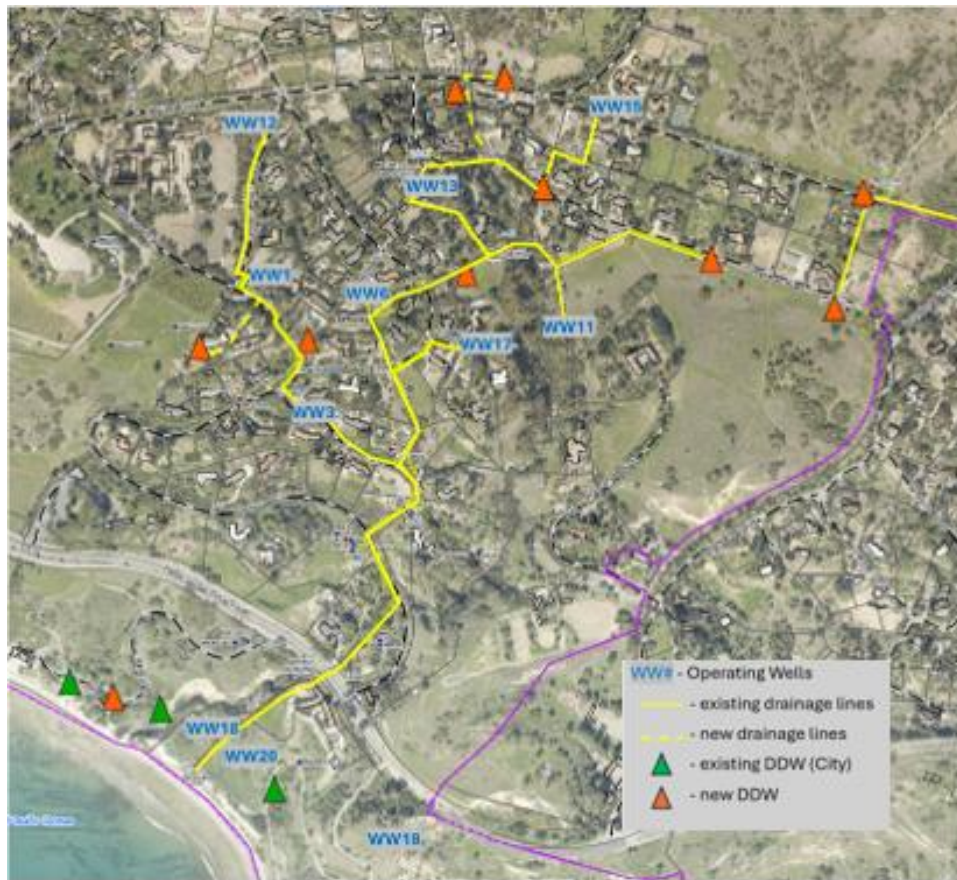

February 4, 2025 City Council Meeting Discussion Recap

At last night's meeting, the City Council received a comprehensive update on the landslide emergency. According to the latest data, average movement for the entire landslide complex has decelerated approximately 3% since early December 2024. The Portuguese Bend Landslide has reached a steady state of movement since the end of

October, while the Abalone Cove Landslide and upper Altamira Complex points continue to slightly decelerate.

The Council affirmed the use of the City's \$1.6 million loan to the Abalone Cove Landslide Abatement District (ACLAD) for its plan to drill 8-10 new deep dewatering wells 250 feet underground within the district's boundaries. ACLAD anticipates installation can be completed within the next couple of months, but more detailed information will be presented at a future Council meeting. The revised loan terms are tentatively scheduled to go before the Council on February 18, 2025.

The Council extended by 60 days the local emergency declarations in the landslide area and the temporary prohibition of bicycles, motorcycles, and other similar wheeled vehicles from an approximately 2-mile stretch of Palos Verdes Drive South from Wayfarers Chapel to Schooner Drive.

Voluntary Property Buyout Program Update

Earlier this week, City staff met with the California Governor's Office of Emergency Services (Cal OES) regarding the Federal Emergency Management Agency's (FEMA) \$42 million Voluntary Property Buyout Program. Cal OES has requested additional information for FEMA's review of program applications, which the City will provide expeditiously. The City now anticipates being able to offer buyouts for 23 properties. Of these buyouts, 15 are expected for red-tagged properties, and eight for yellow-tagged properties. Staff is determining which eight of the 37 yellow-tagged properties seeking buyouts will be prioritized for this round of program funding.

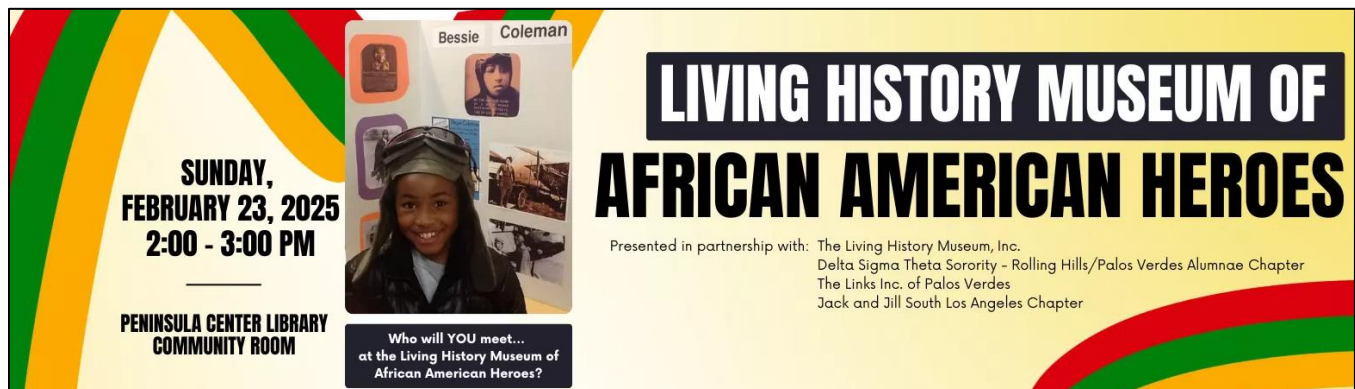

Avian Influenza (H5N1) Safety



Avian Influenza (H5N1) is a viral infectious disease of birds caused by type A influenza viruses. The virus spreads through direct bird-to-bird contact or indirectly when virus is on clothing, shoes, vehicles, rodents, insects, feed, water, feathers, etc. The current circulating strain of H5 bird flu virus is causing outbreaks in poultry worldwide and in dairy cows in the U.S. This is the first time H5 bird flu has been documented to infect cattle. In August 2024, H5 bird flu was detected in dairy cows in California for the first time. H5 bird flu has not been detected in cattle in LA County.

Risk of infection

Although it is rare, people can get sick with bird flu. Most people who have been infected got sick after close or lengthy unprotected contact (i.e., not wearing gloves or respiratory protection or eye protection) with infected birds or in places that sick birds or their saliva, mucous and feces have touched. It is rare for humans to be infected with bird flu viruses from another animal such as a cat or a cow.

During the current outbreak, there have been a small number of humans in the US infected with H5 bird flu. Most people report direct contact with affected poultry or dairy cows before feeling sick. People have reported mild symptoms, with eye redness or irritation often as the only symptom

There is some risk of the virus being spread to mammals such as dogs, cats, and wild mammals, especially if they eat infected, uncooked birds, undercooked poultry or raw infected milk or milk products. Public health does not recommend feeding your pet raw animal products because of the risk of disease spread.

How to prevent infection



- ✓ Do not eat or feed pets raw milk, raw cheese, or undercooked meat.
- ✓ If you own backyard chickens, take steps to protect your flock and yourself. Find out more here: www.aphis.usda.gov/livestock-poultry-disease/avian/defend-the-flock
- ✓ Avoid unprotected contact with sick or dead animals.
- ✓ Anytime you are in contact with animals, wash your hands with soap and water before touching your face or eyes.
- ✓ Report sick or dead birds to local animal control agency for potential collection and testing. Sick birds or animals may not have flu-like symptoms, but may appear generally sick, have difficulty moving, seizures, or be found dead.
- ✓ Prevent wild birds from getting into or defecating down into areas that house pet birds or poultry.
- ✓ Take down bird feeders and shared bird baths to reduce the risk of the virus spreading from bird to bird.

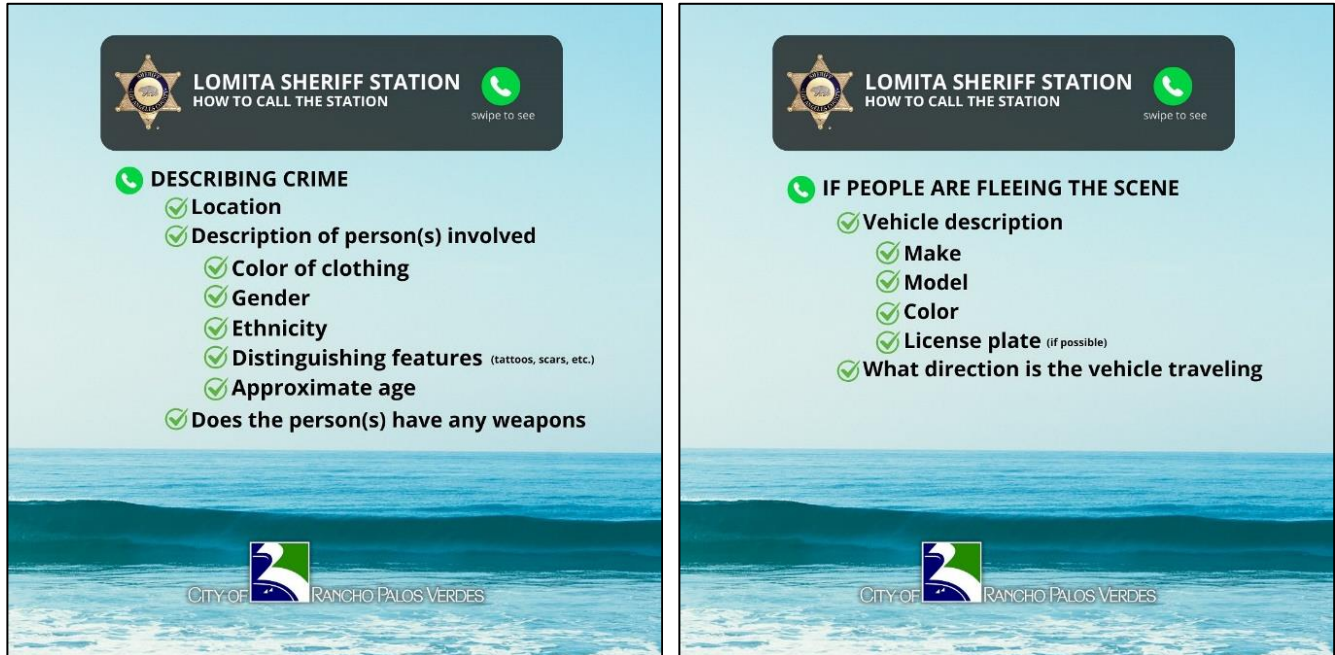

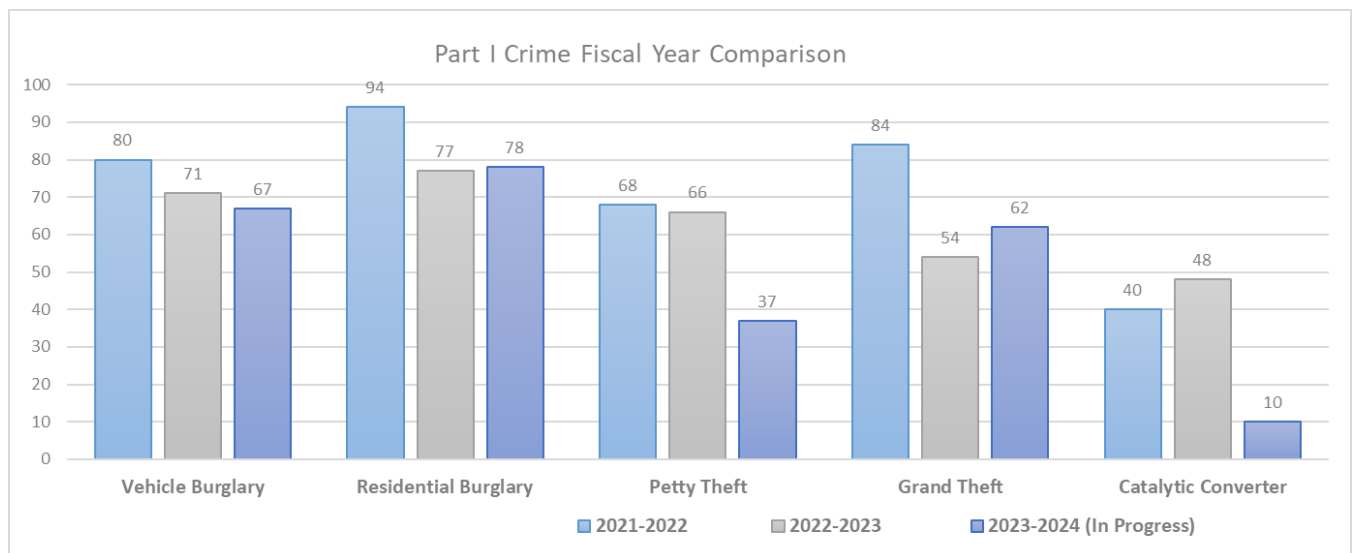

Case-Shiller Home Price Indices – November 2024

On January 28, 2025, data from the S&P CoreLogic Case-Shiller Home Price Indices, the leading measure of residential real estate prices, were released for November 2024. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indices.

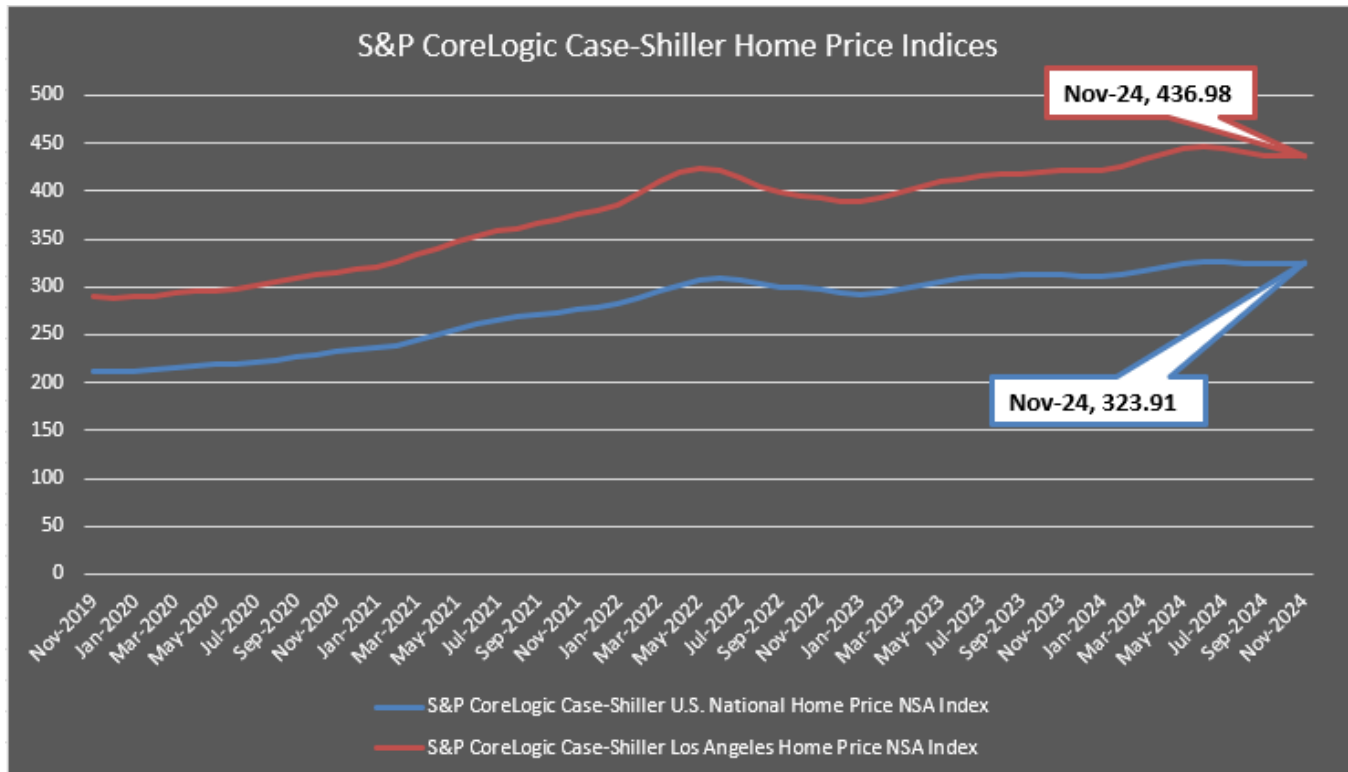
Month-over-Month

The pre-seasonally adjusted U.S. National upward trends continued to reverse in November, with the National Index posting a month-over-month decrease of -0.1% before seasonal adjustments. After seasonal adjustment, the U.S. National indices all posted a month-over-month increase of 0.4%.

Year-over-Year

The National Index reported a 3.8% annual return in November, up from a 3.6% annual return in the previous month. The annual gain for Los Angeles was at 3.84%, slightly above the national average. New York, Washington D.C., and Chicago are all well above the national average, with New York reporting a 7.3% gain in November.

Landslide Financial Assistance Grant Program – Update

As of February 5, 2025, the City has received over **231 applications** and has disbursed payments for **216 completed** and verified applications (**\$2.15M**), with at least one more verified and eligible applicant to receive a grant check on February 7th. Applications will continue to be reviewed and processed as they are received.

Portuguese Bend Landslide Emergency Stabilization Project Update

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the City performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Programs

- Work is complete for all DDWs as well as the associated test boreholes and monitoring wells funded by the City Council.
- The total combined water extraction rate of the DDWs is currently approximately 800 gallons per minute or **1.15 million gallons per day**.
- Since the start of the DDW program, approximately 136 million gallons, or 416 acre-feet, of water have been extracted from certain locations around the toe of the Landslide Complex.

All DDWs will continue to be monitored for pinching/shearing and re-drilling plans will be developed as needed.

Status of Winterization

The following winterization work is complete:

- Shaping, fissure filling, and installation of pond liners at Klondike, Altamira and Kelvin Canyons
- Shaping and fissure filling of Portuguese Canyon
- Winterization of the graben at the intersection of Dauntless and Exultant Drives
- Re-grading and filling of fissures on Exultant, Admirable, and Dauntless Drives
- Installation of a drainage swale between the northern cul-de-sac at the Palos Verdes Drive South frontage street and the Palos Verdes Drive South main road
- Fissure filling and drainage improvements along Palos Verdes Drive South

Drainage pipes in the Seaview neighborhood and along Palos Verdes Drive South have been assessed, and repairs are being scheduled. The repairs are anticipated to be complete by mid-February.

Winterized areas in and around Altamira Canyon have been re-shaped where fissures and grabens have re-opened due to land movement. Adjustments and further strengthening of existing installed pond liner systems within the available budget are underway. Additional high-flow protective measures have been installed at the interface between the base of winterized Klondike Canyon and the existing storm drain inlet structure under Palos Verdes Drive South.

Monitoring of winterized areas will be conducted during the upcoming rain event this week.

New Illuminated Street Name Signs

This week, installation of the new Illuminated Street Name Signs (ISNS) for the nine intersections locations was completed ahead of schedule. The installations are part of Citywide ISNS upgrades to replace broken and faded street name signs.

The ISNS project features new easy to maintain signage assemblies, energy efficient internal LED lighting, and the City logo and color palette.

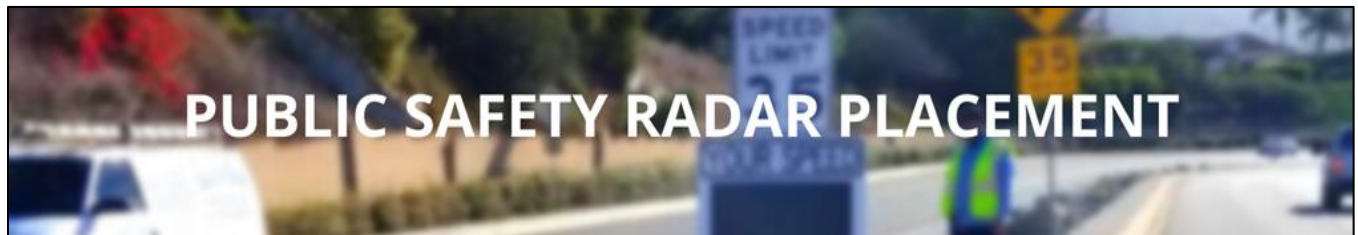
- Weekly landscape maintenance at all City parks. In addition to routine maintenance, the team made the following irrigation repairs:

 - Replaced several broken sprinklers at Hesse Park.



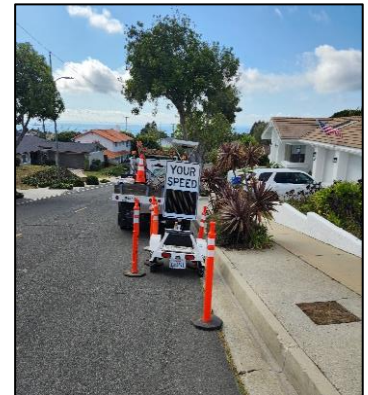

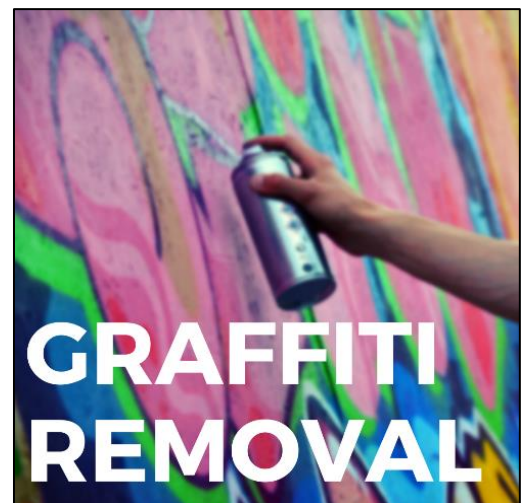

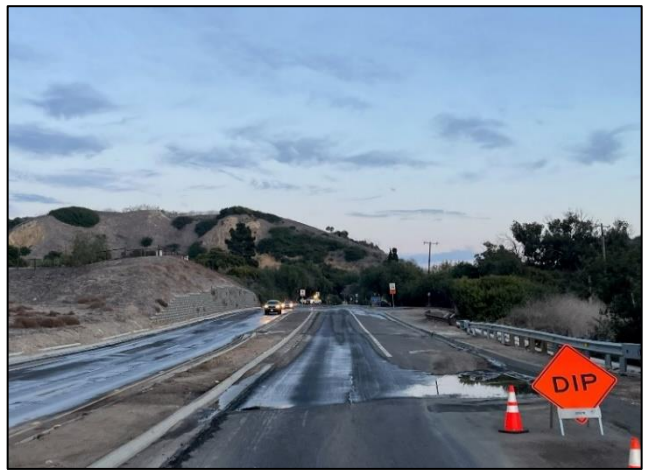
Graffiti Removal

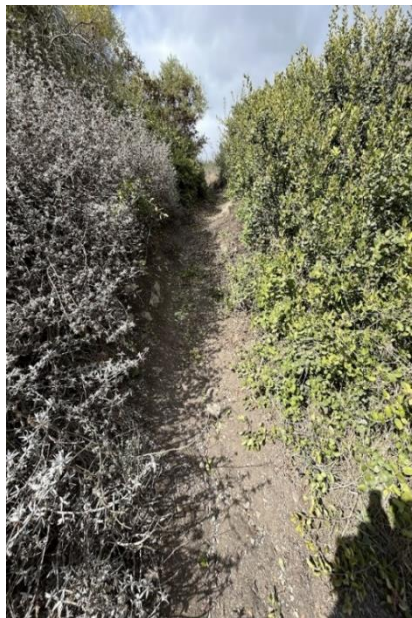
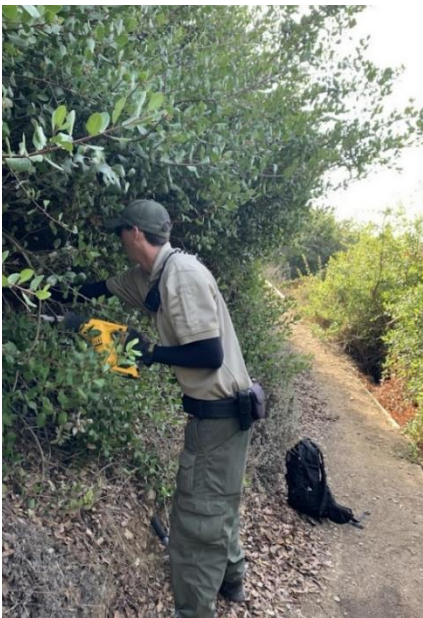
Alta Vicente Reserve

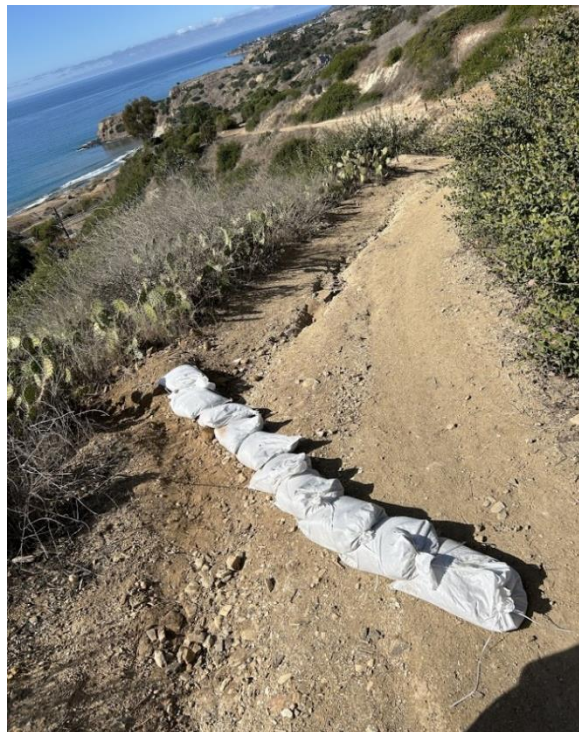

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) "True threat of force" means a threat

that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:
