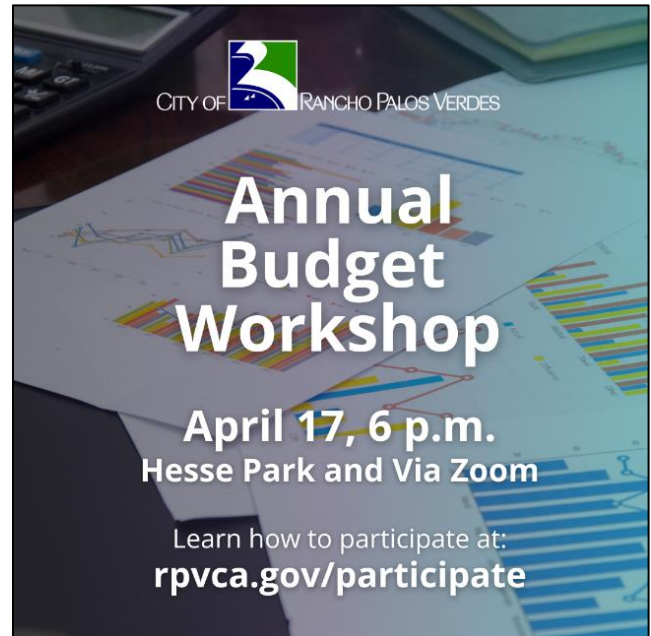

RPV Earns Certificate of Excellence for Landslide Communications at CAPIO Annual Conference

Last week, Staff attended the annual California Association of Public Information Officials (CAPIO) Conference in Napa, where hundreds of public information officers (PIOs) from government agencies across the state convened to train on a full range of key topics for public communicators.

During the conference, the City received a Certificate of Excellence for its EPIC Awards submission for the City's landslide communications program, which is overseen by Staff with support from government communications firm Tripepi Smith.



Staff attended sessions on artificial intelligence, crisis communications, listening and trust building, social media strategies during emergencies, and other informative topics.

PVPUSD Evacuation Drills

The Palos Verdes Peninsula Unified School District, in its dedication to supporting its students' disaster readiness and overall safety, held off-site evacuation drills at all schools from February to April 2025.



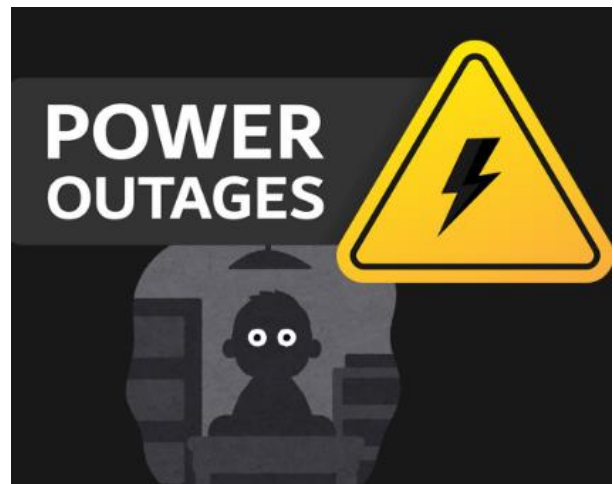
Evacuation drills are an excellent way to prepare both students and staff for emergencies, enhancing familiarity with evacuation routes, locations, and procedures. Drills can save lives and prevent injuries by ensuring everyone knows what to do in an emergency and where to go to stay safe, while also reducing the stress and anxiety that often accompany emergencies.

The 18 drills conducted by the district throughout the peninsula were supported by a collaborative effort between the district and school staff, the Los Angeles County Sheriff's Department, and the local cities. Rancho Palos Verdes City Hall was used for one of the school's evacuation locations, additional evacuation locations included other school sites, parks, fields, and parking lots.

RPV thanks the Palos Verdes Peninsula School District, school staff, first responders, and students for their dedication to disaster readiness. We cannot predict what the next emergency will be, but we can overcome anything when we practice, prepare, and work together.

What to Do When the Power Goes Out

- ✓ Use flashlights, not candles, to avoid fires.
- ✓ Never use a stove to heat your home.
- ✓ If using a generator, ensure it is properly installed and keep it outside in a well-ventilated area away from windows.
- ✓ Carefully turn off and unplug electrical equipment to avoid power surge damage when power is restored. Leave one light on to know when power comes back on.
- ✓ After the power outage: Wait a few minutes before turning on major electric appliances to avoid issues if there is a power surge.



Avoid food spoilage:

- ✓ Avoid opening your refrigerator and freezer to preserve cool temperatures. *An unopened refrigerator will keep foods cold for about 4 hours. An unopened full freezer will keep the temperature for about 48 hours (24 hours if half full).*
- ✓ Freeze refrigerated items that won't be used immediately, such as leftovers, milk and fresh meat and poultry, to keep food colder for longer. Remember to keep your raw foods separate from your ready-to-eat foods.
- ✓ Use perishable food from the refrigerator first, then food from the freezer. Use non-perishable foods and staples last.
- ✓ Measure the food temperature in your refrigerator and freezer with a thermometer. Throw out food that has been warmer than 40 degrees for two hours or more and/or that has an unusual odor, color or texture.

If driving and traffic signals are out, treat them as a stop sign – come to a complete stop at every intersection and look before you proceed. The person on the right has the right-of-way.

FAC Meeting Recap

On April 3, 2025, as part of the FY 2025-26 budget process, the Finance Department presented the draft budget assumptions to the Finance Advisory Committee (FAC). In line with City Council direction from March 17, 2025 City Council Goals Workshop, Staff also presented potential financial sustainability strategies, including a review of existing revenue sources, suspended revenues, financial assistance programs, and cost-containment measures. Staff's presentation was structured into (1) potential short-term actions, such as reviewing current resources and uses, and (2) long-term strategies, developing a framework for fiscal sustainability.



Overall, the FAC provided feedback in all categories, including a suggestion to provide the City Council with a scenario, showing a sensitivity analysis of the current budget assumptions, factoring in a 5% decrease in revenues and a 5% increase in expenditures. Revenue-generating ideas were also provided and will be submitted for City Council's consideration at the upcoming budget workshop on April 17, 2025. These include both short-term revenues-related action items that City Council may consider for the FY 2025-26 budget and long-term strategies that may require more than a year to implement.

The committee also received a presentation on the Greater Portuguese Bend Landslide Complex. Additionally, the Finance Advisory Committee was introduced to the Finance team's newest Sr. Administrative Analyst, James O'Neill.

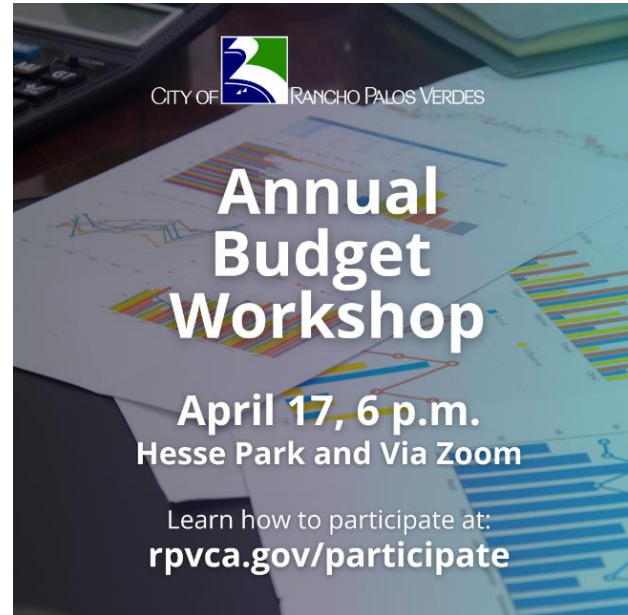

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the city installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the city performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Programs

- Work is complete for all DDWs as well as the associated test boreholes and monitoring wells funded by the City Council. The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **680 gallons per minute** or **1 million gallons per day**.
- Since the start of the DDW program, approximately **192 million gallons**, or **589 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex.
- The re-drilling of DDW-1, DDW-3, and DDW-5 are complete.
- DDW-4 was replaced with a new DDW ("4A") due to land movement pinching off the well to the extent that a re-drill was not possible.
- DDW-6 is being evaluated and could need to be re-drilled in the near future.

- DDW-10 has pinched off due to land movement and is being evaluated for a re-drill in the near future.
- DDW-11 experienced pump failure because of an insufficient water flow rate to keep the pump cooled. Based on the low production rate of this DDW, the City's geologists are advising that this well should not be re-drilled, but rather re-located, should additional funding become available.

All DDWs will continue to be monitored for pinching/shearing and re-drilling plans will be developed as needed.

Status of Winterization

All planned winterization activities are completed. Monitoring of winterized areas will continue, including assessments after rain events, and adjustments made in preparation for future rain events, to the extent possible within the current approved budget.

Putting Extracted Landslide Groundwater to Use

On Monday, April 7, 2025, members of the City's Infrastructure Management Advisory Committee (IMAC) and City staff toured the Robert W. Goldsworthy Desalter facility located in the City of Torrance. This facility extracts brackish (salty) groundwater from the region's groundwater basin and converts it into potable water for use by the City of Torrance. Through this tour, IMAC members hoped to learn more about groundwater

reuse and whether a similar approach could be applied to groundwater extracted by the deep dewatering wells in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex). During the tour, IMAC members learned about topics including:

- Groundwater treatment technologies and how they work;
- Regulatory structures for water systems and requirements for both potable and non-potable water sources;
- Costs of water system infrastructure (wells, pipes, reservoirs/tanks, etc.);
- How water supply planners make financial decisions about whether to invest in groundwater reuse facilities;
- How agencies like the Water Replenishment District might be able to help develop groundwater reuse facilities for the Landslide Complex; and
- Other related topics.

At the conclusion of the tour, IMAC members thanked the Water Replenishment District for the knowledge they shared and committed to exploring these issues further at upcoming meetings.

Update on the Hesse Park Community Center Roof Replacement Project

Work has begun on the Hesse Park Community Center Roof Replacement Project. During the past week, the contractor began to bring in equipment and demolish the existing roof.

The project will replace the aging roof and skylights at the Hesse Park Community Center. During the winter storms in early 2024, sections of the roof leaked and damaged interior areas of the building, including sensitive equipment used to facilitate public meetings and events. Public Works staff made temporary repairs to the building and further determined through a detailed assessment that the roof, including all 17 skylights, was nearing the end of its useful service life; and a full replacement would be needed soon. Subsequently, a heavy wind event in January 2025 damaged some of the temporary repairs made in 2024, as well as some skylights.

The work will be divided into two phases. The first phase is the roof replacement with a duration of approximately 4-5 weeks. Due to the time required to fabricate and deliver the replacement skylights, a second phase to replace the existing skylights is scheduled to start and be completed in June. The work is not anticipated to disrupt normal operations of the facility, including City Council meetings. No construction work will be done during weekends. The project is being constructed in a way that minimizes any impact on parking or access to the facility, the nearby playground, and other park amenities.

Collection Results from the Household Hazardous Waste/Electronic Waste Roundup Event

On Saturday, March 29, the City hosted the annual Los Angeles County sponsored Household Hazardous Waste/Electronic Waste roundup event. Public Works' Maintenance Staff diligently worked to prepare and organize the City's maintenance yard to make accommodations for the event. Additionally, a special event traffic control plan was implemented in the vicinity of City Hall on Hawthorne Boulevard and the main

City Hall parking lot was used to reduce the traffic overflow on Hawthorne Boulevard. This event was repeatedly promoted via fliers, newsletter articles, banners, and Nextdoor announcements. Staff expresses special thanks to the County of Los Angeles and the Sanitations Districts of Los Angeles County for their efforts, sponsorship, and cooperation.

The Goats Have Returned for the 2025 Fuel Modification Season!

Goats have resumed their important role in reducing fire hazards and protecting homes. While we understand that many people enjoy seeing the goats, we ask that you avoid visiting them out of respect for nearby residents.

To ensure safety, a temporary electrified fence is in place to contain the goats while they work. Approaching them puts both you and the goats at risk. Please refrain from taking selfies, attempting to touch them, or bringing pets near the area, as this can cause stress or injury to both you and the goats.



In addition, human crews are performing brush clearance throughout the City as part of the 2025 fuel modification program.



Traffic Safety Committee (TSC)

A joint TSC- Infrastructure Management Advisory Committee (IMAC) special meeting is scheduled for Monday, April 28 at 6 p.m. in the Community Room at City Hall. The agenda will include soliciting public input on a traffic study for the intersections of Palos Verdes Drive South (PVDS) and Conqueror Drive, Schooner Drive, and Forrestal Drive/Trump National Drive.

On July 17, 2018, the City Council discussed existing issues regarding several intersections along PVDS. The issues included periodic turning movement congestion at certain intersections during peak travel times. Staff were directed to investigate any improvements that would allow for better circulation, reduce traffic delays and, most importantly, enhance the safety of these intersections.

Subsequently, plans were prepared for improvements at PVDS and Seahill Drive, Conqueror Drive, Schooner Drive, and Forrestal Drive/Trump National Drive; however, prior to being issued for construction, IMAC expressed interest in studying the feasibility of roundabouts at these intersections. As a result, a joint TSC- IMAC subcommittee was formed to discuss the idea.

On August 17, 2021, a joint TSC-IMAC recommendation was presented to the City Council for a pilot program to install a “modern roundabout” at the intersection of PVDS and Forrestal Drive/Trump National Drive. The City Council adopted FY 2024-25 CIP includes studying a pilot roundabout at Forrestal Drive and the other aforementioned intersections. In addition to a roundabout, the study will evaluate other possible solutions, with input from the community.

The public is invited to attend or participate in person, or remotely via the Zoom platform, to provide input to be considered as part of the traffic study. 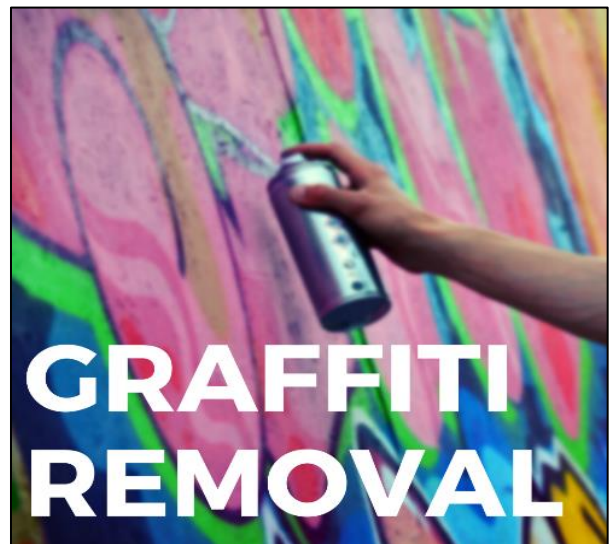

Graffiti Removal

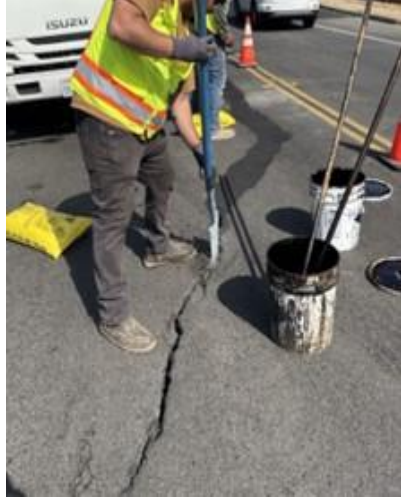
- 19 graffiti incidents were reported and removed this week.

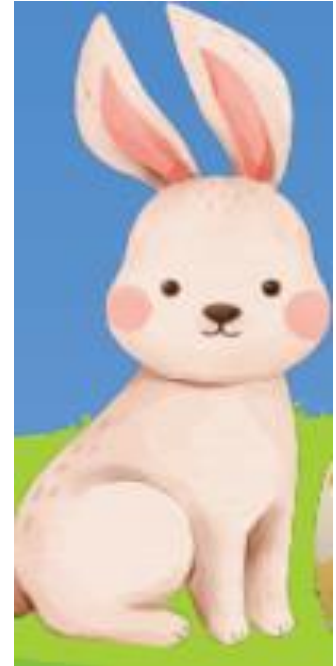

Abalone Cove Reserve

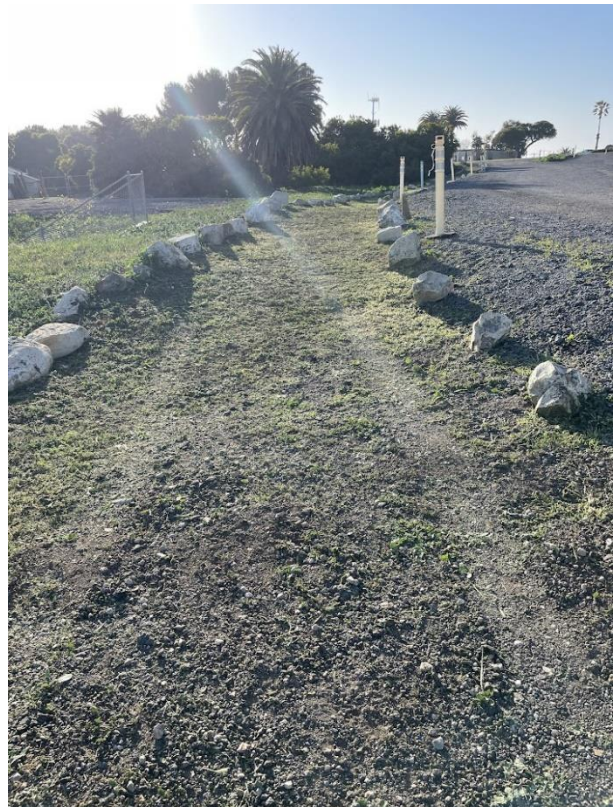
