CITY MANAGER'S OFFICE

April 15, 2025 City Council Meeting Highlights

- City staff gave an annual update on Trump National Golf Club's compliance with its maintenance obligations for trails and open space areas.
- Despite challenges over the past few years related to increased trail use during the pandemic, and damage from heavy rains, Trump National continues to keep up with maintenance needs.
- City staff and Trump National are working on possible solutions to remedy the 2021 closures of the Catalina Trail Bridge due to erosion and the Coastal Switchback Trail due to a small landslide.
- The Council also discussed potentially charging property owners an assessment next fiscal year for the Citywide Landscaping and Lighting Maintenance District, which funds the maintenance of landscaping, lighting, traffic signals, and other improvements in public areas.
- No levy has been charged since 2017 due to sufficient funds. However, due to the financial strain of the Portuguese Bend landslide emergency, the Council opted to consider reinstating a levy of \$23.50 per parcel, which could generate \$325,000-\$350,000.
- The Council is tentatively scheduled to vote on reinstating the levy at the June 3 meeting.

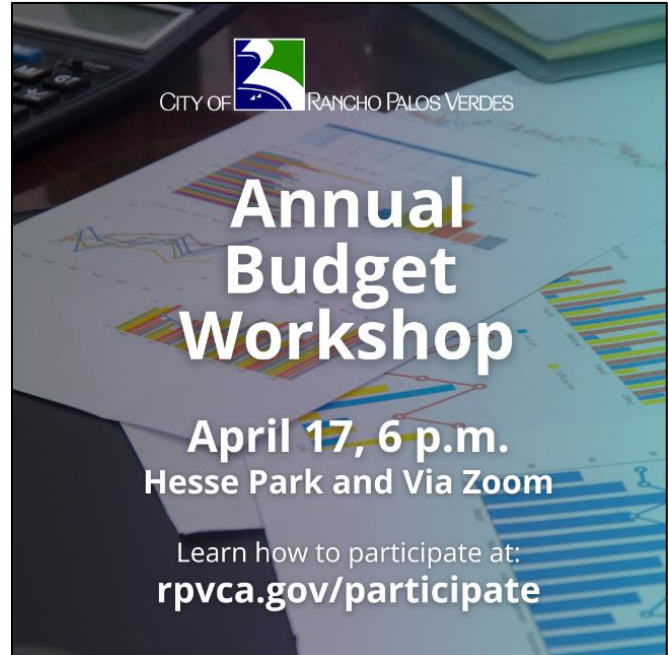

It's California Mosquito Awareness Week

In conjunction with California Mosquito Awareness Week on April 13-19, 2025, the Los Angeles County West Vector Control District encourages residents to dump and drain all sources of standing water around their home and workplace. Mosquitoes can lay eggs in very small amounts of water. The entire life cycle, from egg to adult, takes as little as seven days.

Mosquitoes and Mosquito-borne Diseases

Mosquitoes are not only an annoyance, but they also have the potential of transmitting serious diseases. West Nile virus (WNV) is the most prevalent mosquito-borne disease in California. Common *Culex* mosquitoes (see image on the right) can spread WNV through their bites. They will feed on humans, birds, and other animals primarily at dawn and dusk. Eliminating standing water can help reduce mosquitoes in your community.



WNV infections are often mild or asymptomatic, but in some cases, infection can lead to meningitis, encephalitis, and even death. There have been over 8,000 human WNV cases and over 400 WNV related deaths reported in California since 2003. In 2024, there were 35 human WNV cases and 2 deaths reported in Los Angeles County.

Invasive *Aedes* mosquitoes (see image on the right) are found throughout L.A. County. These mosquitoes primarily bite during the day and often deposit eggs around homes in small sources of standing water. Invasive *Aedes* mosquitoes have the potential to transmit diseases to people, including dengue, chikungunya, Zika, and yellow fever. In 2024, 14 cases of locally acquired dengue in humans were reported in L.A. County.



Locally acquired cases of dengue are rare in California with most reported cases involving travel outside the country.

Protection from Mosquitoes

- Dump and drain all standing water in and around your property, including flowerpots, saucers, old tires, buckets, pet dishes, toys and trash cans.
- Properly maintain swimming pools, spas, and ponds.
- Install screens on windows and doors to keep mosquitoes out of your home.
- Clean rain gutters and cover openings in rain barrels with mosquito-proof screens.
- Apply an EPA-registered mosquito repellent to prevent mosquitoes from biting.
- Dress in long sleeves and pants especially at dawn and dusk when *Culex* mosquitoes are active.
- Report mosquito activity or request an inspection at (310) 915-7370 or online (www.lawestvector.org/service-request/).
- Some bird species, like crows, can become infected with West Nile virus. Report dead birds to the WNV Call Center at (877) WNV-BIRD or online (<https://westnile.ca.gov/report.php>).

Fire Hazard Zone Update Info Session April 30

On March 24, 2025, the State Fire Marshal released updated Fire Hazard Severity Zone maps to local agencies. These zones are tied to safety requirements aimed at reducing wildfire risk. They are developed using a science-based and field-tested model that assigns a hazard score based on the factors that influence fire likelihood and fire behavior.

The City of Rancho Palos Verdes was identified as having a combination of Moderate, High, and Very High Fire Hazard Severity Zones (FHSZ) within our jurisdiction. Notably, the State Fire Marshal's proposed update removes significant portions of the City from the Very High designation, which has covered virtually all of RPV since 2008, due to updated methodology that takes the Peninsula's specific climate and environment into consideration.

To learn more about the updates and new methodology, join the City and the Los Angeles County Fire Department for a **Fire Hazard Zone Update Info Session**. This will be an opportunity to also learn about brush clearance implications and share your feedback, before the City Council considers adopting the map at its June 17, 2025 meeting.

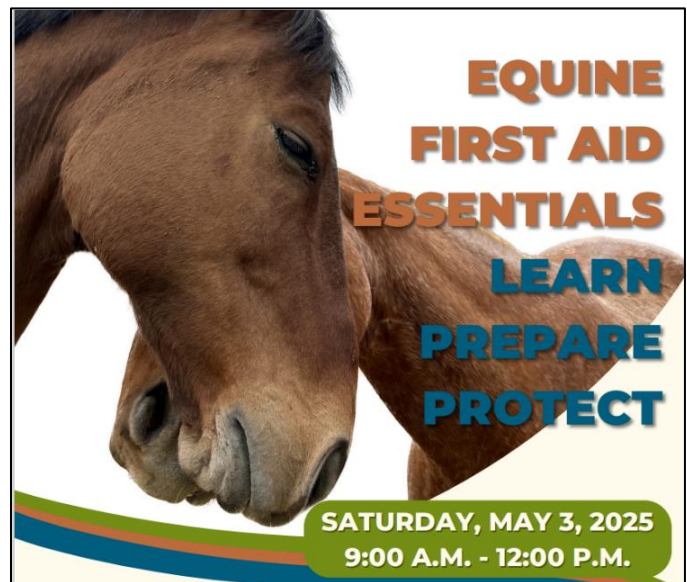

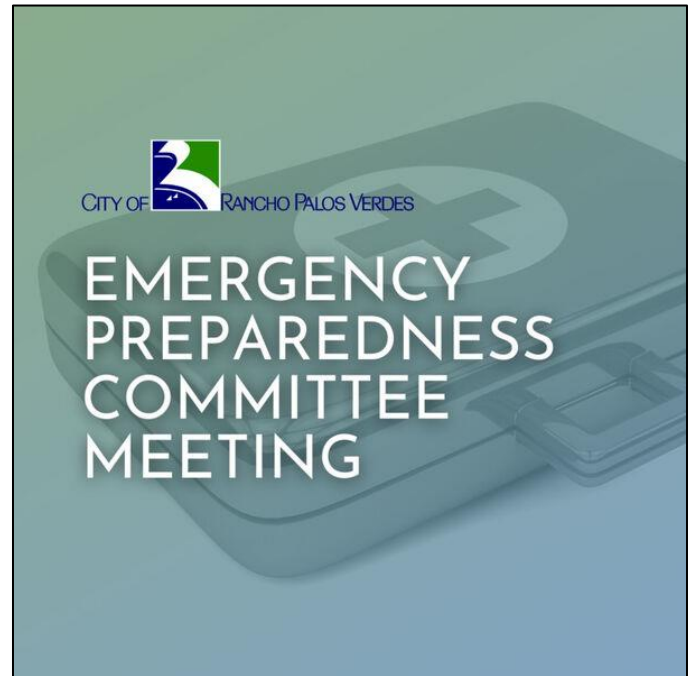

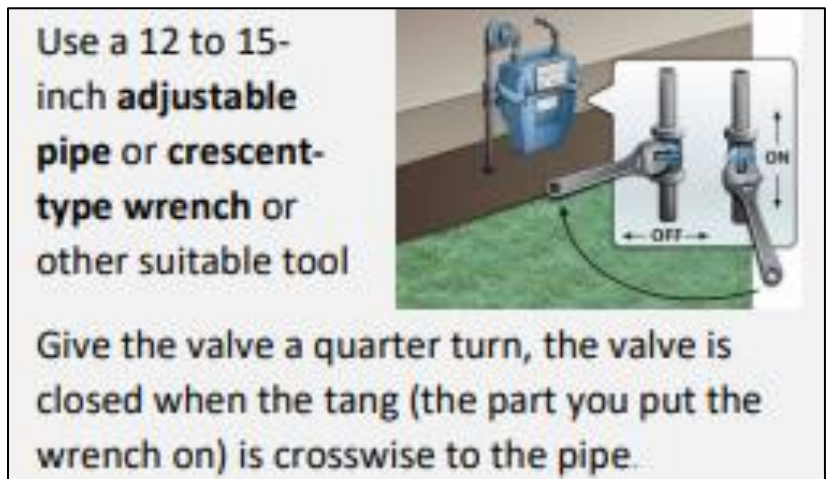


How and When to Shut Off Your Utilities

Gas Line Damage

If you smell gas or rotten eggs, hear a hissing/blowing sound, see a broken line or large gas consumption at the meter, or if told to do so by officials, immediately evacuate the area. Call SoCalGas at 800-427-2200 from a safe location. Call 911 promptly if there is damage resulting in a leak that may endanger life, cause bodily harm

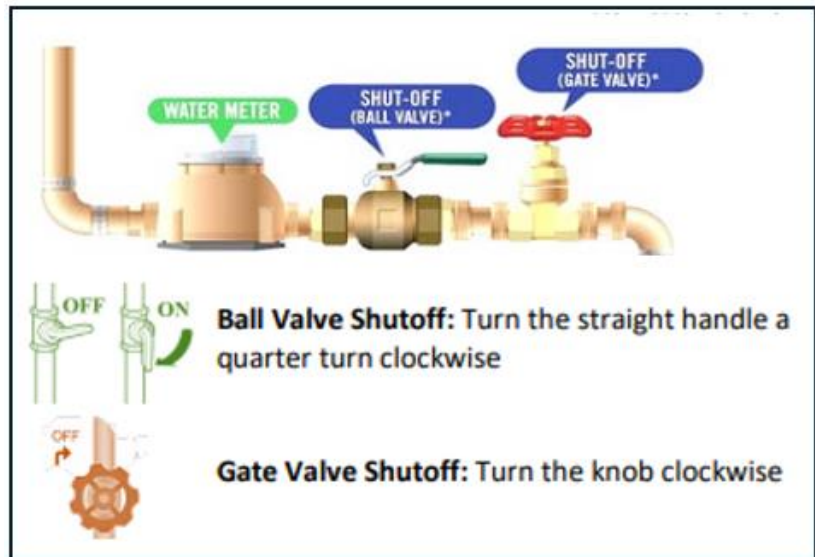
or property damage. Do not smoke, light a match, or turn on any sources of sparks. Do not reenter your home unless So Cal Gas says it is safe to do so.



Identify where your gas meter is located, which is typically outside your building near the front or side. If safe to do so, shut off your gas at the meter. Call your gas company to assist with any gas leak or damage and to turn your gas back on for you (it can be dangerous to turn the gas back on by yourself).

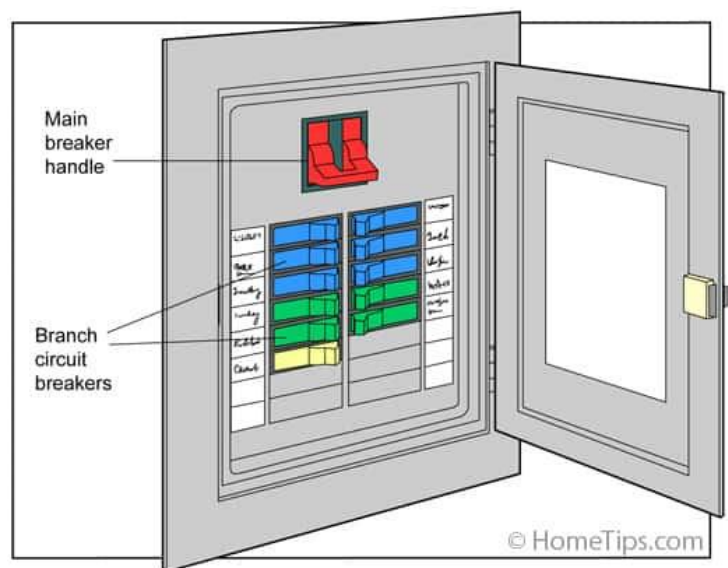
Water and Sewage Line Damages

If you see damage or leaks or if instructed to do so by officials, shut off water valves at the main meter (usually located at the street/sidewalk), or the water main leading into the home (to retain water in your water heater for emergencies.) Turn water back on only if there is no damage and it is safe to do so, otherwise contact your water provider for assistance.



Electrical System Damages

If the inside of electrical devices burn when you plug them in, there is a fire or water leak, there is the smell of insulation burning in your house, the area around switches and plugs is hot when you touch it or is black, or if officials instruct you to do so, shut off the electricity at your electrical circuit box (usually mounted on a wall, often in a basement). Circuit breakers are small, usually horizontal switches and may or may not be labeled (e.g., "kitchen," "bathroom," etc.). Shut off

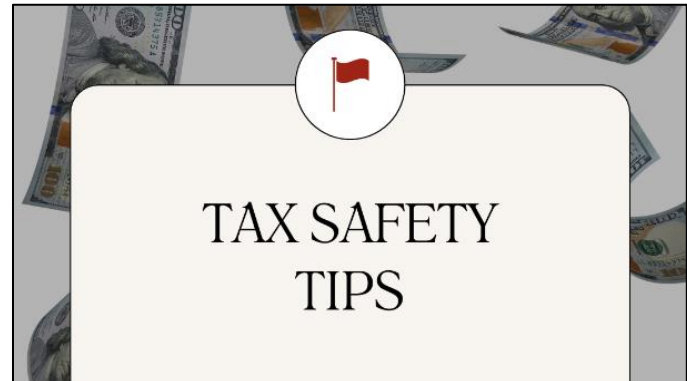


all the individual circuits first, then the main circuit. Do NOT touch electrical systems or equipment if you or it are wet or standing in water. Restore service by flipping the breakers back on, starting with the main breaker. Do not turn electricity back on if there is damage to wiring or fuse/circuit breaker box. Call the power company or an electrician if you cannot restore service or if it seems dangerous to do so.



Tax Safety Tips

This tax season, the Lomita Sheriff's Station has provided tips on how to safeguard your tax refund payment and protect yourself from scammers.



1. Request for your tax refund to be sent via direct deposit. Check your refund here: irs.gov/wheres-my-refund
2. If you anticipate receiving a physical tax refund check, check your mailbox every day. Consider installing a keyed mailbox. Request a replacement check here: tinyurl.com/IRSReplacementCheck
3. Filing or sending a payment via post office? Send via certified mail! Visit [USPS.com under Certified Mail - The Basics](https://usps.com/under-Certified-Mail-The-Basics)
4. Report any stolen tax refund payments to the Lomita Sheriff's Station, IRS, and USPS Postmaster.

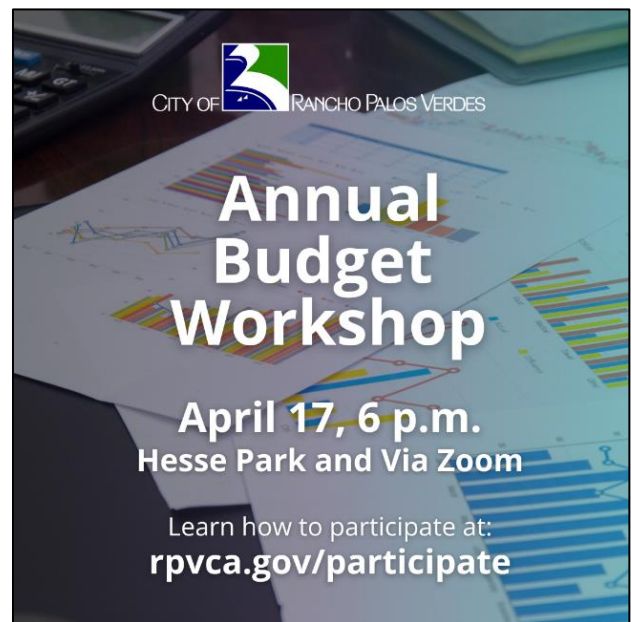

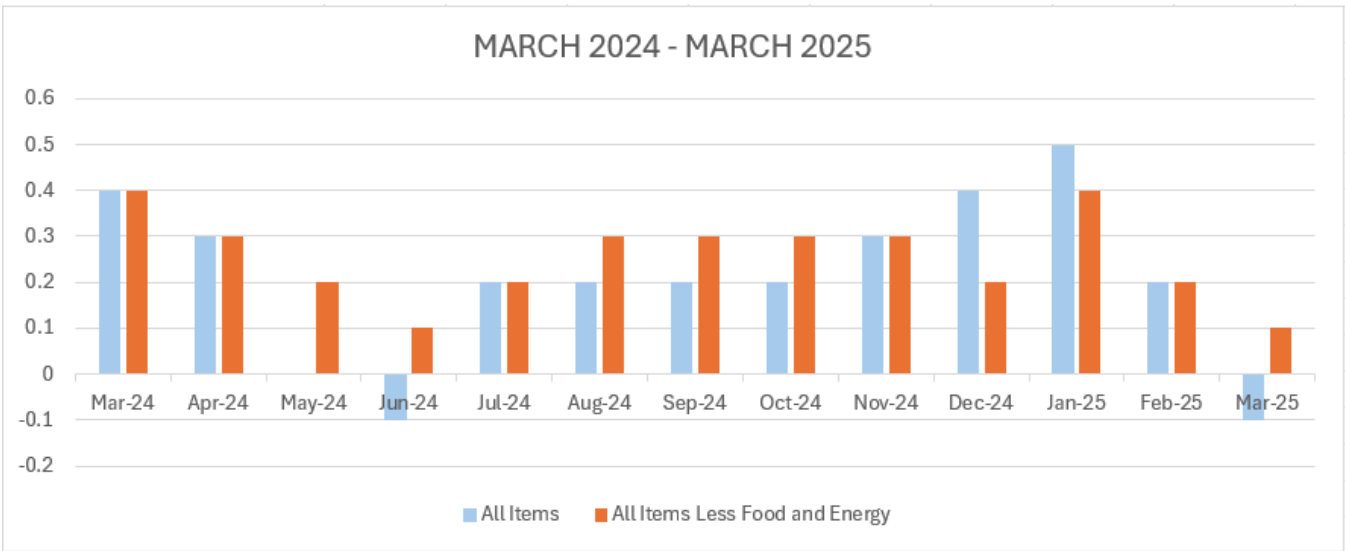

Consumer Price Index – March 2025

Consumer Price Index (U.S.)

The Consumer Price Index (CPI) decreased by 0.1% in the month of March after increasing by 0.2% in February. Compared annually, CPI rose by 2.4% over the past 12 months. The CPI for all items, less food and energy (core inflation), grew by 0.1% in the month of March, following a 0.2% increase in February. Chart 1 further illustrates the monthly percentage changes in CPI for both headline and core inflation.

In summary, the index for energy fell 2.4% in March, with a 6.3% decline in the index for gasoline. However, the overall food index rose by 0.4% and the food at home index increased by 0.5% in March. Other indices that increased over the month include personal care, medical care, education, apparel, and new vehicles. The indices for airline fares, motor vehicle insurance, used cars and trucks all decreased in March.

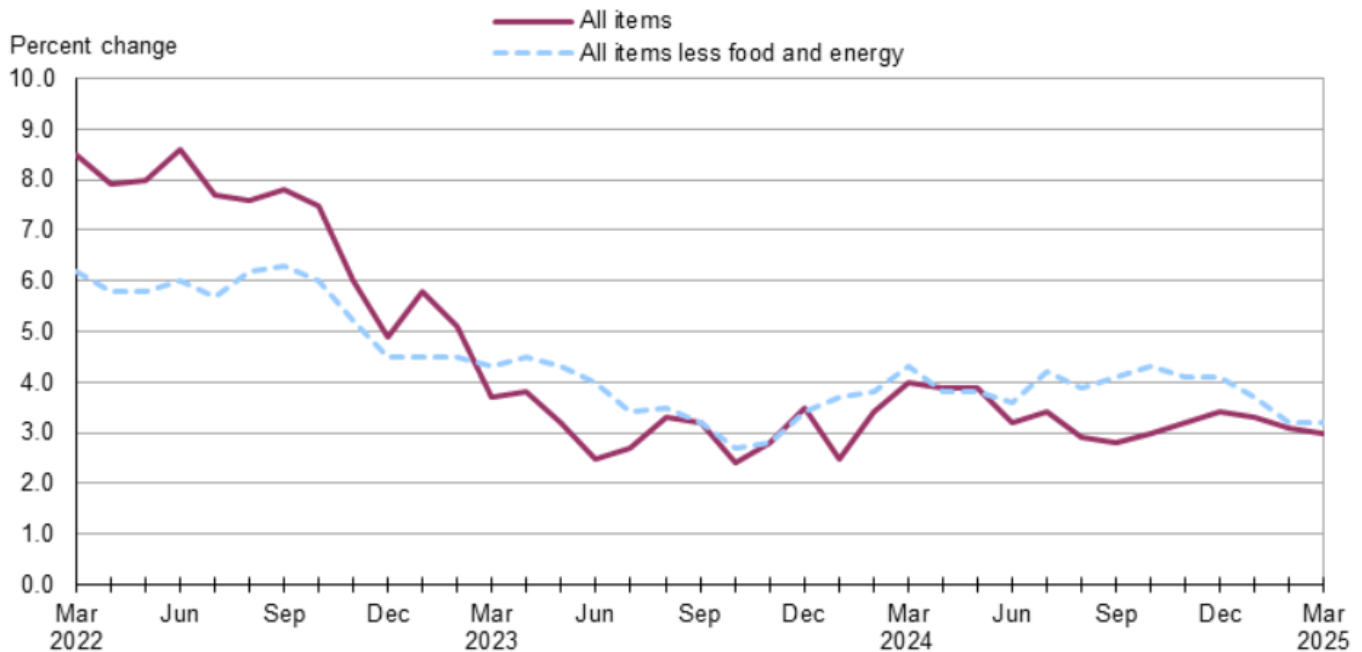
Consumer Price Index (Los Angeles)

Prices in the Los Angeles area, as measured by CPI, increased by 0.7% in March 2025. On an annual basis, prices advanced by 3.0% over the past 12 months. The food index increased by 0.3% in March. Although gasoline prices decreased by 0.1% in March, the energy index increased by 0.7%.

On an annual basis, the index for all items less food and energy increased by 3.2%. Among the indices, the prices for shelter and medical care continued to increase at 0.7%

for both indices in March. In contrast, prices for household furnishings and operations continue to decrease at -1.0%.

Landslide Financial Assistance Grant Program – Update

As of April 16, 2025, the City has received over **234 applications** and has disbursed payments for **221 completed** and verified applications (**\$2.2M**). Applications will continue to be reviewed and processed as they are received.

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the city installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the city performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Programs

- Work is complete for all DDWs as well as the associated test boreholes and monitoring wells funded by the City Council. The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **630 gallons per minute** or **0.9 million gallons per day**.
- Since the start of the DDW program, approximately **198 million gallons**, or **609 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex.
- DDW-6 is being evaluated and could need to be re-drilled in the near future.
- DDW-10 has pinched off due to land movement and is being evaluated for a re-drill in the near future.
- DDW-11 experienced pump failure because of an insufficient water flow rate to keep the pump cooled. Based on the low production rate of this DDW, the City's geologists

are advising that this well should not be re-drilled, but rather re-located, should additional funding become available.

All DDWs will continue to be monitored for pinching/shearing, and re-drilling plans will be developed as needed.

Status of Winterization

All planned winterization activities are completed. Monitoring of winterized areas will continue, including assessments after rain events and adjustments made in preparation for future rain events to the extent possible within the current approved budget.

Update on the Hesse Park Community Center Roof Replacement Project

Work continues at the Hesse Park Community Center Roof Replacement Project. During this initial week of construction, the contractor continued demolition of the existing roof and began installation of a high-performance, multi-layer membrane known for its long-term weather protection and energy efficiency.

The project remains on schedule, and park operations and public access continue to be maintained without disruption.

The project will replace the aging roof and skylights at the Hesse Park Community

Center. During the winter storms in early 2024, sections of the roof leaked and damaged interior areas of the building, including sensitive equipment used to facilitate public meetings and events. Public Works staff made temporary repairs to the building and further determined through a detailed assessment that the roof, including all 17 skylights, was nearing the end of its useful service life; and a full replacement would be needed soon. Subsequently, a heavy wind event in January 2025 damaged some of the temporary repairs made in 2024, as well as some skylights.

The Goats Have Returned for the 2025 Fuel Modification Season!

Goats have resumed their important role in reducing fire hazards and protecting homes. While we understand that many people enjoy seeing the goats, we ask that you avoid visiting them out of respect for nearby residents.

To ensure safety, a temporary electrified fence is in place to contain the goats while they work. Approaching them puts both you and the goats at risk. Please refrain from taking selfies, attempting to touch them, or bringing pets near the area, as this can cause stress or injury to both you and the goats.



In addition, human crews are performing brush clearance throughout the City as part of the 2025 fuel modification program.



Traffic Safety Committee (TSC)

A joint TSC- Infrastructure Management Advisory Committee (IMAC) special meeting is scheduled for April 28 at 6 p.m. in the Community Room at City Hall. The agenda will include soliciting public input on a traffic study for the intersections of Palos Verdes Drive South (PVDS) and Conqueror Drive, Schooner Drive, and Forrestal Drive/Trump National Drive.

On July 17, 2018, the City Council discussed existing issues regarding several intersections along PVDS. The issues included periodic turning movement congestion at certain intersections during peak travel times. Staff were directed to investigate any improvements that would allow for better circulation, reduce traffic delays and, most importantly, enhance the safety of these intersections.

Subsequently, plans were prepared for improvements at PVDS and Seahill Drive, Conqueror Drive, Schooner Drive, and Forrestal Drive/Trump National Drive; however, prior to being issued for construction, IMAC expressed interest in studying the feasibility of roundabouts at these intersections. As a result, a joint TSC- IMAC subcommittee was formed to discuss the idea.

On August 17, 2021, a joint TSC-IMAC recommendation was presented to the City Council for a pilot program to install a “modern roundabout” at the intersection of PVDS and Forrestal Drive/Trump National Drive. The City Council adopted FY 2024-25 CIP includes studying a pilot roundabout at Forrestal Drive and the other aforementioned intersections. In addition to a roundabout, the study will evaluate other possible solutions, with input from the community.

The public is invited to attend or participate in person, or remotely via the Zoom platform, to provide input to be considered as part of the traffic study. 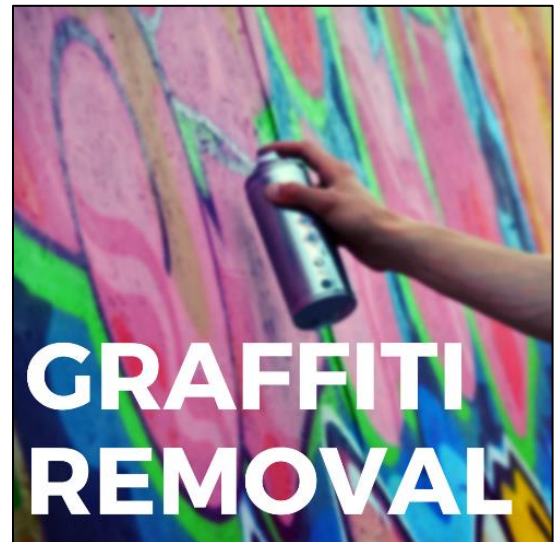

The memorial will include the construction of a 10-foot-high free-standing stone Vietnam War Veteran's Memorial monument and the installation of a 4,963 ft² decorative hardscape memorial with 8.2 yd³ of associated grading to accommodate the proposed improvements.

The REACH program serves the social and recreational needs of youths and adults with developmental disabilities and is back at Hesse Park for in-person activities.

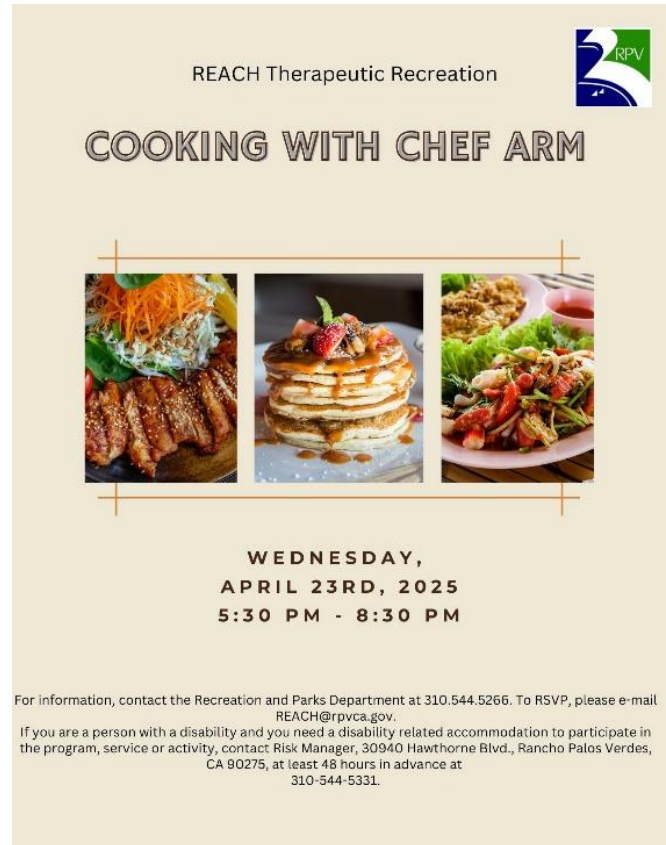

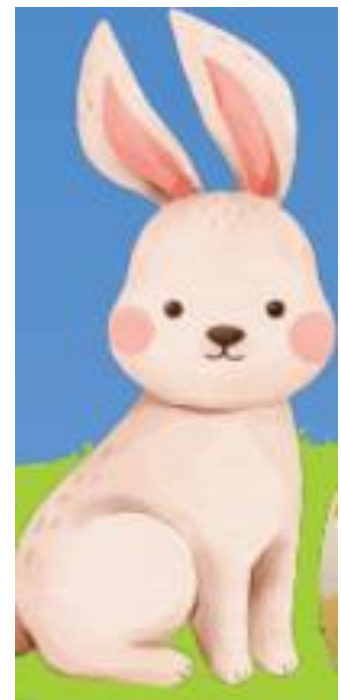
