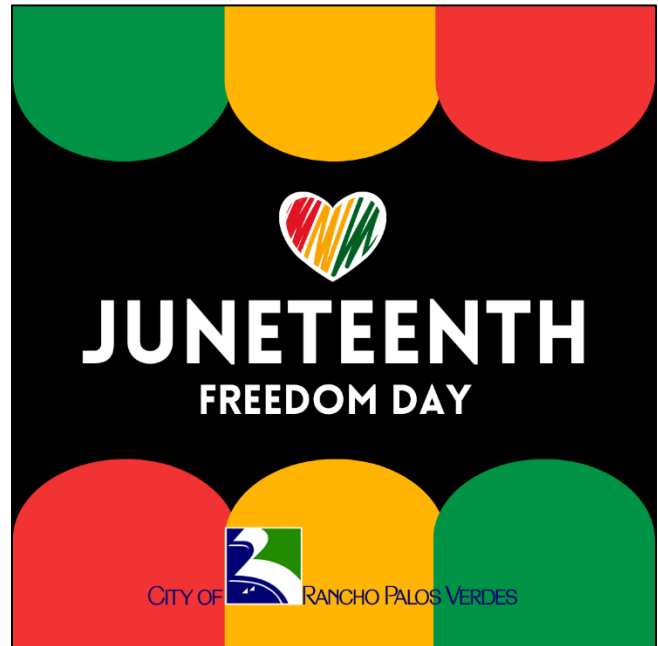

### June 17, 2025 City Council Meeting Highlights

- The Council approved the \$37.3 million Final Budget and \$28.6 million Capital Improvement Program (CIP) for Fiscal Year 2025-26.
- While the City has a balanced budget for next fiscal year, a key focus of the budget process was the growing financial impact of the landslide emergency and stabilization efforts.
- In the current fiscal year, the City spent \$37 million on these efforts — an amount almost equivalent to the City's annual operating budget and representing 37% of the City's previous average cash balance of approximately \$100 million.





- The City continues to pursue grant funding opportunities, go through the appeals process for federal disaster recovery assistance, and explore both short- and long-term strategies for fiscal sustainability.
- The Council approved an updated Fire Hazard Severity Zone map for Rancho Palos Verdes removing significant portions of the City from the “Very High” designation, which covered virtually all of RPV since 2008.
- These maps are developed for local agencies by the State Fire Marshal using a science-based and field-tested model that assigns a hazard score based on factors that influence fire likelihood and fire behavior.
- Finally, the Council approved an \$8.5 million Sheriff’s Department contract to continue providing law enforcement services the next fiscal year.

## Reminder: Fireworks are Illegal on the Peninsula

With the Fourth of July holiday approaching, the City reminds residents that fireworks, including those marketed as “safe and sane,” are illegal year-round. This includes smoke bombs or smoke sticks that are commonly used for gender reveal parties.

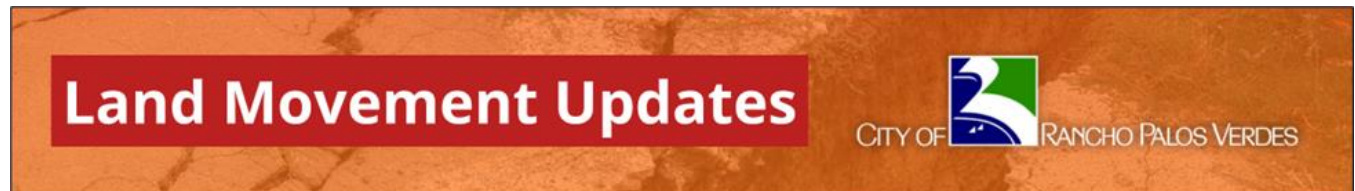
Fines for illegal fireworks in RPV are \$1,000 for a first violation, \$5,000 for a second, and \$7,500 for third and subsequent violations.

January’s destructive wildfires in Southern California underscore the importance of always being mindful of fire risk on the Peninsula, with its vast open space areas and canyons full of brush. It can only take one spark to ignite a catastrophic wildfire on the Peninsula, threatening lives and property in an area with limited evacuation routes. Fireworks can also trigger extreme episodes of trauma and fear in those who have post-traumatic stress disorder and in pets.



Residents and visitors are reminded to respect their neighbors and help protect against wildfire — do not light fireworks. Enjoy the holiday safely; come celebrate with family and friends at the City's Fourth of July Celebration at the Ken Dyda Civic Center featuring a patriotic drone light show at 8:45 p.m.

### **City Requests Rep. Lieu Explore NDAA for Potential Land Transfer**

The City and Wayfarers Chapel continue to work to identify potential pathways to reconstruct the landslide-damaged National Historic Landmark to an ideal site near the Ken Dyda Civic Center. As part of these efforts, earlier this week, the City submitted a request to the office of Rep. Ted Lieu for his staff to explore the feasibility of transferring the Coast Guard-owned Battery Barnes property adjacent to the Civic Center to the City by securing language in the National Defense Authorization Act (NDAA). This was done successfully in late 2024 by Rep. Lieu and Rep. Nanette Barragán for the cities of Los Angeles and Lomita to enable them to [take ownership of ball fields](#) at the Navy's Defense Fuel Support Point (DFSP) on Western Avenue. This strategy of transferring federal land via an act of Congress was pursued due to a change in Department of Defense policy that would have resulted in charging youth sports organizations fair-market user fees. While talks of potentially using the NDAA for the relocation of Wayfarers Chapel to the Battery Barnes site are preliminary and informal at this point, the City is hopeful that our federal representatives will help us explore every avenue to potentially bringing the Chapel to Battery Barnes, so it can remain in its historic community in perpetuity as a historic landmark, educational site, and community gathering space.

### **Last Chance: Financial Assistance Grant Applications Due June 30**

In October 2024, the City began administering emergency financial assistance grants using \$2.8 million in landslide relief funding from the office of Los Angeles County Supervisor Janice Hahn to deliver immediate aid to residents impacted by land

movement and utility shutoffs. Through this program, the City can provide up to \$10,000 to each eligible affected property owner.

The deadline to apply for the Financial Assistance Grant Program is **5 p.m. on June 30, 2025**. This grant program will officially end on July 1, 2025, and no further applications will be accepted after June 30, 2025. Following direction from the City Council at the Annual Budget Workshop on April 17, 2025, the remaining grant funds will then be transferred to the Capital Improvement Program (CIP) Fund to continue supporting landslide emergency response and mitigation efforts, in accordance with the grant requirements.

To date, the City has disbursed payments for 223 completed and verified applications, totaling \$2.2 million. Eligible property owners who have not applied for an assistance grant may do so on the City website at [rpvca.gov/landmovement](http://rpvca.gov/landmovement).

## Disaster Recovery Appeals Update

In March, the City [formally appealed](#) the Federal Emergency Management Agency's (FEMA) decision to deny \$37.9 million in disaster recovery funding requested by the City for costs incurred responding to the landslide emergency due to the winter storms in late January and early February 2024. In May, the City [was notified](#) that the California Governor's Office of Emergency Services (Cal OES) will not support the vast majority of the City's appeals due to the agency's position that while the winter storms may have greatly accelerated land movement, what it considers to be pre-existing conditions in the landslide make the City ineligible for reimbursement under the 2024 federal disaster declaration.

Earlier this week, Cal OES notified the City that it is [now recommending](#) FEMA give partial reimbursement of **\$102,157** for storm-related repairs at an intersection located well outside of the landslide area (Rue La Fleur and Rue De La Pierre). The City continues to await FEMA Region 9 Administrator Robert Fenton's decision regarding all the City's appeals. His decision is then appealable to FEMA's headquarters in Washington, D.C.

## Protect Your Pets From the Heat

With warm weather just around the corner, make sure you keep your pets safe from the heat!

- ✓ **Never leave pets unattended inside of vehicles:** Cars heat up fast even with the windows cracked. The temperature inside of a car is significantly higher than the temperature outside and continually increases with time. For example: If it's 85 degrees outside, the car temperature



can increase to 104 degrees in just 10 minutes and 118 degrees in just 30 minutes.

- ✓ **Keep your pets hydrated and stay vigilant for signs of overheating.** Signs of overheating may include excessive panting or difficulty breathing, increased heart and respiratory rate, drooling, mild weakness, stupor or even collapse. If you think your pet is overheating, quickly move them to a cool place and immediately spray cool (not cold or icy) water on the coat, ensuring it reaches the skin.
- ✓ **Feel free to trim longer hair on your dog/cat but never shave your pets' hair.** The layers of dogs' coats protect them from overheating and sunburn. Brushing cats more often than usual can prevent problems caused by excessive heat. And be sure that any sunscreen or insect repellent product you use on your pets is labeled specifically for use on animals.
- ✓ **Keep paws away from hot pavement.** When the temperature is 77 degrees outside, the asphalt is 125 degrees. Animals walking on asphalt at these temperatures can damage their skin. To see if the pavement is okay for your pet to walk on, rest your hand on the pavement, if it's too hot for you, it's too hot for them. Additionally, when walking pets during the summer, try avoiding midday and long walks, consider investing in pet shoes, and/or walk pets in grass, instead of on the sidewalk or asphalt when possible.

## **Letter to Federal Representatives on Mail Theft**

The City of RPV is taking action on a growing concern in our community: tax-related mail theft and fraud. With reports of stolen and altered tax payment checks, often impacting seniors, residents are left with limited support and mounting frustration. Earlier this week, Mayor Dave Bradley signed the attached letter to our federal representatives, urging them to strengthen mail security, improve victim support, and consider reforms that better protect taxpayers. In response, the office of Rep. Ted Lieu will be inquiring with the U.S. Postal Service regarding this issue. Additionally, Rep. ## FINANCE DEPARTMENT

### FAC Meeting Recap

In the latest meeting of the Finance Advisory Committee (FAC) held on June 12<sup>th</sup>, several key items were discussed. The meeting included a review of the FY 2024-25 June Biannual Report and the approval of the FY 2025-26 Finance Advisory Committee Work Plan. The Biannual Report and Work Plan were approved and are to be presented to the City Council at the July 1, 2025 City Council meeting on the Consent Calendar. The FAC also reviewed the FY 2025-26 Investment Policy for the City of Rancho Palos Verdes. At the meeting, the FAC members proposed an amendment to the third article of the investment limitations. The proposed revision to the investment policy will be presented to the City Council at the July 1, 2025 City Council meeting.



The committee also received presentations on Treasury Report, Greater Portuguese Bend Landslide Complex (financial report), and the FY 2025-26 Preliminary Budget.

Due to a lack of upcoming agenda items, the July 10<sup>th</sup> FAC meeting was cancelled. The next FAC meeting is scheduled for August 14<sup>th</sup> in the Community Room at the Ken Dyda Civic Center, 30940 Hawthorne Blvd.

### Fiscal Year 2025-26 Adopted Budget

The City Council unanimously adopted the Citywide FY 2025-26 Budget at the meeting on June 17, 2025. This includes total revenues of over \$67.3 million and expenditures of roughly \$78.3 million, including transfers and Improvement Authorities. The adopted budget represents the culmination of a meticulous development process and highlights the City's financial plan and priorities for the upcoming fiscal year.

## FY 2025-26 General Fund Budget

The adopted General Fund budget includes revenues and expenditures reaching \$41.5 million and \$37.2 million respectively, excluding transfers.

After including the transfers and 50% reserves pursuant to the City Council's reserve policy, the General Fund is projected to end FY 2025-26 with an Unallocated Fund Balance of \$10.3 million. This projected balance is a decrease of approximately 10% from FY 2024-25, mainly due to the additional transfers to the CIP Fund to address the City's landslide emergency and stabilization efforts. The City continues to carefully manage its resources and recognizes that the significant reduction limits the General Fund's ability to continue making transfers to fund capital projects at the level seen in prior years.



## Landslide Financial Assistance Grant Program – Update

As of June 18, 2025, the City has received over **234 applications** and has disbursed payments for **223 completed** and verified applications totaling **\$2.22 million**. Applications will continue to be reviewed and processed as they are received.

The deadline to apply for the Financial Assistance Grant Program is June 30, 2025. This grant program will officially end on **July 1, 2025**, and no further applications will be accepted after **5:00 p.m. on June 30, 2025**. During the April 17, 2025 budget workshop, the City Council approved the transfer of the remaining grant funds to the Capital Improvement Program (CIP) Fund to continue supporting landslide emergency response and mitigation efforts, in accordance with the grant requirements.

## PUBLIC WORKS DEPARTMENT



### Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the city performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

#### Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **811 gallons per minute** or **1.17 million gallons per day**.
- Since the start of the DDW program, approximately **251 million gallons** or **770 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex.
- DDW-7 recently pinched off due to land movement impinging on the well. Based on the low production rate of this DDWs, the City's geologists are advising that the well not be re-drilled, but rather re-located, should additional funding become available.

## **Los Angeles County Sanitation Districts - Palos Verdes Drive South Pipeline Replacement Project**

Sewer service in Rancho Palos Verdes is provided by both Los Angeles County Public Works and the City. Wastewater from these systems flows into transmission pipelines operated by the Sanitation Districts of Los Angeles County (LACSD), a regional agency serving 5.5 million residents in 78 cities. LACSD operates two above-ground 14-inch transmission pipelines along Palos Verdes Drive South, which carry sewage from across the Palos Verdes Peninsula to treatment facilities in Carson.

Ongoing land movement in the Portuguese Bend Landslide Complex has damaged these pipelines and caused leaks requiring emergency repairs. In response, LACSD has launched a project to replace the existing rigid steel pipes with more flexible High-Density Polyethylene (HDPE) pipes. Construction began several months ago and is expected to be completed in the next 2-3 weeks.

Staff are coordinating closely with LACSD to limit traffic disruptions along Palos Verdes Drive South.





## Coastal Bluff Fence Repair Along Calle Entradero

On June 16, contractors will begin repairing the coastal bluff fence along Calle Entradero. Work will take place in the area shown, and a chain link fence will be installed to secure the work zone. Several parking spaces will be temporarily unavailable to allow space for equipment storage during the repair work. Work is expected to be completed in four to six weeks.





## Update on the Hesse Park Community Center Roof Replacement Project

The work for the Hesse Park Community Center Roof Replacement is substantially complete. The construction contractor will be fully moved off site within the next couple weeks after some minor adjustments and detailing are completed.



The project provides a full replacement for the facility's roof and skylights. During the winter storms in early 2024, sections of the roof leaked and damaged interior areas of the building, including sensitive equipment used to facilitate public meetings and events. Public Works staff made temporary repairs to the building and further determined through a detailed assessment that the roof, including all 17 skylights, was nearing the end of its useful service life; and a full replacement would be needed soon. Subsequently, a heavy wind event in January 2025 damaged some of the temporary repairs made in 2024, as well as some skylights.



A TSC special meeting is scheduled for June 30 at 6:00 p.m. in the Community Room located at the Ken Dyda Civic Center. The public is welcome and encouraged to attend and provide input. 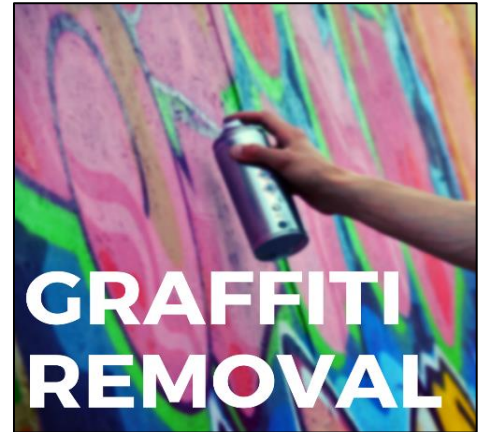

- Residents can help keep RPV looking great by downloading the **RPV Clean** app to report graffiti to City staff.



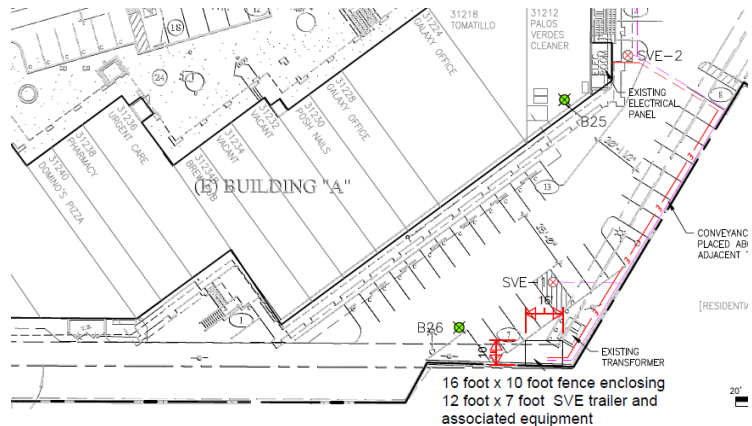

### Golden Cove Shopping Center Special Use Permit (SUP) Approval

On June 12, 2025, the Director of Community Development issued a [Notice of Decision](#) for the conditional approval of a SUP for the proposed extension of a SUP for the Golden Cove Shopping Center located at 31244 Palos Verdes Drive West. The SUP allows for the continued operation of a Soil Vapor Extraction (SVE) system to remediate subsurface chemicals on the property. The SVE system will continue to be contained in a 9-foot tall, 84 ft<sup>2</sup> (7 feet x12 feet) temporary trailer located along the southeast corner of the site behind existing parking stalls as noted in the aerial map.



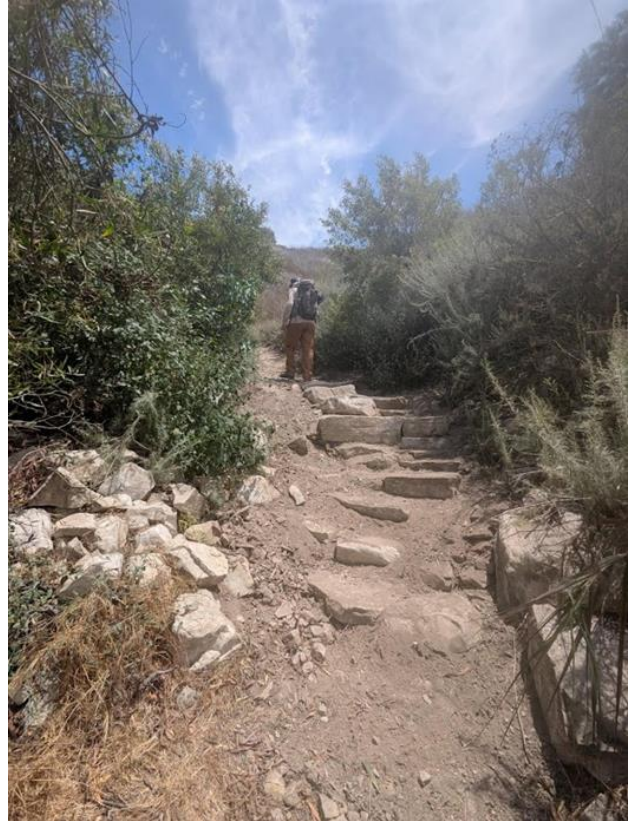

## Filiorum Reserve

The California Governor's Office of Emergency Services (Cal OES) would like to thank the Federal Emergency Management Agency (FEMA) for its ongoing partnership in serving California communities.

On April 25, 2025, Cal OES received the enclosed letter of the same date from the City of Rancho Palos Verdes (Subrecipient) (Enclosure 1). The letter appeals FEMA's Determination Memo (DM) to deny Public Assistance (PA) funding for Project Number (PN) 754844 in the amount of \$5,425,000.00 (Enclosure 2).

Cal OES partially supports the Subrecipient's appeal in the amount of \$102,157.16 because evidence demonstrates that one of the claimed damage locations is an eligible local roadway and not within the area of pre-existing landslide activity.

FEMA's DM was signed and uploaded to Grants Portal on February 25, 2025. In accordance with Title 44 of the Code of Federal Regulations (44 CFR) § 206.206(b)(1)(ii)(A), the Subrecipient's first appeal of PN 754844 was submitted within 60 calendar days of the upload date in Grants Portal (Enclosure 2).



## **Background**

In response to FEMA-4769-DR-CA, California Severe Winter Storms, Tornadoes, Flooding, Landslides, and Mudslides (DR-4769), the Subrecipient claimed work to roadways and storm drains that were damaged by sinkholes caused by ground saturation. Work for repairs were claimed on Palos Verdes Drive, Hawthorne Boulevard, and at the intersection of Rue La Fleur and Rue De La Pierre.

FEMA denied the eligibility of the Subrecipient's project with the following reasons:

1. The work claimed is not required as a result of the declared disaster, and the Applicant cannot demonstrate the damage was directly caused by DR-4769.
2. The facilities were unstable based on pre-disaster evidence making the ground and facility restoration ineligible.
3. Particular to Palos Verdes Drive South and Hawthorne Boulevard, the Federal Highway Administration (FHWA), another Federal Agency, is legally responsible for the maintenance and repair of these roads.

## **Analysis**

FEMA's DM details that pre-existing conditions of landslide and earth movement are well documented by consulting engineers and geologists, Cotton, Shires and Associates, Inc. (CSA), for the City of Rancho Palos Verdes in a September 29, 2023, report. FEMA points out that the report discusses landslide activity in the Landslide Complex dating back to 1956 (Enclosure 3, page 1).

In its response to FEMA's DM, the Subrecipient describes that the claimed damage is caused by hydroclimate volatility or "climate whiplash" induced by climate change. The whiplash effect is characterized by many years of drought and then consecutive years of extraordinary rainfall amounts. The extreme wet weather has contributed to damage to the Subrecipient's infrastructure, including drainage facilities and roadways (Enclosure 1, page 3).

Cal OES agrees with FEMA that the pre-existing instability dating back, particularly to 2018, makes that work ineligible per FEMA policy. Cal OES concurs with FEMA's conclusions that the work claimed at Palos Verdes Drive South and Hawthorne Boulevard is not the result of the declared incident in accordance with 44 CFR § 206.223(a)(1).

Additionally, Cal OES has reviewed the locations of claimed work on Rancho Palos Verdes Drive South and Hawthorne Boulevard and concurs with FEMA's conclusion that these streets are under the authority of FHWA, per the California Road System - Functional Classification provided by the California Department of Transportation (Caltrans).



However, Cal OES observes that claimed work at the intersection of Rue De Fleur and Rue De La Pierre (Intersection) is potentially eligible for PA funding.

Cal OES has previously reviewed six other appeals for DR-4769 presented by the Subrecipient where claimed damage was determined to be ineligible because of well documented pre-existing landslide conditions (Enclosure 4). In this case, Cal OES acknowledges that the Intersection is not located within recognized landslides (Enclosures 3, 5<sup>1</sup>, 6<sup>2</sup>, 7<sup>3</sup>). In a review of Google Earth, it is evident that the Intersection is well North of the overall bowl topography that outlines the historic landslide activity unique to this area (Enclosure 8).

Second, from a review of Caltrans' Functional Classification of California Roads, the Intersection is classified as a local road and therefore is eligible for PA (Enclosure 9).

At the request of Cal OES, the Subrecipient has provided documentation supporting reimbursement for repairs at the Intersection. In a review of the documentation, Cal OES observes the damage claimed occurred in two locations, noted in the contractor's documentation as Project 1 and Project 2 (Enclosure 10, pages 6-7).

Project 1 is at the storm drain that created a sink hole and undermined the sidewalk at the Intersection. Related to Project 1, Project 2 was discovered at the far end of the same drainpipe near where it would normally drain into an open concrete canal, approximately 265 yards away and downhill from the storm drain damage discussed above. Prior to reaching the canal, the drainpipe collapsed at a final grade change eroding the soil to create a 230 cubic foot cavern. Referenced photos and video clearly demonstrate the damage that occurred (Enclosures 11 – 15). The total amount of reimbursement requested for both Project 1 and Project 2 is \$102,157.16.

Cal OES agrees with FEMA that the well documented history of landslide activity in the Rancho Palos Verdes area along with FHWA responsibility of identified roads do disqualify the Subrecipient from PA, with one exception. It appears that FEMA may have missed identifying the eligibility of the Intersection described above. Therefore, Cal OES requests that FEMA now evaluate the supplied documentation to reimburse the Subrecipient in the amount of \$102,157.16.

I am writing to share a concerning issue affecting residents of the City of Rancho Palos Verdes of tax-related mail theft and fraud. This troubling trend is affecting many citizens, particularly seniors, with little to no recourse.

There have been multiple reports of tax payment checks being stolen, altered, and fraudulently cashed. In one case, a resident had to close several bank accounts and spend weeks navigating various agencies to seek a resolution. Despite reporting to local law enforcement and reaching out to county and federal offices, victims often receive little follow-up—especially when cases reach the Postmaster General's Office, where they are typically closed without further support.

While electronic or certified mail payments are recommended, they are not foolproof, and many residents may struggle with digital systems, increasing their vulnerability. This situation highlights the need for stronger protections and broader institutional support.

With another tax installment period approaching in the fall, we expect this issue to intensify. The City of Rancho Palos Verdes respectfully urges your office to investigate these incidents, assess federal mail security protocols, consider discreet redesigns of tax payment envelopes, and explore more robust support for victims. Addressing this matter proactively will help protect our residents' financial security and peace of mind.

We highly encourage written materials regarding Planning Commission Agenda items be submitted no later than 4:00 P.M. the Monday prior to a Planning Commission meeting to allow the Planning Commission Members ample time to review and consider the issues raised prior to making decisions at the Planning Commission meeting. Please keep in mind that it is difficult for Planning Commission Members to carefully review materials submitted after that deadline or at the meeting. Written materials, including emails, submitted to the city are public records and may be posted on the City's website. Accordingly, you may wish to omit personal information from your written materials or oral presentation as it may become part of the public record regarding an agenda item. In addition, City meetings may be televised and may be accessed through the City's website at [www.rpvca.gov/agendas](http://www.rpvca.gov/agendas).

### **Public Participation:**

Participants must speak from the podium using the lectern microphone; comments are to be directed to the Planning Commission and not to the staff or the public; repetition should be avoided; and reading a submission that has been copied or contained in the agenda will be discouraged. Virtual participation is also offered please visit [www.rpvca.gov/participate](http://www.rpvca.gov/participate).

### **Public Comments:**

The Planning Commission may limit the public input on any item based on the number of people requesting to speak, the length of the agenda, or the business of the Planning Commission.

### **Conduct at the Planning Commission Meeting:**

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

### **Time Estimates:**

The time noted next to an agenda item is only an estimate of the amount of time that will be spent

during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

**Continuation of Meeting:**

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Planning Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

**Closed Session:**

Please be advised that, pursuant to the Ralph M. Brown Act, "a person may not disclose confidential information that has been acquired by being present in a Closed Session . . . to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information." (Gov. Code § 54963(a).) "[C]onfidential information" means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet lawfully in Closed Session . . ." (Gov. Code § 54963(a).) Please be further advised that any "violation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law, including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury." (Gov. Code § 54963(c).)
