September 2, 2025 City Council Meeting Highlights

- City staff gave a report on a state pilot program that lets eligible participating cities install automated speed safety cameras in their jurisdictions.
- The Council decided not to pursue joining the program at this time, as RPV is likely ineligible.
- However, the City will begin collecting data from speed feedback signs to use for enforcement operations with the Lomita Sheriff's Station.
- The Council voted to begin the process of amending the Municipal Code to exempt equestrian districts from SB 9 housing development mandates.
- Passed in 2021, SB 9 requires cities to allow homeowners to split their single-family lot in two and build up to two new housing units on each lot with streamlined "ministerial" approval.



- Because subsequent state law created an exemption for horse-keeping zones, the City is updating its Municipal Code accordingly — a process that will next involve a public hearing at the Planning Commission.
- RPV's Equestrian Overlay District covers four areas, including Rolling Ridge Road/Via Campesina, a portion of Crestridge Road, the Portuguese Bend Community Association, and the northern portion of Palos Verdes Drive East between approximately Miraleste Intermediate School and the boundary with Rolling Hills Estates.
- Finally, the Council approved plans for winter holiday festivities at the Ken Dyda Civic Center. While this year's offerings will not include a skating rink, the City will host tree and menorah lighting ceremonies and a series of exciting winter and holiday themed events throughout the month of December.

Council Honors First Responders

At last night's meeting, the Council honored Los Angeles County Sheriff's Deputies and Firefighters who responded to a structure fire at an apartment complex on Caddington Drive on the evening of August 25.

Upon arrival, deputies encountered a third-floor apartment fully engulfed in flames. Without hesitation and despite lacking protective gear or breathing apparatus, deputies began evacuating residents from adjacent units while confronting heavy smoke conditions. One deputy located an emergency fire hose within the complex and used it

in an attempt to suppress the flames. As Los Angeles County Fire Department engine companies arrived and began firefighting operations, deputies worked swiftly to protect residents. Deputies forced entry into nearby units, clearing them one by one to ensure everyone was safely evacuated. Their decisive actions helped prevent injuries, and fortunately, no civilians were harmed during the incident.

A preliminary investigation determined the fire originated from a malfunctioning electrical stove. Five deputies were transported to a local hospital and treated for minor smoke inhalation. All are expected to make a full recovery.

The City expressed its deep appreciation for the professionalism and heroism demonstrated by both Lomita Sheriff's Station Deputies and Los Angeles County Firefighters. Their selfless actions not only safeguarded lives and property, but also reflected the highest ideals of public service.



RPVtv Turns 20

The Council also recognized RPVtv, the City's local educational access channel, for the 20th anniversary of its first live broadcast of a City Council meeting on August 27, 2005. Happy Anniversary, RPVtv, and thank you to the hardworking team for two decades of providing community interest programming from all around the Peninsula.

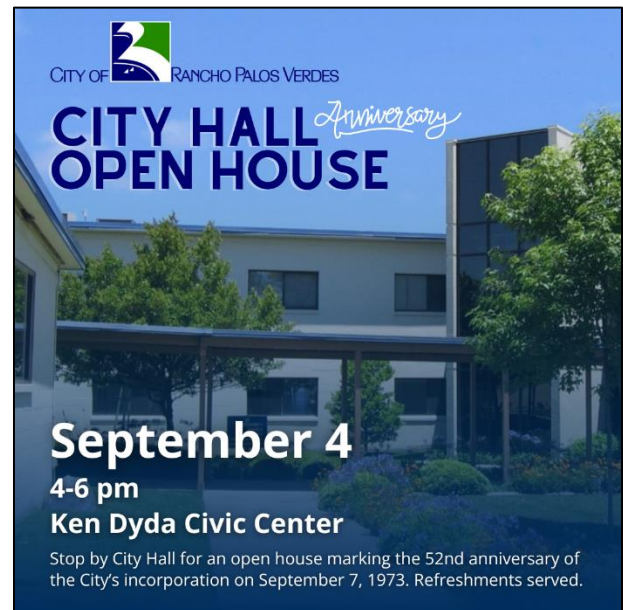


AB 986 Update

On August 29, the Senate Appropriations Committee voted to send Assemblymember Al Muratsuchi's landslide legislation, [AB 986](#), to the Senate Floor. Now co-authored by Senator Ben Allen, who attempted to pass similar legislation last year, the bill would amend the California Emergency Services Act to include landslides as a natural disaster that may be eligible for disaster assistance. The Senate has until September 12 to consider passing AB 986. If signed into law by Governor Gavin Newsom, AB 986 would apply to future local emergency declarations only — it would not make disaster assistance retroactively available for the City's current landslide-related state of emergency.

10 Tips to Prevent House Fires

1. Keep anything that can burn at least 3 feet from furnaces, water heaters, grills, fireplaces, and candles.



2. Stop using lithium batteries if you notice an odor, change in color, too much heat, change in shape, leaking, or odd noises

3. Keep candles away from children and pets

4. Always turn off stovetops, candles, fireplaces, and heaters when you leave a room



5. Keep anything that can catch fire (baking powder, curtains, wooden utensils, etc.) away from the stove top

6. Ensure cooking equipment is clean (ex. crumbs in a toaster, grease in the oven)

7. Turn pot handles toward the back of the stove while cooking and keep a pan lid nearby to smother flames.



8. Make sure you have a working smoke alarm on every level of your home






9. If there is a small stove, grill, or oven fire and it is safe to do so, turn off the source of the heat and try to put out the fire (cover stove tops and grills, use the appropriate type of fire extinguisher if you know how to do so)

- 10.If you have a fire in your oven and the flames escape the oven, leave your home and call 911.



Fire Extinguisher Types

There are 5 types of fire extinguishers designed to put out different kinds of fires.

-  For use with **ordinary materials like cloth, wood and paper**
-  For use with **combustible and flammable liquids like grease, gasoline, oil and oil-based paints.**
-  For use with **electrical equipment like appliances, tools or other equipment that is plugged into an outlet.**
-  For use with **flammable metals.**
-  For use with **vegetable oils, animal oils and fats in cooking appliances.**

There are also multipurpose fire extinguishers that might be labeled "B-C" or "A-B-C" that can be used on most types of home fires. Most home improvement stores carry multipurpose fire extinguishers that cover Class A through Class C.

Always look for the "UL Listed" or "ULC Listed" label on a fire extinguisher to ensure it is certified for use by a nationally recognized testing laboratory.

Fire extinguishers vary in size and weight, but it is recommended to select the largest fire extinguisher that a user can safely and comfortably operate.

Fire Extinguisher Use

Only attempt to put out a fire if it is no larger than a wastebasket, you have a clear escape route, you are safe from fire smoke, and you are physically able to do so.

When operating a fire extinguisher, remember the word PASS:

Pull and twist the pin. Hold the extinguisher with the nozzle pointing away from you and release the locking mechanism.

Aim low. Point the extinguisher at the base of the fire.

Squeeze the lever slowly and evenly.

Sweep the nozzle from side-to-side.



Apply for a Public Safety Reimbursement from the City

The City of Rancho Palos Verdes offers reimbursements for half the cost of a new doorbell or neighborhood camera system, now up to \$2,500 (**newly increased**) for neighborhoods/HOAs, and up to \$100 for individuals. The City aims to encourage the use of cameras and other public safety tools to strengthen neighborhood vigilance and security.

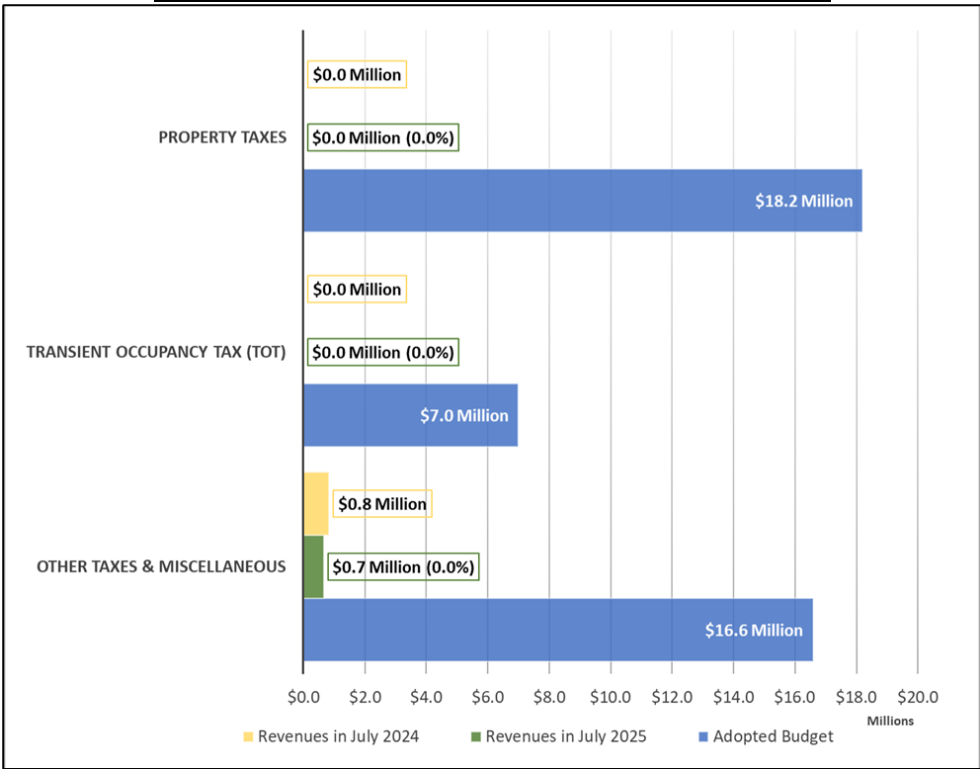
With the first full month of the new fiscal year (which began July 1st) “in the books”, the Finance Department is excited to re-introduce our monthly Finance Corner report!

Here is a snapshot of the General Fund revenue and expenditure categories for the first month of the fiscal year:

General Fund Revenues – July 2025

In July, the City received \$710,888 in General Fund revenues, representing approximately 1.7% of the FY 2025-26 adopted revenue budget of \$41.8 million. While revenues this early in the fiscal year remain modest, the results shown in Table 1: General Fund Revenues – July 2025 provide an initial snapshot of key trends across several categories:

Table 1: General Fund Revenues – July 2025



Property Tax

No property tax revenues were recorded in July, as the bulk of secured and in-lieu property tax payments are received in December and April. This timing reflects the County's apportionment schedule and is consistent with prior years. As such, the absence of property tax revenue in July is expected and does not reflect performance for the year.

Transient Occupancy Tax (TOT)

Similarly, July TOT revenue will be reported in August, as collections from Terranea Resort and other lodging establishments are remitted to the City one month in arrears. For FY 2025-26, the City has conservatively budgeted \$7.0 million in TOT, with \$6.8 million projected from Terranea Resort and \$0.2 million from other sources.

Permits and Fees

Permits and fees totaled \$427,000 in July, an increase of approximately \$78,700 (22.6%) compared to July 2024. Growth reflects higher building and safety permit activity, increased business license revenues, and the reinstatement of the City Council's approved 3% CPI adjustment to the Master Fee Schedule. These adjustments help align fees more closely with the cost of services while ensuring compliance with state law.

Other Taxes and Miscellaneous Revenues

Revenues in this category totaled \$284,000 in July, a decrease of \$223,000 compared to July 2024. The decline is primarily due to lower investment earnings, reflecting a reduced cash balance following significant landslide-related spending in FY 2024-25. Other subcategories such as golf tax, franchise fees, and rental income remain stable at this early stage of the fiscal year.

Although July revenues represent a small portion of the annual budget, results are consistent with the City's adopted assumptions. Property tax and TOT, the City's largest revenue sources, are collected later in the year and will be reflected in upcoming months. Early gains in permits and fees highlight steady development activity, while the decline in investment earnings underscores the impact of prior year reserve spending. Staff will continue to monitor trends closely and provide monthly updates to ensure revenues remain on track with FY 2025-26 projections.

General Fund Expenditures

Through July, General Fund spending (actuals) totaled \$1,457,221, which is 3.5% of the \$41.8 million FY 2025-26 adopted expenditure budget. When encumbrances are included, commitments total \$5.4 million, and the available budget is \$36.4 million. These results are typical for the first month of the fiscal year, when many annual contracts are encumbered up front and invoices begin to post over the next few months. Because invoices are usually paid within 30 days, some July payments are recorded in June and counted in the prior fiscal year (July 1–June 30). Overall, when compared to July 2024, General Fund Expenditures increased by approximately \$531,000, or 57%. This increase was anticipated based on the activities and consistent with the FY 2025-26 adopted budget. Most departments, including Administration, City Clerk, and Finance, reflect only routine operational activities, including personnel costs, typical for the first month of the fiscal year. The following departments show the largest changes:

Public Works

Expenditures in Public Works increased by about \$507,000, accounting for nearly 95% of the year-over-year change. Most of this reflects encumbrances for citywide maintenance, professional services, and facility repair work. Only a small share has been spent in July. The balance represents purchase orders already issued for upcoming work. This is consistent with the adopted plan, which relies heavily on maintenance and repair contracts in the base budget.

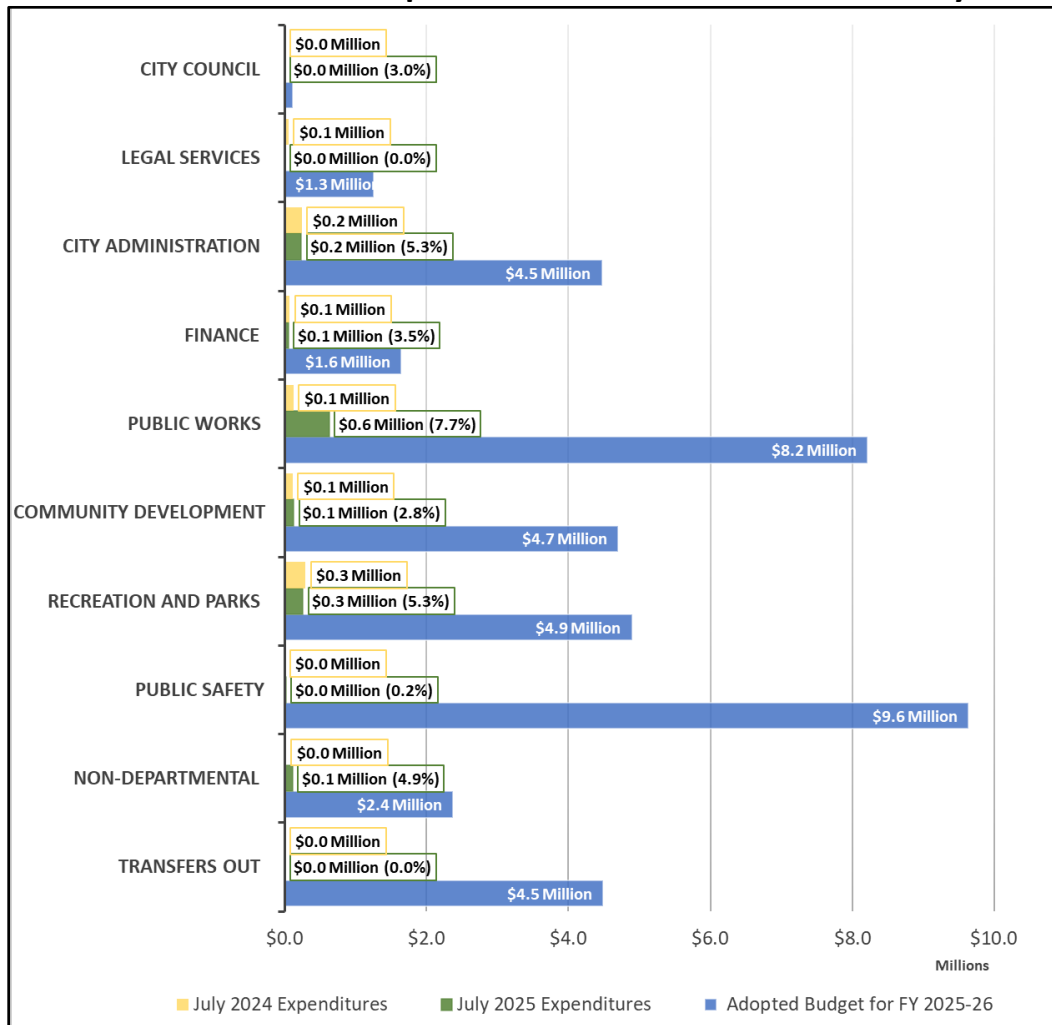
Non-Departmental

Non-Departmental costs rose by approximately \$97,000 compared to last year, mainly because the City booked the annual insurance premium of \$115,212 in July. This timing item is expected and aligns with the budget, which includes about \$1.0 million for insurance across the full year.

Looking ahead, additional citywide items will post over the coming months, including scheduled transfers-out approved by Council (Habitat Restoration, Sub-region One, Abalone Cove Sewer, and Infrastructure). Many of the encumbrances booked in July for Public Works contracts will begin to convert into actual payments as invoices are processed, while departmental operating costs such as utilities, training, and professional services will ramp up as the fiscal year progresses. These trends are consistent with the adopted expenditure plan and provide an early indication of how the City's spending will track through FY 2025-26.

City Overview


The City of Rancho Palos Verdes is a California general law city that operates under a council-manager form of government. It was incorporated in 1973.

Located in the County of Los Angeles, RPV is home to more than 41,000 residents.

The city features the Palos Verdes Nature Preserve, which is comprised of 13 individual nature reserves totaling approximately 1,500 acres, with about 33 miles of hiking trails.

Other notable landmarks include the Point Vicente Lighthouse (listed on the National Register of Historic Places) and the Point Vicente Interpretive Center, a premier whale-watching site for the annual migration of Pacific gray whales.

Rancho Palos Verdes is the largest of four municipalities on the Palos Verdes Peninsula. It covers approximately 13.5 square miles and boasts over 7.5 miles of Pacific coastline.

Budget Overview

- \$79.2 million in expenditures and transfers, across all funds, offset by \$67.3 Million in revenues and transfers, with \$11.9 million from fund balances.
- The General Fund budget reflects \$41.5 million in operating revenues and \$37.3 million in operating expenditures.




- \$3.9 million is transferred to the Capital Infrastructure Program (CIP) Fund for capital projects.

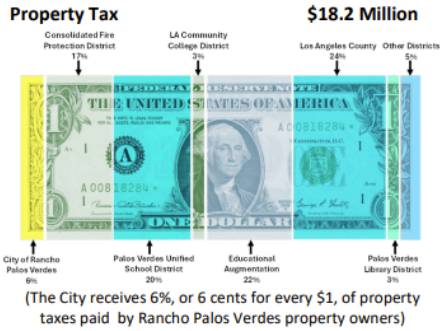

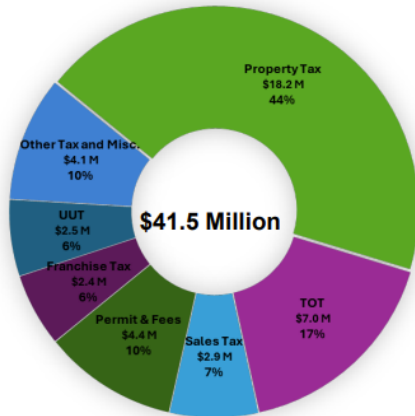
General Fund Revenue

Permits & Fees **\$4.4 Million**

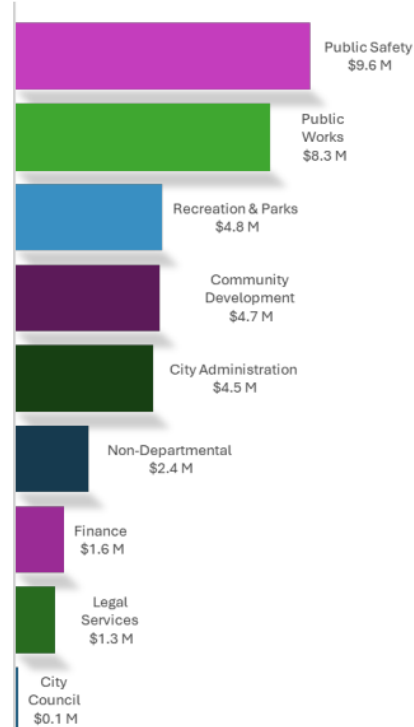

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the city performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **570 gallons per minute** or approximately **0.82 million gallons per day**.
- Since the start of the DDW program, approximately **324 million gallons** or **993 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently below average due to the reasons outlined below:
 - DDW-5 has sheared due to land movement and is offline. Re-drilling began on 9/2/2025 and should be completed in approximately 1 week.
 - DDW-1 appears to have sheared due to land movement and is offline. Re-drilling will be scheduled following the completion of DDW-5.

Status of Winterization:

Staff, in consultation with geologists, are currently developing recommendations for emergency winterization for the 2025-2026 rainy season.

Palos Verdes Drive South in Landslide Area

Wayfarers Chapel has completed maintenance work on their slope adjacent to Palos Verdes Drive South in the landslide area. The work generally consisted of removing material to stabilize the slope.



Los Angeles County Sanitation Districts - Palos Verdes Drive South Pipeline Replacement Project

The sewer service in Rancho Palos Verdes is provided by both Los Angeles County Public Works and the City. Wastewater from these systems flows into transmission pipelines operated by the Sanitation Districts of Los Angeles County (LACSD), a regional agency serving 5.5 million residents in 78 cities. LACSD operates two above-ground 14-inch transmission pipelines along Palos Verdes Drive South, which carry sewage from across the Palos Verdes Peninsula to treatment facilities in Carson.



Ongoing land movement in the Portuguese Bend Landslide Complex has damaged these pipelines and caused leaks requiring emergency repairs. In response, LACSD has launched a project to replace the existing rigid steel pipes with more flexible High-Density Polyethylene (HDPE) pipes. Construction began several months ago and is now expected to be completed by the end of the summer.



Staff are coordinating closely with LACSD to limit traffic disruptions along Palos Verdes Drive South.

Neighborhood Beautification Grant Program - Now Open

Applications for the neighborhood beautification projects will be accepted now through October 17, 2025. Beautification projects must be visible from arterial or collector streets to receive a reimbursement for 50% of the project costs, up to \$5,000.

 - The City is preparing to re-sod approximately 32,000 square feet in the Eastview Park dog park areas, with completion expected by the end of October.





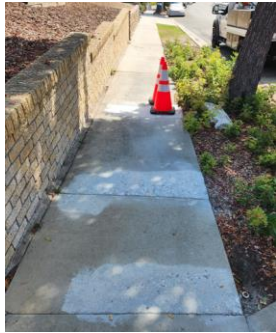

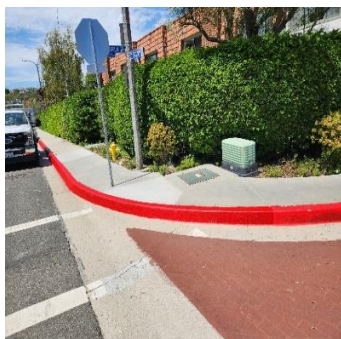

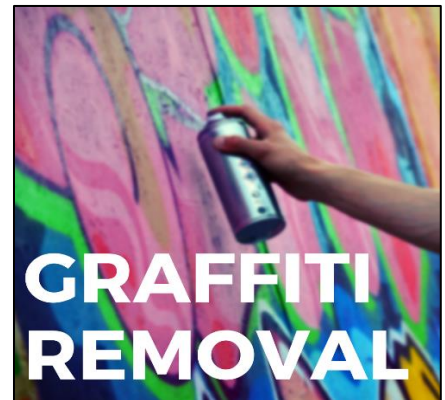

Docent Training Starting Soon: September 3 Open House at PVIC

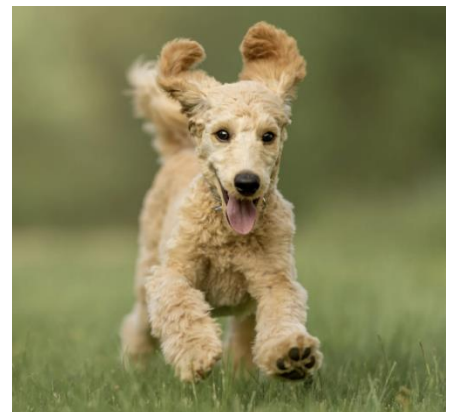
