
City to Receive \$4 Million from LA County Sanitation Districts for Landslide Remediation

The Los Angeles County Sanitation Districts, which is the agency responsible for operating the main trunk sewers that transport wastewater out of the Peninsula, will award the City of Rancho Palos Verdes \$4 million for landslide remediation.

On September 25, the agency [announced](#) its Board of Directors approved the one-time contribution to support the City's landslide stabilization work, including the deep dewatering well and winterization programs, because the City's efforts to slow land movement are vital to protecting the above-ground trunk lines that run along Palos Verdes Drive South through the landslide area. The City expresses its deep gratitude to the Sanitation Districts, under the leadership of Chief Engineer and General Manager Robert Ferrante, for this funding and for their close partnership throughout the landslide emergency as we work together to ensure the protection of the sewer system.



Land Movement Updates



Marguerite Drive Update

On September 27, at approximately 8:20 p.m., land subsidence was reported along a coastal bluff off Marguerite Drive near Palos Verdes Drive West in the City of Rancho Palos Verdes. According to the Los Angeles County Fire Department, approximately 300-400 linear feet of the slope sloughed off, dropping approximately 30-40 feet toward the coastline.

Marguerite Drive Update



The City's geologist conducted a preliminary geotechnical assessment of the site on September 28. The cause of the land movement remains under investigation, and the situation is considered to be static at this time. The City's geologist will continue to closely monitor the area in the days and weeks ahead. No homes are threatened, and no evacuations are in place. This isolated incident is unrelated to ongoing land movement in the Portuguese Bend Landslide Complex, which is located about 4 miles southeast.

The City's Building Official inspected each of the four properties on Marguerite Drive where backyards were damaged by the land subsidence and is in communication with the property owners. No structural damage was found, and no homes were tagged. As this incident occurred entirely on private property, cleanup and next steps are to be determined by the property owners. Out of an abundance of caution, the City is advising the public to avoid the shoreline in the immediate vicinity of Marguerite Drive as the bluff settles.

The City thanks the Los Angeles County Fire Department and Sheriff's Department for their response and coordination.

Finance Department

Two months into the new fiscal year, the City's General Fund revenues and expenditures are tracking as expected. Here is how budget categories are tracking compared to the adopted budget and

where categories were for the same period last fiscal year:


General Fund Revenues – August 2025

Through August, the City received \$908,520 in General Fund revenues, representing approximately 4.6% of the Fiscal Year 2025-26 adopted revenue budget of \$41.8 million. The revenues to date are consistent with the City's adopted budget and are slightly higher than the revenues received in the same period last fiscal year. Property tax and transient occupancy tax (TOT), the City's largest revenue sources, are collected later in the year and will be reflected in upcoming months.

Staff will continue to monitor trends closely and provide monthly updates to ensure revenues remain on track with FY 2025-26 projections.

Table 1 below provides an overview of where the financials stand to date:

Table 1: General Fund Revenues – through August 2025



Property Tax

The City received its first property tax payments in August, totaling \$318,000, or 1.7% of the \$18.2 million budgeted for this category. The percentage is lower at this time of year, which is expected. As noted in last month's report, the majority of secured and in-lieu property tax payments are received in December and April. The amount is 2% higher than the \$312,000 collected during the same period last year.

Transient Occupancy Tax (TOT)

Through August, the City received just over \$700,000 in TOT revenue, or 10.1% of the FY 2025-26 budget projection. This is \$16,000 more than the amount collected at the same point last year. Comparing the budget assumptions for each year, the current percentage of 10.1% is slightly lower than last year's 10.5%.

Utility User Tax (UUT)

UUT revenue received through August is approximately \$243,000, which is 9.9% of the budgeted revenue for this category in FY 2025-26. This is \$4,700 more than the revenue collected in first two months of FY 2024-25, and 0.5% more than the 9.4% that \$238,700 represented of the revenue assumption for last year.

Other Taxes and Miscellaneous Revenues

Revenues in this category totaled \$643,000 through August, an increase of \$181,000 compared to the same period last year. This reflects a slight decline in Building and Safety Permits revenue but is more than offset by a large increase in interest earnings revenue, which is attributed to a change in securities value of the City's investments. Other subcategories included business license tax, golf tax, and rentals and leases.

General Fund Expenditures

Through August, General Fund spending (actuals) totaled \$2,106,770, which is 5.0% of the \$41.8 million FY 2025-26 adopted expenditure budget. When encumbrances are included, commitments total \$14.7 million, and the available budget is \$25.6 million. These results are typical for this point in the fiscal year, when many annual contracts are encumbered up front and invoices are starting to post. Because vendor invoices are usually paid within 30 days, some August payments reflect work that was performed in July, and similarly work performed in August will be reflected in invoices paid in September.

Overall, General Fund Expenditures for the first two months of FY 2025-26 increased by approximately \$295,000, or 16%, compared to the same period in FY 2024-25. This increase was anticipated, with current expenditures representing 5% of the adopted budget, compared to 4.2% at this point last year. Most departments, including Administration, City Clerk, and Finance, reflect only routine operational activities, including personnel costs, typical for the first two months of the fiscal year.

Looking ahead, additional Citywide items will post over the coming months, including scheduled transfers-out approved by Council (Habitat Restoration, Sub-region One, Abalone Cove Sewer, and Infrastructure). Many of the encumbrances booked through August will begin to convert into actual payments as invoices are processed, while departmental operating costs such as utilities, training, and professional services will ramp up as the fiscal year progresses. These trends are consistent with the adopted expenditure plan and provide an early indication of how the City's spending will track through FY 2025-26.

The following departments show the largest changes:

Public Works


Expenditures in Public Works is about \$142,000 higher or 35% compared to last year. The increase is largely attributed to previously vacant positions that are now filled, along with higher budgeted Citywide maintenance, professional services, and facility repairs. The expenditures reflect only 6.5% of the annual budget for the department, which is only slightly higher than the 4.5% of the budget spent at this time last year.

Public Safety

Although expenditures in this category are approximately \$55,000 higher than last year, only 0.7% of the adopted budget has been expended. The increase in expenditures reflects a full-time staff position being added to this category, as well as part-time staff, while the low percentage shows that these expenditures do not reflect anticipated expenditures in this category for the year, including the contract with the Los Angeles County Sheriff's Department.

Table 2 below provides a summary of General Fund expenditures through August, showing spending by department, the FY 2025-26 adopted budget, and the percentage of the budget spent to date:



HDL's Annual Property Tax Report

The Tax Year 2025/26 Property Tax Newsletter for the City of Rancho Palos Verdes, prepared by HDL in September, is now ready and provided below. The newsletter is designed to help readers understand how property tax dollars are allocated, outline changes for the coming year, and explain how local trends and policies may affect property taxes in our community.

In this report, you will find:

- An overview of assessed value trends and growth factors influencing property taxes.
- A breakdown of how property tax revenue is distributed among the County, the City of Rancho Palos Verdes, schools, and special districts.
- Comparative data, charts and facts to clarify common questions.

The Basics - Property Tax Dollar Allocation

FY 2025-26 Property Tax Adopted Budget

Property tax continues to serve as the City's primary and most stable revenue source in the General Fund. The FY 2025-26 Adopted Budget is \$18.2 million or 44% of the total budget of \$41.8 million budget for revenues.

Proposition 13, Assembly Bill 8 (AB 8)

In 1978, Proposition 13 (Assembly Bill No. 8 - AB 8) was passed by voters as a constitutional amendment that established formulas to allocate property taxes, ensuring cities, counties, schools, and special districts received their share based on the average taxes they levied in the three years prior to Prop 13. Local jurisdictions that received a large share of property taxes prior to 1978 received a relatively larger share of property taxes after Prop 13.

City of Rancho of Palos Verdes Allocation = \$0.6 of every \$1.00

As shown in the graphic below, under Prop 13, the City receives 6% of the 1% property tax collected, which is roughly \$0.06 of every \$1 in property tax collected.


Property Tax Allocation



Also shown in the HDL report, the City of Rancho Palos Verdes' taxable assessed value in 2025 is \$17.7 billion, an increase of 3.4% from the prior year. For illustrative purposes, 1% of this taxable assessed value is approximately \$177 million in property tax revenue. Of the estimated amount of \$177 million, the City will receive approximately \$10.6 million only and the rest is distributed to Los Angeles County, the Los Angeles Community College District, Palos Verdes Unified School District, Palos Verdes Library District, Consolidated Fire Protection District, and the Education Revenue Augmentation Fund (ERAFF), which voters approved in 1992 under Prop 172.


The charts below show the City's property tax breakdown and allocation, along with a sample of how taxes are calculated and distributed.

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure.

Additionally, the City performed emergency winterization measures in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **710 gallons per minute** or approximately **1 million gallons per day**.
- Since the start of the DDW program, approximately **346 million gallons** or **1,059 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-1 was re-drilled last week and is back online.
 - DDW-9 water level continues to drop. The City's geologists continue to monitor the well and recommend adjustments to its pump depth and extraction rate to reduce the risk of the pump running dry and burning out.

Status of Winterization:

Staff has finalized the scope of work for implementing winterization measures ahead of the rainy season. The work is anticipated to begin by the second week of October and will require approximately 3-4 weeks to complete.

Los Angeles County Sanitation Districts - Palos Verdes Drive South Pipeline Replacement Project

The sewer service in Rancho Palos Verdes is provided by both Los Angeles County Public Works and the City.

Wastewater from these systems flows into transmission pipelines operated by the Los Angeles County Sanitation Districts (LACSD), a regional agency serving 5.5 million residents in 78 cities. LACSD operates two above-ground 14-inch transmission pipelines along Palos Verdes Drive South, which carry sewage from across the Palos Verdes Peninsula to treatment facilities in Carson.

Ongoing land movement in the Portuguese Bend Landslide Complex has damaged these pipelines and caused leaks requiring emergency repairs. In response,



LACSD has launched a project to replace the existing rigid steel pipes with more flexible High-Density Polyethylene (HDPE) pipes. Construction began several months ago and is now expected to be completed within the next 1-2 weeks.

Staff is coordinating closely with LACSD to limit traffic disruptions along Palos Verdes Drive South.

Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update

On March 4, 2025, the City Council awarded a construction contract to install a left-turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. Since that time, the contractor has been ordering and acquiring the long lead items such as the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On or around October 6, the contractor will begin construction at the intersection. The project will include the following improvements:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns.
- Traffic signal hardware and equipment updates, including new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new left-turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

Construction is anticipated to be complete by the end of the year.

Traffic Safety Committee (TSC) Special Meeting – September 29, 2025

A special TSC meeting was held on September 29 at 6 p.m. in the Community Room at City Hall. Highlights of the key agenda items are as follows:

Trudie Drive Traffic Calming Study

The TSC adopted a motion (5-0) accepting the staff recommendation to implement the following speed reduction traffic measures and return with an effectiveness study one year after implementation:

- A. Install a stop-ahead sign on eastbound Trudie Drive before S Highmore Avenue.
- B. Install a solid painted edge line to reduce width of travel in each direction.
- C. Install reflective markings on the existing stop sign at Trudie Drive and S Highmore Avenue to increase visibility
- D. Install and refresh reflective pavement marking on centerline of Trudie Drive.



Trudie Drive Traffic Calming Study Area and Recommendations

Hawthorne Boulevard Guardrail Study

The TSC adopted a motion (4-1) accepting the staff recommendations from the Hawthorne Boulevard Guardrail Study. The study evaluated the feasibility of installing guardrails following a run-off-road crash along the segment of Hawthorne Boulevard between Highridge-Granvia Altamira and San Nicolas Drive. Staff recommended implementing the following traffic measures:

- A. Install chevron curve warning signs in the southbound direction.
- B. Install a curve warning sign arrow (W1-2R) just north of San Nicolas Drive in the northbound direction.
- C. Restripe the existing 8-foot bike lane to provide for a 2-foot buffer and 6-foot bike lane with reflective striping to increase visibility.
- D. Consider adding landscaping with raised ivy or shrubs in the parkway between the curb and sidewalk.





REMINDER: Applications being Accepted for the Western Avenue Storefront Improvement Program

The City's Community Development Department is currently accepting applications for Round 3 of the Western Avenue Storefront Improvement Program. **Submittal deadline is October 31.** Grants of \$5,000-\$20,000, requiring a 50% match, are available for eligible projects that enhance or restore the physical condition or appearance of the building (must be visible from the street). Examples include new exterior paint, lighting, landscaping, signs, awnings, entry doors, outdoor seating, and resolving code violations. Storefronts must be located along Western Avenue within the boundaries of the City of Rancho Palos Verdes (NOT in the City of Los Angeles). 
A Boo-tiful Day of Ghosts on the Coast! Trunk or Treat Is Less Than Two Witchy Weeks Away!






PROPERTY HIGHLIGHTS

The largest assessed value increase was reported at Terranea Resort, owned by Long Point Development LLC. The parcel's value change was mostly caused by the CPI increase with minor increases in fixtures and personal property value, adding \$11.8 million to the roll. New improvements added to a single-family residential parcel located at 32042 Isthmus View Drive caused a reappraisal and a \$5.1 million increase in value. Similarly, new improvements added to a single-family parcel located at 6501 Palos Verdes Drive East added \$4.5 million in value to the roll this year.






REAL ESTATE TRENDS

Through June 2025, about one-third of the 43 counties where we purchase sales data are still experiencing declines in median sale prices. In many areas, however, home sales rebounded in June ending three months of median price declines. The mostly modest year-over-year median sales price changes for June 2025 showed the State's Far North area having the strongest price growth at 13.7%; the Central Coast grew by 11.4%; Southern California grew by 1.9%; and, the San Francisco Bay area grew by 1.0%. The Central Valley area posted a median sales price decline, slipping down by 0.8 %. The median sale price of Rancho Palos Verdes detached single-family homes from January through July 2025 was \$1,840,000, an increase of \$18,500 (1.0%) from 2024's median price.
