### **San Pedro International Film Festival to Screen Documentary on DDT Dumping**

The San Pedro International Film Festival, which takes place November 7-9 in RPV and San Pedro, will present a screening of a Los Angeles Times documentary about deep-water chemical dumping off the coast of the Palos Verdes Peninsula.

From the Los Angeles Times and Pulitzer Prize-finalist Rosanna Xia, “Out of Plain Sight” is a cinematic exposé of an environmental disaster lurking just off the coast of Southern California. Not far from Catalina Island, aboard one of the most advanced research ships in the world, David Valentine discovered a corroded barrel on the seafloor that gave him chills. The full environmental horror sharpens into greater clarity once he calls Xia, who pieces together a shocking revelation: In the years after World War II, as many as half a million barrels of toxic waste had been quietly dumped into the ocean – and the consequences continue to haunt the world today.

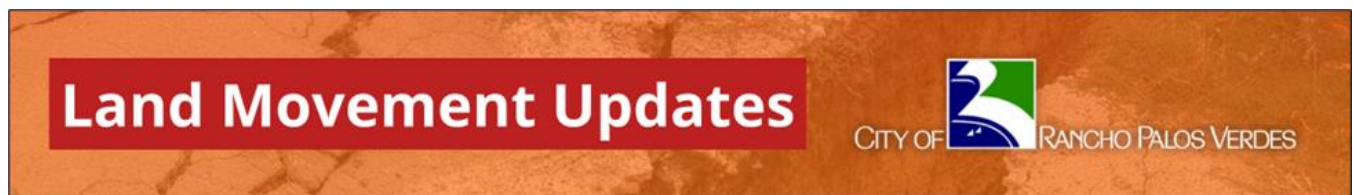
## Palos Verdes Peninsula Village Information Session on November 19

## **City Receives \$2 Million Payment from L.A. County for Winterization**

Earlier this week, the City received a check for \$2 million from the County of Los Angeles to partially reimburse the City's 2024 winterization efforts in the landslide area. The L.A. County Flood Control District authorized the funding in March 2025 to help offset the costs of emergency measures that were put in place to prepare for the last rainy season. The overall \$4 million work included filling fissures, lining canyons, installing drainage improvements and repaving vulnerable streets in the Seaview neighborhood. The City thanks the County for its continued support and financial assistance.

## **Coastal Commission to Consider KCLAD Permit for Dewatering Wells**

On November 6, the California Coastal Commission [will consider](#) an application from the Klondike Canyon Landslide Abatement District (KCLAD) to construct three dewatering wells on the beach at Portuguese Bend Beach Club. The project was granted an emergency coastal development permit by the agency in August 2024, and KCLAD is now seeking a required follow-up coastal development permit to retain the authorization on a more permanent basis. The Coastal Commission's geologist agrees that the wells will protect dozens of homes by reducing water pressure that is fueling land movement. The agenda item is on the consent calendar, which means it may, or may not, be pulled for discussion.





## **Amateur Radio Training in November at Hesse Park**

Get trained on Amateur/HAM Radio use this November. 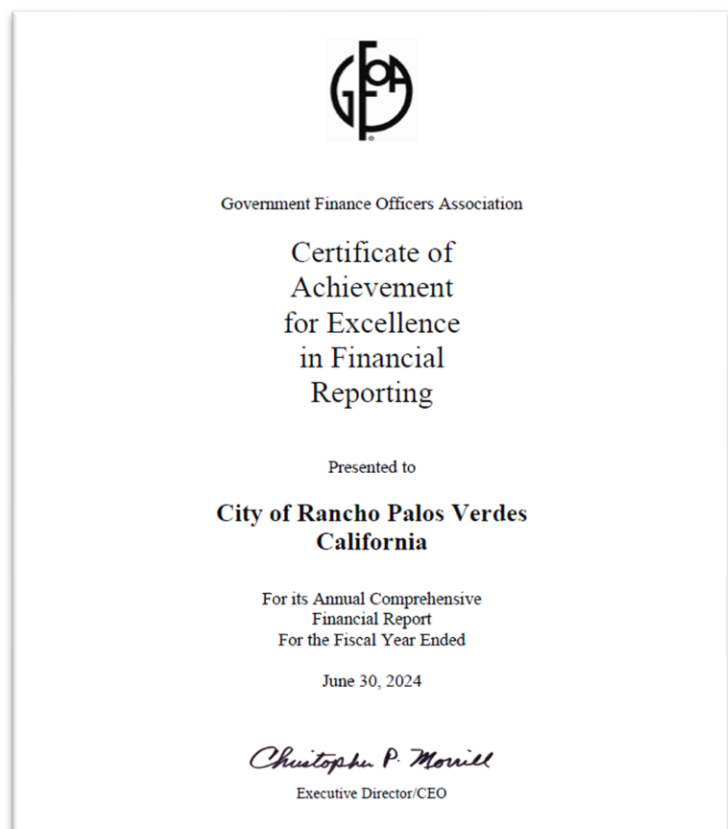
### RPV Receives the Certificate of Achievement for Excellence in Financial Reporting

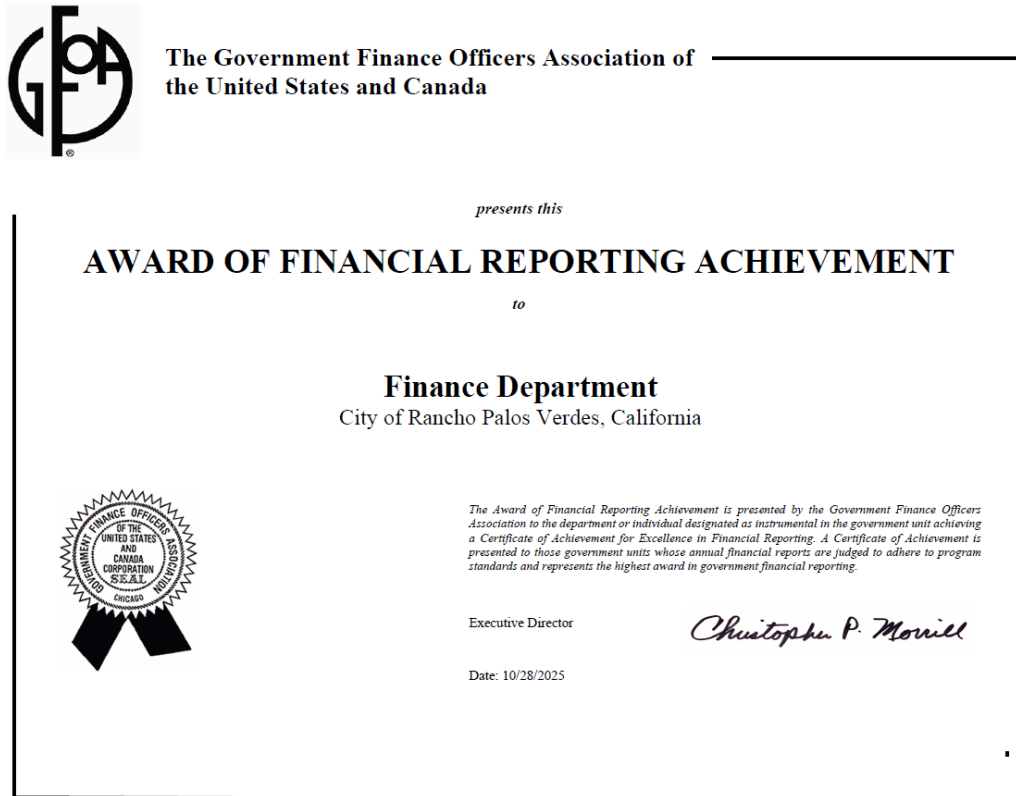
On October 28, 2025, the Government Finance Officers Association (GFOA) announced that the City of Rancho Palos Verdes has been awarded GFOA's Certificate of Achievement for Excellence in Financial Reporting for its annual comprehensive financial report (ACFR) for the Fiscal Year that ended June 30, 2024.

This marks another consecutive year that the City has received this Certificate of Achievement, which is the highest form of recognition in governmental accounting and financial reporting. Its attainment represents a significant accomplishment for the government, its management, City staff, and the Finance team.



When a Certificate of Achievement is awarded to a government, an Award of Financial

Reporting (AFRA) is also presented to the department designated by the governmental agency as primarily responsible for earning the Certificate. This award has been received by the City of Rancho Palos Verdes Finance Department.

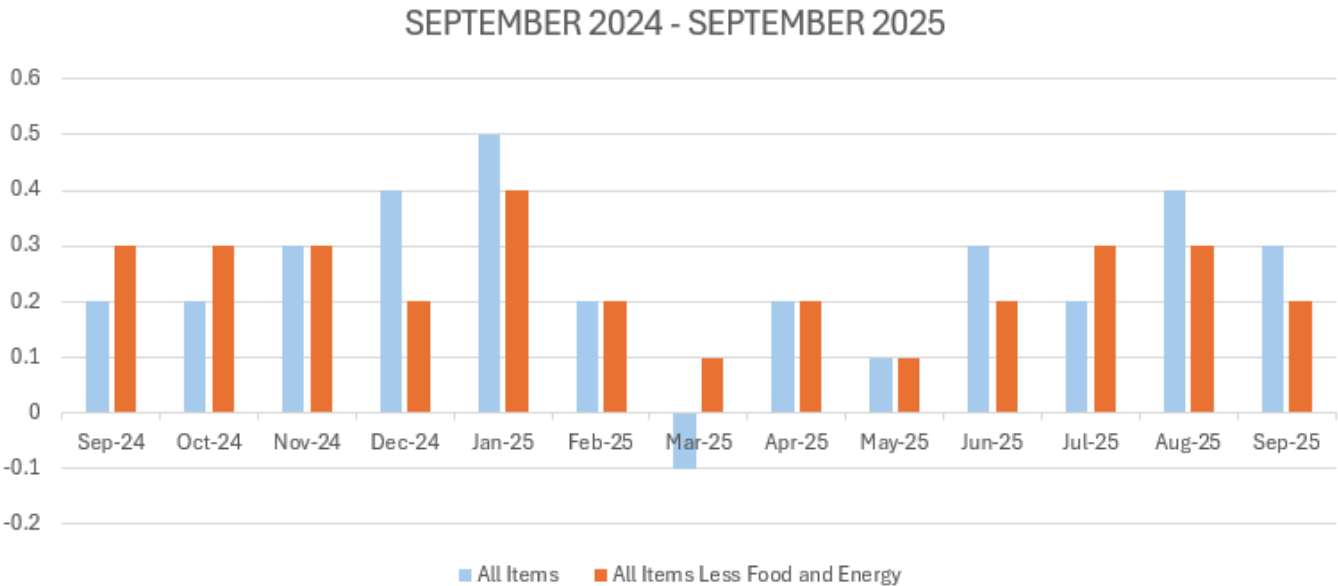

Consumer Price Index – September 2025

Consumer Price Index (U.S.)

The Consumer Price Index (CPI) increased by 0.3% in the month of September after increasing by 0.4% in August. Compared annually, CPI rose by 3.0% over the past 12 months. The CPI for all items, less food and energy (core inflation), grew by 0.2% in the month of September, following a 0.3% increase in August. Chart 1 further illustrates the monthly percentage changes in CPI for both headline and core inflation.

In summary, all items index rose by 3.0% for the 12 months ending September, after rising 2.9% over the 12 months ending August. The indexes for shelter, airline fares, recreation, household furnishings and operations, and apparel, all increased in the month of September. The indexes for vehicle insurance, used cars and trucks, and communications saw a decrease for the month of September.

On a continuing trend from last month, the index for food at home increased by 2.7% over the 12 months ending in September. The index for food away from home increased by 3.7% over last year. And although the indexes for electricity and natural gas



decreased by 0.5% and 1.2% respectively, the overall index for energy increased by 1.5% in September. This is mostly due to the 4.1% increase with the gasoline index for the month of September.

## **California Sales Tax Returns – 2<sup>nd</sup> Quarter 2025**

California's local one-cent sales and use tax receipts for the months of April through June 2025 were 0.6% higher than the same quarter one year ago. This modest growth may have confirmed the end of an eight-quarter decline prior to the 1<sup>st</sup> Quarter of 2025. The 2<sup>nd</sup> Quarter is traditionally met with improved weather and marks the beginning of summertime activities.

The most noticeable sales tax gains came from increased online sales, whether from California based businesses or shipped from outside the state. Office and electrical equipment also saw increases of sales tax receipts. Traditional retailers saw a 1% decline, with specialty, sporting goods, and department stores underperforming compared to the same quarter one year ago. Despite increased menu prices and tip fatigue, most restaurant categories saw increased sales tax receipts. However, disposable income is growing at a slower pace than prior years.

## **Rancho Palos Verdes Sales Tax Update – 2<sup>nd</sup> Quarter 2025**

The City of Rancho Palos Verdes' share of the countywide use tax pool was 5.7% higher than the same quarter one year ago. Local consumer goods retailers reported modest gains and quick-service concept restaurants also saw increased sales. However, all other restaurant categories experienced lower sales. Despite the overall growth, the hospitality sector remained sluggish with three consecutive quarters of decline. Economic uncertainty amongst consumers throughout the first half of the year potentially limited local tourism.

## PUBLIC WORKS DEPARTMENT



### Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

#### Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **670 gallons per minute** or approximately **1.0 million gallons per day**.
- Since the start of the DDW program, approximately **369 million gallons** or **1,131 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
  - DDW-9 is currently offline due to low water level. The City's Geologists are studying how quickly its water level rises and will then recommend adjustments to the pump's operation to minimize the risk of it running dry and burning out.

**Status of Winterization:**

Construction work continues this week on winterization measures. The work is anticipated to be complete by end-November / early-December.

**Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update**

On March 4, 2025, the City Council awarded a construction contract to install a left turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. Since that time, the construction contractor has been ordering and acquiring the long lead items like the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On Monday, October 6, 2025 construction activities began at the intersection. The project will include the following improvements:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns.

- Traffic signal hardware and equipment updates including a new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

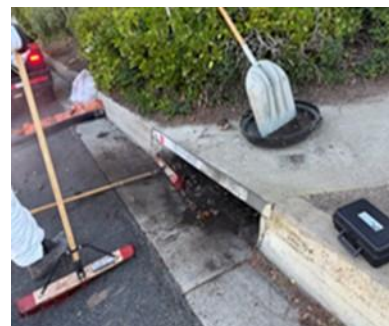
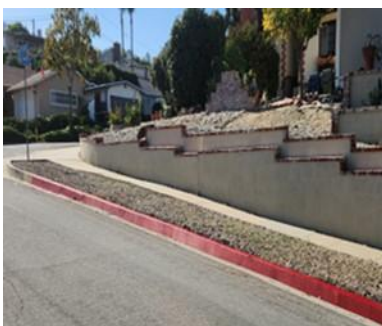

  - Unplugged a storm drain on Palos Verdes Drive East

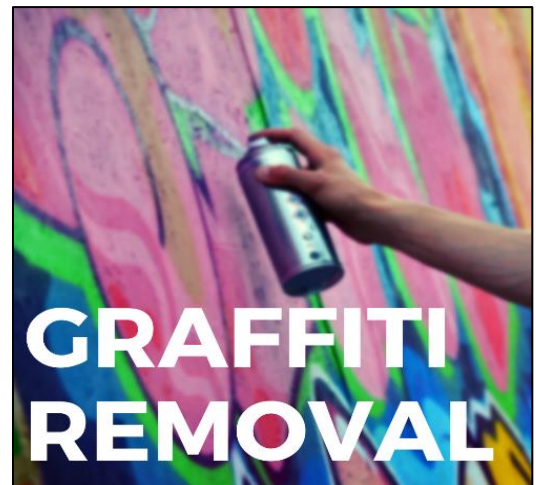

### Pet Safety Tips this Halloween

The City of Rancho Palos Verdes' animal care partner, the Los Angeles County Department of Animal Care and Control (DACC), recently issued a new release highlighting tips to keep pets safe during Halloween celebrations. DACC urges pet owners to consider the following tips to keep their beloved four-legged family members safe:

- Securely store all candy in containers that are out of reach of pets.
- Proper disposal of wrappers is essential to keep pets safe from choking hazards or intestinal blockages.
- Remain vigilant for signs of anxiety in dogs, such as panting or drooling, which may indicate that they need to be removed from the situation and placed in a safe space.



Additionally, DACC reminds pet owners that all pets should be microchipped, and the chip must be registered with the owner's current contact information so they can be reunited in case pets become separated during festivities. ### Coyote Sightings Update

On October 7, 2025, the Code Enforcement Division provided the City Council with a status report on the City's Coyote Management Plan including coyote sighting and monitoring information. As part of the update, it was reported that the City received 907 coyote sightings during the period of January 2025 to September 2025. In further assessing reporting information, it was noted that total reported coyote sightings during this period was 897. City Staff also collected coyote sightings during reporting periods in 2023 and 2024, which identified 440 and 484 sightings, respectively. ## REMINDER: Applications being Accepted for the Western Avenue Storefront Improvement Program

Grants of \$5,000-\$20,000, requiring a 50% match, are available for eligible projects that enhance or restore the physical condition or appearance of the building (must be visible from the street). Examples include new exterior paint, lighting, landscaping, signs, awnings, entry doors, outdoor seating, and resolving code violations. Storefronts must be located along Western Avenue within the boundaries of the City of Rancho Palos Verdes (NOT in the City of Los Angeles). 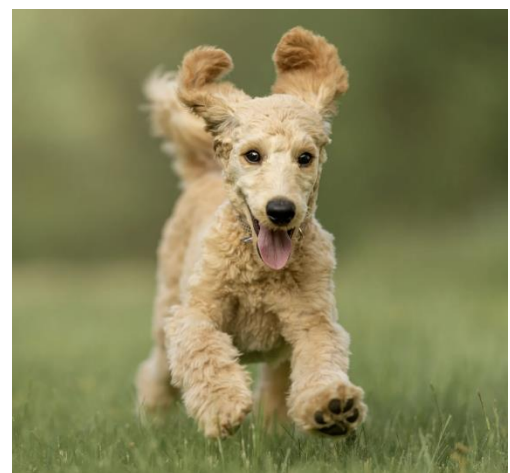

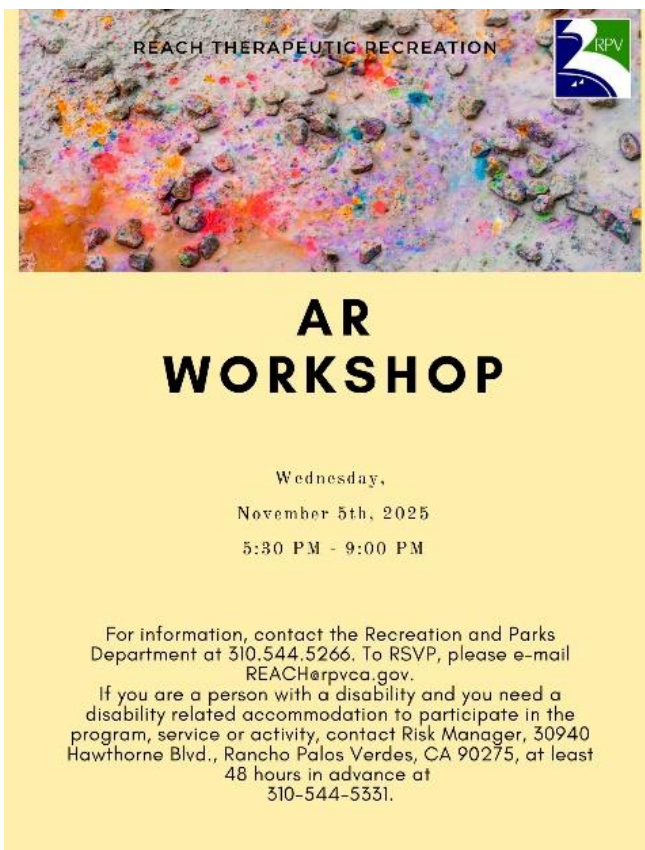

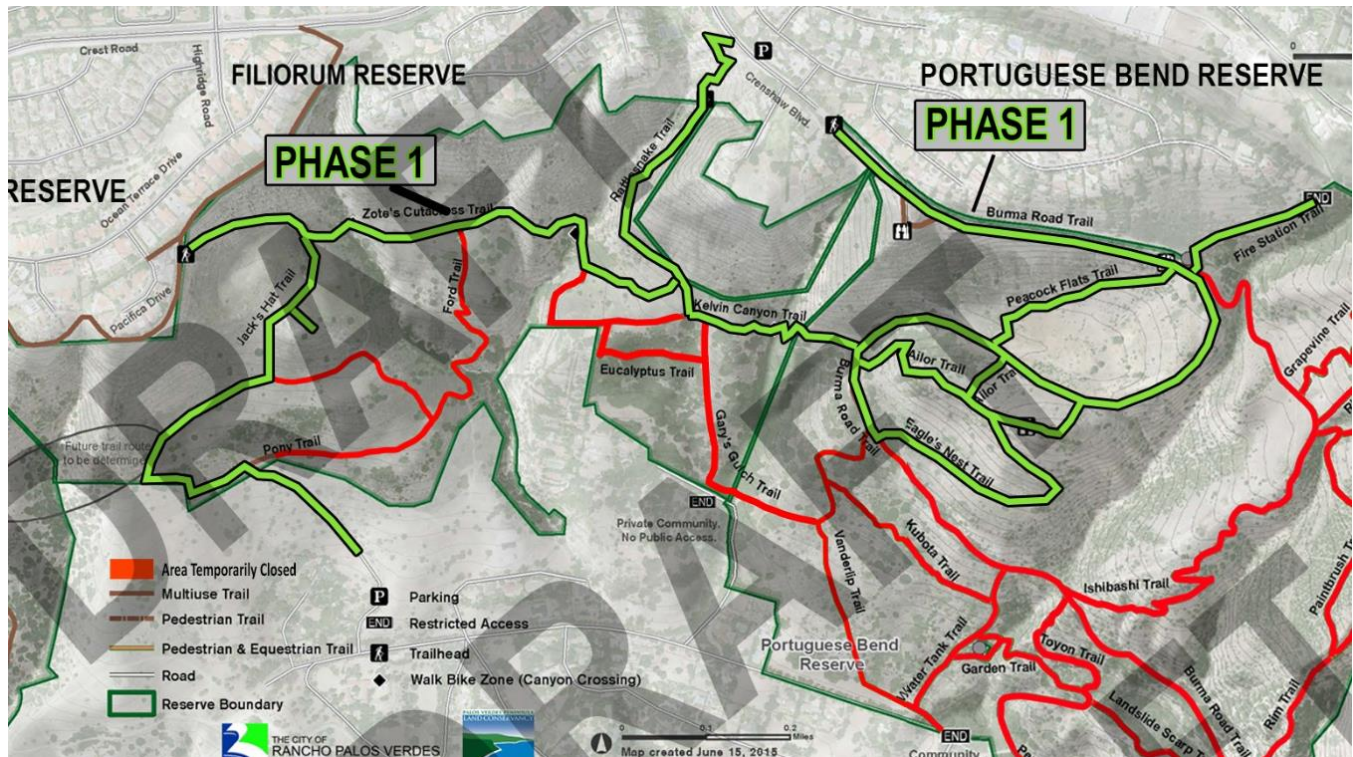

## **Palos Verdes Nature Preserve Partial Trails Re-opening Plan**

At the October 23 Palos Verdes Nature Preserve Public Forum, City Staff shared the City's goal to reopen five miles of trails currently closed due to landslide-related activity by December 1, 2025. These trails include some trails within Portuguese Bend Reserve

and Filiorum Reserve and are approximately 5 miles in length. City Staff alongside Palos Verdes Peninsula Land Conservancy Staff and Volunteers have inspected and repaired several miles of trails and are continuing to perform work to meet this goal.



## City Applies for Two Grants to Improve Landslide-Impacted Trails and Habitat

Open Space and Trails staff have partnered with Public Works staff and Blais and Associates to submit two grant applications to the Los Angeles County Regional Park and Open Space District (RPOSD) Measure A Program to improve trail accessibility and connectivity and habitat restoration within the Portuguese Bend, Filiorum, and Three Sisters Reserves.

The first grant application is for the Palos Verdes Nature Preserve Restoration Project under the Natural Lands, Local Beaches, Water Conservation and Protection Grant Program. This grant would include partnering with the Palos Verdes Peninsula Land Conservancy to perform 25 acres of habitat restoration and 4.5 miles of trail improvements within landslide-impacted areas of the Preserve.

The second grant application is for the Three Sisters-Filiorum Reserves Connector Project under the Planning and Design Grant Program. This project involves the



planning and design of a trail that would connect the Three Sisters Reserve and Filiorum Reserves. This trail has been long-envisioned in the Preserve Public Use Master Plan as a vital connection point between these two Reserves; however its realization has been delayed due to the challenging terrain in the area. This grant project will help analyze how to create a multiuse connector trail/canyon crossing, which may be in the form of a multiuse bridge. Once the planning and design process is complete, the City would seek funding sources to build the trail. This connector trail would greatly enhance trail connectivity and access, which is especially needed because of the many miles of landslide-related trail closures in the vicinity.

Whether for emergency communication, communicating around the world, or learning a bit about electronics, there's nothing else like amateur radio (also known as "ham radio"). Amateur radio operators have long provided communications "when all else fails" during disasters. With a short course they can join over 710,000 men, women, and children in the United States from all walks of life who are license to operate ham radios. At the start of the Technician license course, a member of the Palos Verdes Amateur Radio Club will give a 30-minute presentation on what ham radio is all about and what the many benefits of being a "ham" are.

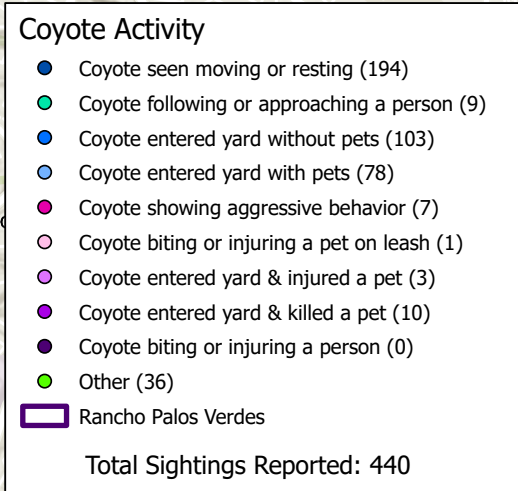

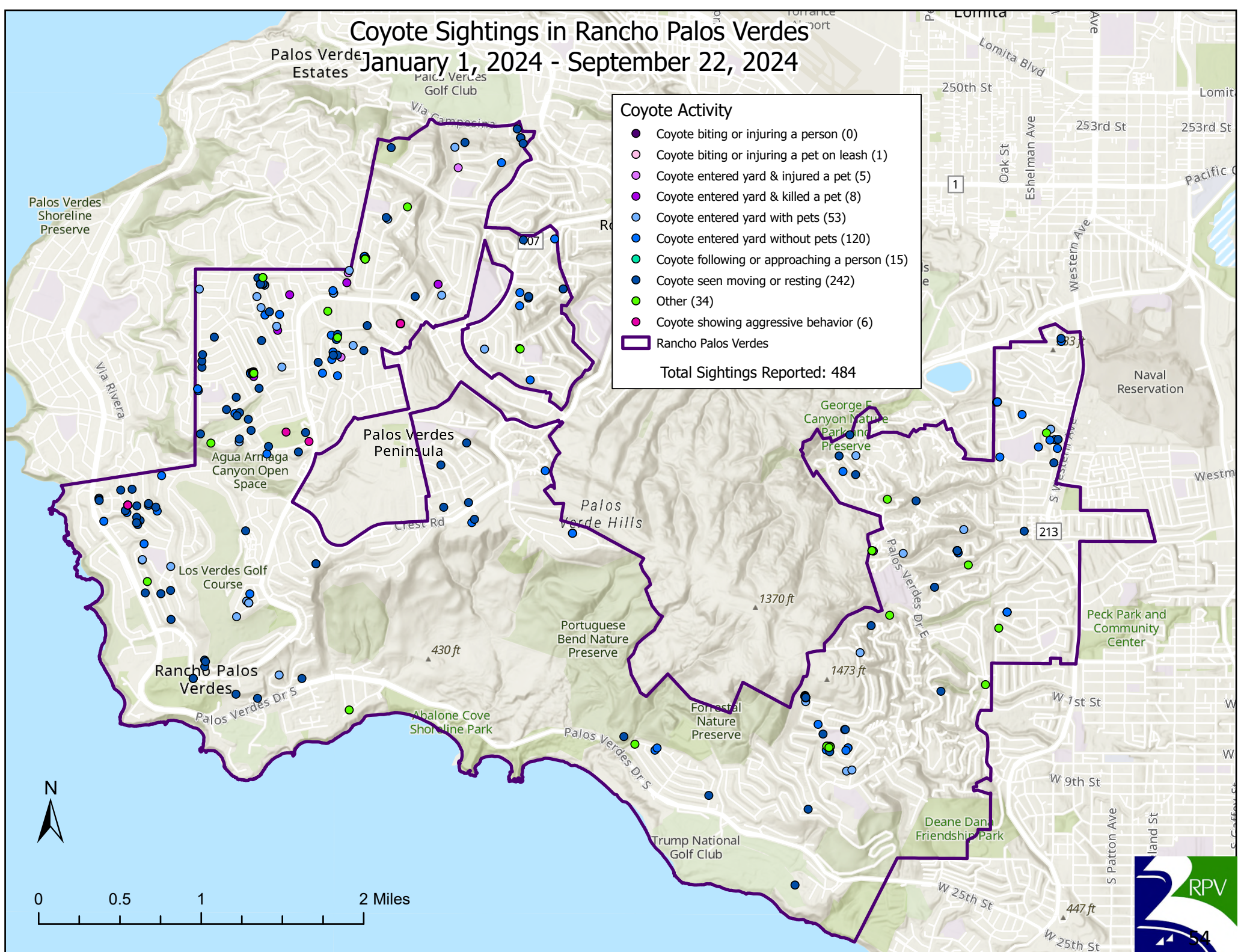

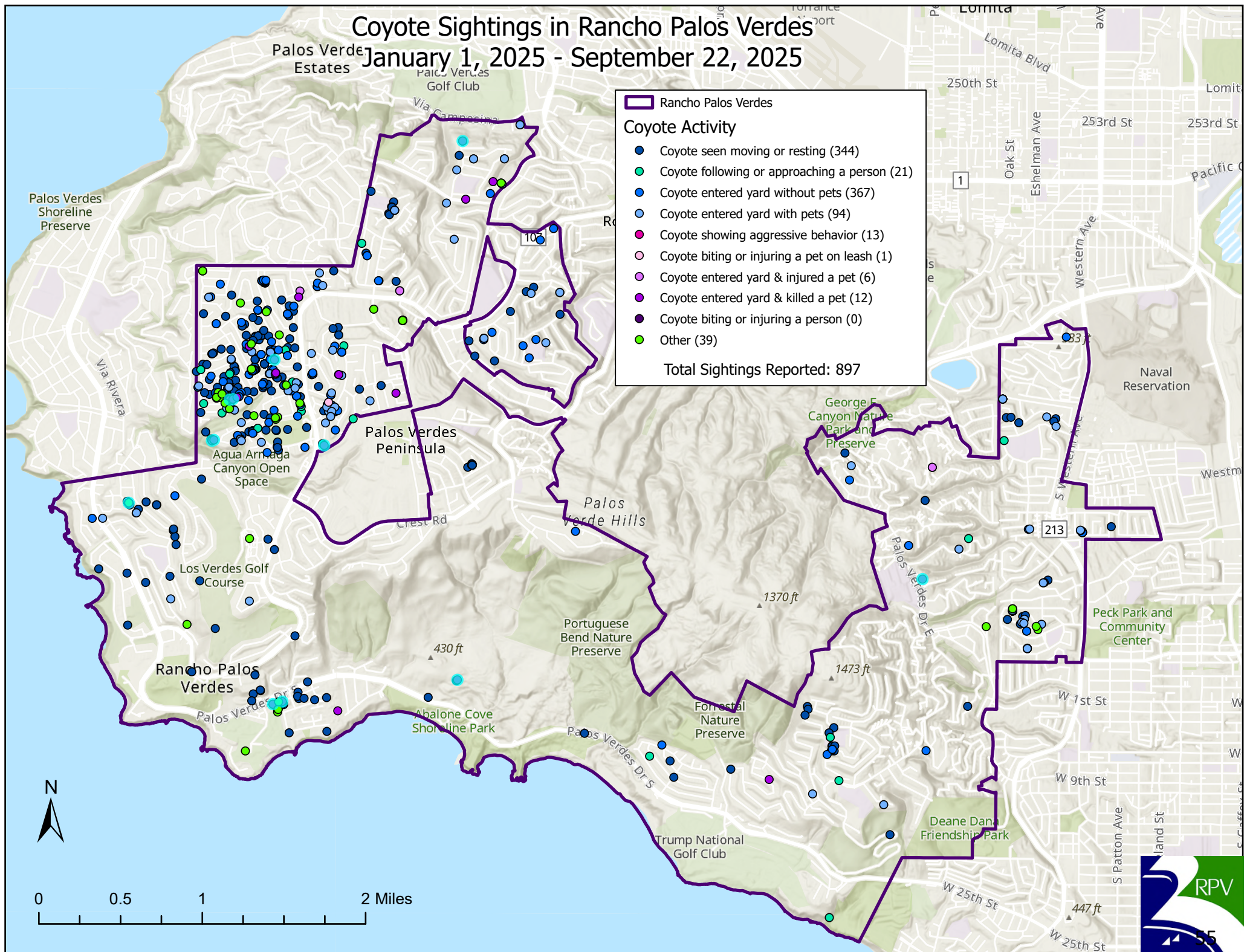
