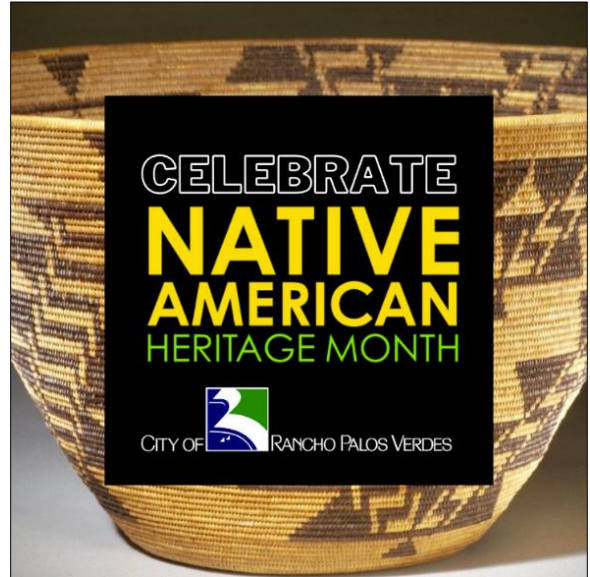

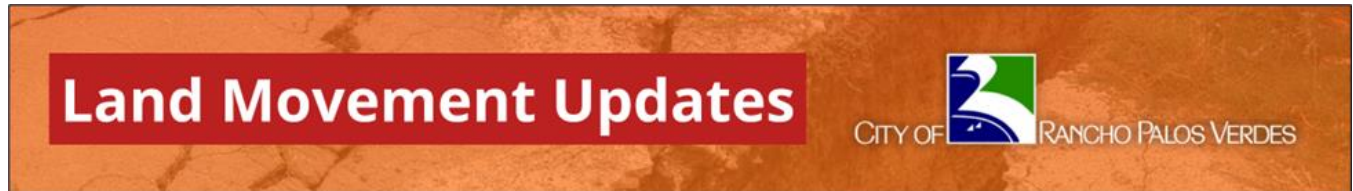
November 4, 2025 City Council Meeting Highlights

- City staff gave the latest updates on the landslide emergency.
- Since August, land movement decelerated by an average of 29% in the Abalone Cove Landslide, by 26% in the Portuguese Bend Landslide, and by 30% in Upper Altamira. The Klondike Canyon Landslide has not moved for one year.
- The City expects to complete “winterization” work — measures designed to prevent rainwater from infiltrating into the ground — in Upper Altamira Canyon and Portuguese Canyon by late November or early December. Winterization work in Klondike Canyon and the Seaview neighborhood is complete and maintenance is ongoing.
- The Council renewed for 60 days the local emergencies in the landslide area and the temporary prohibition of motorcycles and bicycles along a two-mile stretch of Palos Verdes Drive South.
- Finally, City staff gave an update on the implementation of the City’s Public Safety Division, which will supplement Sheriff’s Department services in RPV.
- The Division has been actively engaging with the community, building relationships and coordinating with partner agencies during large events. In the coming months, it will continue to build on this momentum through a series of



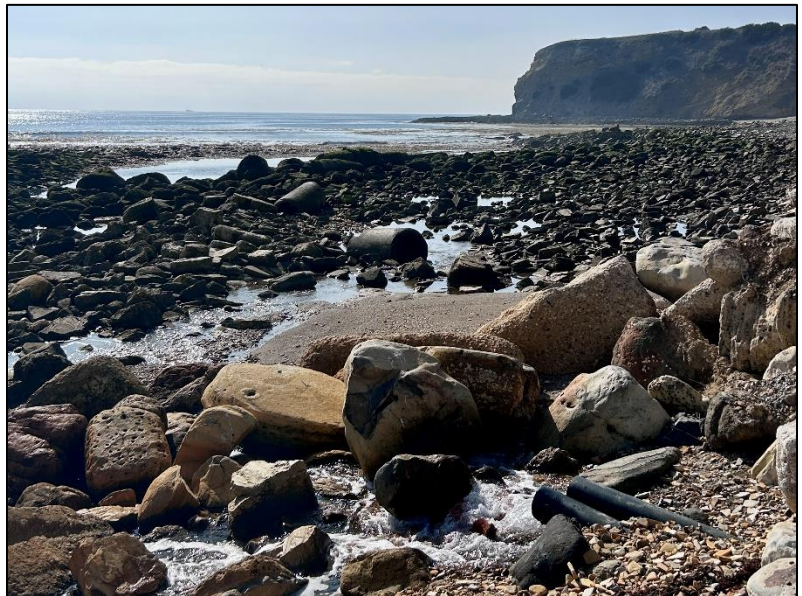
focused initiatives, including a comprehensive crime suppression and community outreach plan centered on addressing residential and vehicle burglaries.

November 4, 2025 City Council Meeting Discussion Recap

At last night's City Council meeting, City staff gave a comprehensive update on the landslide emergency and the impact of deep dewatering wells. From September-October 2025, movement continued to slow considerably, decreasing from an average rate of 1.8 inches per week within the active landslide area, to 1.46 inches per week. As a reminder, Southern California Edison (SCE) previously stated that a continued and sustained reduction in land movement near its electrical infrastructure to less than 1 inch per week would be necessary for the utility to consider re-energizing the Portuguese Bend Community Association neighborhood, which has been without service since September 2024.



A deep dewatering well on the beach removes groundwater at the toe of the Portuguese Bend Landslide.

The City's deep dewatering wells have removed over 370 million gallons of groundwater from the toe of the Portuguese Bend Landslide since last fall, with eight wells currently pumping out approximately 1 million gallons per day. The Klondike Canyon Landslide Abatement District's two deep dewatering wells are removing approximately 400,000 gallons per day, and the Abalone Cove Landslide Abatement District's 16 dewatering wells (including seven original wells and nine deep dewatering wells) are removing

approximately 165,000 gallons per day. The combined dewatering efforts are believed to have had a dramatic impact on reducing land movement.

City staff continues to “winterize” Upper Altamira Canyon and Portuguese Canyon for the rainy season, with this work expected to be completed by late November or early December. Staff is performing maintenance elsewhere in the landslide area where these measures are already in place.

Finally, the Council renewed for 60 days the local emergencies in the landslide area and the temporary prohibition of motorcycles and bicycles along a two-mile stretch of Palos Verdes Drive South.

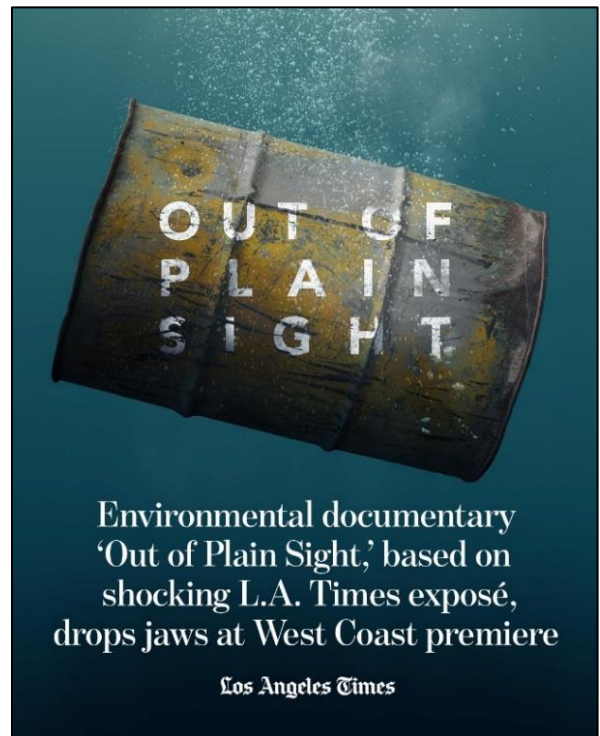

San Pedro International Film Festival to Screen Documentary on DDT Dumping

The San Pedro International Film Festival, which takes place November 7-9 in RPV and San Pedro, will present a screening of a Los Angeles Times documentary about deep-water chemical dumping off the coast of the Palos Verdes Peninsula.

From the Los Angeles Times and Pulitzer Prize-finalist Rosanna Xia, “Out of Plain Sight” is a cinematic exposé of an environmental disaster lurking just off the coast of Southern California. Not far from Catalina Island, aboard one of the most advanced research ships in the world, David Valentine discovered a corroded barrel on the seafloor that gave him chills. The full environmental horror sharpens into greater clarity once he calls Xia, who pieces together a shocking revelation: In the years after World War II, as many as half a million barrels of toxic waste had been quietly dumped into the ocean – and the consequences continue to haunt the world today.

November 5 is Tsunami Awareness Day

All California coastline faces some tsunami risk, including the beaches and low lying areas in L.A. County and RPV.



When time allows, you may receive notifications about Tsunami watches, advisories, or warnings. Always follow official instructions.


- **Tsunami Watch:** A tsunami may occur, be alert.
- **Tsunami Advisory:** A tsunami is expected, get out of the water and stay away from beaches and coastline.
- **Tsunami Warning:** A tsunami is likely to cause widespread damage, evacuate the coastline immediately, moving inland and/or to higher ground.

You may not receive a notification for all tsunamis, especially localized ones. Pay attention to natural tsunami warnings such as:

- Feeling a strong or long earthquake
- Seeing a sudden rise or fall of the ocean
- Hearing a loud roar from the ocean


If you suspect a tsunami, even if you have not received a warning, move quickly to higher ground further inland and do not return to the coastline until officials say it is safe.

Important Beach Safety: *How to spot a rip current and how to escape a rip current if you are caught*



Spotting Rip Currents:

- Look for a **churning** motion in the water, or a **difference in water color**
- Look for a smoother area where the waves aren't breaking, or a **line of foam** going out to sea





Escaping Rip Currents

Stay calm and don't swim against the current

Swim in a direction following the shoreline, then at an angle toward the beach


If you need help, call or wave for assistance



If you don't feel comfortable about your ability to spot (and avoid) Rip Currents, swim only on lifeguarded beaches. Ask the lifeguard if or where it is safe to swim!

Rip Current Safety

If you are caught in a rip current,

- Stay calm and don't fight it
- Swim parallel to the shore until you are out of the current or float/tread water until you are free of the rip current and then head to shore.
- If you can't get out of a rip current or are otherwise in danger while in the water, try to draw attention by waving and calling for help.

FINANCE DEPARTMENT

Finance Department

At the close of the first quarter of the Fiscal Year (through September 30, 2025), the City’s General Fund revenues and expenditures continue to track as expected. This report presents a summary of budgeted revenue sources and expenditures by department, compared to the adopted budget and the revenue and expenditures of those categories for the same time last fiscal year. A more comprehensive report was presented to the City Council at its regularly scheduled meeting on November 4th.



General Fund Revenues – through September 30, 2025

Through the first quarter of the fiscal year, the City has received approximately \$6.8 million in General Fund revenues, representing approximately 16.3% of the FY 2025-26 adopted revenue budget of \$41.8 million. This is slightly below last year’s revenue, after adjusting for last year’s one-time grant from Los Angeles County. Revenues are expected to align with projections for the year, and Staff will continue to monitor trends closely and provide monthly updates.

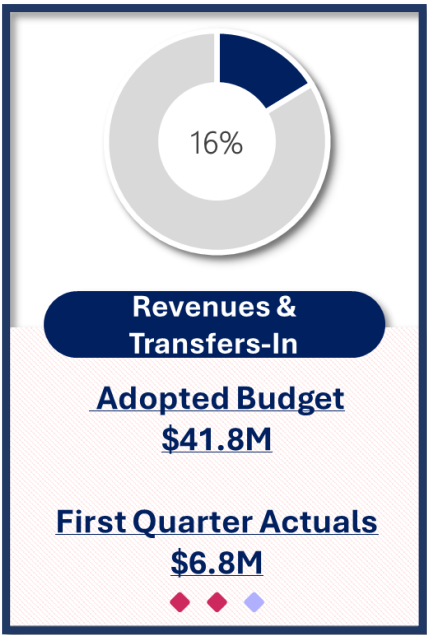
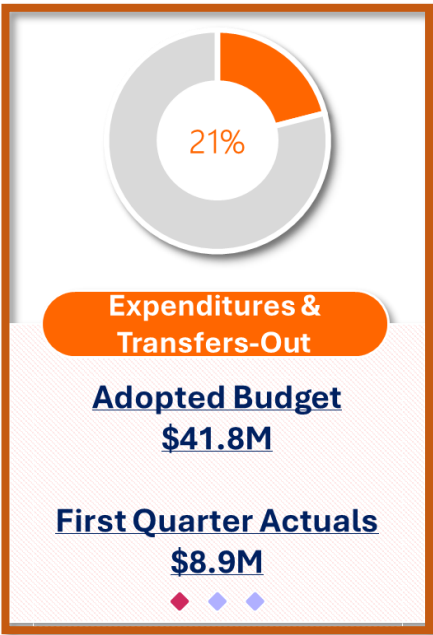
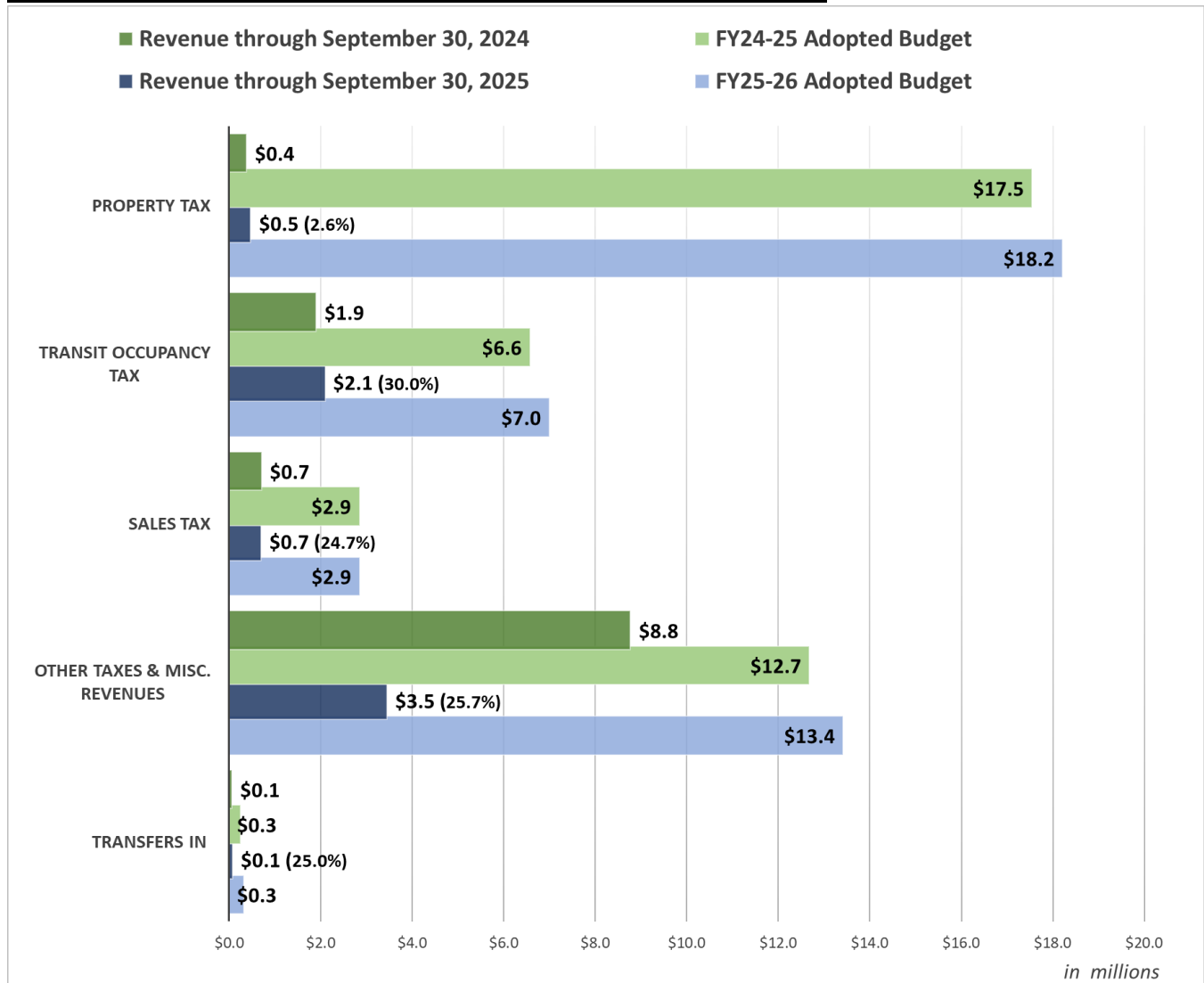


Chart 1 below provides an overview of revenues for the first quarter of FY2025-26:

Property Tax

Property tax revenue totaled approximately \$470,200 through the first quarter, or 2.6% of the \$18.2 million adopted budget. This is slightly higher than the 2.2% collected in the same quarter last year. Revenues increased by about \$86,600 (22.6%) year-over-year, driven by higher secured property taxes, stronger property transfer tax receipts, and the timing of in-lieu-of revenue distributions from Los Angeles County. As in prior years, the majority of secured property tax revenue will be received in December and June.

Transient Occupancy Tax (TOT)

First quarter TOT totaled just under \$2.1 million, representing 30% of the \$7.0 million adopted budget. This reflects an increase of approximately \$194,000 compared to the

same period last year, due to continued strong performance from Terranea and stable lodging demand citywide. Current results are slightly ahead of last year's pace.

Sales Tax

Sales tax revenue totaled approximately \$704,700 through the first quarter, which is nearly identical to the same amount collected at this point last year. This reflects stable consumer spending and aligns with adopted revenue projections.

Utility User Tax (UUT)

UUT revenues totaled approximately \$789,800, representing 32.1% of the budget for this category. This is an increase of roughly \$55,500 compared to the same period last year and reflects consistent utility consumption and moderate rate adjustments.

Other Taxes and Miscellaneous Revenues

This category totaled just over \$1.3 million through the first quarter. This amount is down compared to last year due primarily to a one-time \$5 million landslide recovery grant received last year during Q1. When adjusting for this one-time grant, revenues are lower by about \$497,000. Interest earnings remain relatively strong, but some timing variances (including a fair value adjustment recorded in October instead of September this year) impact the year-over-year comparison.

General Fund Expenditures

General Fund expenditures and transfers for the first quarter totaled approximately \$8.9 million, which is 21.5% of the adopted budget of \$41.8 million. This is an increase of about \$756,000 compared to the same period last year, driven largely by filled vacancies, cost-of-living increases, the City's annual prepayment of the CalPERS unfunded liability, and higher tax assessments. Non-personnel costs increased approximately 12.2% due to timing differences in invoices, the Sheriff's contract escalation, and scheduled maintenance activity.

Transfers-out totaled \$1.4 million, slightly lower than last year due to timing and lower programmed transfers in the adopted budget.

Overall expenditures remain consistent with the timing and spending patterns anticipated in the adopted FY 2025-26 budget.

The following departments show the largest changes:

Public Works

Expenditures in Public Works are about \$615,000, or 49.3%, higher when compared to last year. This represents 22.7% of the adopted budget for FY2025-26. As reported last month, the increase is largely attributed to previously vacant positions that are now filled, along with higher budgeted citywide maintenance, professional services, and facility repairs.

Non-Departmental

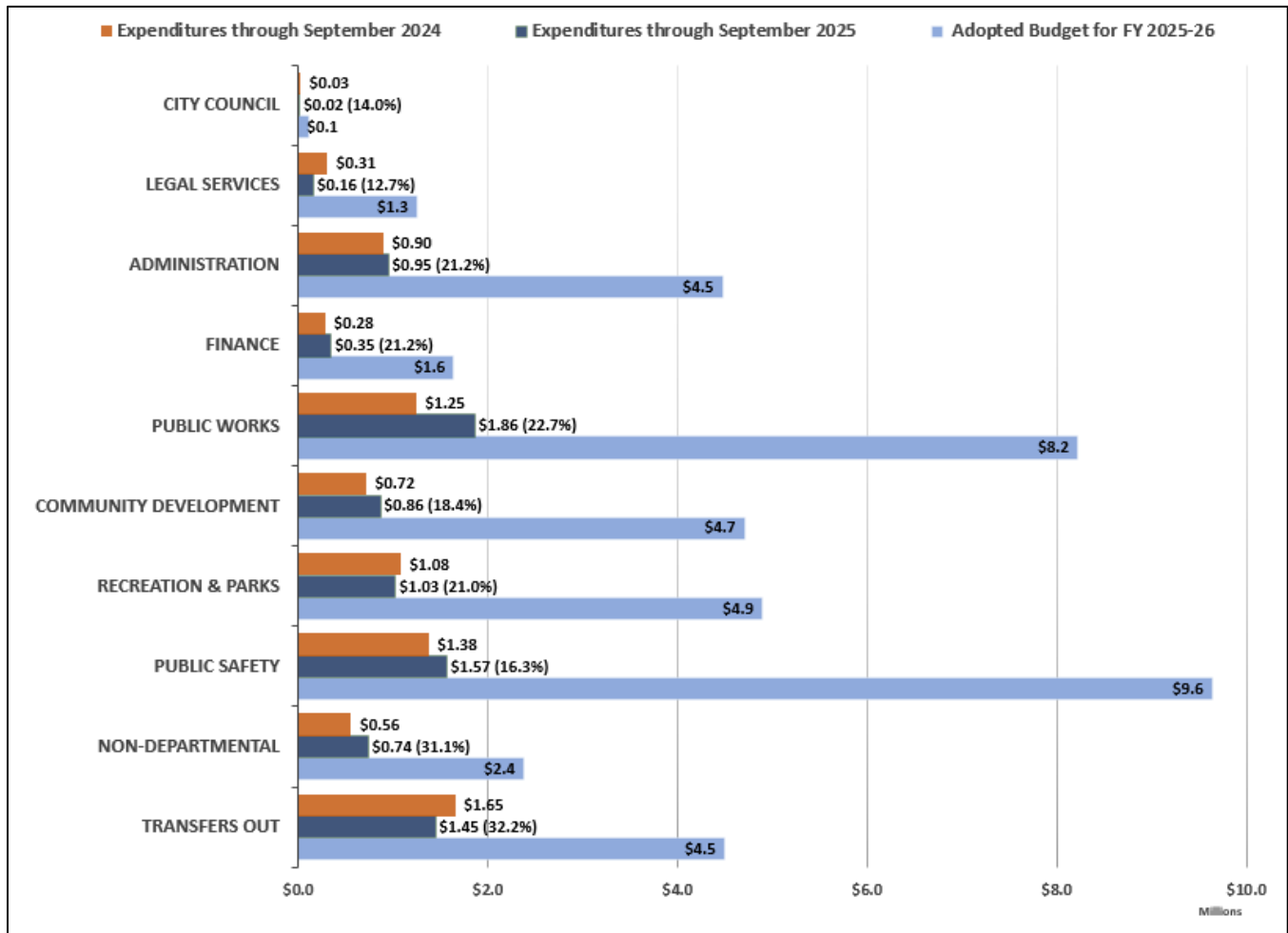
Expenditures in this category totaled slightly less than \$739,000, representing 31.1% of the adopted budget for FY2025-26. This is approximately \$181,000 higher than last year, where the first quarter expenditures represented 26.0% of last year's adopted budget.

Finance

Expenditures in the Finance Department for the first quarter were \$348,000, representing 21.2% of the adopted budget for the department. The 23.1% increase over last year's first quarter expenditures of \$283,000 is attributed to filled positions that were vacant last year.

Case-Shiller Home Price Indexes – August 2025

On October 28, 2025, data from the S&P CoreLogic Case-Shiller Home Price Indexes, the leading measure of residential real estate prices, was released for August 2025. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indexes.

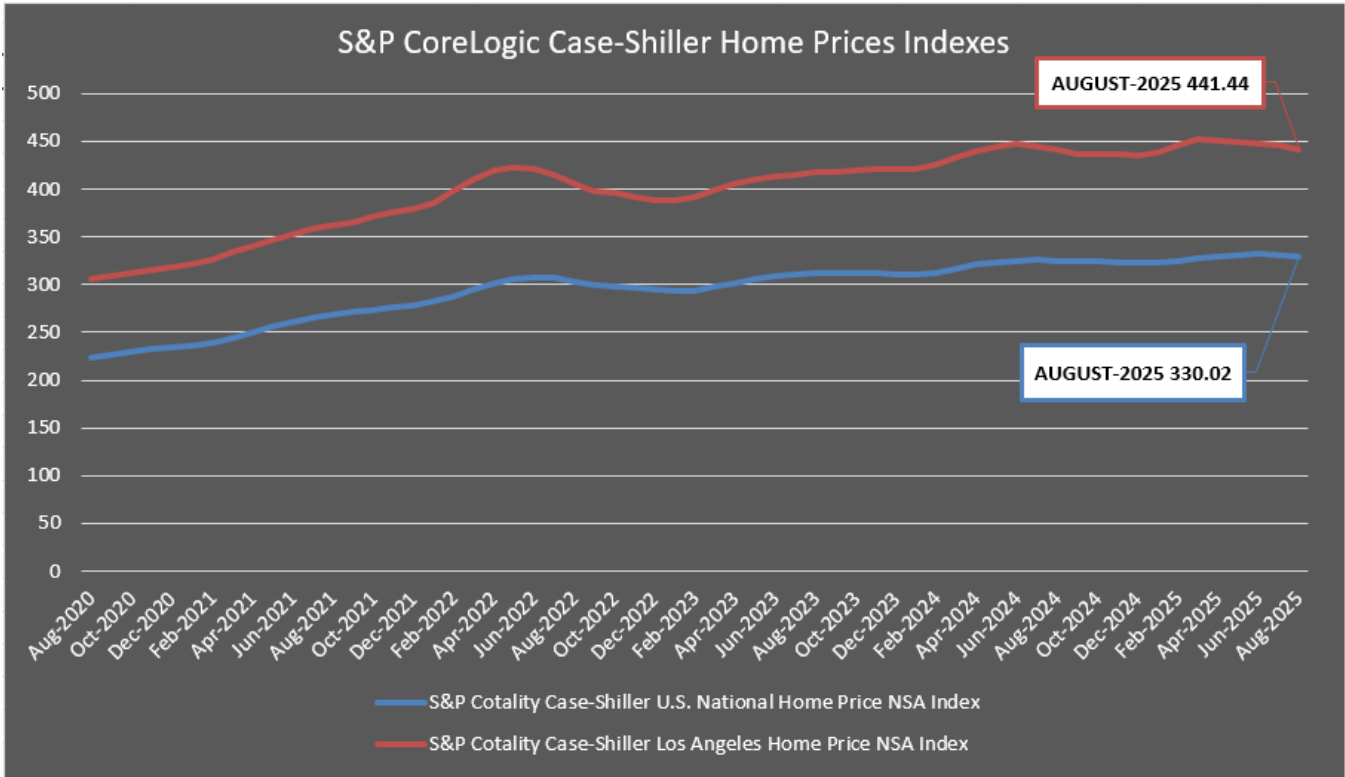
Month-over-Month

The pre-seasonally adjusted U.S. National Index reported a slight decrease of -0.3%. The 10 City Composite and 20 City Composite Indexes both reported drops in August 2025, at -0.6%, respectively. After seasonal adjustment, the U.S. National Index, 10 City Composite and 20 City Composite all posted a month-over-month increase of 0.2% for August 2025. A small but noticeable increase from the -0.1% decrease reported in July 2025.

Year-over-Year

The National Index reported a 1.5% annual return in August 2025, down from a 1.6% annual return in July 2025. At -0.01%, the annual loss for Los Angeles was significantly lower than the national average gain. Among the 20 cities in the indexes, New York again reported the highest annual gain with a 6.1% increase in August 2025. Chicago and Cleveland also reported higher than average annual increases of 5.9% and 4.7%, respectively. Many Western markets posted significant losses, including: Phoenix, San Francisco, Denver, San Diego, and Portland for August 2025.

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **640 gallons per minute** or approximately **0.9 million gallons per day**.
- Since the start of the DDW program, approximately **375 million gallons** or **1,150 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-9 is currently offline due to low water level. City crews have completed making adjustments to the pump's operation to minimize the risk of it running dry and burning out. The well is expected to be operational again by the end of the week.

Status of Winterization:

Construction work continues this week on winterization measures. The work is anticipated to be complete by the of end-November/early-December.

Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update

On March 4, 2025, the City Council awarded a construction contract to install a left turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. Since that time, the construction contractor has been ordering and acquiring long lead items like the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On Monday, October 6, 2025 construction activities began at the intersection. The project will include the following improvements:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns lanes.
- Traffic signal hardware and equipment updates including a new traffic cabinet

and signal controller; upgraded traffic signal mast arms to accommodate the new left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

To minimize traffic disruptions, work hours are generally Monday – Friday from 9am to 4pm. Construction is anticipated to be complete by the end of the year.

Another Successful Drive-Thru Document Shred, Electronic Waste and Mulch Event – October 25, 2025

The City of Rancho Palos Verdes and its solid waste contractor, EDCO, offered a drive-thru document shredding event on Saturday, October 25, between 8AM to 11AM.

Public Works welcomed a total of 932 vehicles, shredded 12 tons of confidential or sensitive documents, collected 4.97 tons of unwanted Electronic Waste (computers, TVs, printers, etc.), and provided 17.16 tons of compost for residents to self-serve, self-load, and self-haul.

Traffic Safety Committee (TSC) Special Meeting Recap – November 3, 2025

A special TSC meeting was held on November 3 at 6 p.m. Highlights of the key agenda items are as follows:

Point Vicente Elementary School Traffic Calming

The TSC adopted a motion (5-0) recommending the implementation of the following traffic calming measures:

1. Install a School Children Crossing sign with the “SCHOOL” plaque at the centerline of the school driveway exit at Rue La Fleur.
2. Extend the white curb drop-off zone westward to the existing red curb on Rue La Fleur.
3. Improve the crosswalk at the intersection of Rue Langlois/Rue La Fleur/Rue De La Pierre as recommended in the 2020 Palos Verdes Peninsula-wide Safe Routes to School Plan by extending the curbs at the intersection into the parking path of the roadway and installing a curb ramp to the crosswalk on the east leg of the intersection.
4. Add red curb at the intersections around the school site.
5. Install a raised crosswalk across Rue La Fleur by the school exit driveway.
6. Add “School” flashing signs as deemed appropriate by a traffic engineer.

7. Prioritize the area for enforcement.
8. Perform an after-installation study.

Cornerstone Elementary School Traffic Calming Update

The TSC adopted a motion (5-0) recommending the implementation of the following traffic calming measures:

1. Install 25 mph speed limit signs in the vicinity of the school on the downhill sections of Groveoak Place and Springcreek Road.
2. Install a modular raised crosswalk on Groveoak Place in front of the school.
3. Replace faded parking signs, as appropriate, in the study area.
4. Study a potential crosswalk where Springcreek Road turns into Groveoak Place.

Avenida Classica Traffic Circles Pilot Project Update

The TSC adopted a motion (3-2) to receive and file the petition to remove the Avenida Classica Traffic Circles Pilot Project and recommend to the City Council to continue with the Avenida Classica Traffic Circles Pilot Project and implement the modifications recommended by Staff, which include the following:

- A. Convert both intersections to all-yield intersections to reduce confusion of right-of-way.
- B. Install delineators and Botts' dots to the entrances of the traffic circles to prevent errant left turns and further slow vehicles as they enter the intersections.
- C. Installing advanced signage, as determined by a traffic engineer.

Infrastructure Management Advisory Committee (IMAC)

An IMAC special meeting is scheduled for November 17 at 6:00 p.m. in the Community Room located at the Ken Dyda Civic Center. The public is welcome and encouraged to attend and provide input. The agenda will be available on the City's website at rpvca.gov/agendas by November 14 at 4:30 p.m. Tentative agenda items include an update on reopening trails within the Landslide Complex, discussion of the Water Reuse Subcommittee's feasibility study for reusing water extracted by the City's deep dewatering wells, and an update on the City's Western Avenue Traffic Flow Improvements Project.



- This week, the following resident service requests were submitted to the City and addressed by staff and/or contractors:
 - **48** service requests were reported.
 - **27** service requests were completed and closed out.

 - Cleaned and removed debris along Ladera Linda steps to Seaview neighborhood to ensure pedestrian safety.
 - Installed new larger ADA door access system and motor system to improve accessibility for visitors at City Hall.





- This week, ROW maintenance crews conducted landscape cleaning, weed whacking, and general landscape maintenance along medians and the public right-of-way throughout various City areas. Work locations included:
 - Calle Entradero Parkway and right-of-way
 - Western Avenue center medians and right-of-way
 - Palos Verdes Drive South center medians and right of way from 25th Street City limit to Forrestal Drive.
- This week, the irrigation team completed inspections, repairs, and system upgrades at these locations:
 - Adjusted irrigation system for the winter season and repaired broken sprinkler near the playground at Hesse Park.
 - Adjusted irrigation system for the winter season at Ryan Park.
 - Replaced one valve in the center field and replaced a broken sprinkler near the restrooms at Point Vicente Interpretive Center.

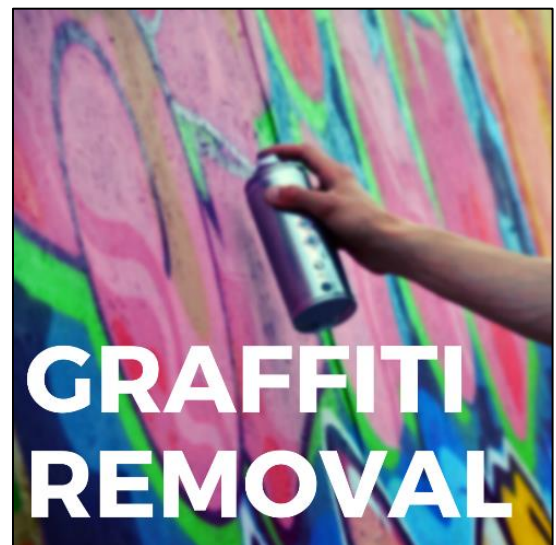

and 5:00 P.M. on Saturday. No such activity shall be permitted on Sundays, or the legal holidays (within the city's permitted construction hours), unless a Special Construction Permit is approved by the Community Development Director. Western Plaza Remodel Update

Community Development Department Staff received several complaints and concerns regarding sidewalk inaccessibility due to on-going construction at the corner of Trudie Drive and S. Western Avenue. Although related to the recently completed Western Plaza Shopping Center and parking lot remodel, the delay in finishing this component of the project is related to Caltrans-required permits. Staff recently received updated information from the property owner noting that Caltrans permitting was recently completed with some final corrections still pending. 2025 Building Code Adoption

On November 18, the City Council will consider the adoption of an ordinance to update the City's Building Code to the 2025 California Building Standards Code. The adoption of the ordinance is part of a three-year cycle, in which the California Building Standards Commission updates the Uniform Codes that govern construction practices in the State

of California. After the State Building Code is published, every City and County throughout the state must adopt these Codes, with an opportunity to include more stringent local amendments based on local geological, topographical and/or climatic conditions.

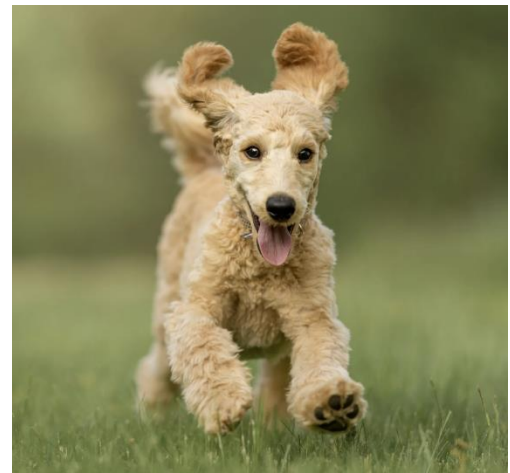
Pet Adoptions Purred Along Purrfectly at Eastview Park

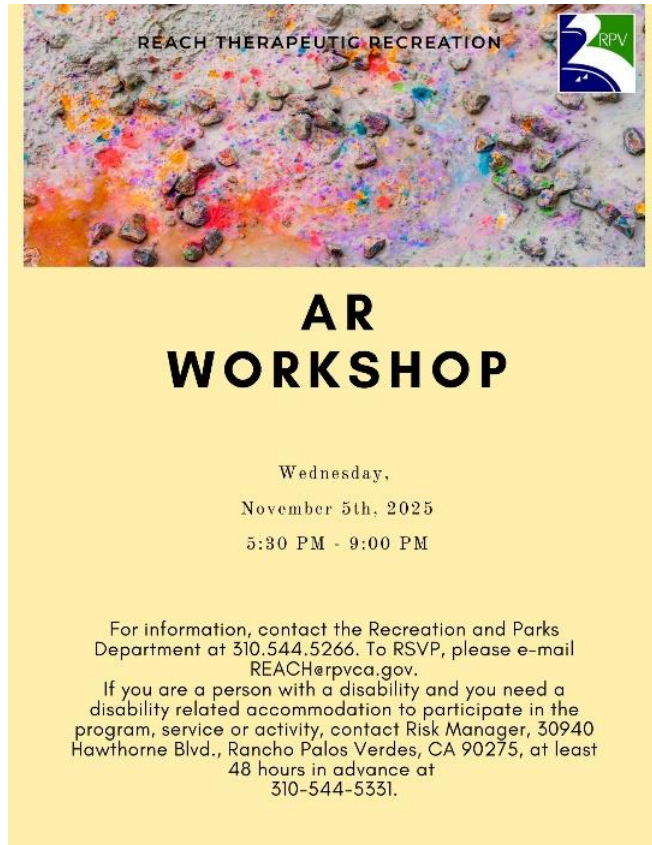

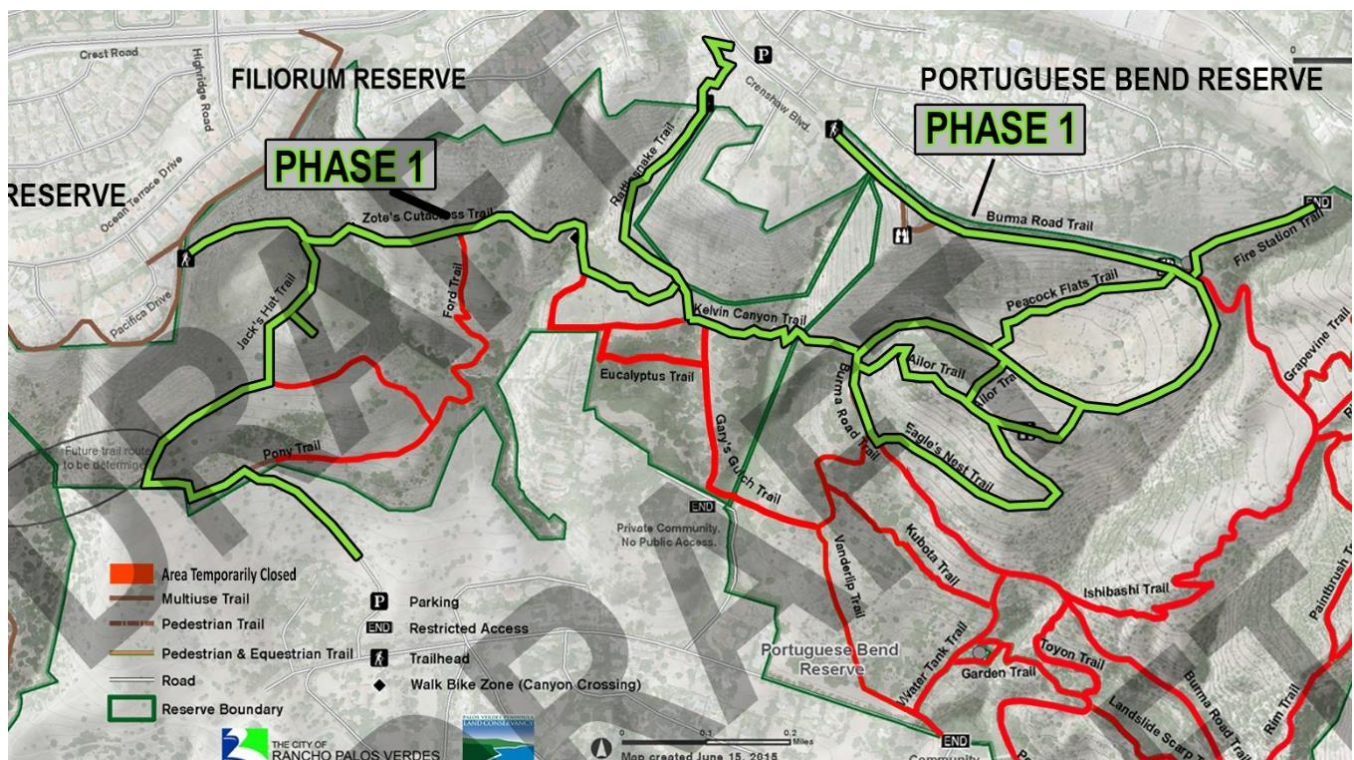
