City Hall Closed on November 27-28 Due to Thanksgiving

City Hall will be closed on November 27-28 due to the Thanksgiving holiday.

Staffed City parks will be closed only on Thanksgiving Day.

There will be no trash collection on Thanksgiving Day, and collection for the Thursday and Friday routes will be delayed by one day. There will be no street sweeping on Thanksgiving Day, and the Thursday route will be performed on Wednesday, November 26.

November 18, 2025 City Council Meeting Highlights

- To align with updated state law, the Council introduced an ordinance exempting equestrian districts from SB 9, which requires cities to allow homeowners to split their single-family lot in two and build up to two new housing units on each lot with streamlined “ministerial” approval.
- RPV’s Equestrian Overlay District covers four areas, including Rolling Ridge Road/Via Campesina, a portion of Crestridge Road, the Portuguese Bend Community Association, and the northern portion of Palos Verdes Drive East between approximately Miraleste Intermediate School and the boundary with Rolling Hills Estates.
- The Council introduced an ordinance updating the City’s General Plan to reflect the recently implemented development regulations for the landslide area, where new residential construction is prohibited. Updating the General Plan ensures cross-references are aligned with the new provisions.
- Finally, City staff gave an update on wildfire mitigation and readiness projects in the City.
- This includes a routine update of the City’s Emergency Operations Plan, a document used to ensure City facilities and staff are ready to respond to any size and type of wildfire.
- Staff recently trained on such a scenario with an all-day functional exercise simulating a major wildfire.
- Other efforts include implementing a fire weather protocol to provide guidance on actions the City will take during Red Flag Warning days, coordinating with neighboring cities and public safety agencies, participating in community outreach events, and making grant funding requests to strengthen wildfire mitigation and readiness.

Council Honors Phantom Cubs and Phantom Botz for LEGO League Wins

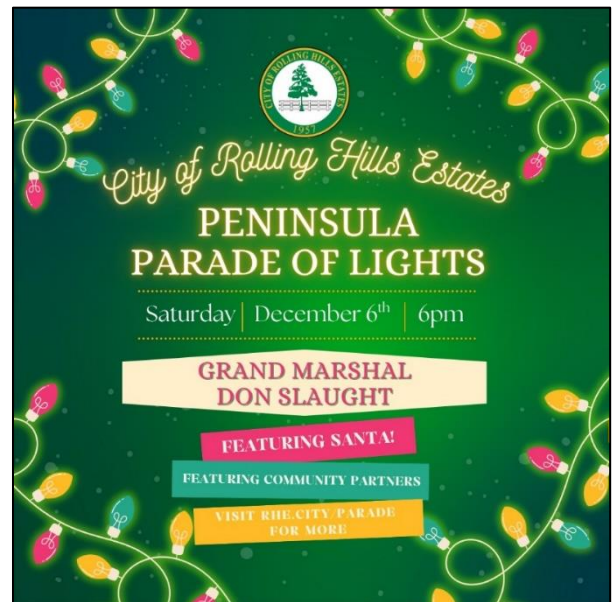

Apply for a Public Safety Reimbursement from the City

FAC Meeting Recap

In the latest meeting of the Finance Advisory Committee (FAC) held on November 13th, several key items were discussed.

Line of Credit Option Review

The Committee received a report and presentation from Staff, detailing the explored line of credit options with the City's operating Bank, BMO. The Committee approved for Staff to explore the line of credit options as part of the City Council Policy No. 52, Debt Management Policy review. Based on the current market conditions at high interest rates and approximately \$50,000 costs to open and maintain a line of credit of approximately \$5 million, the FAC voted to receive and file the report.



The goal for this item was for Staff to explore and learn about the City's different options in case of an emergency, and based on the findings, additional research is not necessary at this time.

Other FAC items

FAC also received presentations from Staff on the City's Consolidated Loan to the Redevelopment Agency and the FY2025-26 First Quarter Financial Report for General Fund.

The next FAC meeting is scheduled for December 18th, in the Community Room at the Ken Dyda Civic Center, 30940 Hawthorne Blvd. The tentative agenda will include:

- Review and provide feedback/recommendations regarding the Biannual Report;
- Consideration and possible action to receive and file the FY 2025-26 Year-End Unaudited Financial Report;

- Update the Fiscal Year 2025-26 FAC Workplan. To include creating a framework for a financial plan.

Do You Need a City Business License?

The City of Rancho Palos Verdes collects applications and issues certificates to businesses that operate within the City's jurisdiction. As defined in the City's Municipal Code, [5.04.015](#), any business that provides services (including construction), supplies, or equipment to any individual or to any entity within the city, and which has any physical presence within the city, however fleeting, shall obtain a business license. Business licenses are renewed in January and expire in December of each calendar year. The applicable business license tax is determined by the business type, which includes In-City Business, Home Occupancy, Out of City Business, General Contractor, Subcontractor and others.

FAQ

Do I need a business license if I operate a non-profit organization?

Non-profit organizations are exempt from business license taxes if they can provide proof of non-profit status by the IRS under section 501(c)(3).

Are all my employees covered under my business license?

Yes. Employees of a business are covered under an active business license. However, contracted workers need their own business license. This commonly applies to real estate agents, hairdressers and physical therapists who can operate as independent contractors within a business.

Is there a penalty fee for late renewals?

Yes. Per the municipal code, [5.04.220](#), a late fee of 5% is applied to the business license tax for each month past the renewal period. With a maximum late fee of 50% the regular business license tax.

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **680 gallons per minute** or approximately **1.0 million gallons per day**.
- Since the start of the DDW program, approximately **388 million gallons** or **1,190 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - All DDWs are currently online and extracting water.

Status of Winterization:

Construction work continues this week on winterization measures. The work is anticipated to be complete by end-November / early-December.

Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update

On March 4, 2025, the City Council awarded a construction contract to install a left turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. Since that time, the construction contractor has been ordering and acquiring the long lead items like the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On Monday, October 6, 2025 construction activities began at the intersection. The project will include the following improvements:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns.
- Traffic signal hardware and equipment updates including a new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new

left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

To minimize traffic disruptions, work hours are generally Monday – Friday from 9am to 4pm. Construction is anticipated to be complete by the end of the year.

****UPDATE**** The delivery of the traffic signal poles have been delayed. No early work will occur the week of November 24. To keep the project on schedule, construction will continue within the intersection, weather permitting. Please use caution while driving through construction zones.

 - Sealed and cleaned gutters at the Point Vicente Interpretive center.



STREET LANDSCAPING

- This week, ROW maintenance crews conducted landscape cleaning, weed whacking, and general landscape maintenance along medians and the public right-of-way throughout various City areas. Work locations included:
 - Crenshaw Boulevard center medians and right of way
 - Whitley Collins Drive and Highridge Road center medians and right of way
 - Palos Verdes Drive South from Barkentine Road to Point Vicente Interpretive Center medians and right of way
- This week, the irrigation team completed inspections, repairs, and system upgrades at these locations:
 - Adjusted sprinkler heads to prevent overspray onto weed posts at City Hall.
 - Replaced 30 broken risers and adjusted irrigation timing along Whitley Collins Drive medians.
 - Turned off irrigation controllers at City parks due to recent rain.

- In addition to routine tree trimming throughout the City, the Public Works Department regularly inspects trees for structural integrity and safety. Below is the list of trees inspected this week for potential City action, such as trimming or removal:

 - Fred Hesse Jr. Community Park - 1 Tree



- The Public Works Department performed the following infrastructure repairs and replacements in the public right-of-way:
 - Pressure washed and cleaned bus stops at Western Avenue/Crestwood Street and Hawthorne Boulevard/Palos Verdes Drive West
 - Filled several potholes along General Street
 - Pressure washed sidewalk on Albergo Court
 - Applied crack filler to Dauntless Drive

- Repaired a sewer transmission line serving 10 residences along Cinnamon Lane and Narcissa Drive. No service interruptions were experienced.

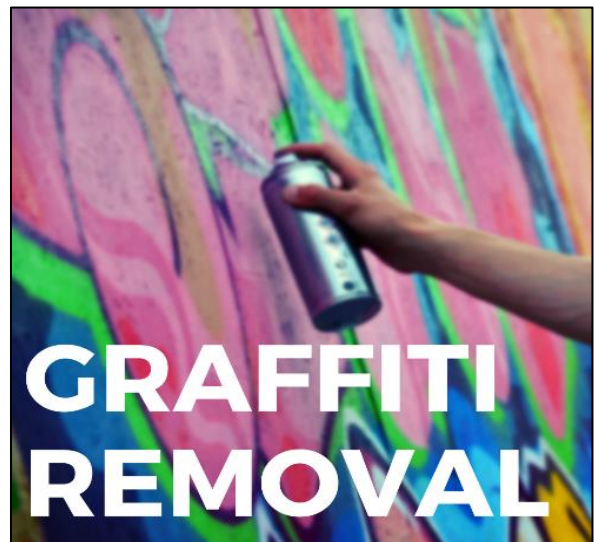




- Traffic signals and street lights were recently serviced at the following locations:

Graffiti Removal

- **38** graffiti incidents were reported and removed this week.
- Residents can help keep RPV looking great by downloading the **RPV Clean** app to report graffiti to City staff.



- To prepare for this past week's storm, crews cleared debris from drainage systems, checked known concern spots, cleaned gutters, and ensured all storm drains were open and functioning properly to reduce the risk of flooding.



- During the storm, crews monitored conditions and responded as needed. Crews removed tree debris from roadways and confirmed water was flowing properly into drainage systems. Crews also worked along Palos Verdes Drive South to remove ponding water to keep the road passable throughout the event.



- On November 14, crews removed a fallen tree along Hedgewood Drive. Debris was removed from the sidewalk and roadway to ensure pedestrian and vehicle safety.



- On November 15, crews, in coordination with a City contractor, worked to repair a pump failure at the main sewer lift station for Abalone Cove. The system was repaired and was functioning within four hours of being reported. There were no service interruptions.

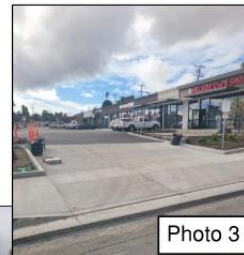

Keeping Pets Warm During Cold Weather

The Los Angeles County Department of Animal Care and Control (DACC) reminds pet

owners that as temperatures drop and winter weather sets in it is important to keep pets warm and safe. Specifically, DACC recommends the following tips to keep pets safe during winter months:

- **Keep Pets Indoors:** Whenever possible, keep dogs and cats indoors, especially during freezing temperatures. If pets must go outside, limit their time outdoors.
- **Provide Shelter:** Ensure your pet has a warm and dry place to sleep, away from drafts and moisture. Indoor spaces are always the safest option.
- **Monitor Outdoor Time:** If pets need to be outside, supervise them closely and bring them back inside as soon as possible.
- **Watch for Signs of Cold Stress:** Be alert for signs of discomfort in your pets, such as shivering, whining, or seeking shelter. If you notice these signs, bring them indoors immediately.

No Construction on Thursday, November 27 (Thanksgiving Day) and Friday, November 28

Pursuant to Section 17.56.020(B) of the Rancho Palos Verdes Municipal Code, it is unlawful to carry on construction, grading, or landscaping activities, or to operate heavy equipment except between the hours of 7:00 A.M. and 6:00 P.M. Monday through Friday, and between the hours of 9:00 A.M. and 5:00 P.M. on Saturday. No such activity shall be permitted on Sundays, or the legal holidays (within the city's permitted construction hours), unless a Special Construction Permit is approved by the Director of Community Development. 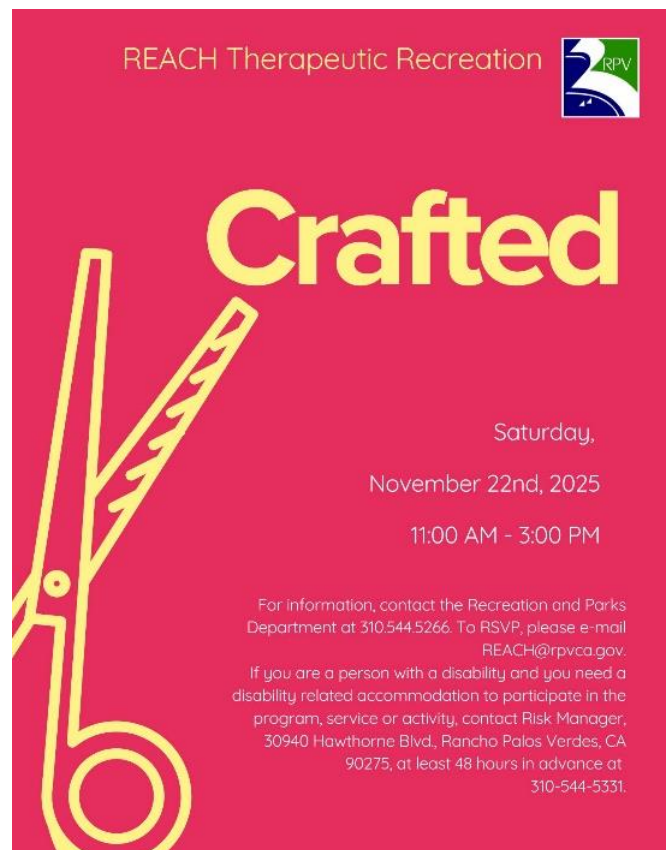
REACH Buttons up for Fall

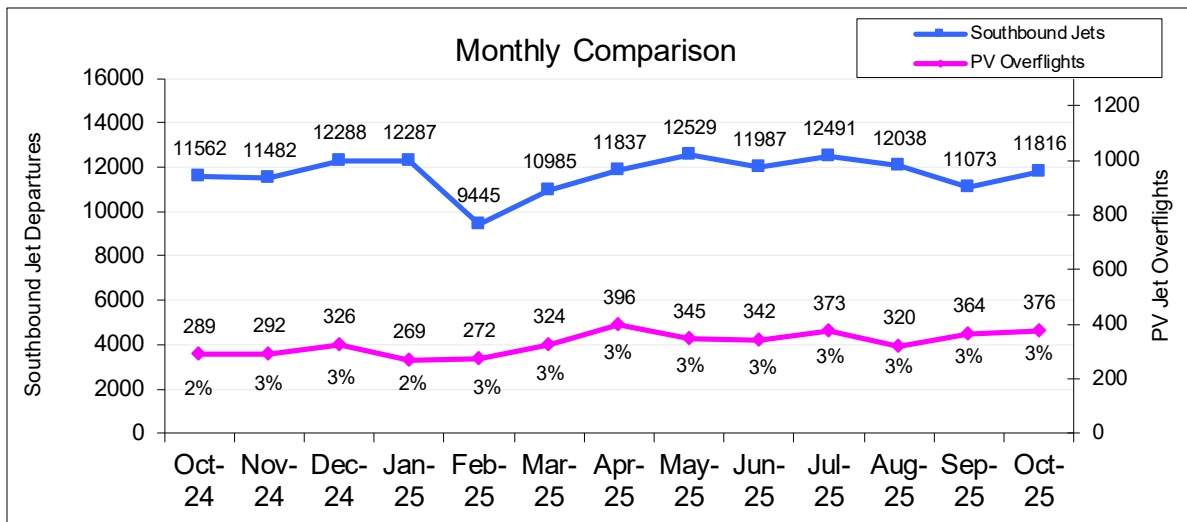
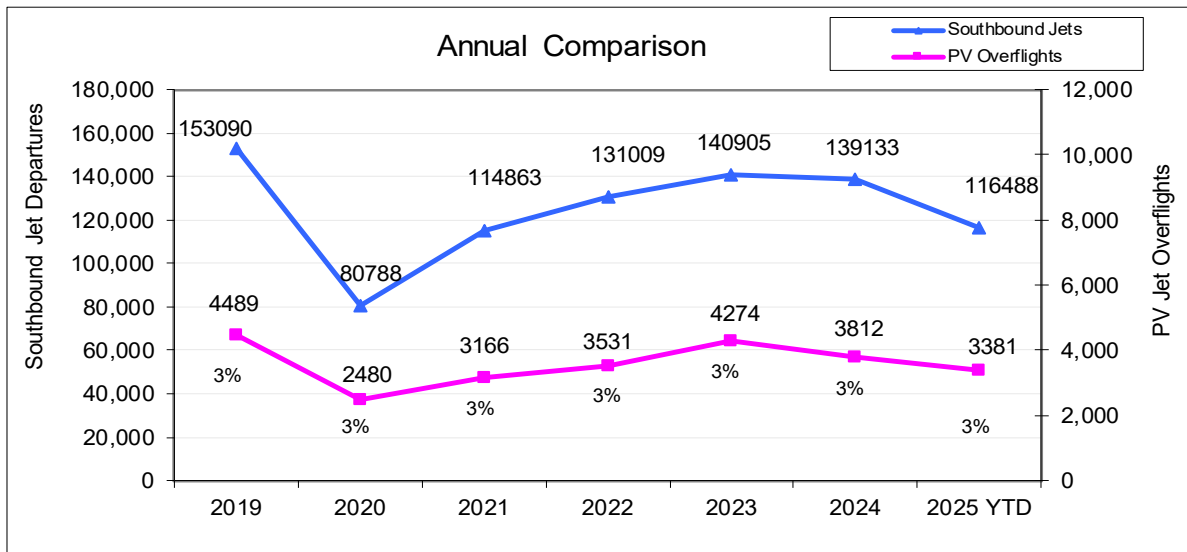
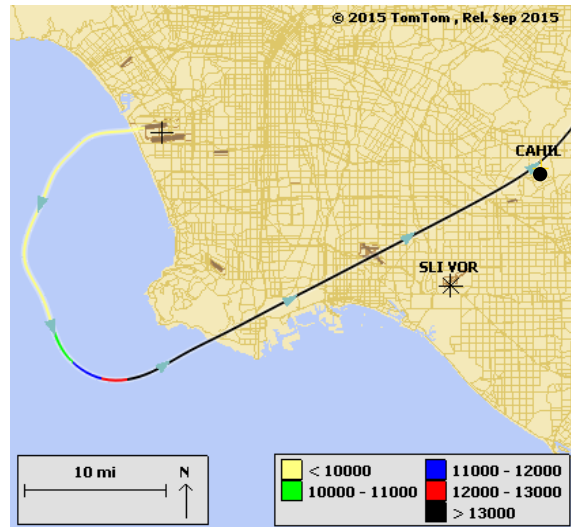

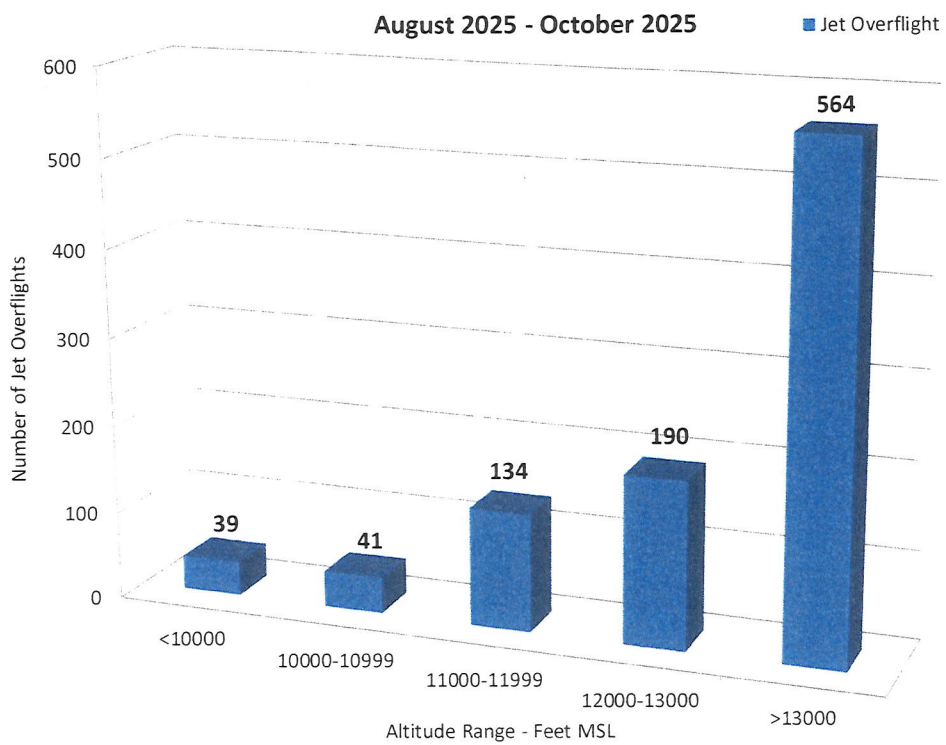

ADJOURNMENT:

Planning Commission Agendas and Staff Reports:

The agenda and staff reports are available on the City's website at www.rpvca.gov/agendas no later than 72 hours before the meeting.

Materials related to an item on an agenda submitted after distribution of the agenda packet are available on the City's website at www.rpvca.gov/agendas by clicking the link titled "Late Correspondence" at the top of the agenda.

Ordinances:

Government Code 36934 provides, except when, after reading the title, further reading is waived by regular motion adopted by majority vote all ordinances shall be read in full either at the time of introduction or passage; provided, however, that a reading of the title or ordinance shall not be required if the title is included on the published agenda and a copy of the full ordinance is made available to the public online and in print at the meeting prior to the introduction or passage.

Public Correspondence:

We highly encourage written materials regarding Planning Commission Agenda items be submitted no later than 4:00 P.M. the Monday prior to a Planning Commission meeting to allow the Commission Members ample time to review and consider the issues raised prior to making decisions at them meeting. Please keep in mind that it is difficult for Commission Members to carefully review materials submitted after that deadline or at the meeting. Written materials, including emails, submitted to the City are public records and may be posted on the City's website. Accordingly, you may wish to omit personal information from your written materials or oral presentation as it may become part of the public record regarding an agenda item. In addition, City meetings may be televised and may be accessed through the City's website at www.rpvca.gov/agendas.

Public Participation:

Participants must speak from the podium using the lectern microphone; comments are to be directed to the Planning Commission and not to the staff or the public; repetition should be avoided; and reading a submission that has been copied or contained in the agenda will be discouraged. Virtual participation is also offered please visit www.rpvca.gov/participate.

Public Comments:

The Planning Commission may limit the public input on any item based on the number of people requesting to speak, the length of the agenda, or the business of the Commission.

Conduct at the Planning Commission Meeting:

Pursuant to GC 54957.95: (a)(1) In addition to authority exercised pursuant to Sections 54954.3 and 54957.9, the presiding member of the legislative body conducting a meeting or their designee may remove, or cause the removal of, an individual for disrupting the meeting. (2) Prior to removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure

to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force.(2) “True threat of force” means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:

The Planning Commission will adjourn its meetings on or before 11:00 p.m. and will not consider new business items after 10:15 p.m., unless a majority of the Commission members who are present affirmatively vote either to extend the meeting after 11:00 p.m. or to consider new business after 10:15 p.m. If the meeting ends before all items listed on the agenda are completed, any unfinished business will be continued to the next succeeding day that is not a holiday, at a location to be determined.

Closed Session:

Please be advised that, pursuant to the Ralph M. Brown Act, “a person may not disclose confidential information that has been acquired by being present in a Closed Session . . . to a person not entitled to receive it, unless the legislative body authorizes disclosure of that confidential information.” (Gov. Code § 54963(a).) “[C]onfidential information’ means a communication made in a Closed Session that is specifically related to the basis for the legislative body of a local agency to meet[] lawfully in Closed Session” (Gov. Code § 54963(a).) Please be further advised that any “[v]iolation of [Government Code § 54963] may be addressed by the use of such remedies as are currently available by law, including, but not limited to: (1) injunctive relief to prevent the disclosure of confidential information prohibited by this section; (2) disciplinary action against an [public or city official] who has willfully disclosed confidential information in violation of this section; (3) referral of a member of a legislative body who has willfully disclosed confidential information in violation of this section to a grand jury.” (Gov. Code § 54963(c).)
