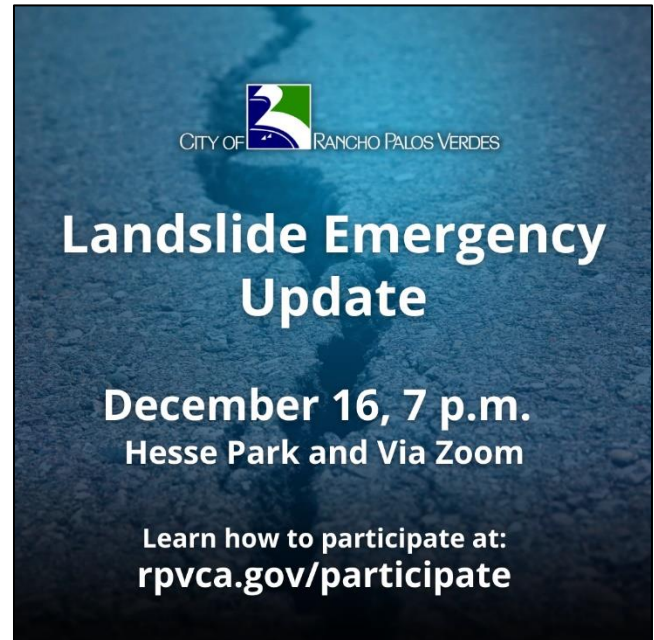
## Land Movement Updates



### December 16, 2025 City Council Meeting

On December 16, 2025, the City Council will receive a comprehensive update on the landslide emergency.

From October to November, the Abalone Cove Landslide decelerated by an average of 7% and the Portuguese Bend Landslide decelerated by an average of 2%. The Klondike Canyon Landslide continued to see no measurable movement. The average movement rate for areas still moving within the active landslide boundary was 1.44 inches per week, down just slightly from October.



“Winterization” measures designed to prevent rainwater from infiltrating into the ground are expected to be completed in Upper Altamira Canyon and Portuguese Canyon this month, and maintenance in other winterized areas is ongoing. City staff is recommending additional priority winterization measures within City property on Plumtree Road and a fissure near Cinnamon Lane to reduce the risk of water intrusion and erosion to nearby private property.

Over the course of November, the City’s nine deep dewatering wells removed approximately 30 million gallons of groundwater, the Abalone Cove Landslide Abatement District’s 16 wells pumped approximately 4.5 million gallons, and the Klondike Canyon Landslide Abatement District’s one operational deep dewatering well removed approximately 10.8 million gallons.

As of this month, \$9.9 million or 60% of the City’s total landslide budget for Fiscal Year 2025-26 has been spent or encumbered, including \$3.3 million (20%) spent and \$6.6 million (40%) encumbered.

Finally, the Council will consider extending by 60 days the local emergency declarations in the landslide area and the temporary prohibition of bicycles, motorcycles, and other similar wheeled vehicles from an approximately 2-mile stretch of Palos Verdes Drive South.

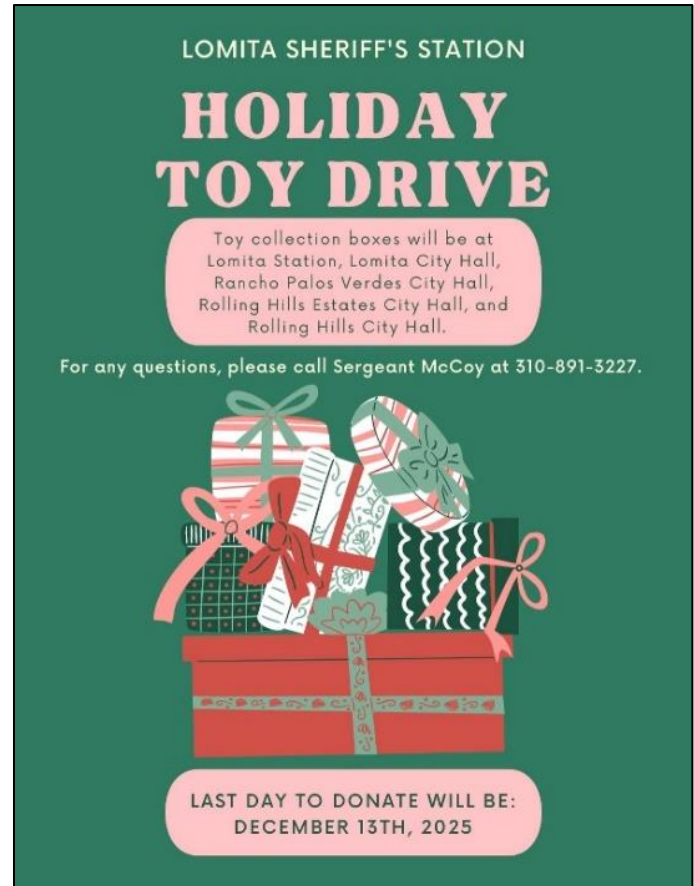




## LASD-Lomita Station: Annual Toy Drive

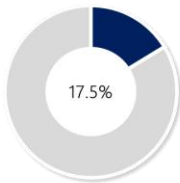

# FINANCE DEPARTMENT

## Finance Department Monthly Report

Through October 31, 2025, the City’s General Fund revenues and expenditures continue to track as expected. This report presents a brief summary of budgeted revenue sources and expenditures by department, compared to the adopted budget and the revenue and expenditures of those categories for the same time period last fiscal year.

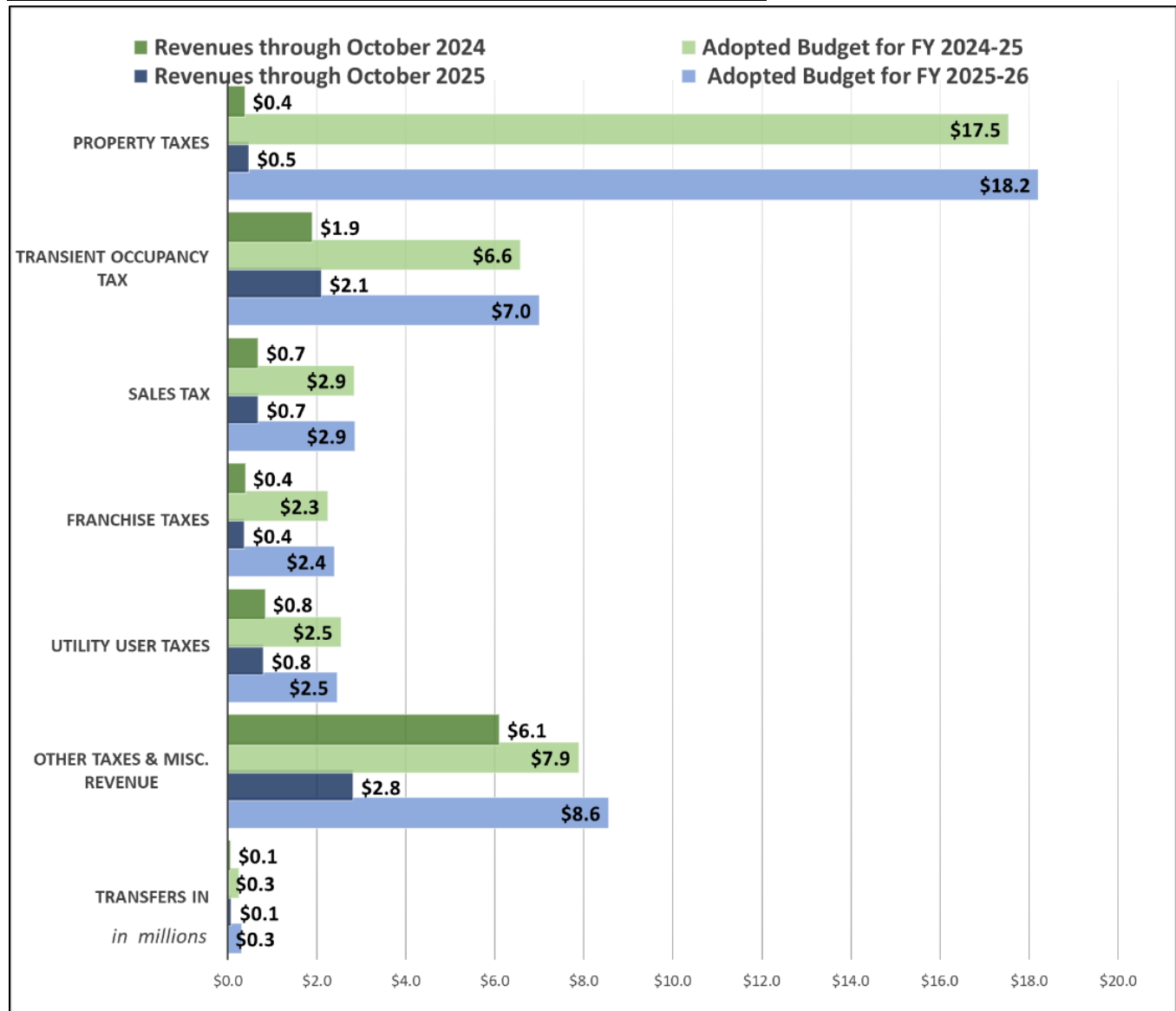


### General Fund Revenues – through October 31, 2025

Through October 31, the City has received approximately \$9.4 million in General Fund revenues, representing approximately 17.5% of the FY 2025-26 adopted revenue budget of \$41.8 million. This is above last year’s revenue, which was at 13.5% after adjusting for last year’s one-time grant from Los Angeles County. Revenues are expected to align with projections for the year, and Staff will continue to monitor trends closely and provide monthly updates.

### Property Tax and Transient Occupancy Tax (TOT)

Property Tax and TOT remain unchanged from last month's report, due to the timing of posting receipts. Staff will continue to track these revenue categories as they relate to the revenue assumptions for the fiscal year.

### Sales Tax

Sales tax revenues totaled \$683,500 through October, essentially unchanged from the same period last year. Collections are tracking in line with the City's FY 2025-26 projections and reflect steady consumer activity.

### Franchise Tax

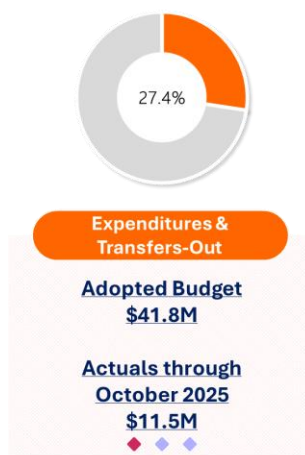
Franchise Tax revenues totaled \$371,200 through October, approximately 6% below last year's \$395,600. The decrease is primarily due to timing differences in utility and cable franchise remittances and does not indicate a downward trend at this time.

### Utility User Tax (UUT)

UUT revenues totaled approximately \$795,500, representing 32.4% of the budget for this category. This represents a roughly \$46,000 lower than the same period last year, a decrease of 5% from \$841,500. Even with the dip in revenue, overall utility consumption has stayed relatively steady.

### Other Taxes and Miscellaneous Revenues

Other Taxes and Miscellaneous Revenues totaled \$2.8 million through October. Year-over-year revenues is lower due to the receipt of a one-time landslide recovery grant in the prior fiscal year. Excluding the one-time revenue, permitting activity and investment earnings are performing as expected.



### **General Fund Expenditures**

General Fund expenditures and transfers through October 31 totaled approximately \$11.5 million, which is 27.4% of the adopted budget of \$41.8 million. This is an increase of about \$208,000 compared to the same period last year, driven largely by filled vacancies, agreed upon employee labor contract changes, the City's annual prepayment of the CalPERS unfunded liability, and higher tax assessments. Non-personnel costs increased approximately 12.2% due to timing differences in invoices, the Sheriff's contract escalation, and scheduled maintenance activity.

Transfers-out totaled \$1.4 million, slightly lower than last year due to timing and lower programmed transfers in the adopted budget.

Overall expenditures remain consistent with the timing and spending patterns anticipated in the adopted FY 2025-26 budget.

The following departments show the largest changes:

### Public Safety

Expenditures in Public Safety are about \$2.3 million, or 67%, higher when compared to last year, representing approximately 24.2% of the FY 2025-26 adopted budget. This is largely due to the addition of the Public Safety division and increases in the Sheriff's Department contract.

### Public Works

Public Works expenditures totaled \$2.4 million through October, a 51% increase over the prior year and equal to 29.2% of the department's adopted budget. The increase is primarily attributable to filling previously vacant engineering and maintenance positions, anticipated higher contract maintenance costs, and scheduled facility repair work occurring earlier in the fiscal year.

### Non-Departmental

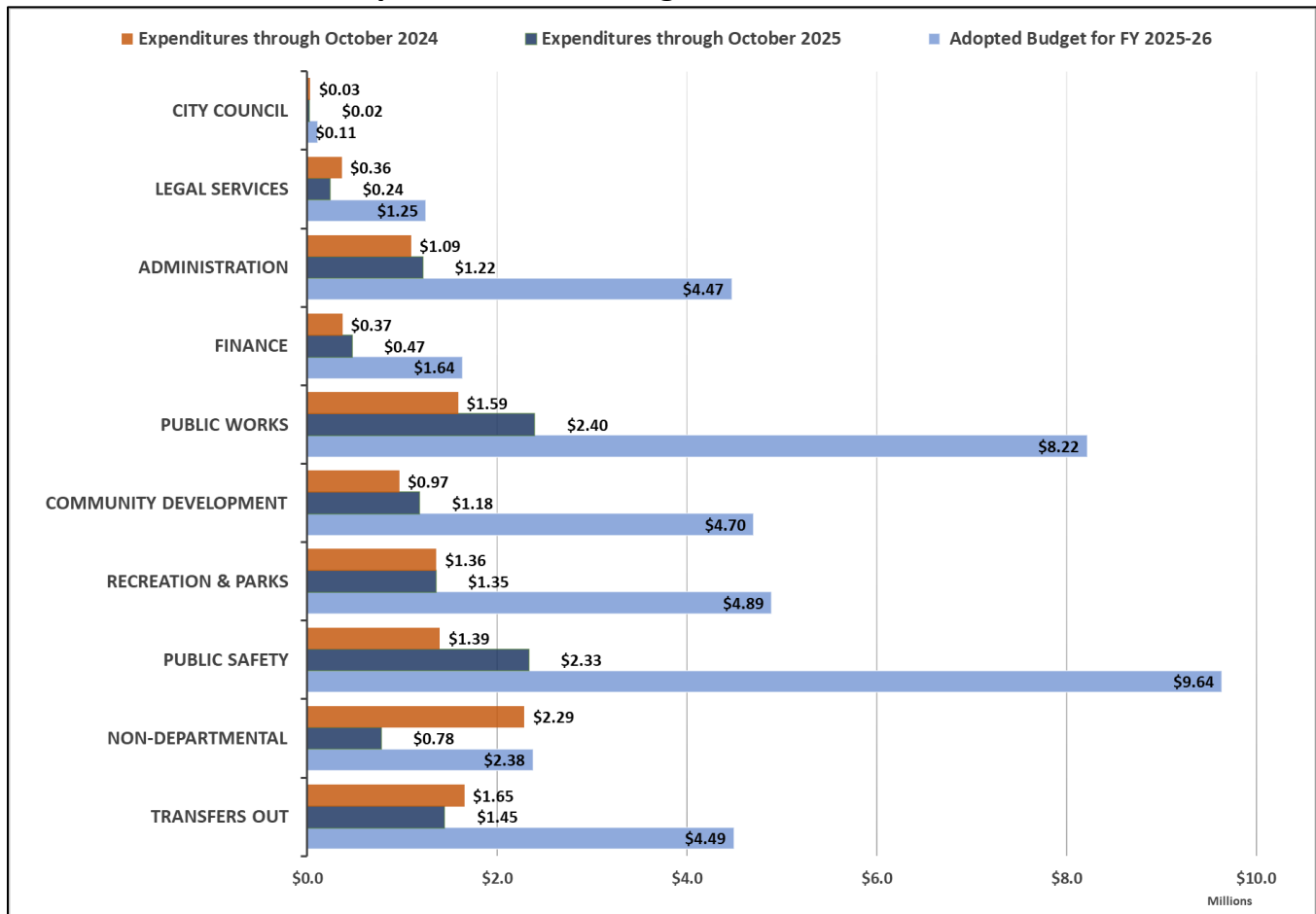
Expenditures in this category totaled slightly less than \$778,000, representing 32.7% of the adopted budget for FY2025-26. This is approximately 66%, or \$1.5 million lower than last year.

### Finance

Expenditures in the Finance Department for the first quarter were \$473,000, representing 28.9% of the adopted budget for the department. The 28% increase over last year's expenditures through October 2024 is attributed to filled positions that were vacant last year.

## PUBLIC WORKS DEPARTMENT



### Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

#### Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **690 gallons per minute** or approximately **1.0 million gallons per day**.
- Since the start of the DDW program, approximately **407 million gallons** or **1,248 acre -feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
  - All DDWs are currently online and extracting water.

**Status of Winterization:**

Construction work continues this week on winterization measures. The work is anticipated to be complete by mid to late December. Meanwhile, staff are identifying additional scopes of winterization work within the current approved budget for the City Council's consideration.

**Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update**

On March 4, 2025, the City Council awarded a construction contract to install a left turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. The project includes:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns.
- Traffic signal hardware and equipment updates including a new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

Following contract award, the construction contractor ordered the long lead items like

the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On Monday, October 6, 2025 construction activities began at the intersection.

On Wednesday, November 26, 2025, the installation of the new traffic poles began and was completed Monday, December 1, including the removal of the old signal poles. Currently the new north-south left turn signal arrows are not functional (bagged) but will be activated in a few weeks upon installation of the new traffic signal controller.

For the week of December 8<sup>th</sup>, the following construction activities are anticipated.

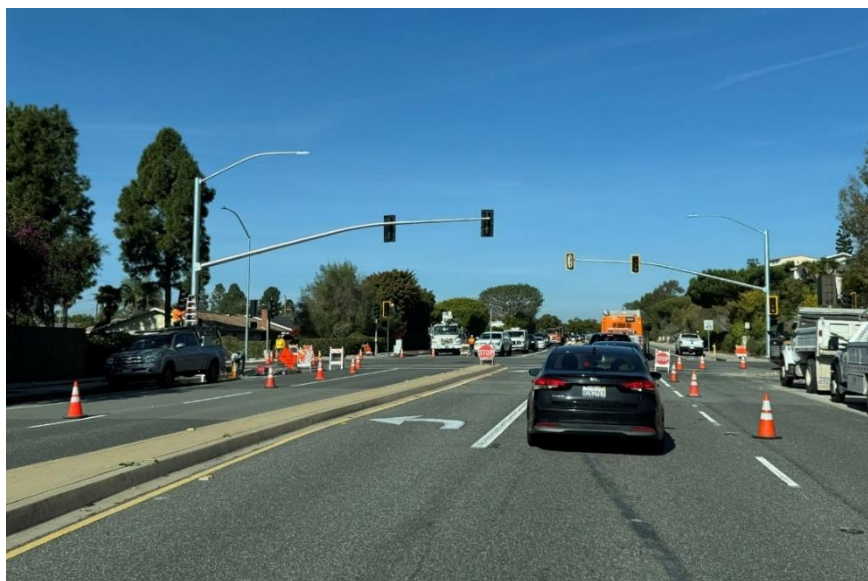
- Construction of sidewalks, curbs, and ADA ramps.
- Asphalt paving work.

For the week of December 15<sup>th</sup>, the following construction activities are anticipated.

- Installation of signs and pavement markings.
- Installation of traffic loop detectors. The loop detector is a simple, in the ground, sensor that is used to tell when a car is present at the intersection.

Planned activities may change due to unforeseen conditions or weather changes. Activities will be resumed immediately upon resolution of the aforementioned conditions.

Construction is anticipated to be complete by the end of the year.





### **Infrastructure Advisory Management Committee (IMAC)**

The IMAC meeting scheduled for December 15 at 6:00 p.m. has been cancelled due to a lite agenda. The next regularly scheduled meeting of the IMAC will be January 19, 2026.

### **Traffic Safety Committee (TSC)**

A TSC special meeting was recently held last Wednesday, December 3, at 6:00 p.m. in the Community Room at the Ken Dyda Civic Center. TSC discussed the following:

- Twice Yearly Update and Workplan
  - TSC discussed committee accomplishments and the workplan for the upcoming year (2026).
- Traffic Request Framework Update
  - TSC discussed the current traffic request framework and provided input to modify and streamline the process including removing ineffective TSC review steps and incorporating early community feedback and consensus prior to committing City resources to the implementation of proposed recommendations.
  - Staff was requested to modify the current Traffic Request Framework to incorporate TSC comments.
  - The revised Framework will be presented for further refinement during the next scheduled TSC meeting in 2026.

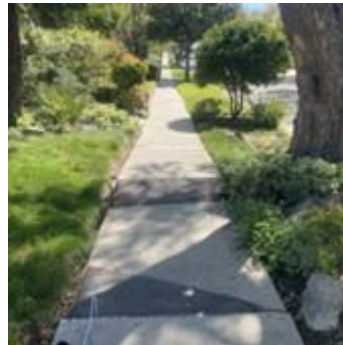

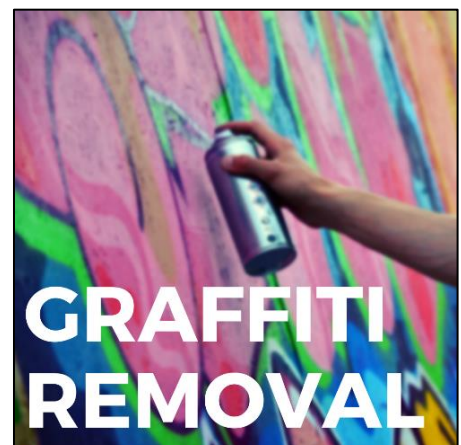

## Swale Maintenance

Swales tend to become filled with leaves, overgrown vegetation, and debris over the course of the year. As a reminder, it is a property owner's responsibility to maintain a drainage swale on their property so that it functions properly. Improperly maintained drainage swales interfere with proper drainage flows that can result in property damage caused by slope failure, erosion, or excess storm-water runoff. As we fast approach the wet months of the year, now is the time to clean your swales.



As an additional reminder, the City's Municipal Code does not permit the construction of any structure within or above a drainage swale, or on a slope on or equal to 35% or greater. This includes decks, stairs, or structures of any kind. Please keep this in mind if you're planning a project near or on a slope.

## REACH Visits the Enchanted Forest

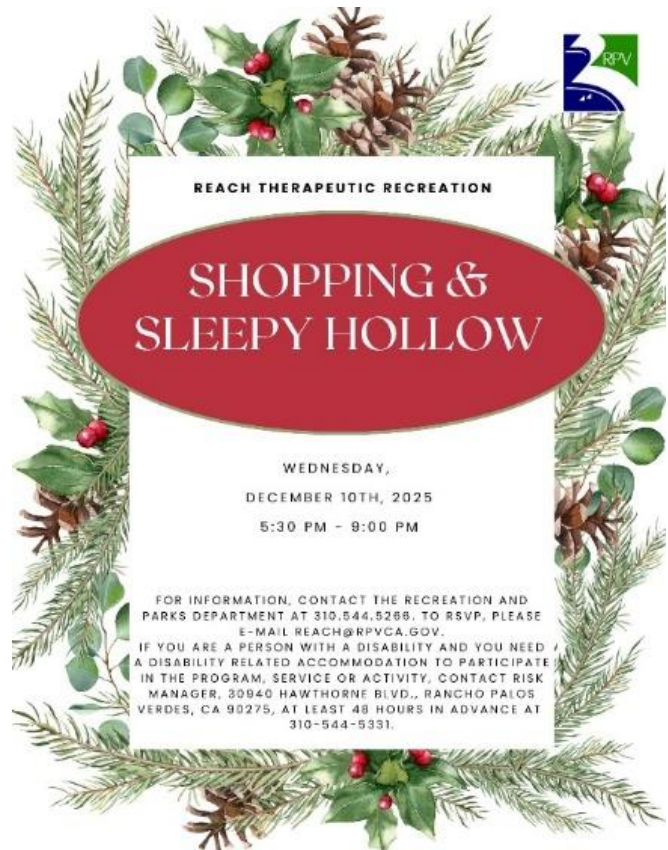

## Abalone Cove Park/Reserve

On Thursday, Friday, and Saturday last week, the coastline experienced King Tide events with extreme low and high tide. Staff monitored several coastal locations throughout the City, including Abalone Cove Beach for debris that washed ashore. Unfortunately, staff reported a deceased dolphin that washed ashore. Cause of death is unknown.

## Forrestal Reserve

On Tuesday, Staff performed maintenance on several grade dips on Flying Mane Trail. Grade dips are a trail improvement designed to divert water off of the trail as quickly as possible to minimize damage.





## Portuguese Bend Reserve

On Thursday, Staff continued and completed further rock delineation of Peacock Flats Trailhead to assist visitors with wayfinding. Staff also replaced a faded trail signage that had been damaged from extensive sun and weather exposure on Fire Station Trail.



On Saturday and Sunday, Staff hosted a booth on Burma Road Trail to assist visitors with directions, information, and other updates within the Palos Verdes Nature Preserve.



On Monday, Staff installed additional map signage on Kelvin Canyon Trail and Burma Road Trail to assist with wayfinding at a critical junction for trail users visiting from Filiorum Reserve and Portuguese Bend Reserve.





### Three Sisters Reserve



On Friday, Staff installed a four-way sided fiberglass post to assist with wayfinding at the intersection of Three Sisters Trail and Sunshine Trail. Staff also installed a grade dip and other barriers to ensure visitors stay on trails and avoid sensitive habitat areas.
