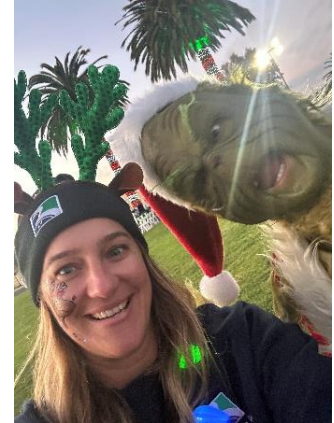
- **Winter Night Magic – Saturday, Dec. 13, 5–8 p.m.**

City Hall Closed December 24 – January 4 for Winter Break

Please note that due to the City Hall closure, there will be no City Manager's Weekly Administrative Reports until the second week of January.

City Hall will be closed for winter holiday break from December 24, 2025 - January 4, 2026, and will reopen on January 5. Emergencies should be reported by calling 9-1-1.



Building and Safety will provide **limited building inspections** on December 29 and 30. Inspection requests may be called in to 310-544-5279 or submitted electronically on the [City website](#).

Construction is prohibited on December 25 (Christmas Day) and January 1 (New Year's Day) unless a Special Construction Permit is approved by the Director of Community

Development. Special Construction Permits must be requested at least 48 hours before any such work is to begin, and requests for January 1 must be submitted by December 22 due to the City Hall winter holiday break closure. Please note that minor repairs, maintenance and landscaping activities (i.e., work that does not otherwise require a building permit) are not prohibited on legal holidays. For additional information, please contact the Community Development Department at 310-544-5228 or planning@rpvca.gov.

There will be no **trash collection** on Christmas Day and New Year's Day, and a one-day delay for the Thursday and Friday routes. There will be no **street sweeping** on Christmas Day and New Year's Day. Instead, street sweeping for these days will be performed on December 24 and December 31, respectively.

Parks (except for Abalone Cove Park and all park buildings) will be open on Christmas Day and New Year's Day for their regular hours.

December 16, 2025 City Council Meeting Highlights

- City staff gave the latest updates on the landslide emergency.
- From October to November, the Abalone Cove Landslide decelerated by an average of 7% and the Portuguese Bend Landslide decelerated by an average of 2%. The Klondike Canyon Landslide continued to see no measurable movement. The average movement rate for areas still moving



within the active landslide boundary was 1.44 inches per week, down just slightly from October.

- “Winterization” measures designed to prevent rainwater from infiltrating into the ground are expected to be completed in Upper Altamira Canyon and Portuguese Canyon this month, and maintenance in other winterized areas is ongoing.
- The Council renewed for 60 days the local emergencies in the landslide area and the temporary prohibition of motorcycles and bicycles along a two-mile stretch of Palos Verdes Drive South.
- The Council approved a commemorative City logo that will be used for merchandise benefitting the Friends of the Lighthouse, a nonprofit formed to mark the Point Vicente Lighthouse’s centennial in 2026. The design features the iconic lighthouse against the City logo within a gold seal.
- Finally, the Council adopted the first update since 2018 of the Emergency Operations Plan, the City’s primary all-hazard emergency planning document to respond to and mitigate an emergency, safeguard community members, and maintain essential public services before, during, and after the emergency.
- To plan will now be reviewed and updated every three years to ensure it is up to date with state regulations and best practices.

RPV Honored for Energy-Saving Achievements

Last week, the South Bay Cities Council of Governments (SBCCOG) in partnership with the Southern California Regional Energy Network (SoCalREN), recognized South Bay cities, including RPV, for their efforts in pursuing energy-efficiency initiatives and sustainability-related tasks over the past year as part of the second annual “South Bay Energy and Climate Recognition Program.”

Taking home platinum-level achievement were the cities of Carson, Gardena, Manhattan Beach and Torrance. El Segundo, Hawthorne, and Rolling Hills Estates reached gold; Rancho Palos Verdes, Hermosa Beach, Inglewood, and Lomita reached silver; and Lawndale, Palos Verdes Estates, Redondo Beach, and Rolling Hills reached bronze.

Participating cities were honored at a luncheon at the Harold E. Hofmann Community Center in Lawndale. Rita Kampalath, chief sustainability officer for Los Angeles County, was the keynote speaker.

To participate, cities were required to be enrolled in the SoCalREN—a program administered by Los Angeles County to provide energy-saving services to residents, businesses and public agencies served by Southern California Edison (SCE) and/or Southern California Gas Company (SoCalGas). Cities’ progress was tracked through a point system.

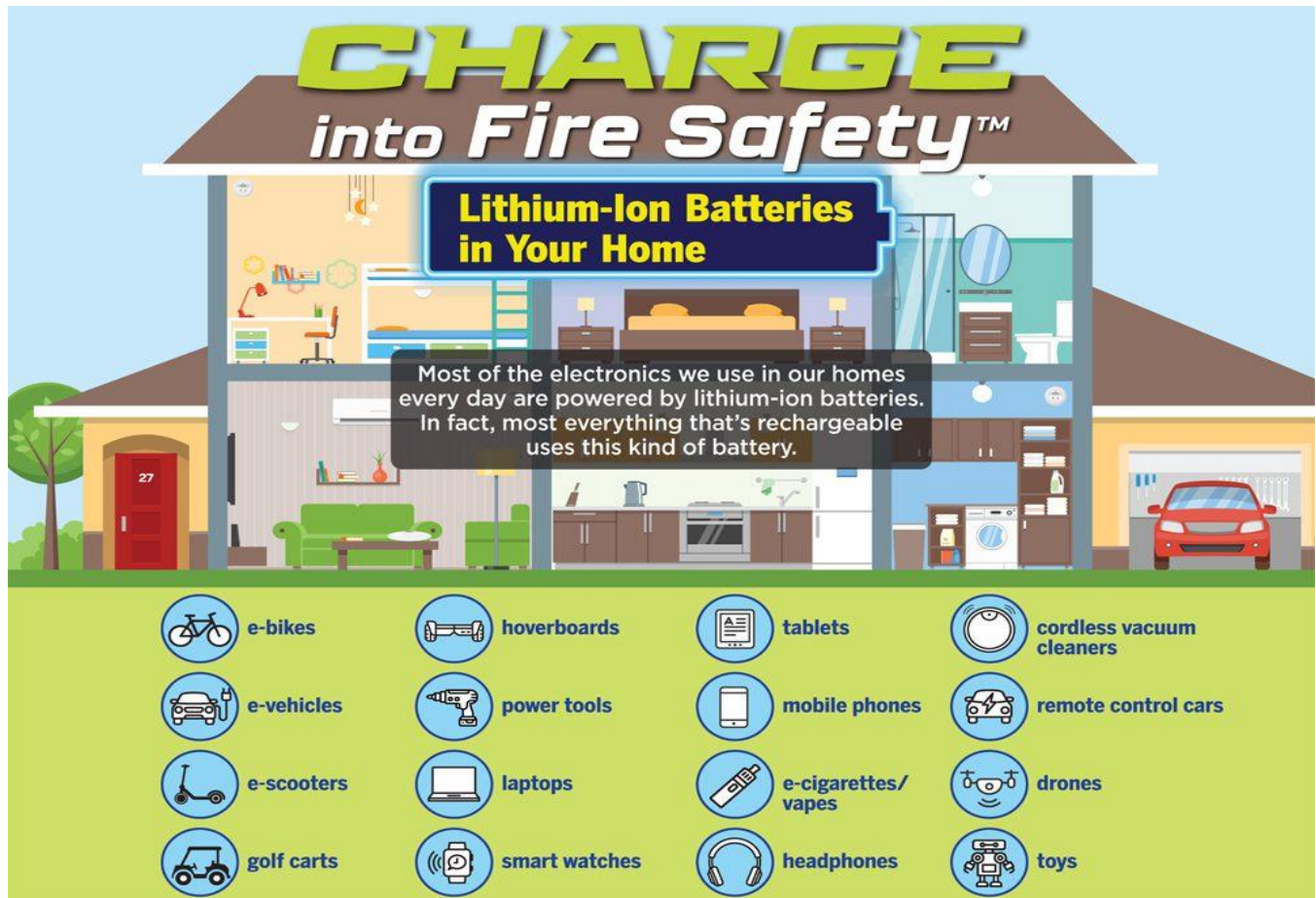

Tips for Preventing Home Fires Over the Holidays

Home fires most often occur between December and February. To make sure you have a safe and enjoyable holiday, follow these safety tips:





LITHIUM-ION BATTERIES

- ✓ When buying a product that uses lithium-ion batteries look for a safety certification mark (ex. UL, ETL, or CSA), which means it meets safety standards
- ✓ Always use the original charging cable that came with the device.
- ✓ Read and follow all manufacturer directions.
- ✓ Charge on a hard, flat surface and avoid charging on beds or couches.
- ✓ Don't overcharge the device or battery after it is fully charged.
- ✓ For e-scooters, e-bikes, or power tools, the safest place to charge them is outside, away from doors and windows.
- ✓ STOP using your device right away if the battery smells weird, gets too hot, makes popping noises, or changes in shape or color.

CANDLES

- ✓ Consider using flameless candles, which look and smell like real candles.
- ✓ Keep candles 12 inches away from things that can burn and remember to blow them out when you leave the room.
- ✓ Use candle holders that are sturdy, won't tip over, and are placed on uncluttered surfaces.
- ✓ Never use lit candles to decorate a Christmas tree.

- ✓ Never leave a child or pet in a room with a burning candle.

CHRISTMAS TREES

- ✓ Select a fresh tree with needles that do not easily fall off when touched or break when gently bent. Add water to the tree stand and make sure to water the tree daily.
- ✓ If you have an artificial tree, be sure it's labeled, certified or identified by the manufacturer as fire retardant.
- ✓ Locate the tree at least three feet away from heat sources. Make sure not to block exits with the tree or rearranged furniture.
- ✓ Always unplug Christmas tree lights before leaving home or going to sleep.

COOKING

- ✓ If you are sleepy or have consumed alcohol, don't use the stove or stovetop.
- ✓ Stay in the kitchen while you are cooking
- ✓ Keep anything that can catch fire — oven mitts, wooden utensils, food packaging, towels or curtains — away from your stovetop.
- ✓ Keep a lid nearby when you're cooking to smother small grease fires. Smother the fire by sliding the lid over the pan and turn off the stovetop. Leave the pan covered until it is completely cooled. Never throw water on a grease fire.
- ✓ For an oven fire, turn off the heat and keep the door closed.
- ✓ Turn pot handles toward the back of the stove so that no one can bump them or pull them over.

WASTE DISPOSAL

Whether you are at work or at home, be careful what you throw into the trash to avoid starting a fire. Avoid throwing batteries, devices, and hot, flammable or sharp objects into the trash. If you have a Christmas tree, safely dispose of it when it begins dropping needles. Dried-out trees are highly flammable and should not be left in a house or garage or placed against the house. *Residents can use EDCO tree disposal from 12/26 to 1/15.*

A Message from Cal Water on Wildfire Preparedness

At Cal Water, we have a comprehensive emergency preparedness program in place. We work closely with our local fire departments and proactively coordinate with the cities we serve so when the time comes, we're ready together.



Wildfires are unexpected, but fire prevention and preparedness don't have to be. While urban water systems aren't designed to combat wildfires, **we take proactive measures in our communities to support firefighters, maintain our systems, and help keep water flowing in emergencies.** Here's how:

1. **Partnering with local fire agencies** - Through our Firefighter Grant Program, we help local fire departments get the gear they need—hoses, helmets, and even a HeloPod, which helps helicopters to refill their water tanks without landing. Each year emergency operation center joint-trainings are conducted with local first responders to increase our team's coordination and readiness.
2. **Upgrading and maintaining water infrastructure** - We proactively upgrade pump stations, storage tanks, water mains, and install back-up generators at key facilities to help keep our infrastructure operating properly. We also reconfigure pipelines to increase water flow, manage vegetation growth, and monitor our systems for opportunities to increase pressure and fire resilience.
3. **Maintaining operational readiness** – Cal Water's regional Operational Rapid Response Teams are able to quickly mobilize in the event of emergencies. We also maintain a fleet of Emergency Response Trailer Units, which can efficiently deploy equipment during emergencies.

Apply for a Public Safety Reimbursement from the City

The City of Rancho Palos Verdes offers reimbursements for half the cost of a new doorbell or neighborhood camera system, now up to \$2,500 for neighborhoods/HOAs, and up to \$100 for individuals. Job Openings and Labor Turnover – October 2025

On December 9, 2025, the Bureau of Labor Statistics released the October 2025 data from the Job Openings and Labor Turnover Survey (JOLTS). This monthly report includes estimates of the number and rate of job openings, hires, and separations and provides insights into the current labor market.

As reported, the number of job openings totaled 7.7 million for the month ending October 2025, with minimal changes from the previous month. At 4.6 percent, the job opening rate did not change from September. However, within the federal government, job openings decreased by 25,000.

October 2023 - October 2025

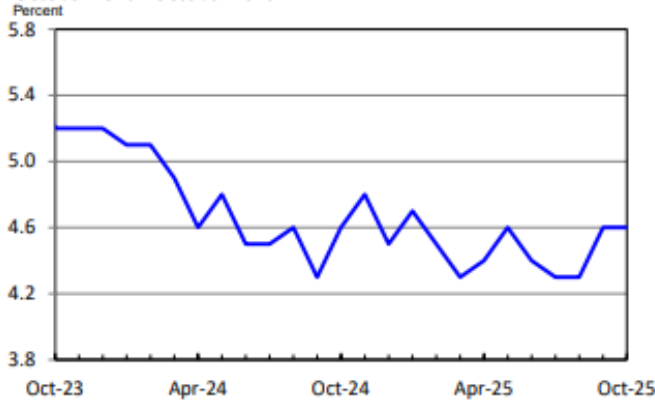
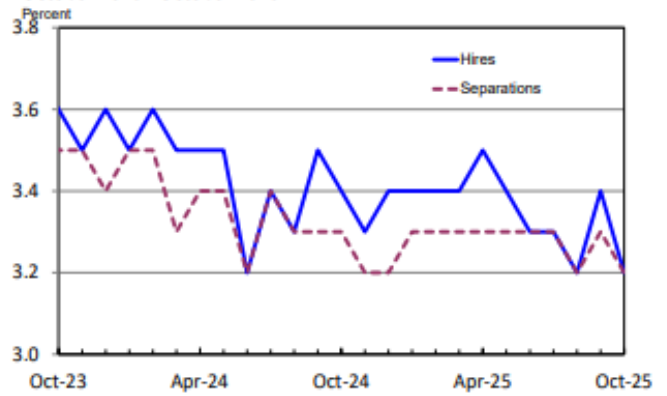


Chart 2. Hires and total separations rates, seasonally adjusted,

2026 Business License Renewal Information

On December 2, 2025, the Rancho Palos Verdes City Council reinstated the Home Occupancy Business Tax, sunset the Small Business Financial Assistance Plan, and an increase of 3% on all taxes based on the annual Consumer Price Index (as of September 2025). The business license office is now accepting renewal applications for 2026. Below is a list of some of the applicable business types and fees:

2025 Maintenance Summary

Through teamwork, adaptability, and effective coordination, staff met changing priorities and delivered reliable results in support of the community and the City's operational goals in the midst of the ongoing landslide emergency. Below is a snapshot of the amount of work the maintenance team responded to throughout the year.



- Trimmed 2,000 trees throughout the city under routine maintenance.
- Inspected 111 trees for service and action throughout the City.
- Serviced 247 trees originating from residents' requests.
- Opened and resolved 2,250 work orders for various repair and maintenance items.
- Received and fielded approximately 2,000 plus resident inquiries via email, phone, or front-counter interactions.
- Responded to 450 cases of right-of-way and road repairs throughout the year that included: potholes, sign replacements, sidewalk repairs, and general repairs.
- Responded to 76 emergencies throughout the year that included: tree obstructions, sewer problems, and storm /flood-related issues.
- Responded to and removed approximately 1,087 graffiti reports throughout the year in the City.
- Replaced 12 sewer grinder pumps in the Abalone Cove sewer area.



Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **630 gallons per minute** or approximately **0.9 million gallons per day**.
- Since the start of the DDW program, approximately **411 million gallons** or **1,260 acre-feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-8 has sheared and is offline. The City's geologist team is reviewing the situation and preparing recommendations on how to proceed.

Status of Winterization:

Construction work continues this week on winterization measures. The work is anticipated to be complete by late December. Meanwhile, staff has identified additional scopes of winterization work within the current approved budget for the City Council's consideration.

Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Update

On March 4, 2025, the City Council awarded a construction contract to install a left turn signal arrow for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive. The project includes:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns.
- Traffic signal hardware and equipment updates including a new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps.

Following contract award, the construction contractor ordered the long lead items like the steel poles, signal heads, and the controllers. The fabrication and acquisition of those items is now nearly complete.

On Monday, October 6, 2025 construction activities began at the intersection.

On Wednesday, November 26, 2025, the installation of the new traffic poles began and was completed on Monday, December 1; including the removal of the old signal poles. Currently the new north-south left turn signal arrows are not functional (bagged) but will be activated upon installation of the new traffic signal controller.

For the week of December 15th, the following construction activities are anticipated.

- Installation of signs and pavement markings.
- Installation of traffic loop detectors. The loop detector is a simple, in the ground, sensor that is used to tell when a car is present at the intersection.
- Installation of the new traffic controller and signal cabinet will occur on **Thursday, December 18.**
 - Work will result in a **temporary shutdown of the traffic signal** (going dark) for approximately 5 hours, **between 9:00 a.m. to 2:00 p.m.** The intersection will function as an All-Way STOP during this period.
 - Flaggers will be on site to assist if traffic backups become excessive.
 - The Los Angeles County Sheriff's Department will be on-site to provide additional support and enforcement, if needed.

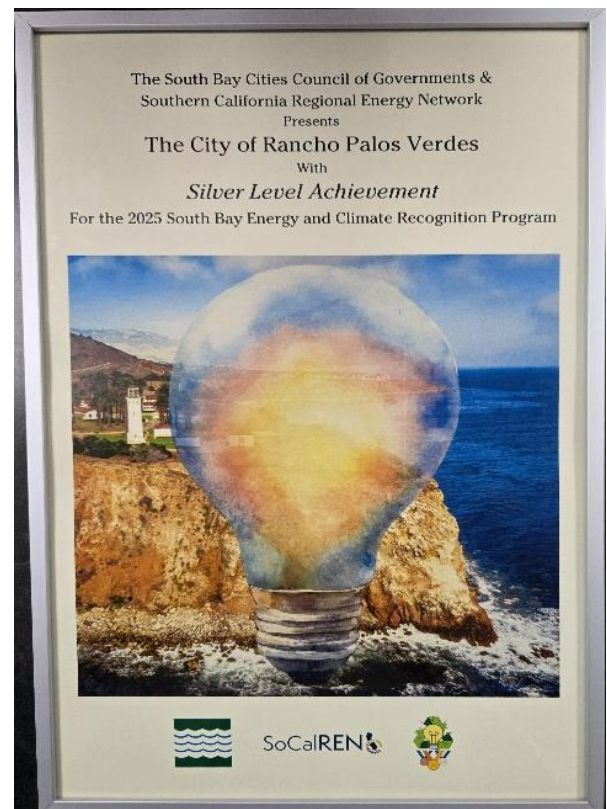
Planned activities may change due to unforeseen conditions or weather changes. Activities will be resumed immediately upon resolution of the aforementioned conditions.

Construction is anticipated to be complete by the end of the year.



2025 South Bay Energy and Climate Recognition Program – Silver Level Achievement

On December 11, the City was awarded the Silver Level Achievement for the 2025 South Bay Energy and Climate Recognition Program launched by the South Bay Cities Council of Governments (SBCCOG), in partnership with the Southern California Regional Energy Network (SoCalREN). South Bay cities enrolled in SoCalREN that meet certain thresholds in promoting strategies that demonstrate a commitment to energy efficiency, climate action, and adaptation receive recognition through this program.





- This week, the following resident service requests were submitted to the City and addressed by staff and/or contractors:
 - **74** service requests were reported.
 - **61** service requests were completed and closed out.

- In addition to routine weekly landscape maintenance at all City parks, the following were completed:
 - Repaired rutted walking trails at Eastview Park.
 - Repaired rutted walking trails at Ladera Linda Community Park.
 - Repaired several exterior lighting fixtures at City Hall.
 - Cleared a stoppage to a urinal unit at Hesse Park.
 - Repaired the heater in McTaggart Hall at Hesse Park.



- This week, ROW maintenance crews conducted landscape cleaning, weed whacking, and general landscape maintenance along medians and the public right-of-way throughout various City areas. Work locations included:

- Palos Verdes Drive South center medians and right of way from La Rotonda to Forrestal Drive.
- Hawthorne Boulevard center medians and right of way near Palos Verdes Drive West.
- Palos Verdes Drive West center medians and right of way from Hawthorne Boulevard to the City Border.
- Silver Spur Road center medians and right of way from Dry Bank Drive to Montemalaga Drive.
- Irrigation Maintenance
 - Repaired leaking irrigation lines, performed system check and made necessary adjustments to sprinkler heads at Hesse Park.
 - Repaired and adjusted several sprinkler heads at Eastview Park.

 - Repaired sidewalk deviations along Indian Peak Road and Shorewood Road.

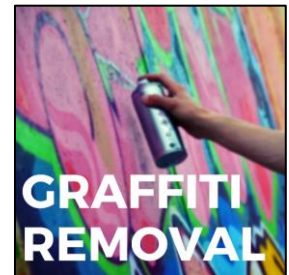

Public Works Training

The Public Works Department is dedicated to attending formal training sessions and participating in conferences from various industry organizations in order to continuously enhance the collective skillset of the department and maintain the highest standard of public service:

In 2025, Staff attended training sessions and conferences conducted by various agencies, including Caltrans, UC Berkeley, UC Davis, American Public Works Association, American Traffic Safety Services Association, South Bay Council of Governments, American Society of Civil Engineers, Los Angeles Area Maintenance Superintendents Association, Institute of Transportation Engineers, California Joint Powers Insurance Authority, and consultant partners.

Following is summary of formal training attended by Public Works Department Staff:

- Roadways – The following training sessions reinforce and expand staff’s knowledge and skills to deliver successful roadway improvement projects and provide safe work zones within and around roadways.
 - Asphalt pavement design, construction, and maintenance fundamentals
 - Development and use of pavement construction specifications and quality assurance procedures
 - Innovative asphalt mix applications, including the use of reclaimed asphalt pavement and recycled asphalt shingles
 - Pavement construction inspection techniques
 - Constructing thin-surface treatments for asphalt pavements
 - Crosswalk illumination technologies
 - Traffic Signal Operations – Overview of traffic signal timing, phasing, coordination strategies, and optimizing signal operations
 - Temporary traffic control standards, including how to establish safe work zone layouts and traffic channelization using the Work Area Traffic Control Handbook.
 - Traffic Control Technician training – Staff were trained (hands-on and via classroom) in the successful installation, maintenance, and removal of temporary traffic control devices for worksites.
 - Traffic Flagger Training, which taught staff essential skills to safely direct traffic in work zones, including training on flagger equipment and appropriate hand signaling.
- Estimating - Three training courses were conducted by staff in-house on budgeting & cost estimating fundamentals, reviewing vendor proposals, reviewing estimates for professional and construction services, and preparing detailed cost estimates. These skills further enable staff to accurately budget and forecast expenditures for maintenance work and capital projects; as well as negotiate and validate vendor cost proposals for related work.
- Project Management Best Practices – Included effective project scoping, defining project objectives, stakeholder coordination, and developing project management

plans. Applying these best practices helps minimize the risk of schedule and budget overruns over the lifecycle of a project.

- Stormwater Management – Included an overview of regulatory discharge requirements, implementation of best stormwater management practices, inspection procedures, and discharge permit responsibilities of the City. Staff's knowledge and application of these practices ensure the continued health and safety of the public and the environment.
- Public Works Specialist Certification Program – The course covered many topics including supervision, infrastructure inspections, worker safety, estimating, drainage infrastructure maintenance, traffic control, and stormwater management.
- Southern California Waste Management Forum – The forum shared knowledge regarding solid waste best management practices, and current issues of concern to the solid waste management industry. These forums help staff be aware of the latest solid waste regulations and challenges, and how to best prepare for any related impacts to our city's waste management operations.
- California Joint Powers Insurance Authority Annual Conference – staff attended several courses including the following:
 - Americans with Disabilities Act (ADA) Evaluation and Transition Planning – The course covered topics including how to effectively assess ADA compliance of public infrastructure and facilities and prepare a reasonable plan of action to implement new ADA elements.
 - Risk Management – covering strategies and methods for reducing a public agency's liability related to public contracting and public right of way matters.
 - Crisis communication – the course addressed the outcome of the LA wildfires in relation to effectively sharing critical information with the public during emergencies and disasters and how the experience and lessons learned can be applied by public agencies for future emergencies.
- Information Technology
 - Artificial intelligence (AI) – As AI continues to gain traction in the public sector, staff continue to attend conferences and sessions that enable staff to apply the use of AI for tasks proven to be effective, including project research, cost estimating references, and assistance with drafting written communications. Attending conferences about AI also keeps staff informed on recent developments in AI technology and what may be on the horizon for adoption by public agencies.
 - Cloud file storage technology – Staff attended training on the use of Microsoft Sharepoint, which is a filing and collaboration tool that allows users to securely manage and share information across multiple groups and locations, and

collaborate on individual documents simultaneously and in real-time. This tool was used this year to deliver the department's FY2025-26 5-year Capital Improvement Plan, with a high degree of success.



The Ladera Linda Community Park main backflow experienced a break in its building's main water line. The issue was identified and promptly addressed. Repairs were completed efficiently, and the system was fully restored within 24 hours of it being reported to the department. All operations are now functioning normally, and no further issues have been reported.

Over the past year(2025), the Public Works team successfully completed key maintenance, infrastructure, and emergency response projects while maintaining essential City services.

WINTER WEATHER SAFETY



Winter weather presents hazards including extreme cold, rain, snow, and high winds. These hazards cause an increase in car accidents, hypothermia, carbon monoxide poisoning and heart attacks from overexertion. Staying informed of inclement weather and being prepared is the key to staying safe during winter weather.



At Home:

- Have a disaster supply kit or “Go-Bag” that has enough food, water, medication, and other necessities that could last for 10 days. Be ready in case of you must evacuate.
- Ensure smoke and carbon monoxide detectors are working properly.
- Check your home heating to make sure your heating system is working properly.
 - If using a generator, keep it outside and 10 feet away from doors and windows.
 - Only use approved heaters that have the Underwriters Laboratories (UL) logo, which indicates it meets safety standards. 
 - Never use stoves, barbecues, or ovens for home heating purposes as they can produce deadly carbon monoxide



Outdoors:

- Dress warmly, wearing layers of warm clothing including gloves, scarves, and hats.
- Limit your time outside in cold weather and avoid overexertion.
- Stay dry. Wet clothing loses its insulation, so change into dry clothes as soon as possible.
- Seek a warm environment and/or medical attention if you notice signs of hypothermia, which may include: shivering, disorientation, and/or drowsiness.



BUILDING YOUR EMERGENCY SUPPLY KIT ✓

This month's item: **Warm clothes.** Pack jackets and other warm clothing for all household members in your go bag, in case you must quickly leave home.





Driving and Road Safety:

- If possible, avoid driving during inclement weather.
- If you must drive in bad weather, slow down and stay alert. Fallen trees, downed power lines, potholes, and flooded streets are among the hazards that can be expected during and after storms.
- Never attempt to drive across flooded streets. Just 6 inches of fast-moving water can carry away an adult, 12 inches can carry a small car, & 2 feet can carry away a truck.
- Check your vehicles tires for proper inflation pressure and condition or tread depth.
- Keep a survival kit or go-bag in your car. A blanket, flashlight, first-aid kit, and extra clothing are just some of the recommended items.
