




Volunteer for the Homeless Count 2026


Wind Safety

Strong winds may impact RPV this week. Keep yourself and your property safe:

- ✓ Secure loose gutters and shutters.
- ✓ Trim tree branches near your house.
- ✓ Tie down or bring inside any loose outdoor items.
- ✓ Charge batteries of essential items, as strong winds can create power outages.
- ✓ If you are driving, use caution and:
 - Treat traffic lights that are non-operational as a 4 way stop sign.
 - Keep both hands on the wheel and watch for hazards.
 - Keep a distance from high profile (large or tall) vehicles.
- ✓ Never walk or drive over a downed power line.



10 Tips for Preventing Electrical Fires



1. Plug only 1 heat-producing appliance (ex. space heater, microwave) directly into a wall outlet at a time.
2. Do not use an appliance with a cracked, damaged or loose cord.
3. Do not overload outlets.
4. Use power strips that have internal overload protection.
5. Never use an extension cord with a heat-producing appliance or major appliances (stove, dryer, fridge).
6. Stop using your device right away if the battery smells weird, gets too hot, makes popping noises, or changes in shape or color.
7. Always use the original charging cable that came with the device, and follow all manufacturer directions.
8. Charge lithium-ion batteries on a hard, flat surface and avoid charging on beds or couches. For e-scooters, e-bikes, or power tools, the safest place to charge them is outside, away from doors and windows.
9. Keep anything that can burn away from lamps, light fixtures and light bulbs.
10. Use lightbulbs that match the recommended wattage on the lamp or fixture.




Job Openings and Labor Turnover – November 2025

On January 7, 2025, the Bureau of Labor Statistics released November 2025 data from the Job Openings and Labor Turnover Survey (JOLTS). This monthly report includes estimates of the number and rate of job openings, hires, and separations and provides insights into the current labor market.

As reported, the number of job openings totaled 7.1 million for the month ending November 2025, with minimal changes from the previous month. At 3.2 percent or 5.1 million, the rate and number of hires were little changed from October 2025. The rate and number of total separations were little changed, at 3.2 percent or 5.1 million.

November 2023 - November 2025





Chart 2. Hires and total separations rates, seasonally adjusted,

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The DDWs continue to be monitored and re-drilled or replaced as needed within the current approved budget.
- The total combined water extraction rate of the DDWs is currently at approximately **490 gallons per minute** or approximately **0.7 million gallons per day**.
- Since the start of the DDW program, approximately **423 million gallons** or **1,296 acre -feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-4 is currently offline due to pump failure. The City team is investigating the situation to determine root cause and appropriate remedy.
 - DDW-6 is currently offline due to pump failure. The City team is investigating the situation to determine the root cause and an appropriate remedy.
 - DDW-8 has sheared and is offline. The City's geologist team is reviewing the situation and preparing recommendations on how to proceed.

Status of Winterization:

Construction work for winterization measures was largely completed prior to the Christmas 2025 storms. Remaining winterization work in and around Altamira Canyon will be wrapped up over the next two weeks barring any adverse weather impacts.

Sinkhole on Hawthorne Boulevard at Indian Valley Road

On December 27, 2025, Public Works responded to reports of a sinkhole in a northbound travel lane on Hawthorne Boulevard at Indian Valley Road. With the assistance of the Los Angeles County Sheriff's Department, the road was temporarily closed to allow for an assessment of the sinkhole. Traffic-rated steel plates were installed on Hawthorne Boulevard in the vicinity of the sinkhole to allow traffic to safely resume travel while long-term repair plans are developed and implemented. Public Works is preparing repair plans with associated schedules for the City Council's consideration at a future City Council meeting. Information on road impacts will be provided to the public as soon repair plans and schedules are finalized.

Hawthorne Boulevard at Eddinghill/Seamount Left Turn Signal Construction Completed Ahead of Schedule

The left turn signal arrows for Hawthorne Boulevard at Eddinghill Drive/Seamount Drive have been completed.

The project included:

- Left-Turn Arrow for both northbound and southbound Hawthorne Boulevard left turns
- Traffic signal hardware and equipment updates including a new traffic cabinet and signal controller; upgraded traffic signal mast arms to accommodate the new left turn signal heads; upgraded intersection lighting, new illuminated street name signs; and upgraded intersection accessibility curb ramps

Construction of the intersection began on October 6, 2025 and was completed on December 18, 2025, which was eleven days ahead of schedule.

Staff are monitoring operations and may adjust signal timing if necessary.


EMERGENCY ISSUES

During the holiday closure from December 24, 2025 to January 2, 2026, the Maintenance team responded promptly to multiple service calls related to the Christmas 2025 storm that impacted the City. Public Works team members and City vendors addressed multiple downed trees, fallen branches, and mud and debris/rockfall encroaching onto sidewalks and roadways to ensure public safety. In addition, crews removed debris and sediment from catch basins to restore proper drainage and reduce the risk of localized flooding.

Public Works team members also implemented traffic control measures and removed ponding water on Palos Verdes Drive South near Wayfarers Chapel area as well as near Klondike Canyon.

The Public Works team also responded to a sinkhole implementing measures to open travel lanes as soon as safely possible.

These responses occurred outside of regular business hours, demonstrating Public Works' continued commitment to public safety and readiness to respond during emergencies, holidays, and adverse weather conditions.

COMMUNITY DEVELOPMENT DEPARTMENT

No Construction on Monday, January 19 (Martin Luther King Jr. Day)

Pursuant to Section 17.56.020(B) of the Rancho Palos Verdes Municipal Code, it is unlawful to carry on construction, grading, or landscaping activities, or to operate heavy equipment except between the hours of 7:00 A.M. and 6:00 P.M. Monday through Friday, and between the hours of 9:00 A.M. and 5:00 P.M. on Saturday. No such activity shall be permitted on Sundays, or the legal holidays, unless a Special Construction Permit is approved by the Community Development Director. January 19, 2026, is considered a legal holiday for this application. Click [here](#) to download the Special Construction Permit application. Swale Maintenance

Swales tend to become filled with leaves, overgrown vegetation, and debris over the course of the year. As a reminder, it is a property owner's responsibility to maintain a drainage swale on their property so that it functions properly. Improperly maintained drainage swales interfere with proper drainage flows that can result in property damage caused by slope failure, erosion, or excess storm-water runoff. As we have approached the rainy season, now is the time to clean your swales.

As an additional reminder, the City's Municipal Code does not permit the construction of any structure within or above a drainage swale, or on a slope on or equal to 35% or greater. This includes decks, stairs, or structures of any kind. Please keep this in mind if you're planning a project near or on a slope.

Planning Division Monthly Activity Report





removing an individual, the presiding member or their designee shall warn the individual that their behavior is disrupting the meeting and that their failure to cease their behavior may result in their removal. The presiding member or their designee may then remove the individual if they do not promptly cease their disruptive behavior. This paragraph does not apply to any behavior described in subparagraph (B) of paragraph (1) of subdivision (b)(1) means engaging in behavior during a meeting of a legislative body that actually disrupts, disturbs, impedes, or renders infeasible the orderly conduct of the meeting and includes, but is not limited to, one of the following: (A) A failure to comply with reasonable and lawful regulations adopted by a legislative body pursuant to Section 54954.3 or any other law. (B) Engaging in behavior that constitutes use of force or a true threat of force. (2) "True threat of force" means a threat that has sufficient indicia of intent and seriousness, that a reasonable observer would perceive it to be an actual threat to use force by the person making the threat.

Time Estimates:

The time noted next to an agenda item is only an estimate of the amount of time that will be spent during the meeting on that particular item. Accordingly, these estimates should not be relied on in determining when a matter will be heard, especially since agenda items are often re-ordered during a meeting and may be discussed at any time.

Continuation of Meeting:
