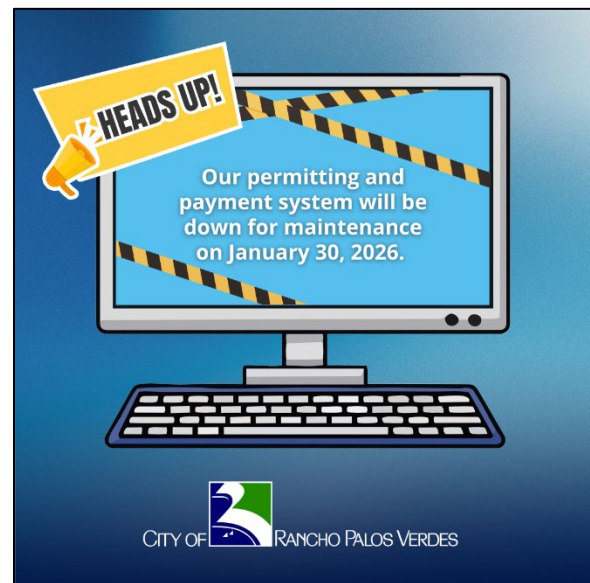

One-Day Permitting System Outage on January 30

On January 30, 2026, the City of Rancho Palos Verdes will perform scheduled maintenance on its permitting and payment system, TRAKiT. During this time, processing for all City permits, planning projects, and payments using TRAKiT will be **temporarily unavailable**. The permit system is scheduled to be back at full functionality during normal business hours on February 2. Online payments are expected to resume on January 31.



What will be affected and unavailable, both in person and online:

- Processing and issuance of almost all City permits:
 - Planning Division permits and project approvals
 - Building and Safety Division permits
 - Public Works permits
 - Film permits
 - Business License applications and renewals
- All payments

City staff will remain available for questions and inspections during normal business hours.

Please plan ahead:

- Submit urgent applications and payments **before January 30**, or after maintenance is complete.

Thank you for your patience as we work to maintain and improve City services.

Mayor Seo Tours Wastewater Treatment Plant

Today, Mayor Seo toured the Los Angeles County Sanitation Districts' (LACSD) San Jose Creek Water Reclamation Plant in Whittier. Mayor Seo joined fellow Directors to learn about the agency's wastewater projects and tour the facility, which serves approximately 1 million people. LACSD is a public agency composed of 24 independent special districts, which is focused on converting



waste into resources like recycled water, energy and recycled materials. Mayor Seo is the City's representative for Sanitation District No. 5 and the South Bay Cities Sanitation District for 2026. In Rancho Palos Verdes, LACSD maintains two above-ground sanitary sewer trunk lines that run along Palos Verdes Drive South, which convey wastewater from much of the Palos Verdes Peninsula to the treatment facility.

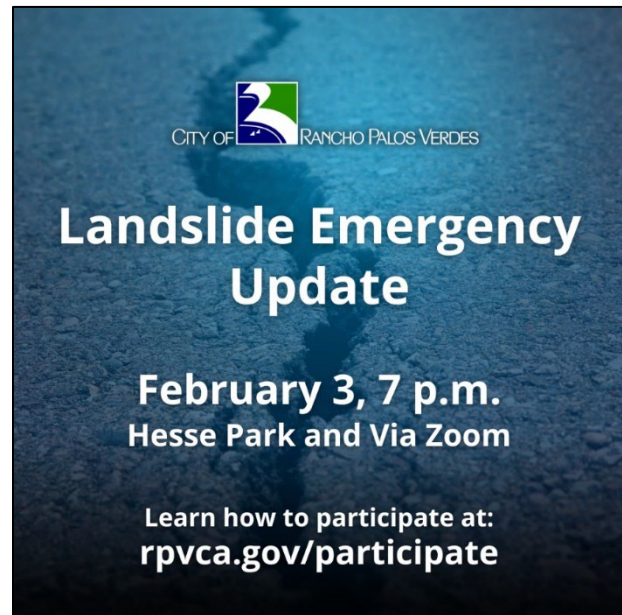
Land Movement Updates



February 3, 2026 City Council Meeting

On February 3, 2026, the City Council will receive the latest updates on the landslide emergency.

According to the most recent survey data collected in early January, since November, the Abalone Cove Landslide accelerated by an average of 18% to approximately 2.15 inches per week and the Portuguese Bend Landslide accelerated by an average of 20.8% to 1.38 inches per week. The Klondike Canyon Landslide continued to see no measurable movement. The average movement rate for areas still moving within the active landslide boundary was 1.66 inches per week, a 14.3% increase since November.



The City's geologist believes the most likely factor contributing to reacceleration is the added mass of significant early season rainfall percolating into the landslide. As of last week, 11.61 inches of rain have fallen on the Palos Verdes Peninsula in the 2025-26 rainy season, which is about 84% of average seasonal rainfall. A similar phenomenon was observed in March and April of 2025, following February and March 2025 rainfall. However, landslide deceleration resumed by May 2025, as the rainy season waned and the pumping of deep dewatering wells continued.

At next week's meeting, the Council will also receive a financial update and consider extending by 60 days the local emergency declarations in the landslide area and the temporary prohibition of bicycles, motorcycles, and other similar wheeled vehicles from an approximately 2-mile stretch of Palos Verdes Drive South.

Palos Verdes Drive South Overnight Closures February 11-13

Palos Verdes Drive South will be fully closed overnight in the landslide area for three consecutive nights on February 11-13, 2026, due to Public Works surveying the area. The 2-mile stretch of the roadway will be closed from 8 p.m. to 6 a.m. nightly to all vehicle traffic in **both directions** from Peppertree Drive to Schooner Drive. **Drivers should plan ahead and use an alternate route.**

Why is the temporary road closure necessary?

The City of Rancho Palos Verdes is conducting a study to help better understand groundwater in the Portuguese Bend Landslide and how it flows underground. This valuable information will be used by the City's engineers to optimize solutions to slow the landslide, prevent future acceleration, and ensure the long-term integrity of Palos Verdes Drive South. The three-night, full closure is necessary so equipment used for subsurface mapping can detect groundwater without noise and vibration interference.



What is the City doing to minimize impacts?

This work is taking place overnight to ensure minimal disruptions. The City is notifying impacted neighborhoods and businesses and coordinating with the Lomita Sheriff's Station and the Los Angeles County Fire Department so they can plan accordingly. Portuguese Bend Community Association residents will still have access to the Narcissa Drive gate and the Peppertree Drive gate (westbound travel only). Message boards are being placed along Palos Verdes Drive South to advise drivers of the planned closures.

New Legislative Priority Added to the 2026 Legislative Platform

Rancho Palos Verdes City Council directed staff to include a new legislative priority in the upcoming 2026 Legislative Platform to ensure the continued availability of paper coupons or the extension of digital coupon pricing to grocery store patrons

in Rancho Palos Verdes. This new priority aims to protect equitable access to grocery discounts for all residents, including those who rely on traditional paper coupons or cannot easily access online offers.

As grocery stores increasingly shift towards offering digital coupons, requiring customers to access them through smartphones applications or online accounts, concerns have emerged about residents who may have limited access to smartphones, the internet or digital literacy. While digital promotions might streamline store operations, they may exclude older adults, individuals with limited connectivity, or others who face barriers using digital platforms.

Since October 2025, Staff have sent letters to Kroger (parent company of Ralphs) and Smart & Final, the two grocers serving Rancho Palos Verdes, requesting information about each company's approach to balancing digital promotions with more traditional formats such as paper coupons. Staff have also met with local store managers to understand how digital pricing is provided to customers who request paper coupons alternatives upon request, particularly for senior citizens. Both stores indicated that they honor both digital and paper coupons. Staff are currently awaiting responses from the corporate offices of both Kroger and Smart & Final. In addition, the City Council has directed staff to work with our State representatives to explore opportunities for introducing or supporting state legislation in 2026 to ensure the continued availability of paper coupons throughout California.

Since 2021, the City Council has adopted an annual Legislative Platform that identifies the most salient issues each year. The City monitors and acts upon legislation, programs, and funding opportunities that may have an impact on Rancho Palos Verdes, the Palos Verdes Peninsula and the surrounding region.

Utility Safety

In Rancho Palos Verdes, home utility services include electricity, natural gas, and water. While most of the time these services are provided without issue, it is important to understand how to stay safe with these utilities at home. Read below for utility emergency safety tips and guidance. Always consult the local utility provider and/or a licensed professional for additional home utility safety requirements and suggestions.

Electrical: Southern California Edison – <https://www.sce.com/>

- A Ground Fault Circuit Interrupter (GFCI) outlet will cut power when an imbalance in current is detected. Having a licensed electrician install GFCI outlets in wet areas like bathrooms, kitchens, garages, and outdoors is required by code and can prevent electrical arcing that can lead to a fire.
- Do not overload outlets with too many devices or plugs.
- Use extension cords that are not damaged and that have a third (ground) prong.
- Consider outlet covers or safety plugs.
- Only use approved space heaters that have the Underwriters Laboratories (UL) logo, which indicates it meets safety standards.
- Never use stoves, barbecues, or ovens for heating since they can produce deadly carbon monoxide.

Gas: Southern California Gas Company – www.socalgas.com

- Natural gas is naturally odorless, but mercaptan, a sulfur or rotten egg smelling additive, is added to natural gas so it becomes recognizable when present.
- If you smell gas, do NOT light matches, smoke, or use appliances. Open windows and doors as you leave the building and call 911.
- Know where your gas shut off is and know how to turn it off. Ensure you have a tool, such as a crescent wrench, close by the meter in case you must shut it off.
- Install smoke detectors that include carbon monoxide (CO) detectors near bedrooms and around the house.
- Store flammable items such as paint, paper goods, and solvents away from gas appliances.
- Cal 811 or visit www.california811.org prior to any digging project to have underground natural gas lines identified and marked to prevent accidental leaks, fires, explosions, and injuries.

Water: California Water Service – www.calwater.com/rpv

- If a water leak occurs, locate the closest water shut off valve. For sinks, shutoff valves may be under the sink and/or located outside near a hose bibconnection. The main water shut off may also be in the water meter box near the sidewalk or street at the front of your property.
- Using a meter key, wrench, or screwdriver, turn the valve closest to your home in a clockwise direction, a quarter turn at a time until the water stops.
- Attempt to contain the water by diverting it to a drain or to the outside using rolled up towels.

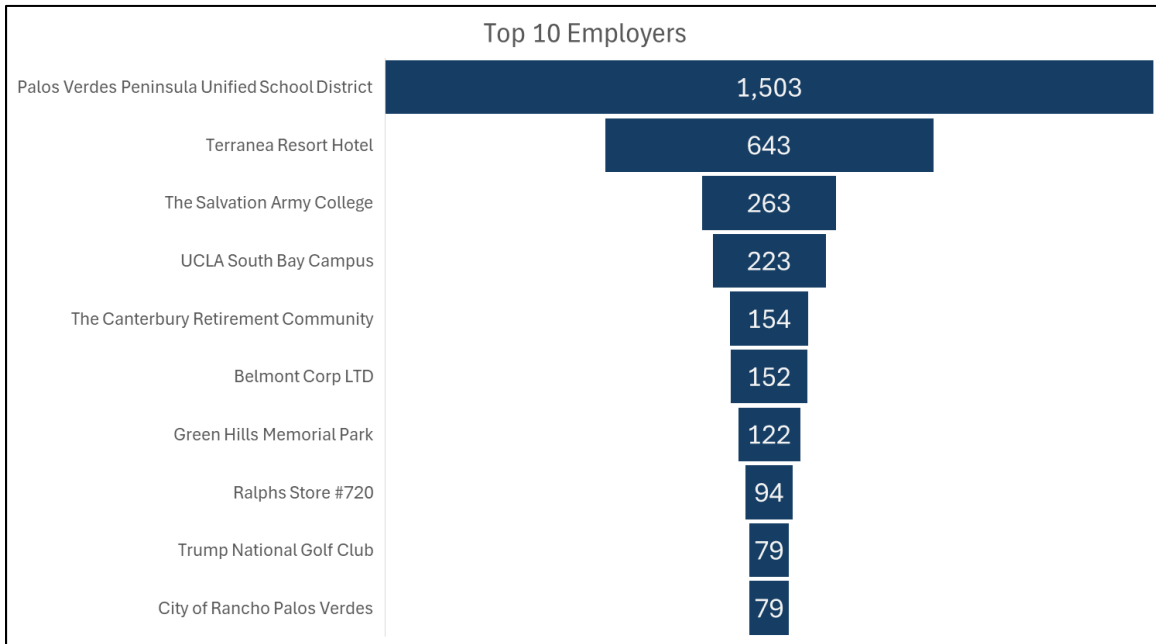

Case-Shiller Home Price Indexes – November 2025

On January 27, 2026, data from the S&P CoreLogic Case-Shiller Home Price Indexes, the leading measure of residential real estate prices, was released for November 2025. This information provides insight into the housing market by highlighting monthly and annual changes reported in the National and Los Angeles Home Price Indexes.

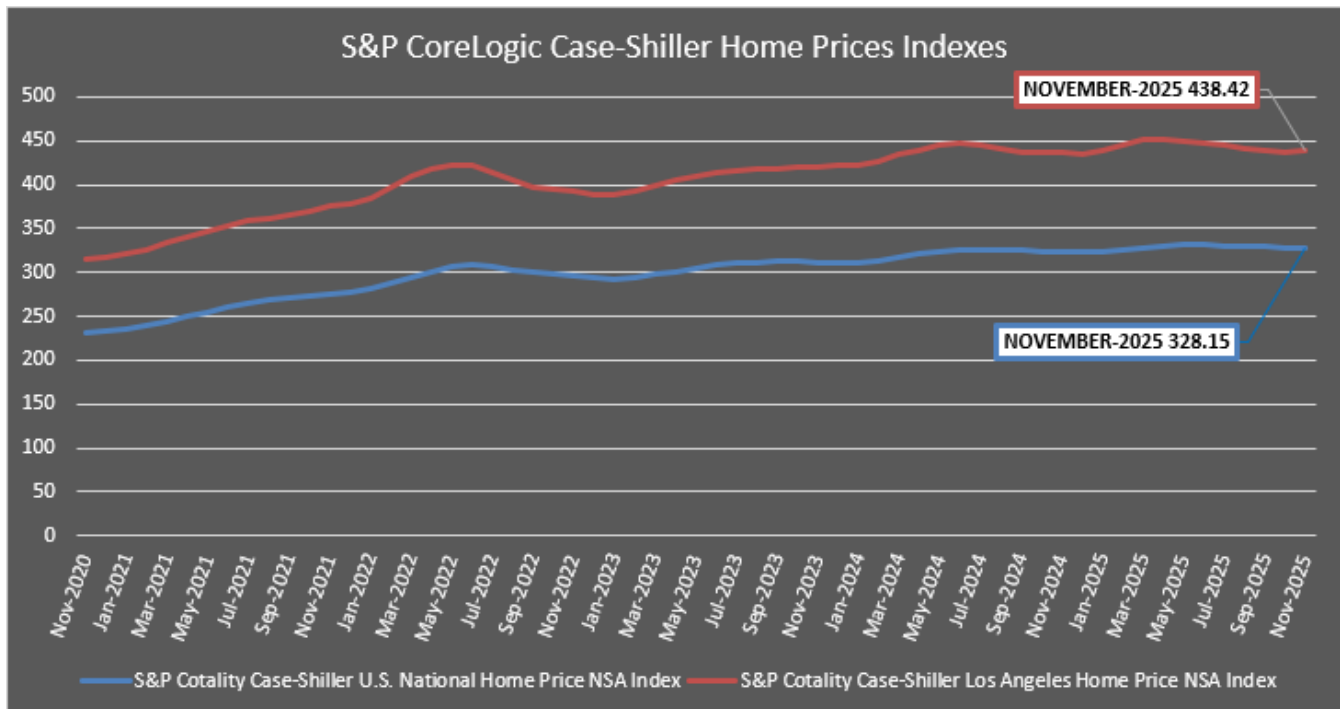
Month-over-Month

The pre-seasonally adjusted U.S. National Index reported a slight decrease of -0.1%. The 20 City Composite reported a decrease of 0.03% while the 10 City Composite Index reported an increase of 0.1% for November 2025. After seasonal adjustment, the U.S. National Index reported an increase of 0.4% and the 10 City Composite and 20 City Composite both posted a month-over-month increase of 0.5% for November 2025.

Year-over-Year

The National Index reported a 1.4% annual return in November 2025. At 0.4%, the annual return for Los Angeles was significantly lower than the national average gain. Among the 20 cities in the indexes, Chicago reported the highest annual gain with a 5.7% increase in November 2025. New York and Cleveland also reported higher than average annual increases of 5.0% and 3.4%, respectively. Tampa posted the lowest return for the month of November 2025 at -3.9%.

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

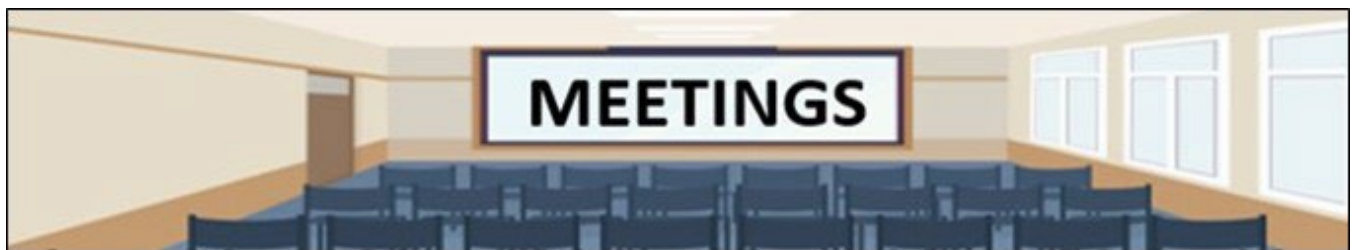
- The total combined water extraction rate of the DDWs is currently at approximately **400 gallons per minute** or approximately **0.6 million gallons per day** which is lower than typical because of three sheared wells.
- Since the start of the DDW program, approximately **431 million gallons** or **1,321 acre -feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-4, DDW-6 and DDW-8 have recently sheared and are currently offline. In accordance with the recommendations from the City Geologist team, the wells are scheduled to be re-drilled and brought back into service over the next several weeks.

Status of Winterization:

City winterization of Upper Altamira Canyon is substantially complete with site clean-up and erosion control measure remaining. Portuguese Canyon winterization is also substantially complete, as is the winterization of other areas.

Traffic Safety Committee (TSC)

A TSC meeting was held on Monday, January 26, at 6:00 p.m. in the Community Room at the Ken Dyda Civic Center and discussed the following:

Bloomwood Speed Hump Study Update:

TSC recommended implementing the following staff-recommended traffic measures:

- Enhance existing stop signs with “stop ahead” signs, additional pavement markings, and reflective posts.

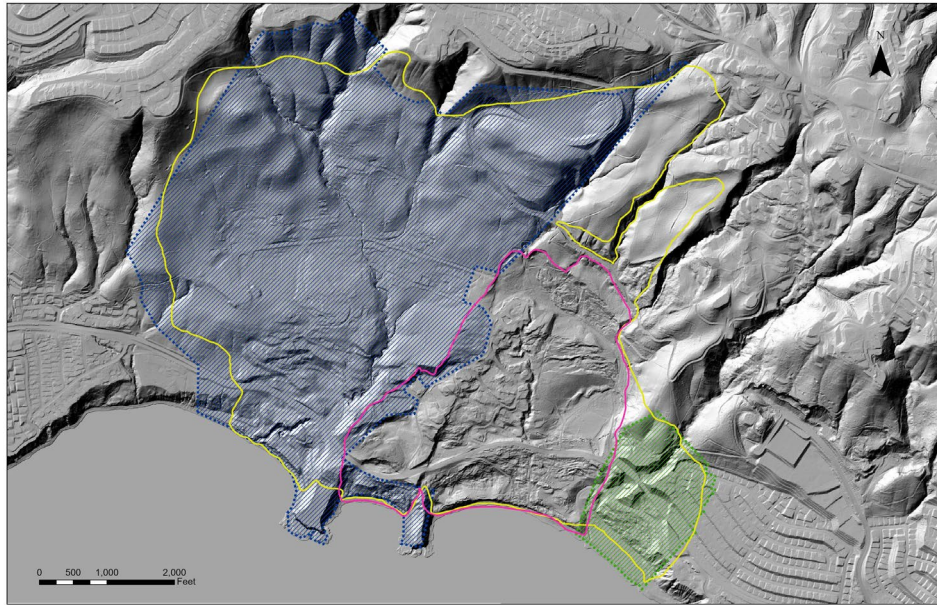
Speed humps were not recommended as the traffic study data collected showed that prevailing speeds are below the 25 MPH speed limit. Additionally, speed humps were not recommended because the roadway segment slope exceeds 8%, which is the maximum threshold recommended for the installation of speed humps.

Traffic Request Framework Update:

TSC continued discussions to streamline the traffic request process by removing inefficient review steps and incorporating early community feedback. Staff presented a revised framework reflecting comments from the December 3, 2025 Special TSC Meeting. Following discussion, the TSC unanimously adopted the revised framework, now titled “TSC Process Guidelines” (January 2026), for use by the TSC, staff, and residents going forward.

Request for Proposals Issued for Investigating Formation of Portuguese Bend Landslide Abatement District

The City issued a Request for Proposals (RFP) so that a consultant may be hired to investigate the formation of a new Geologic Hazard Abatement District (GHAD) for the Portuguese Bend Landslide. The new GHAD is planned to be called the Portuguese Bend Landslide Abatement District (PBLAD). The PBLAD would be the third GHAD in the City of Rancho Palos Verdes joining the Abalone Cove Landslide Abatement District (ACLAD) and the Klondike Canyon Landslide Abatement District (KCLAD).



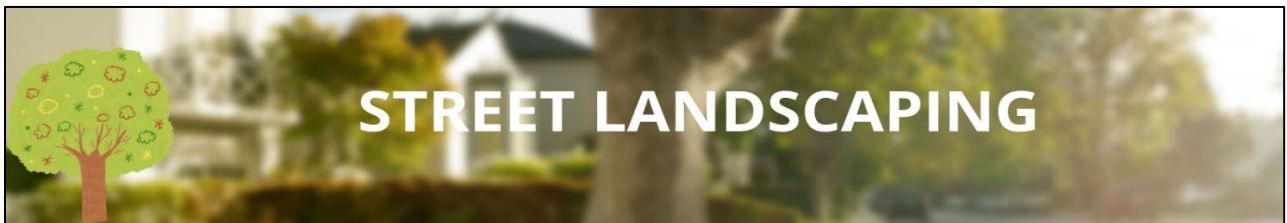
MAINTENANCE ACTIVITIES

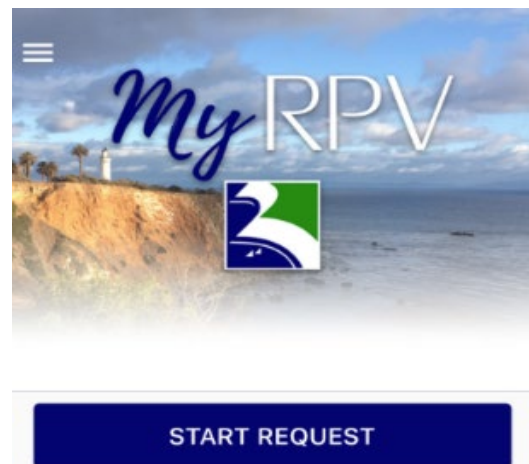

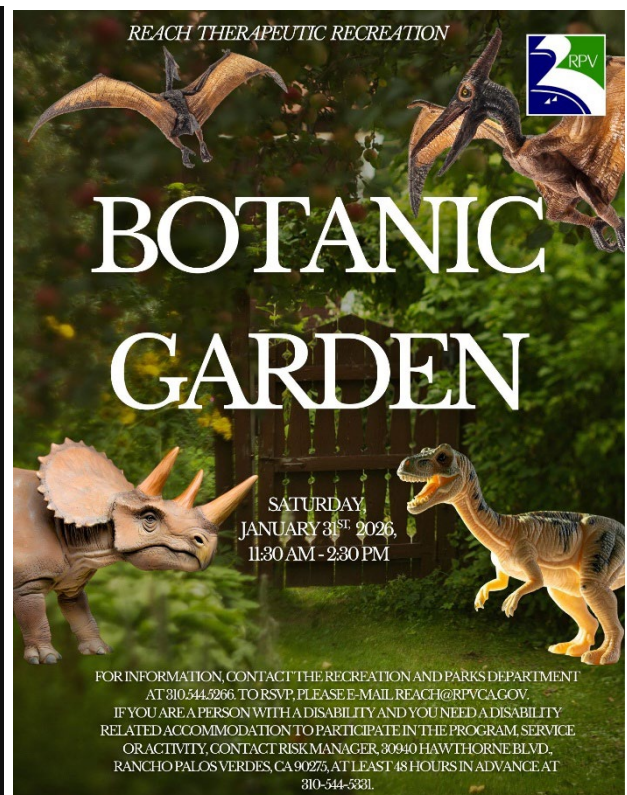

HOME UTILITY SAFETY

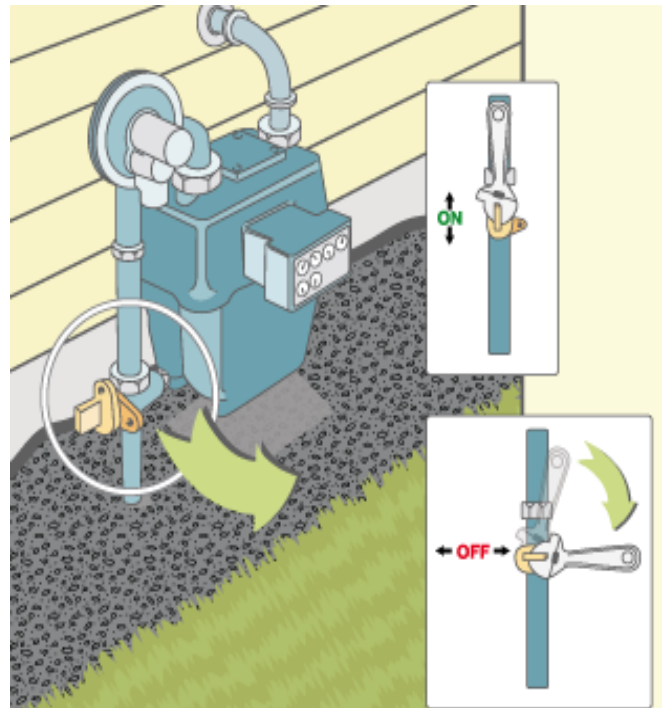
In Rancho Palos Verdes, home utility services include Electricity, Natural Gas, and Water services. While most of the time these services are provided without issue, it is important to understand how to stay safe with these utilities at home. Read below for utility emergency safety tips and guidance. Always consult the local utility provider and/or a licensed professional for additional home utility safety requirements and suggestions.

Electrical: Southern California Edison – <https://www.sce.com/>

- A Ground Fault Circuit Interrupter (GFCI) outlet will cut power when an imbalance in current is detected. Having a licensed electrician install GFCI outlet in wet areas like bathrooms, kitchens, garages, and outdoors is required by code and can prevent electrical arcing that can lead to a fire.
- Do not overload outlets with too many devices or plugs.
- Use extension cords that are not damaged and that have a third (ground) prong.
- Consider outlet covers or safety plug
- Only use approved space heaters that have the Underwriters Laboratories (UL) logo, which indicates it meets safety standards.
- Never use stoves, barbecues, or ovens for heating since they can produce deadly carbon monoxide.

Gas: Southern California Gas Company – www.socalgas.com

- Natural gas is naturally odorless, but Mercaptan, a sulfur or rotten egg smelling additive, is added to natural gas so it becomes recognizable when present.
- If you smell gas, do NOT light matches, smoke, or use appliances. Open windows and doors as you leave the building and call 911.
- Know where your gas shut off is and know how to turn it off. Ensure you have a tool, such as a crescent wrench, close by the meter in case you must shut it off.
- Install smoke detectors that include Carbon Monoxide (CO) detectors near bedrooms and around the house.
- Store flammable items such as paint, paper goods, and solvents away from gas appliances.
- Cal 811 or visit www.california811.org prior to any digging project to have underground natural gas lines identified and marked to prevent accidental leaks, fires, explosions, and injuries.

- If a water leak occurs locate the closest water shut off valve. For sinks, shutoff valves may be under the sink and/or located outside near a hose bib connection. The main water shut off may also be in the water meter box near the sidewalk or street at the front of your property.
- Using a meter key, wrench, or screwdriver, turn the valve closest to your home clockwise, a quarter turn till the water stops.
- Attempt to contain the water by diverting to a drain or outside using rolled up towels.

GET THE NOTIFICATION

- Stay alert and pay attention to weather reports, forecasts, and warnings.
- Sign up for **Alert Southbay** to receive local emergency alerts for RPV:
Text AlertSB to 888777, online at alertsouthbay.com, download the free Everbridge app on Google Play or the App Store.

LITHIUM-ION BATTERIES

Lithium-ion batteries store a large amount of energy in a small amount of space. Due to this feature, they are used to supply power to many kinds of devices including smart phones, laptops, e-scooters and e-bikes, e-cigarettes, smoke alarms, toys, and even cars. If used incorrectly, such as for an application other than originally designed, or if they become damaged or defective, these batteries can overheat, catch on fire, or explode.



LITHIUM-ION BATTERY SAFETY RECOMMENDATIONS

- Only purchase and use devices, batteries, and charging equipment that are listed by a nationally recognized testing lab and labeled accordingly. Look for these markings or symbols:
 - “CSA” (CSA Group)
 - “ETL” (Intertek)
 - “UL” (Underwriters Laboratories)
 - *Note: If product has a “CE” marking, it means it’s sold in Europe and isn’t recommended for use in the United States.*
- Always follow the manufacturer’s instructions.
- Only use the battery that is designed for the device.
- Place batteries in the device the right way.
- Only have device repairs performed by a qualified professional.
- Only use the charging equipment that is supplied with your device.
 - Many “aftermarket” chargers have been known to overheat.
- Stop charging a battery once it is full (at 100%) and remove from power source to avoid overheating.
- Store batteries at room temperature when possible.
- Don’t store lithium-ion batteries in direct sunlight or inside vehicles.
- Keep batteries or devices away from heat sources.
- Keep batteries or devices away from anything that can catch fire.
- Do not charge a battery when either the charger or the battery is damaged.
- Do not store batteries in an area that blocks the only exit out of a room.
- Do not attempt to modify the battery or charger.

PROBLEM INDICATORS

Stop using the battery if you notice these problems:

- Odor
- Change in color
- Excessive heat
- Change in shape
- Leaking
- Odd noises

If you encounter any of these and it is safe to do so, move the device away from anything that can catch fire. **Call 911 if necessary.**

BATTERY DISPOSAL

Do not place lithium-ion batteries in the trash. Recycling is the best option. Do not place discarded batteries in piles. **Follow your department's battery recycling procedure if you must dispose of the battery at your work location.**

CHARGING E-BIKE or ELECTRIC VEHICLE

The safest place to charge these devices is outdoors in a flat, dry area away from structures, children, direct sunlight, liquids, tripping hazards, and in a location where the electronic vehicle is not at risk of falling.

Electric Vehicles: Safe Charging at Home

SAFETY TIPS

- Use devices that are listed by a qualified testing laboratory.
- Read and follow all manufacturer directions.
- Check chargers and cords for damage before using. Never use if damaged.
- Do not use extension cords with the charger.
- Install charging equipment in safe locations. Keep away from busy areas and things that could catch fire.
- Keep charging items out of reach of children and animals when not in use.
- Cover charging station outlet to keep water out.
- Before charging an electric vehicle at home, have a qualified electrician:
 - ~ Check your electrical system to see if it can handle charging.
 - ~ Install a new circuit just for your charging device.

Warning!

- ⚡ Electric vehicles have high voltage batteries.
- ⚡ Battery maintenance should be performed by the manufacturer.
- ⚡ Do not touch the orange high voltage cables.



For Level 1 Charging:

- Use the charging cord that came with the electric vehicle.
- Use a standard household plug.
- Make sure charger or outlet has GFCI protection.
- Use only a dedicated circuit to charge.

For Level 2 Charging:

- Use a 240-volt outlet. A qualified electrician needs to install this type of outlet.
- Only use outdoor rated charging stations outdoors.
- Keep cords off the ground.

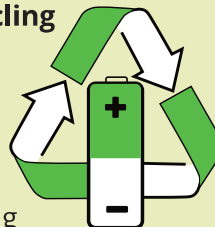

- Dispose lithium-ion batteries at designated recycling facilities to avoid environmental hazards or call 2-1-1 for assistance.
