Land Movement Updates



Starting TONIGHT: Palos Verdes Drive South Overnight Closures February 11-13

Palos Verdes Drive South will be fully closed overnight in the landslide area for three consecutive nights on February 11-13, 2026, due to Public Works surveying the area. The 2-mile stretch of the roadway will be closed from 8 p.m. to 6 a.m. nightly to all vehicle traffic in **both directions** from Peppertree Drive to Schooner Drive. **Drivers should plan ahead and use an alternate route.**



Why is the temporary road closure necessary?

The City of Rancho Palos Verdes is conducting a study to help better understand groundwater in the Portuguese Bend Landslide and how it flows underground. This valuable information will be used by the City's engineers to optimize solutions to slow the landslide, prevent future acceleration, and ensure the long-term integrity of Palos Verdes Drive South. The three-night, full closure is necessary so equipment used for subsurface mapping can detect groundwater without noise and vibration interference.

What is the City doing to minimize impacts?

This work is taking place overnight to ensure minimal disruptions. The City has notified neighborhoods and businesses and coordinated with the Lomita Sheriff's Station and the Los Angeles County Fire Department, so they can plan accordingly. Portuguese Bend Community Association residents will still have access to the Narcissa Drive gate and the Peppertree Drive gate (westbound travel only). Message boards have been placed along Palos Verdes Drive South to advise drivers of the planned closures.

Get Emergency Alerts

1. [Alert South Bay](#) is the primary source of providing local emergency alerts and information. Alerts are provided via phone calls, texts, and/or emails, based on your preference. You can sign up to receive alerts for multiple locations in the area. Sign up at: www.alertsouthbay.com.
2. [WEAs](#) (Wireless Emergency Alerts) may be sent during emergency situations. You do not have to sign up to receive these alerts. Alerts have a unique sound and appear like a text message on your phone.
3. [MyRPV App](#) provides emergency and safety-related push alerts directly from RPV City Staff. The app also provides city related information.
4. [American Red Cross App](#). This all-inclusive app combines more than 35 emergency alerts to help keep the user safe. The app provides alerts for earthquakes, floods, wildfires, hurricanes and more. Users can put multiple locations around the nation to monitor.

Find Emergency Information

1. [PVPReady.gov](#) is a Palos Verdes Peninsula-run website that hosts an emergency zone map, where you can learn your zone and find its current status, along with what actions you should take to stay safe in the event of an emergency. The website also includes information about preparing for and responding to emergencies.

2. **Wildfires:** The [Watch Duty App](#) provides a one stop shop for local wildfire information collected from a variety of sources, including local fire departments' websites, Genasys Protect, Air Quality Indexes, and AlertCalifornia Wildfire Cameras.
3. **Weather-Related Disasters:** The [National Weather Service](#) website and app provide current weather alert information, forecasts, and other weather-related emergency information

Operating Budget Excellence Award

The Finance Department is proud to announce that the City received the "Operating Budget Excellence Award" for Fiscal Year 2025-26 by the California Society of Municipal Finance Officers (CSMFO). This is the first year the City has received this award, which recognizes the City's well-presented budget documents, best practices, processes,

and procedures.



The list of award winners for 2025 has not yet been posted; however, approximately 100 municipalities, out of 483 in California (20%), received the award in 2024. This award is in addition to the “Distinguished Budget Presentation Award” from the Government Finance Officers Association (GFOA), received in December for the FY2025-26 Budget Book, marking the fourth time the City has earned the award.

Top 25 Sales Tax Producers in Rancho Palos Verdes

As reported, receipts for the City of Rancho Palos Verdes from July through September 2025 were 25.6% above the same period in 2024. Restaurants and hotels reported a beneficial increase of more than \$40,000. The business industry increased by more than 50% or \$7,000, compared to the third quarter of 2024. While overall results were strong, fuel service stations followed the statewide trend of lower results due to lower consumption and increased prices. It is also worth noting that taxable sales for all of Los

Angeles County were flat over the comparable time period, and the general Southern California region was up by 1.8%.

Job Openings and Labor Turnover – December 2025

On February 5, 2026, the Bureau of Labor Statistics released the December 2025 data from the Job Openings and Labor Turnover Survey (JOLTS). This monthly report includes estimates of the number and rate of job openings, hires, and separations and provides insights into the current labor market.

As reported, the number of job openings totaled 6.5 million for the month ending

December 2025, continuing a downward trend. At 3.9 percent, the job opening rate slightly decreased from November 2025. The number of job openings decreased was most noticeable in the business services (-257,000), retail trade (-195,000) and finance and insurance (-120,000).

Chart 1. Job openings rate, seasonally adjusted, December 2023 - December 2025





Chart 2. Hires and total separations rates, seasonally adjusted, December 2023 - December 2025

Landslide Emergency Stabilization

In response to unprecedented movement of the deep slide plane in the Greater Portuguese Bend-Ancient Altamira Landslide Complex (Landslide Complex), the City installed vertical deep de-watering wells (DDWs) to penetrate the deep slide plane and relieve water pressure. Additionally, the City introduced an emergency winterization program in the form of filling fissures/grabens, lining canyons, and improving drainage.

Status of the Deep Dewatering Wells Program

- The total combined water extraction rate of the DDWs is currently at approximately **460 gallons per minute** or approximately **0.7 million gallons per day**, which is lower than typical because of three sheared wells described below.
- Since the start of the DDW program, approximately **436 million gallons** or **1,338 acre -feet** of water have been extracted from certain locations around the toe of the Landslide Complex. Weekly extraction rates are currently influenced by the following circumstances:
 - DDW-4, DDW-6, and DDW-8 have recently sheared and are currently offline. In accordance with the recommendations from the City Geologist team, the re-drilling of DDW-8 is underway and is scheduled to be complete by the end of this week. Similarly, the re-drilling of DDW-4 is also underway and is expected to be completed early next week. Re-drilling of DDW-6 will begin immediately following the completion of DDW-4.

Status of Winterization:

All other planned winterization measures are complete. All winterized areas will continue to be monitored and maintained within the approved budget.

- On February 7, the Public Works Department responded to a sewer line emergency for the Abalone Cove Sanitary Sewer System. Staff identified a deviation in a section of the mainline sewer. Public Works staff and its contractor partners excavated the buried pipe, completed temporary repairs, and installed a bypass to maintain uninterrupted service. Permanent repairs are scheduled to be completed this week. Further repairs to the sewer system are being scheduled.

No Construction on Monday, February 16 (President's Day)

Pursuant to Section 17.56.020(B) of the Municipal Code, it is unlawful to carry on construction, grading, landscaping activities, or operation of heavy equipment except between the hours of 7:00 A.M. and 6:00 P.M. Monday through Friday, and between the hours of 9:00 A.M. and 5:00 P.M. on Saturday. No such activity shall be permitted on Sundays, or the legal holidays (within the city's permitted construction hours), unless a Special Construction Permit is approved by the Community Development Director. Drainage Swale Maintenance

Drainage swales/slope-drains tend to become filled with leaves, overgrown vegetation, and debris over the course of the year. As a reminder, property owners are responsible for the maintenance of swales located on their property to ensure that the swales function properly. Improperly maintained swales interfere with proper drainage flows that can result in property damage caused by slope failure, erosion, or excess storm-water runoff.



As an additional reminder, the City's Municipal Code does not permit the construction of any structure within or above a drainage swale, or on a slope on or equal to 35% or greater. This includes decks, stairs, or structures of any kind.



The sugar Bush (*Rhus ovata*) was removed from the native garden due to overgrowth. This species typically grows between 8-15 ft in height. Tidal Influence replaced the Sugar bush with five smaller native plants to maintain the garden's beauty while preserving the ocean views at the Point Vicente Interpretive Center.

Portuguese Bend Reserve



On Tuesday, Park Rangers trimmed back overgrowth on Marymount Trail.





Three Sisters Reserve
