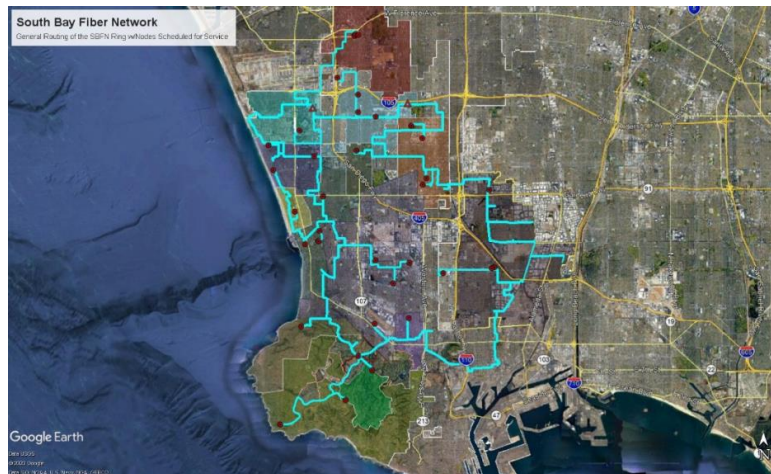
Construction of the Burma Road Trailhead Gate is Underway

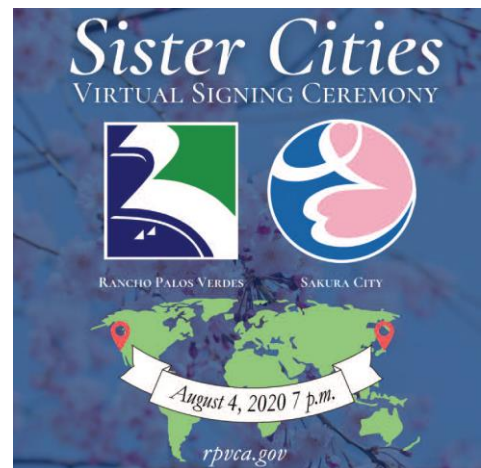

On August 4, 2020, the City Council officially recognized and welcomed Sakura City as a "Sister City" during a virtual ceremonial signing event. Since then, staff continues to meet with Sakura City to discuss opportunities to ensure a strong cultural bond and lasting friendship is sustained.

In the coming New Year, the Sister Cities will invite their communities to participate in virtual webinars that embrace cultural exchange. Webinars will include preparing a traditional Japanese dish, one-on-one cooking with an RPV restaurant chef, sharing traditional Japanese folklore, and reading to children traditional folktales and folklore.

Letter from Dr. Cherniss on School Reopening

On November 16, the Palos Verdes Peninsula Unified School District shared a letter with the City from Superintendent Dr. Alex Cherniss to Governor Gavin Newsom and State Superintendent of Schools Tony Thurmond urging the safe reopening of K-12 schools (see attachments). Dr. Cherniss noted the impacts of school closures on student achievement and mental health, among other concerns. Staff will continue to monitor the status of school reopening.

COVID-19 Cases

As of November 17, there are 344,523 confirmed cases of COVID-19 across Los Angeles County (population 10.17 million), including the South Bay, so the public should not think one location is safer than another, and everyone should be aware and practice physical distancing. The total includes 378 cases in Rancho Palos Verdes (population 41,731), 125 in Palos Verdes Estates (population 13,190), 59 in Rolling Hills Estates

(population 8,066), 12 in Rolling Hills (population 1,874), and 18 in the unincorporated areas of the Peninsula. Countywide, 7,299 people have died.

According to the Department of Public Health, 13 deaths have been reported in Rancho Palos Verdes. The City extends its deepest condolences to the families of these residents.

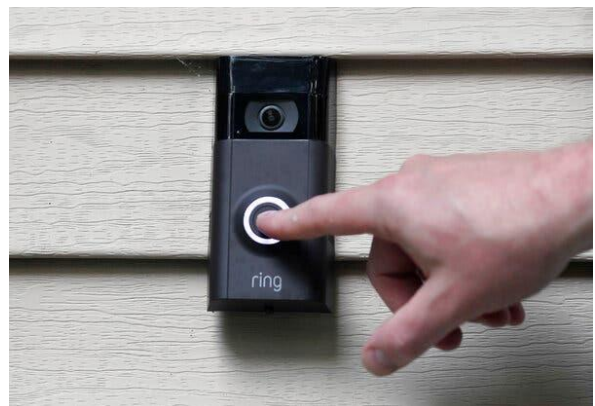


Ring Recalls Video Doorbells After Several Catch Fire

Ring Video Doorbells has recalled more than 350,000 of its devices after nearly two dozen of them caught fire. This became apparent when Ring received 85 reports from consumers complaining about “incorrect doorbell screws.” This led to 23 doorbells igniting.

RPV residents that own a Ring devices can find out if their doorbell is included in the recall by entering the serial number at

Flock Safety Grant Program

The HOA Neighborhood Flock Security Camera Grant Program went live on September 30 and since then, the City has experienced an influx of applications from its HOA's. The popularity of this program has generated so much interest that the City has expended the allocated grant funds for this fiscal year. The City Council may consider appropriated additional funds to continue this program at the fiscal mid-year report.

The City's Grant program provides 50% of the cost of each security camera leased, or no more than \$1,000 per camera for one year.

The Flock Safety's license plate-reading camera system was created to reduce crime and they integrate with the Lomita Sheriff's Station to notify deputies if wanted vehicles enter your community.

Invitation to Virtual Meeting on Home Hardening Standards and Wildfire Catastrophe Modeling in Ratemaking

On December 10, California Insurance Commissioner Ricardo Lara will host a virtual meeting with fire and home hardening experts and wildfire catastrophe modeling experts regarding potential administrative and regulatory changes to incentivize home-hardening and discuss models that are based in fire science to protect lives and property (see attachments).

The purpose of this workshop is to provide a technical, fire science-based conversation as the Commissioner considers further administrative actions. Specifically, this meeting will explore the extent to which wildfire catastrophe modeling as a ratemaking tool can impact market competition and insurance availability.

City Staff will be attending this virtual meeting to glean a better understanding of how the City can avoid premium hikes and reduced insurance availability for residents and neighborhoods interested in fire hardening homes.

2020 Multi-Jurisdictional Hazard Mitigation Plan

On November 17, the City Council adopted the 2020 Multi-Jurisdictional Hazard Mitigation Plan (Plan) for the Cities of Rancho Palos Verdes and Rolling Hills Estates.

The Plan identifies hazards and ways to minimize damage by natural and human-caused disasters and ensures continuing eligibility for Hazard Mitigation Grant Program funding. It is mandated by the Disaster Mitigation Act of 2000, also known as Public Law 106-390, which requires state and local governments to prepare mitigation plans to document their mitigation planning process and identify hazards, potential losses, mitigation needs, goals, and strategies.

The most recent RPV/RHE Multi-Jurisdictional Hazard Mitigation Plan was released in August 2014 and updated in January 2016. The 2020 update incorporates all federal requirements relating to local hazard mitigation plans.

The Plan is designed to have the following benefits:

- Reduce loss of life and property, human suffering, economic disruption, and disaster costs.
- Prioritize hazard mitigation at the local level with increased emphasis on planning and public involvement, assessing risks, implementing loss reduction measures, and ensuring critical facilities/services survive a disaster.
- Promote education and economic incentives to form community-based partnerships and leverage non-federal resources to commit to and implement long-term hazard mitigation activities.

With the November 17 City Council Resolution adopting the 2020 Multi-jurisdictional Hazard Mitigation Plan, staff and the emergency planning consultant will seek FEMA's final approval letter to complete the Hazard Mitigation Plan process.

Wildfire Preparedness

With an uptick in recent brush fires across the Los Angeles County region, Peninsula residents are reminded to be on heightened alert and to be prepared for wildfire.

- If you see something, say something. Report any sign of smoke or fire immediately to your local fire department by dialing 9-1-1. If you dial 9-1-1 from your cellphone, be sure to know your location.
- Have your Ready! Set! Go! Wildfire Action Plan in place. It is critical for residents to be familiar with the Ready! Set! Go! program that provides important pre-planning and evacuation information.



Sign up for Alert SouthBay

Alert SouthBay is a multi-jurisdictional emergency notification system used by 13 South Bay cities – including Rancho Palos Verdes -- to keep our communities informed about disasters and emergencies with uniform, expeditious alerts.

Alert SouthBay is an opt-in system using the Everbridge software application. Similar to Nixle alerts, Everbridge sends notifications via email, text message, cellular, and landline phones. Users can subscribe to receive alerts from multiple South Bay cities. If you live in Rancho Palos Verdes, for example, but work in Torrance, you can subscribe both cities' alerts.

Everbridge is the City's primary vehicle for emergency communication. Users can sign up by:

- Texting "alertsb" to 888-777, which returns a link to register for Everbridge (for COVID-19-related alerts, text the keyword "cv19rpv")
- Registering online at alertsouthbay.com
- Downloading the free [Everbridge app](#) on an iOS or Android device from the [App Store](#) or [Google Play](#)

Helping Others After a Disaster

The impact of natural disasters like earthquake and wildfires can be felt for weeks, months, and even years after disaster strikes. After a disaster, people often come together to help. To make the most of your contributions, here are some general guidelines on helping others after a disaster.

Cash Donations

Financial contributions to a recognized disaster relief organization are the fastest, and the most efficient way of helping those impacted by disaster.

- Allow voluntary organizations to fund response and recovery efforts, obtain goods and services locally, and provide direct financial assistance to disaster survivors to meet their own needs.
- Make a financial contribution to the voluntary organization of your choice.
- If you need help in determining who to give to, the National Voluntary Organization Active in Disaster website has a list of [recognized disaster relief organizations](#) that are active in disaster work.
 - When the public supports these voluntary organizations with financial contributions, it helps ensure a steady flow of important services to the people in need after a disaster.

Volunteering

- Don't self-deploy to disaster areas.
 - Volunteer with trusted organizations operating in the affected area who know best where volunteers are needed and can ensure appropriate volunteer safety, training, and housing.
- Before a disaster strikes Volunteer with a non-profit organization to be trained before the next event to find meaningful volunteer opportunities following a disaster.
- There are many organizations and faith-based groups in your community that have active disaster programs and need volunteers.

Donating Goods

- Donate in-kind goods that are specifically requested or needed by recognized organizations.
 - Unsolicited goods that are not needed such as used clothing, miscellaneous household items, and mixed or perishable foodstuffs require helping agencies to redirect valuable resources away from providing services to

sort, package, transport, warehouse, and distribute items that may not meet the needs of disaster survivors.

- Critical needs change rapidly. Confirm with trusted organizations what items are needed BEFORE collecting.

Be Patient

Recovery lasts a lot longer than the media attention. There will be volunteer needs for many months, often many years, after the disaster — especially when the community enters the long-term recovery period. Your help is often needed long after a disaster.

Statewide Sales Tax Trends

General Consumer Goods

FY 2020-21: Projected 1.5% growth

FY 2021-22: Projected 9.4% growth

Brick & mortar's turbulence lingers as merchants navigate economic headwinds while trying to balance reopening stores with public health and safety concerns. Consumer spending saw a quick recovery in June as retailers began opening doors but has leveled off since July at just under 15% of pre-COVID levels. New demand for electronics, appliances, and home



furnishings spurred by the need to create work from home and virtual learning environments are anticipated in the short term. Federal stimulus combined with a lack of outlays on fuel and entertainment allowed households to make use of excess discretionary income. Initial third-quarter reports show spending being tempered as unemployment benefits expired and consumer confidence staggered to a six-year low. HdL projections have tax volumes staying below the pre-pandemic peak through fiscal year 2021-22.

Business/Industry

FY 2020-21: Projected 0.4% growth

FY 2021-22: Projected 6.0% growth

Initial recovery is primarily related to accommodation of pandemic and climate-related changes. Strong demand for warehouse and shipping technology and equipment support the shift to online shopping in addition to home offices and virtual classrooms. Climate-induced investment in irrigation and agricultural technology remains. HdL anticipates a strong rebound in medical equipment and pharmaceuticals once pandemic controls allows return of elective and non-emergency medical procedures. Unprecedented fires and hurricanes may temporarily close some production capacities and cause new supply chain interruptions. Expect uneven gains through fiscal year 2020-21 with overall improvement not until 2021-22.

Small Business Financial Assistance Plan Update

On April 8, 2020, the City of Rancho Palos Verdes implemented the Small Business Financial Assistance Plan to provide relief and promote the general welfare of the City's small business community experiencing negative financial impacts stemming from the COVID-19 pandemic. The Small Business Financial Assistance Plan provides a one-time refund of the 2020 business license.

On June 2, 2020, the City Council received a status report on the Small Business Financial Assistance Plan. As a result of the low response, the City Council expressed a desire to increase the number of eligible small businesses by removing the limitation that a small business must have a "brick-and-mortar" location to be eligible to receive a refund.

Since the implementation on April 8:

- the City has received 22 requests for business license tax refunds
- 14 refunds totaling \$4,939 have been issued to date

Initial Study Released Recommending the Preparation of an EIR for the Portuguese Bend Landslide Mitigation Project

In accordance with the California Environmental Quality Act (CEQA) the City will prepare an Environmental Impact Report (EIR) for the proposed Portuguese Bend Landslide Mitigation Project. The proposed project involves a series of recommended mitigation measures for the landslide, which began moving in 1956 and has resulted in significant infrastructure damage to homes, utilities, and roadways.

The City released the Initial Study that describes what issues to be addressed in the project EIR. The comment period for the Notice of Preparation ends at 4:30 p.m. on January 15, 2021.

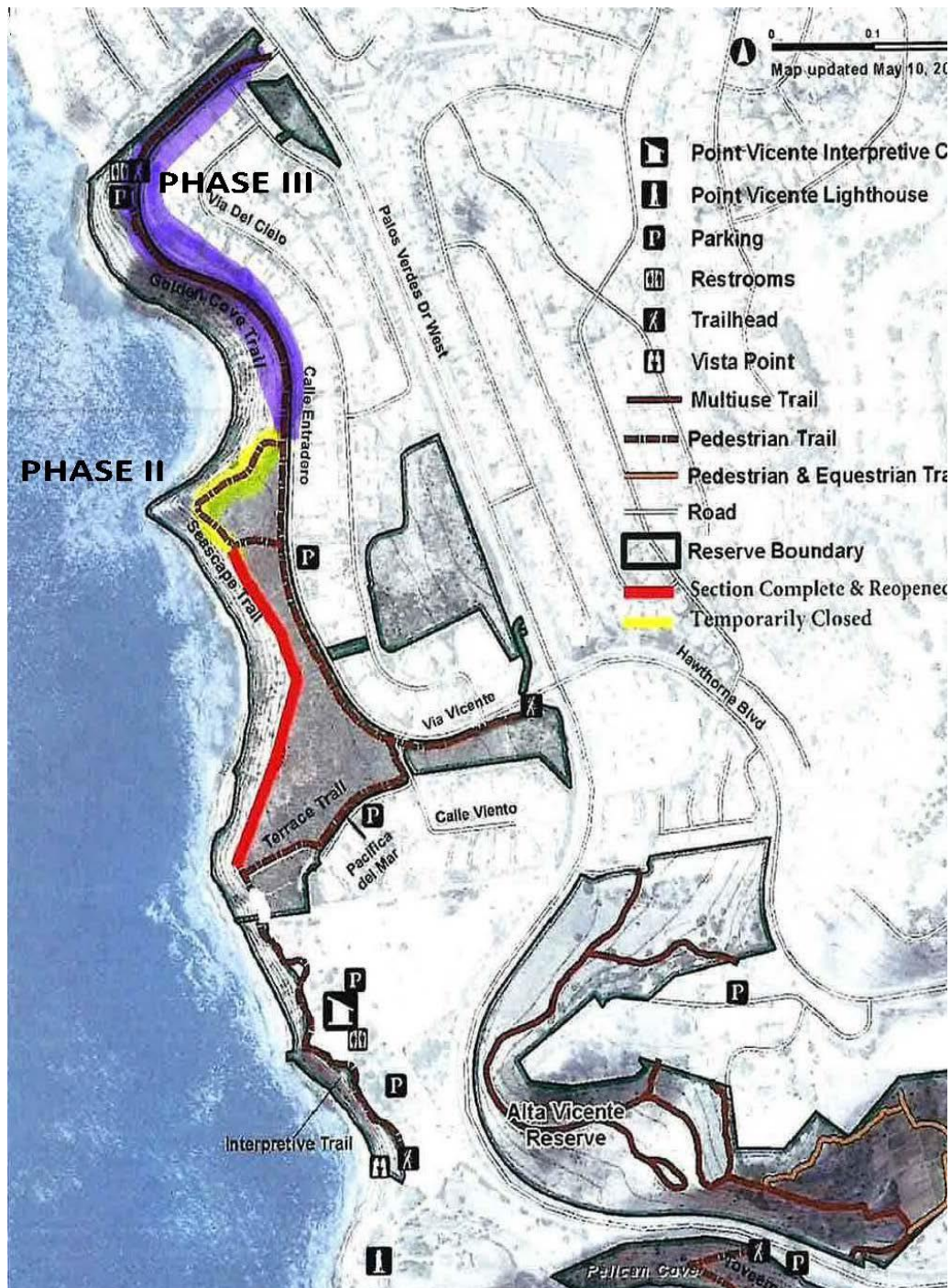


Figure 2 Posts secured

Speed Radar on Palos Verdes Drive East

Proposed Raising Cane's Update (29501 S. Western Avenue)

On February 13, 2020, an application was submitted to the Planning Division requesting the demolition of two existing restaurants located at 29035 & 29051 S. Western Avenue (see aerial map) to accommodate the construction of a new 2,798 ft² drive-thru restaurant known as Raising Cane's, a fast-food restaurant specializing in chicken fingers. To date, the project has gone through several reviews with the Planning Division and on August 31, 2020, the Traffic Safety Committee (TSC) reviewed the application as it pertains to circulation and potential traffic impacts. Due to potential impacts that may result from the drive-thru component of the restaurant, the proposed project will be heard again by the TSC in January to review more in-depth studies related to traffic and queuing. Housing Element Request for Proposals/Qualifications (RFP/RFQ) Update

On September 28, 2020, the Planning Division issued an RFP/RFQ to obtain professional contract services for the preparation of the 2021-2029 Housing Element Update. Staff did not receive any submittals as a result of the RFP/RFQ issuance. The City is required to update its Housing Element every eight years to correspond with the Regional Housing Needs Assessment (RHNA) cycle. Staff contacted Michael Baker International, the City's on-call planning support consultant, directly to discuss the scope of the proposal and is awaiting more information on possible procurement of services.

Regional Housing Needs Assessment (RHNA) Update: City Manager Letter to the Southern California Association of Governments (SCAG)

On November 18, 2020, the City Manager issued a letter (Attached) to Hon. Rex Richardson, SCAG President, outlining the City's concern with the State Department of Housing and Community Development's (HCD) issuance of a regional housing need of 1.34 million units to the SCAG region. The letter also highlights the City's support of a regional effort requesting that the SCAG Regional Council conduct a special meeting related to consider pursuing litigation against HCD's regional housing need determination. Staff will provide additional updates as more information becomes available.

No Construction Allowed on Thanksgiving Day (November 26)

Pursuant to Section 17.56.020(B) of the City's Zoning Code, it is unlawful to carry on construction, grading or landscaping activities, or to operate heavy equipment on legal holidays, unless a Special Construction Permit is approved by the Director of Community Development. Special Construction Permits must be requested at least 48 hours before any such work is to begin. Please note that minor repairs, maintenance and landscaping activities (i.e., work that does not otherwise require a building permit) are not prohibited on legal holidays.

New Guidance on Outdoor Recreation and Private Gatherings

The Los Angeles County Department of Public Health has updated its guidance on attending private group gatherings and participating in outdoor recreation activities. Public parks and outdoor spaces are ideal places to participate in small group gatherings and recreation activities, as they can help reduce the spread of the virus from one person to another. When participating in a gathering or other activity, all park rules must be followed.

Outdoor Recreational Activities

Outdoor recreation is permitted in the City of Rancho Palos Verdes! In addition to individual and passive household recreation in City parks and Open Space, the Recreation and Parks Department offers a variety of in-person, outdoor, organized group classes and activities for all ages. Classes include yoga, dance, fitness, lacrosse, art, enrichment, and more. To limit the risk of exposure to and transmission of the virus, all classes are held outdoors, class sizes are limited, and participants and instructors are required to wear face coverings except during heavy physical exertion.

Playgrounds Now Open

Following Governor Newsom's and the California Department of Public Health's announcement that outdoor playgrounds are permitted to open statewide, the Los Angeles County Department of Public Health released Reopening Protocols for Outdoor Playgrounds on October 1, 2020. While the Los Angeles County Department of Public Health issued guidance, the decision to re-open outdoor playgrounds is made by each individual agency. City Staff worked to ensure that all playgrounds were in compliance with health guidance and safety standards and then opened playgrounds at all parks on Friday, October 9.

Unrelated to Covid-19 and in accordance with industry best practices, the City recently conducted a playground equipment safety inspection. When the safety inspection report was received, the City took action to remediate items that could be addressed immediately. Some playground equipment will require longer-term solutions to remediate. As a result, the following equipment will remain closed to the public until further notice:

- Swings for ages 5-12 years at Hesse Park, Ryan Park, Ladera Linda Park, and Eastview Park
- Select playground structure elements including slides and climbers at Hesse Park and Ladera Linda Park.

A schedule for the remaining work is under development and shared as soon as it is available.

- Playground structures at Hesse Park, Ryan Park, Ladera Linda Park, and Eastview Park
- Swings for ages 4 years and under at Eastview Park

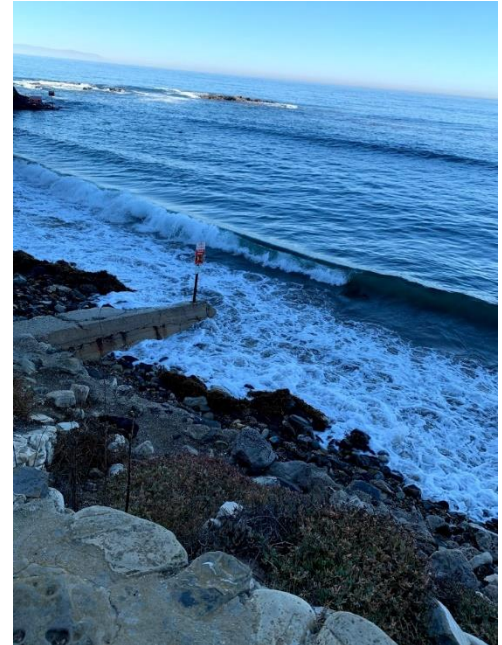
Abalone Cove Reserve:

On Friday, November 13, a vacant panga boat was found at Sacred Cove. Rangers informed U.S. Customs and Border Protection and the U.S. Coast Guard investigating the boat, believed to be part of a human smuggling incident.

On Sunday, November 15, a patron reported finding human remains on Abalone Cove Beach. Los Angeles County Sheriff's Deputies were called and confirmed they were not human, but were marine mammal.

A king tide occurred Sunday, November 15 and 16 which is a very high tide which results in high water levels that can cause damage to the coastline and coastal property. At Rancho Palos Verdes, the high reached 7.07 feet at 8:25 am. Patrons are asked to be safe and take extra precautions when walking on the coastline during these events. High water levels can result in partial trail closures and strong waves.

Ocean Trails Reserve:

Rangers continued to receive reports of increased dog use at Rancho Palos Verdes Beach. Animals are not allowed on any beach in the City of Rancho Palos Verdes. Dogs are allowed on the trails, as long as they are on a leash no longer than 6 feet in length. The City is working with Trump National Staff to ensure adequate signage is in place to educate and enforce the City's Municipal Code.



Portuguese Bend Reserve:

Vanderlip Trail repairs are in progress. Work began on Wednesday, November 4th. Crews began to fill in and repair the ruts caused by a water main break in October. Vanderlip Trail remains closed, and a portion of Gary's Gulch Trail is also closed while crews station heavy machinery and transport aggregate and other materials to Vanderlip trail. Trail closure signage is in place in these areas.



Vicente Bluffs Reserve:

As of November 3, 2020, Phase 1 of the Vicente Bluffs Fence Project is complete. A section of Seascapes Trail is now open to the public. Construction crews are still on-site, and all “trail closed” signage will remain in place in affected areas where work is still being completed.

TORRANCE, CALIF., November 17, 2020 – With the completion of a dedicated fiber-optic network in the South Bay region of Los Angeles County, city halls, along with other local and regional public agencies, will now benefit from high-speed, low-cost broadband connectivity that provides the critical infrastructure for South Bay Cities to boldly step into the world of “smart city” applications.

The new network, called the South Bay Fiber Network (SBFN), was made possible through a 15-city municipal partnership forged by the South Bay Cities Council of Governments (SBCCOG). The new broadband infrastructure provides an essential public asset and resource to city governments as they manage economic viability during the COVID-19 pandemic and beyond and creates opportunities to bridge the “digital divide” in communities underserved with broadband.

“The COVID-19 crisis has demonstrated the importance of investing in the technology that makes telehealth, tele-education and telecommerce possible,” LA County Supervisor Janice Hahn and member of the SBCCOG Board of Directors, said. “By bringing a fiber network to our city halls, the South Bay has leaped ahead of the curve by creating the possibility of the eventual extension of a low-cost, comprehensive network to our residents and businesses throughout the South West Los Angeles region.”

By the end of 2020, SBCCOG member city halls, as well as a diverse community of public agencies, will be connected to the SBFN. These include Carson, El Segundo, Gardena, Hawthorne, Hermosa Beach, Inglewood, Lawndale, Lomita, Manhattan Beach, Palos Verdes Estates, Rancho Palos Verdes, Redondo Beach, Rolling Hills, Rolling Hills Estates and Torrance. The following public agencies will also benefit from access: Beach Cities Health District, the South Bay Workforce Investment Board (SBWIB), LA Metro Transportation Authority, Los Angeles County Department of Public Works, West Basin Municipal Water District and the Lundquist Institute for Biomedical Innovation, located at Harbor-UCLA Medical Center in Torrance.

Through an innovative collaboration, the SBCCOG funded the capital costs of the SBFN through use of \$6.9 million in Los Angeles Metro Measure M subregional transportation improvement funds. Use of the funding for IT infrastructure was a creative application of these public funds, which are typically targeted for road improvements.

“Working together as one entity to pay for the capital costs of the infrastructure, the SBCCOG members were able to collectively pay substantially less for world-class, secure, broadband and internet service than individual cities would have paid separately.” Olivia Valentine, chair, SBCCOG board of directors and City of Hawthorne councilmember, said. “By laying this groundwork, cities and the other participating agencies will be able to provide more effective services to their constituents online and reduce trips, saving time and greenhouse gas emissions.”

The genesis of the SBFN began in 2016 as an economic development issue, following the departure of South Bay companies who cited a lack of sufficient broadband infrastructure to meet their needs.

A two-year study by Magellan Advisors, commissioned by the South Bay Workforce Investment Board (SBWIB) with additional funding from 2nd district Los Angeles County Supervisor Mark Ridley Thomas' office, and administered by the SBCCOG, detailed this issue. It identified the challenges local governments face by spending “too much for too little IT service.”

The study resulted in a SBCCOG RFP to find out if there were opportunities to lower the costs and prepare South Bay cities for their future needs.

“We immediately recognized the value of high-speed broadband as a major economic driver for the South Bay region,” Jan Vogel, executive director and chief executive officer, South Bay Workforce Investment Board, said looking back. “As ‘Silicon Beach’ continues its migration south from Santa Monica/Playa del Rey into El Segundo and beyond, a high-speed broadband infrastructure is critical to sustaining a viable high-tech job market immediately and as we transition to a post-COVID-19 world.”

The SBWIB's headquarters and six satellite offices located throughout the South Bay region will connect to the network to support remote employment training and development programs.

SBFN enables local municipalities and other public agencies to access a secure, high-speed, 1 gigabyte (GB) network at a rate of \$1,000 per month, roughly half the cost of what commercial rates might be for similar service in the South Bay.

The new network is also scalable to accommodate future geographic expansion and data growth and provides a platform for the following examples of “smart city” applications:

- **Work-from-Home Governments** – High speed internet will support cities’ accelerated transition to telework through COVID-19 and beyond, and the evolution to “smart city halls” that can provide virtual municipal services and interactive distance learning to residents, with outcomes of reduced traffic and greenhouse gas emissions through “trips not taken.” Enhanced online services will be available to their residents, such as permitting and processing applications.
- **Improved Traffic Management** – Real-time traffic information from LA County’s Information Exchange Network (IEN) will be available for each participating agency. In partnership with Metro’s Regional Integration of Intelligent Transportation Systems (RIITS), South Bay cities will be able to combine and share transportation data as a resource for congestion management, improved transit services, and support of transportation demand management (TDM) programs.
- **Future Autonomous Vehicle (AV) Support** – High speed and resilient broadband capacity will be necessary for vehicle-to-network and vehicle-to-vehicle communications for a safe and reliable AV transportation system.
- **Telehealth and Telemedicine Opportunities** – Applications include remote diagnostics, video appointments, transmission of large files, such as MRIs, scans, etc., initially to be utilized by Beach Cities Health District and Lundquist Institute for Biomedical Innovation, with possible future expansion to other health care providers.

Additional benefits of low-cost broadband to participating agencies include the following:

- Greater resiliency for IT services, useful for emergency preparedness and data back up
- Efficient use of cloud-based software applications for day-to-day business
- Necessary IT capacity for future video and audio-based municipal software applications
- Sharing of municipal software platforms with other public agencies, including
 - Online permitting or applications with Los Angeles County
 - Sub-regional geographic information system geographic information system (GIS) mapping tools with other cities and SBCCOG
- The opportunity for cities to install municipal Wi-Fi in public spaces, parks and buildings
- Future expansion of broadband infrastructure for commercial and residential use

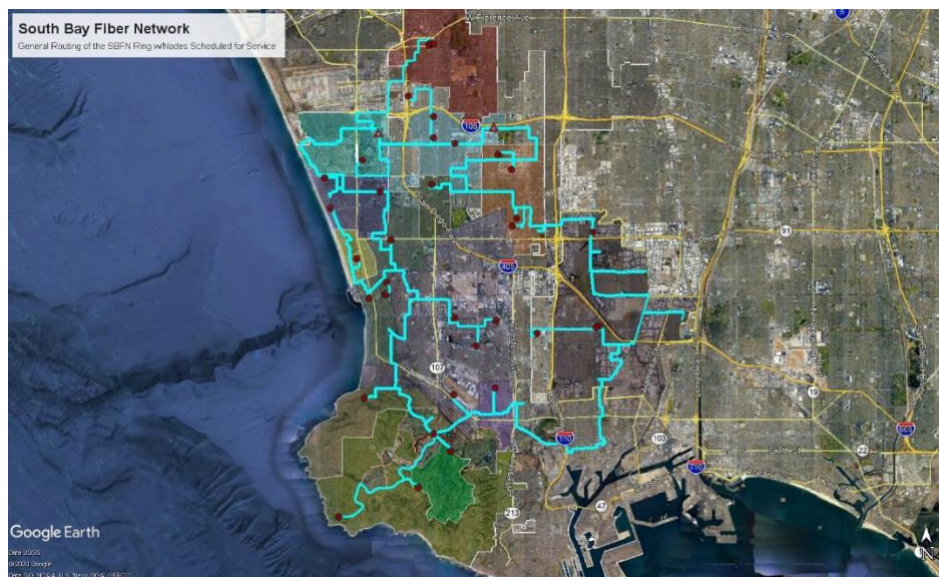
In 2019, American Dark Fiber was awarded the contract to build the network. Its architectural design features a middle-mile “fiber ring” that connects to the world wide web at two local data centers. A scalable two-fiber GB network provides bidirectional resiliency and security for SBFN members, once connected to the ring.

Construction of the project’s “fiber ring” and initial lateral connections to public agencies’ sites has been underway for the last nine months. The core ring became operational in August 2020. A total of 22 sites are now connected and running on the network, with another dozen sites planned for service over the next few months.

Gardena-based HP Communications is completing the physical construction of the network, while Race Communications is providing the fiber optic electronic equipment and customer service as the SBFN's internet service provider.

“Our goal with the South Bay Fiber Network is to drive digital literacy across the South Bay and to empower those who need it most,” Dave Daigle, CEO, American Dark Fiber, said. “This infrastructure lays the groundwork for better quality of life for residents and businesses in the South Bay for years to come.”

An example of a South Bay community already benefitting from the network is a day care program offered at Gardena's Rowley Park for children of city employees and essential workers. Using a 1GB transport circuit from City Hall to upgrade connectivity at the park, the city can now provide enhanced Wi-Fi service to support virtual classes and other interactive web-based programs for participants.

The Imperative for School Reopening and Student Support

Dear Governor Gavin Newsom and State Superintendent Tony Thurmond,

As you appropriately respond to the dangerous resurgence of COVID-19, it has become increasingly imperative to revisit the approach to school reopening as part of the modifications to the State's "blueprint for a safer economy." While the evidence and science support the notion of reimposing greater restrictions on most all sectors as conditions worsen, there concurrently exists an opportunity to take safe steps to actually accelerate school reopening. Over the last many months there has been an abundance of focus on opening most other sectors first and schools last. Now it seems, is the time to flip that order so that school reopening moves ahead of the many sectors where reopening may be exacerbating the spread of the virus.

This Global Pandemic has exacerbated the two primary challenges impacting education in California and in the United States of America: the failure in teaching and learning in our K-12 schools and a ballooning mental health crises among our kids.

Currently, there are over 6 million students enrolled in K-12 schools in California. Of this population, over 4 million students are English learners, foster youth, or eligible for free and reduced price meals based on family income. Over 3 million students are NOT achieving at grade level in English and Mathematics. Put simply, over half of our students in the state are not reading at grade level and do not have the mathematical foundation for future success. In addition, only 50% of high school students are meeting UC/CSU Course Requirements by the time they graduate (www.ed-data.org/state/CA). Our state currently has over 800,000 students who qualify for special education services, the majority of whom are not receiving their services in the same manner as pre-COVID (<https://lao.ca.gov/Publications/Report/4110#Introduction>).

The closure of schools has and will do nothing to help any of these dire statistics. The economic downturn has forced many more families toward hardship, thus increasing the number of students in need of free/reduced price meals. The remote learning environment will only widen the learning gap and increase the number of students not achieving grade level standards or meeting the necessary UC/CSU Course Requirements. Therefore, less of our kids will be able to go to college and more students will drop out; currently 1 in 10 high school students drop out prior to graduation (<https://edsources.org/2018/californias-graduation-rate-ticks-up-but-still-1-in-10-high-school-students-drops-out/605378>). Finally, our students with special needs, many of whom require a combination of several specialized services, will likely see deepening learning and developmental delays without the in-person learning.

In the absence of retaining half of the State's student population in 2021-22, our kids require immediate action to remedy this learning loss. It is hard to argue that in-person school is far more effective than remote learning for the vast majority of students. We are now looking at the possibility of our 6 million K-12 students denied the opportunity for pre-COVID in-person instruction for a period of 12-18 months. This reality carries dire consequences for the academic future of our youth and will only be mitigated by reopening our schools immediately in the safest manner possible.

In addition to the academic cataclysm that our kids face, which could negatively affect them for a lifetime, there also exists a significant student mental health crises, which was accelerating at alarming rates pre-COVID. Just last week, Clark County Nevada, a school district of 300,000 students, reported that they have lost more kids to suicide this first semester of 2020 than they had in all of last year (<https://lasvegassun.com/news/2020/nov/13/school-district-sees-rise-in-student-suicides-amid/>).

The thought of losing twice the number of kids to teen suicide over the course of this year is unthinkable. Pre-COVID suicide rates among teens was already a crisis schools and districts have been trying to remedy. In 2019, California experienced a 34% increase in teen suicides (<https://www.dailybulletin.com/2019/10/01/new-health-report-for-california-shows-34-increase-in-teen-suicide-and-29-rise-in-childcare-costs-in-past-3-years/>). The teen suicide rate currently stands at 8.2 deaths per 100K. Can you imagine if this rate doubles, similar to the data out of Clark County, Nevada? Moreover, a 2019 survey estimated that about 1 in 5 high school students nationwide seriously considered suicide in the previous year, a figure more than 35% higher than findings from a decade earlier (www.kidsdata.org).

The reality is that this teen suicide data is more than just numbers. We are facing the reality of losing thousands more kids to teen suicide in the midst of this pandemic. Furthermore, exponentially more teen deaths will occur through suicide this year than from COVID. Unfortunately, while teen suicide is the extreme case of student mental health crises facing our youth, it is just the tip of the iceberg in addressing mental health challenges among our most vulnerable kids. Cases of anxiety and depression are also

increasing at alarming rates during COVID, while parents and families are struggling to help their kids.

Recommendations:

1. “Mask Up” and Open School

While most every economic sector has been able to reopen with restrictions, including commercial business, food, and retail, schools have not been provided the same opportunities. Millions of parents in California have been forced to alter their work schedules in order to accommodate remote learning for their kids. This has been at the detriment of their livelihood, and at the detriment of the education and mental health of their children.

Schools should be one of the first sectors afforded the opportunity to reopen with restrictions, rather than the last. The State and Counties have provided detailed reopening guidelines, of which our schools are more than capable of following. The spacing out of staff and students, the face covering requirements, and the sanitation policies and procedures will ensure that school will be as safe, if not safer, than many other sectors of our economy. The State and Counties must recalibrate their policies and procedures so that all schools are permitted to reopen in the safest manner possible. The 6 million students and the millions of parents and families in California are entitled to a full scale reopening, in order to mitigate the aforementioned challenges we face as a state and as a country.

2. Fund Learning Loss

The tsunami of failing kids, student dropouts, and decreased college-ready students has yet to arrive on shore. As previously mentioned, holding back millions of kids for a “do-over” school year is not a likely remedy. Kids need schools to intervene immediately. Intensive support courses in the area of English Language Arts and Mathematics need to be free and commonplace in every school. The thought of losing 12-18 months of pre-COVID schooling cannot be remedied without an expansive teaching and learning program. Additionally, special education funding must be massively increased in order to mitigate the loss of pre-COVID in-person services these 800,000 students require.

3. Fund Student Mental Health

Every kid should have free access to therapists and counselors immediately. Parents are already over extended in their efforts to balance home and work. Mental health providers should be serving any kid in the State requiring counseling and support. Unfortunately, schools are ill equipped to successfully meet this need. Certified therapists and counselors must be a resource that all families can access expediently and effectively.

In conclusion, please take immediate action to put kids first and address this education and societal crisis we face.

**INVITATION TO VIRTUAL MEETING¹ RE: HOME HARDENING STANDARDS AND
WILDFIRE CATASTROPHE MODELING IN RATEMAKING**

Insurance Commissioner Ricardo Lara convened an Investigatory Hearing on October 19, 2020 to take public input on the impact of wildfires on the availability and affordability of residential insurance from homeowners, first responders, “home hardening” experts, consumer groups, and insurance representatives. The testimony received that day highlighted the continuing difficulty that Californians in rural areas and the wildland urban interface (WUI) endure when seeking residential property insurance options, driven by climate change and extreme weather.

Two common questions that arose from the discussion at the hearing were:

- 1) How – if at all – would the use of catastrophe modeling in ratemaking help to make homeowners’ insurance more affordable and more widely available to homeowners?
- 2) How can wildfire mitigation reduce the spread and risks of future wildfires?

At the hearing, the Commissioner announced he will take further regulatory action that will allow homeowners to find and keep their residential property insurance while enhancing competition and availability in the insurance market.

In furtherance of these efforts, the Commissioner will now convene a virtual meeting² with fire and home hardening experts as well as wildfire catastrophe modeling experts regarding potential administrative and regulatory changes to incentivize home-hardening and discuss models that are based in fire science to protect lives and property.

***Modeling Wildfire Risk and Mitigation in the Era of Climate Change – A Workshop on Insurance
Availability and Affordability

The Commissioner’s authority under Proposition 103 includes broad rulemaking authority to prevent excessive, inadequate, or unfairly discriminatory insurance rates in California. This virtual meeting will be live-streamed to the public so all interested persons are able to watch as experts in the field of wildfire science discuss how the Commissioner can use his existing authority to reduce the risk of wildfire spread

while also enhancing competition in rural and WUI areas of California.

Specifically, this meeting will explore the extent to which wildfire catastrophe modeling as a ratemaking tool can impact market competition and insurance availability.

Earthquake Preparedness




Earthquakes can happen at any time – day or night. You could be anywhere when the earthquake strikes. The RPV Emergency Preparedness Committee encourages all Peninsula residents to plan, prepare, and practice what you and your loved ones will do when an earthquake occurs.

- ✓ **Make an Emergency Plan:** Create a [family emergency communications plan](#) that has an out-of-state contact. Plan where to meet if you get separated.
- ✓ **Make a supply kit:** Create a [supply Kit](#) that includes enough food and water for several days, a flashlight, a fire extinguisher and a whistle.
- ✓ **Practice DROP, COVER, and HOLD ON:** Get prepared for Earthquakes before it happens by practicing DROP, COVER, and HOLD ON.

- ✓  **DROP** where you are, onto your hands and knees. This position protects you from being knocked down and also allows you to stay low and crawl to shelter if nearby.

-  **COVER** your head and neck with one arm and hand
 - Crawl underneath a nearby table or desk for shelter
 - If no shelter is nearby, crawl next to an interior wall (away from windows)
 - Stay on your knees; bend over to protect vital organs

-  **HOLD ON** until shaking stops
 - Under shelter: hold on to it with one hand; be ready to move with your shelter if it shifts
 - No shelter: hold on to your head and neck with both arms and hands.

Protect Your Home: Secure heavy items in your home like bookcases, refrigerators, televisions and objects that hang on walls. Store heavy and breakable objects on low shelves. Consider making improvements to your building to fix structural issues that could cause your building to collapse during an earthquake.


We have been monitoring the information and discussions that have been raised by jurisdictions, on whether the State Department of Housing and Community Development (HCD) followed housing law in issuing a housing need of 1.34 million units to the SCAG region. This was an issue that was raised by SCAG staff as part of an objection letter to HCD dated September 18, 2019, and a reason why SCAG established the SCAG RHNA Litigation Committee and convened meetings in late 2019. At that time, it was reported that no litigation would be pursued.

Since that time, and at the request of SCAG RHNA Subcommittee Chair Peggy Huang, we understand that you reconvened the SCAG RHNA Litigation Committee, and further, that a meeting was held on November 2, 2020, to continue discussions on the issue. You reported at the November 4, 2020 SCAG Executive/Administration Committee meeting and the November 5, 2020 SCAG Regional Council meeting that there was a general consensus of the RHNA Litigation Committee that SCAG not pursue any litigation actions against HCD.

At the November 5, 2020 Regional Council meeting, two Regional Council members inquired as to whether a special closed session of the SCAG Regional Council could be scheduled, to further discuss the recommendation of the RHNA Litigation Committee and to receive the information that was presented to the RHNA Litigation Committee. It is our understanding that in your response you indicated that you needed to hear from a cross-section of members and be respectful of all viewpoints and to see if there are any concerns with the recommendation of the RHNA Litigation Committee.

The City of Rancho Palos Verdes is responding to your outreach. We support the request that the SCAG Regional Council conduct a special closed meeting to discuss the RHNA Litigation Committee's recommendation. As a SCAG member jurisdiction, we feel this discussion has direct relevance to our jurisdiction and our RHNA allocation and merits the additional consideration and recommendation of the Regional Council. We hope that this special meeting can be convened immediately.
