**CODE AMENDMENT (Planning Case No. ZON2017-00157):** A request to amend Rancho Palos Verdes Municipal Code Sections 15.20.040 (Moratorium on Land Use Permits – Exceptions), 15.20.050 (Landslide Mitigation Measures Required) and 15.20.060 (Application) to establish Landslide Moratorium Exception Category "U" to allow the construction of a single-family residence and ancillary site improvements pursuant to a settlement agreement between the City and the property owner on a vacant lot located at 48 Cinnamon Lane.
