NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, August 15, 2017, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following:

REVISION TO MAJOR GRADING PERMIT, MINOR EXCEPTION PERMIT & FENCE/WALL PERMIT (CASE NO. ZON2016-00224): On June 5, 2007, the City Council granted an approval for, among other things, the construction of a 4.5' tall retaining wall north of the garage, replacement of two unpermitted terraced retaining walls at the northeast corner, and a 2.5' tall retaining wall at the rear of the property. The proposed request is for the following:

- Replace the approved 4.5' tall retaining wall north of the garage with two terraced walls consisting of an 8.22' tall lower retaining wall and an 8.04' tall upper combination wall (4.54' retaining topped with a 3.5' guardrail).
- Replace the two unpermitted terraced retaining walls at the north-east corner of the property with two new terraced walls consisting of an 3' tall lower retaining wall and a 7' tall upper combination wall (3.0' retaining topped with 0.5' of freestanding wall and a 3.5' tall guardrail.)
- Replace an existing deteriorating 3.9' tall retaining wall along the west property line with a new 8.6' tall retaining wall that will extend around to the rear yard, which will replace a previously approved 2.5' tall wall in the rear yard. The portions of said retaining wall along the west side yard will be topped with 0.5' of freestanding wall and a 3' tall guardrail.)
- A total of 124.42yd³ of grading (123.12yd³ cut and 1.3yd³ fill) to accommodate the proposed improvements.
