**CODE AMENDMENT:** A request to adopt by reference Title 32, entitled "Fire Code" of the Los Angeles County Code for the consolidated fire protection district of Los Angeles County, which in turn adopts by reference, with certain changes and amendments, the 2016 edition of the California Fire Code and the 2015 Edition of the California Fire Code and the 2015 edition of the International Fire Code, and ratifying the more restrictive building standards contained in Title 32, and delegating enforcement of the Fire Code in the City to the Fire Chief.
