## PRESERVE OVERVIEW

During the second quarter of 2017, we continued to adapt to the role of wilderness preserve law enforcement officers.

With the improvement in weather conditions, we continue to see an increase in the number of people coming to use the reserves listed below. As noted in the first quarter report. This increase may also be related to the hikers use of the computer internet and websites including (but are not limited to) Facebook, YouTube, Yelp! And Twitter.

Although there have been many noticeable improvements and repairs within the reserves, trail borders and markings, especially closure signs, continue to be a slight problem. Enforcement of the rules and regulations can be extremely trying when violators have plausible excuses for not knowing the rules and regulations.

During the last two months, San Ramon Reserve, Forrestal Reserve and Abalone Cove Reserve have been targeted for Friday and Saturday evening patrols with varying results. The night time cold front makes it difficult to predict the best times to patrol. On several warm evenings, there were no contacts, while on cooler, overcast evenings, there were several contacts with people who were headed towards the trails.
