PRESERVE OVERVIEW

During the third quarter of 2017, we contacted numerous people while patrolling the Preserve via Polaris ATV and on foot. While enforcement of Preserve rules and regulations remained our primary mission, we helped numerous trail users' access resources from the City of Rancho Palos Verdes and Palos Verdes Peninsula Land Conservancy. These resources included the trail maps, trail information, the Preserve mission, and other subjects related to the Preserve found on the City's and Land Conservancy's websites.

Most of the violators we observed in the past claimed they didn't know they were breaking the law. This quarter, we have contacted many violators who, upon seeing us, stopped doing the violation, as if they knew the act they were committing was wrong. Examples of this include; hikers with dogs off leash, bending down to attach leashes to their unleashed dogs and hikers in closed areas climbing over rails to exit closed areas upon seeing us approach.

The fact that most Preserve users do not carry any identification continues to make citing violators a time consuming process. Despite this, we have been able to lower detention times slightly, if not significantly.

This reserve has numerous official and unofficial entrances that are not clearly marked. This makes enforcement of rules and regulations extremely difficult.
