### **NOTICE**

NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a special meeting on Thursday, March 29, 2018 at 6:00 p.m. at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following recommendations to the 2018 Draft Natural Communities Conservation Plan/Habitat Conservation Plan (NCCP/HCP):

- (1) Approve Addendum No. 1 to the 2004 Certified Final Environmental Impact Report;
- (2) Approve the 2018 Draft NCCP/HCP which includes the Implementing Agreement and Conservation Easements; and,
- (3) Direct Staff to submit these Documents along with the permit application, to the Wildlife Agencies to start the process for the 60-day public comment period and for Wildlife Agencies' permit decisions.

The 2018 Draft NCCP/HCP (including a redline version tracking the changes between the 2017 Draft NCCP/HCP presented to the City Council on October 2, 2017 and the current Draft) will be available on Friday, March 16, 2018 on the City's website at the following link:

Only those who have submitted written comments will receive notification of the decision.
