PRESERVE OVERVIEW

During the first quarter of 2018, we contacted 2,017 Preserve users while patrolling with a Department-marked Ford SUV, an unmarked City of Rancho Palos Verdes Polaris ATV and on foot. Out of those 2,017 contacts, we warned 56, assisted 2 and cited 66. Additionally, we helped trail users access resources from the City of Rancho Palos Verdes and the Palos Verdes Peninsula Land Conservancy. These resources included trail maps and information regarding Preserve closures. We also educated interested Preserve users with information regarding plants and animals found in the preserve.

We assisted two Preserve users during this quarter. On 01-16-18, after citing a woman with a dog off leash, we provided her with a make-shift leash, so she and her dog could safely complete their hike. On 01-27-18, we responded to Burma Road Trail at the top of Barn Owl Trail, regarding a report of a woman with a possible broken knee. We stabilized her knee fracture and directed paramedics to our location. We did not need to assist as many trail users during this quarter, possibly because of trail closures and the cooler weather.

Volunteer Trail Watchers routinely report violations at the different Reserves. We alter our patrol areas to respond to their helpful reports. During this quarter, a majority of our citations were issued in response to reports of violations that occurred in the coastal Preserves. Violations included; hikers who were in closed areas; hikers walking with dogs off leash and hikers with their dogs on the beach.
