ANNUAL COMPLIANCE REVIEW NO. 6 OF A CONDITIONAL USE PERMIT FOR THE POINT VIEW MASTER PLAN (CASE NO. ZON2010-00087): Pursuant to Planning Commission adopted P.C. Resolution No. 2015-19, the Planning Commission will conduct an annual review of the Applicant's compliance with all of the Conditions of Approval associated with the Master Plan.
