NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, January 15, 2019 at 7 p.m. at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes to consider the following:

Code Amendment (PLCA2018-0008) – A request to consider adopting an urgency ordinance amending Chapter 17.02 (Single-Family Residential (RS) Districts) and Chapter 17.10 (Second Unit Development Standards) of the Rancho Palos Verdes Municipal Code to require Neighborhood Compatibility review for detached second units over 12' in height, and to clarify the Neighborhood Compatibility triggers.

Only those who have submitted written comments will receive notification of the decision.

If you would like the opportunity to discuss or review the draft Code language, it is on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review from 7:30 a.m. to 5:30 p.m. Monday through Thursday, and from 7:30 a.m. to 4:30 p.m. Friday. Please also note that City Hall will be closed for the holiday break from Monday December 24, 2018 through Tuesday January 1, 2019, and will reopen on Wednesday January 2, 2019.
