**AN APPEAL OF THE DIRECTOR-APPROVED MAJOR GRADING PERMIT AND SITE PLAN REVIEW (CASE NO. PLSR2018-0192)** – An appeal has been filed requesting that the Planning Commission overturn the Director's approval of a Major Grading Permit and Site Plan Review for the construction of an 886ft<sup>2</sup> addition, a 550ft<sup>2</sup> roof deck, and ancillary site improvements with 105yd<sup>3</sup> of associated grading to an existing split-story residence.
