NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on December 10, 2019 at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, to consider the following:

CONDITIONAL USE PERMIT (CASE NO. PLCU2019-0006) – A request to allow a veterinary hospital to operate between the hours of 8:00 AM and 8:00 PM on Monday, 8:00 AM and 6:00 PM Tuesday through Friday, and 7:00 AM and 1:00 PM on Saturday, within a 4,605ft² leasing space on the lower level of an existing two-story commercial building.

Only those who have submitted written comments at or prior to, and/or given testimony at the public hearing will receive notification of the decision. The Planning Commission's decision may then be appealed, in writing, to the City Council.
