NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a meeting **on July 14, 2020 at 7:00 p.m. via a virtual meeting. The public hearing will be conducted pursuant to the provisions of the Governor's Executive Orders N-25-20 (<https://www.gov.ca.gov/wp-content/uploads/2020/03/3.12.20-EO-N-25-20-COVID-19.pdf>) and N-29-20 (<https://www.gov.ca.gov/wp-content/uploads/2020/03/3.17.20-N-29-20-EO.pdf>).** Please note that depending on the COVID-19 circumstances in the following weeks, an amended notice may be issued on the change from a virtual meeting to a regular meeting at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes. The Planning Commission will consider the following proposed project:

SITE PLAN REVIEW, VARIANCE, COASTAL DEVELOPMENT PERMIT, AND MINOR GRADING PERMIT (CASE NO. PLSR2019-0282) – A request to allow the following improvements to an existing two-story single-family residence:

- Construct a 727ft² addition to an existing two-story residence, consisting of a 275ft² addition to the first floor and a new 415ft² two-car garage as well as a 37ft² after-the-fact addition on the second floor, resulting in a new total structure size of 2,203ft²;
- Construct ancillary site improvements including planters and stairs in the front yard, a combination wall up to 8' in height along the rear yard, and replacement of existing stairs along the south side yard; and,
- Conduct 44yd³ of total grading, consisting of 25yd³ of cut and 19yd³ of fill with a maximum cut and fill of 3' and 4', respectively;

The overall height of the proposed residence will remain the same as no modifications are proposed to the roof and the after-the-fact second story addition has been constructed below the existing highest roof ridgeline elevation.

This project is categorically exempt pursuant to California Environmental Quality Act, Article 19, Section 15301 (Existing Facilities).

In addition, this virtual City meeting will be televised and can be accessed through the City's website.

If you would like the opportunity to review application materials, the information is on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and is available for review from 7:30 a.m. to 5:30 p.m. Monday through Thursday, and from 7:30 a.m. to 4:30 p.m. Friday. **In light of COVID-19 response measures from the Governor of the State of California and the Los Angeles County Public Health Department, and in the interest of the health and well-being of residents and City employees, City Hall is limiting counter hours and walk-ins by appointment only.
