NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, March 2, 2021 at 7:00 PM. Pursuant to Section 3 of [Executive Order N-29-20](#), issued by Governor Newsom on March 17, 2020, the regular meeting of the City Council for October 6, 2020, will be conducted through a hybrid combination of in-person attendance with not less than three members of the City Council, invited staff, and limited members of the public at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at [rpvca.gov/agendas](http://rpvca.gov/agendas) and on RPTV channels Cox 33 and Frontier FiOS 38. The City Council will consider the following:

**MORATORIUM PERIOD EXTENSION FOR THE ACCEPTANCE OR PROCESSING OF APPLICATIONS, ISSUANCE OF PERMITS, AND THE CONSTRUCTION OF TREEHOUSES (CASE NO. PLCA2021-0001):** On January 19, 2021, the City Council initiated code amendment proceedings to the Rancho Palos Verdes Municipal Code to develop provisions for the regulation of treehouses, and on February 2, 2021, adopted an Urgency Ordinance No. 641U to establish a temporary 45-day moratorium on the acceptance or processing of applications, issuance of permits, and the construction of treehouses. As the moratorium period is set to expire on March 19, 2021, the City Council will consider extending the moratorium period as allowed pursuant to Section 65858 of the California Government Code to continue the code amendment process.
