**NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on October 26, 2021, at 7:00 p.m.

Pursuant to Section 3 of Executive Order N-29-20, issued by Governor Newsom on March 17, 2020, the regular meeting of the Planning Commission for October 26, 2021, will be conducted through a \*hybrid combination of in-person and/or all virtual attendance of the members of the Planning Commission and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at [rpvca.gov/agendas](http://rpvca.gov/agendas) and on PVPtv channels Cox 35 and Frontier FiOS 39. Public participation highly encourage using the virtual platform as there will be very limited seating (with a combined total of 25 people between two rooms) at Hesse Park. Please note that depending on the COVID-19 circumstances in the following weeks, an amended notice may be issued on the change from a virtual meeting to a regular meeting at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes. The Planning Commission will consider the following:

**Zoning Code Amendment (Case No. PLCA2021-0004): A City Council directive to consider amending Section 17.76.030 (Fences, walls and hedges) of Title 17 (Zoning) of the Rancho Palos Verde Municipal Code requiring view assessments be conducted for new fences, walls and hedges from public roads and areas within the City.**

**Location: City-wide**
