## 1. Community Survey Overview

The City of Rancho Palos Verdes (RPV) will be updating their Housing Element in the City's General Plan. The adopted Housing Element covers the planning period from October 2013 through October 2021. Staff is currently implementing the respective actions and programs for the current planning cycle. The next housing cycle (6th Cycle) will cover the planning period from October 2021 through October 2029. The 6th Cycle Housing Element and associated environmental document(s) will be reviewed for compliance with State law and shall be adopted by the City Council with a goal in mind of Fall 2021. The Housing Element of the General Plan is intended to provide the city with a comprehensive strategy for promoting the production of safe, decent, and affordable housing within the community.

On August 25, 2021 Rancho Palos Verdes published an online survey through the SurveyMonkey platform. A downloadable version of the survey was also published on the Rancho Palos Verdes Housing Element webpage. The surveys provided an opportunity for community members to answer questions about the Housing Element Update and share their feedback with the City of Rancho Palos Verdes.

A total of 695 responses were obtained through the SurveyMonkey platform. Three individuals completed the survey and returned their results to the City via mail. The City also received four general comments from individuals regarding the community survey and Housing Element Update.

Rancho Palos Verdes Community Survey can be referenced in Appendix A.

## 2. Outreach and Notification

Stakeholders were invited to take the community survey through a range of outreach methods outlined below.

### 2.1 Social Media

Social media posts were published to promote the Rancho Palos Verdes' Housing Element Update survey. These posts were developed by MBI Media and the City of Rancho Palos Verdes. Subsequently, these posts were published on Rancho Palos Verdes social media accounts. The posts included information on the survey location and the date the survey would close. Table 1 includes a schedule of the social media posts made by Rancho Palos Verdes.

### **3. Public Comments**

The City received general comments from four individuals regarding the survey and Housing Element Update.

### **4. Community Survey Summary**

On August 25, 2021, Rancho Palos Verdes published an online and printable survey for the Housing Update. The survey questions were written and published to allow Rancho Palos Verdes property owners, tenants, business, and community leaders the opportunity to provide

feedback on the Housing Update process. The results from the survey will assist the City in developing the Housing Element of the General Plan.

- Of the 695 unique online community survey responses obtained, 681 live in the City of Rancho Palos Verdes.
  - 492 of these respondents have lived in Rancho Palos Verdes for more than 16 years and 658 own their current home in the City.
  - 68.24% of the respondents were 55 or older.
  - 56.68% of respondents identified as Caucasian, while 8.59% identified as multiracial and 7.82% identified as East Asian.
- 12.82% of respondents stated that their housing costs represent more than 30% of their household income.
- When asked if the City of Rancho Palos Verdes has an adequate supply of multifamily housing 87.83% of respondents selected yes, there is an adequate supply of multifamily housing in the City.
  - Only 10.39% of respondents own more than one residential property in Rancho Palos Verdes.
- When asked what the City's focus as part of the Housing Element Update process should be, individuals selected:
  - 83.16% selected Maintain existing housing
  - 18.89% selected Increase availability of housing options for seniors
  - 16.25% selected Redevelop underutilized parcels in commercial areas to include higher density
  - 15.52% selected Incentivize and encourage the development of vertical, mixed-use units in Commercial Zones
- When asked what areas in the City are appropriate for new Housing, 48.05% selected In commercial areas (as part of a new mixed-use developments), 36.90% selected on vacant lots and 22.58% selected in commercial areas (as new developments).
- Respondents were asked to rank the biggest challenges to increased housing in Rancho Palos Verdes. High cost of land was selected most frequently, followed by public opposition, and low supply of vacant land.
  - 22.38% of respondents selected that home prices in Rancho Palos Verdes are preventing them from becoming a first-time homeowner.
- When respondents were asked if they would support residential density increases, 25.25% selected yes, in or near commercial areas, or in multifamily residential zones. 3% selected yes, anywhere within the City, and 71.70% selected no, I would not support any density increases.
  - 91.62% of respondents selected no, they do not support allowing properties currently zoned for single-family residences to be developed with multiple dwelling units.

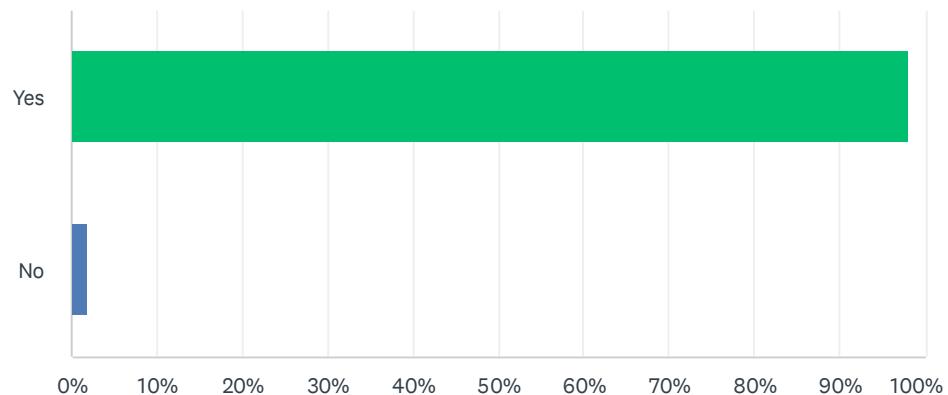

## Q1 Do you live in the City of Rancho Palos Verdes?

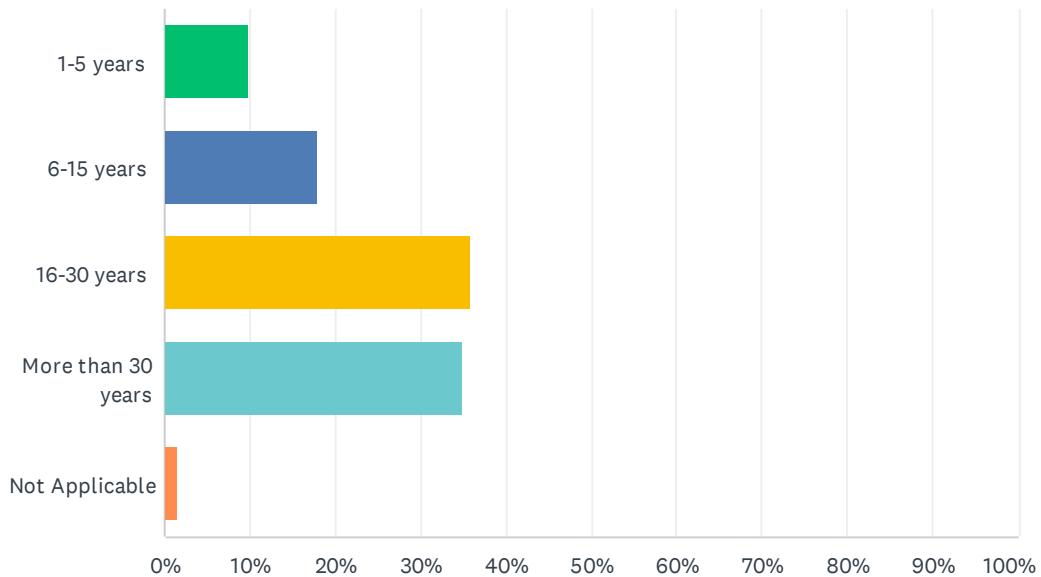

## Q2 How long have you lived in Rancho Palos Verdes?

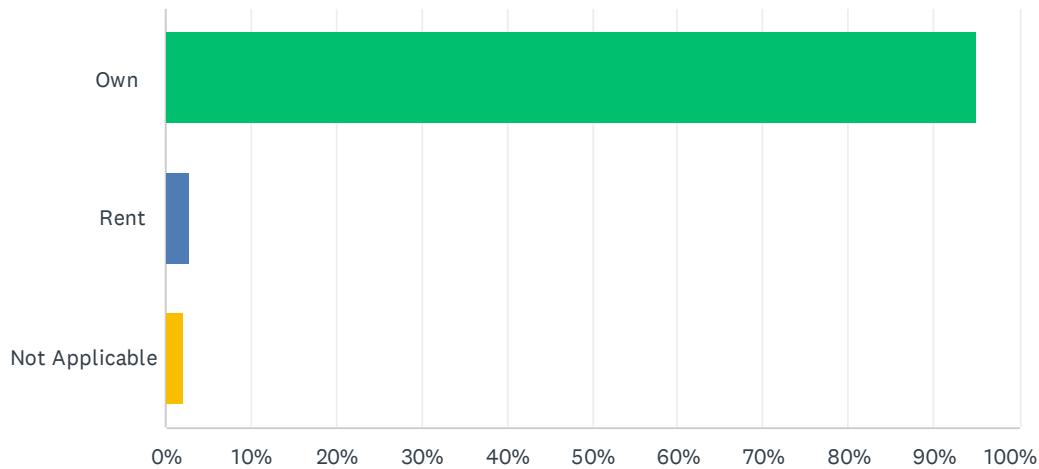

## Q3 Do you currently own or rent your home in Rancho Palos Verdes?

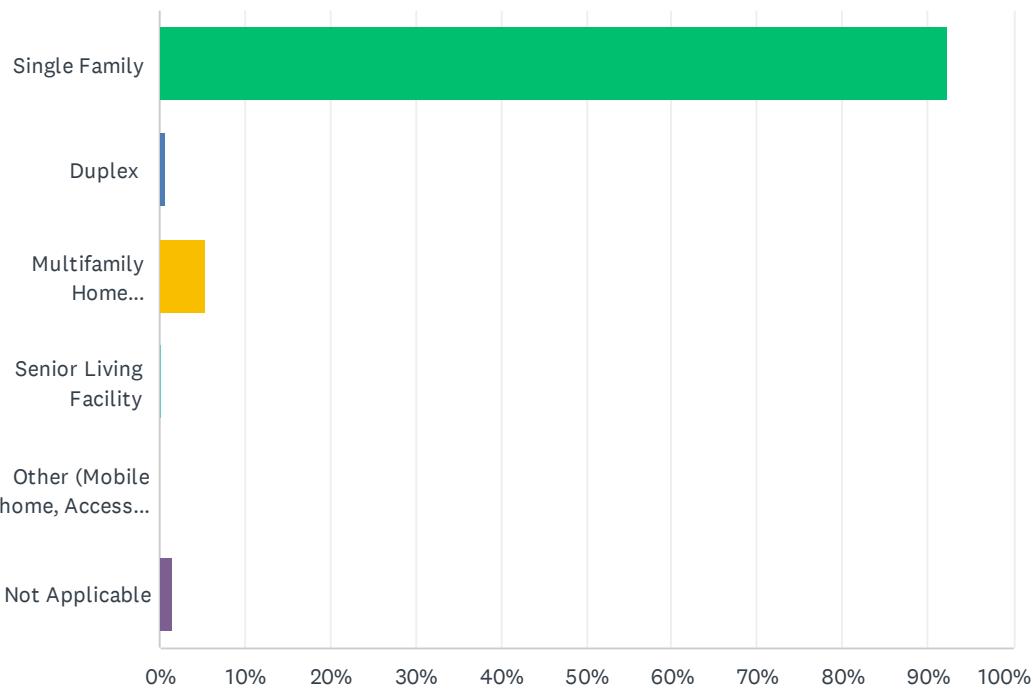

## Q4 Select the type of housing that best describes your current home in Rancho Palos Verdes:

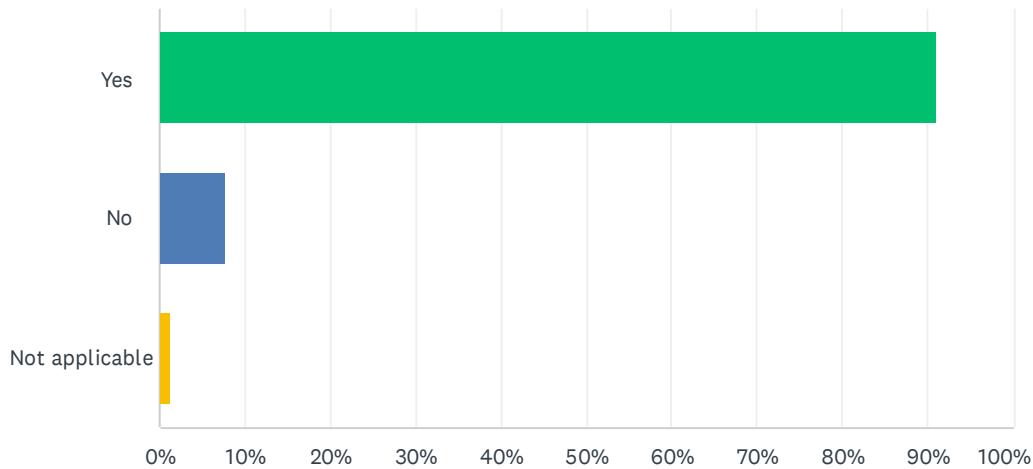

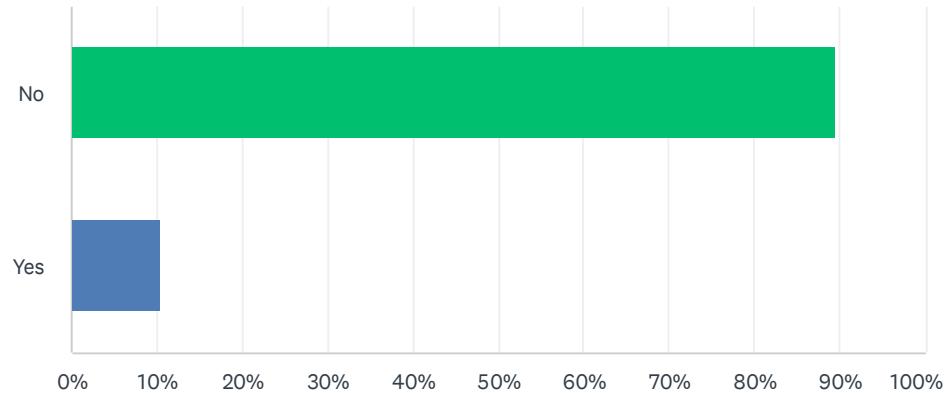
## Q7 Do you believe the City of Rancho Palos Verdes has an adequate supply of multifamily housing?

## Q8 Do you own other residential (other than your primary residence) or commercial properties in Rancho Palos Verdes?

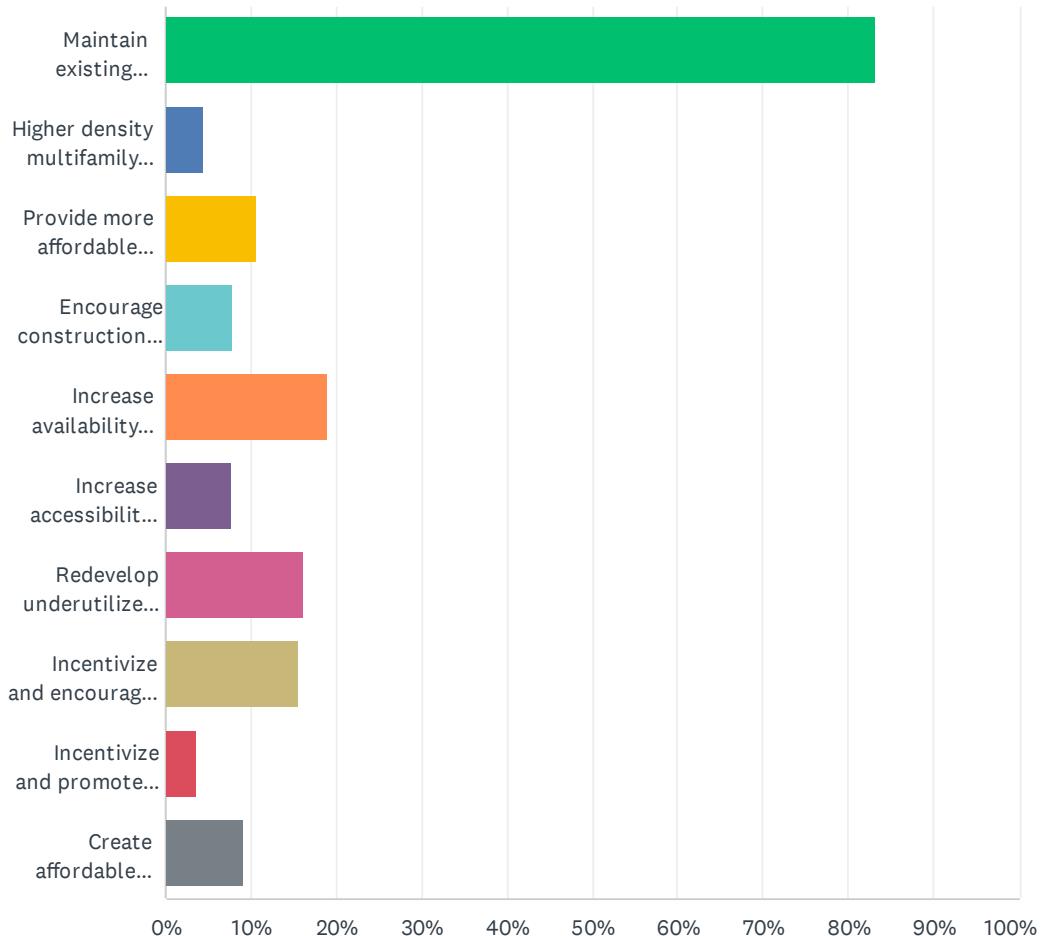

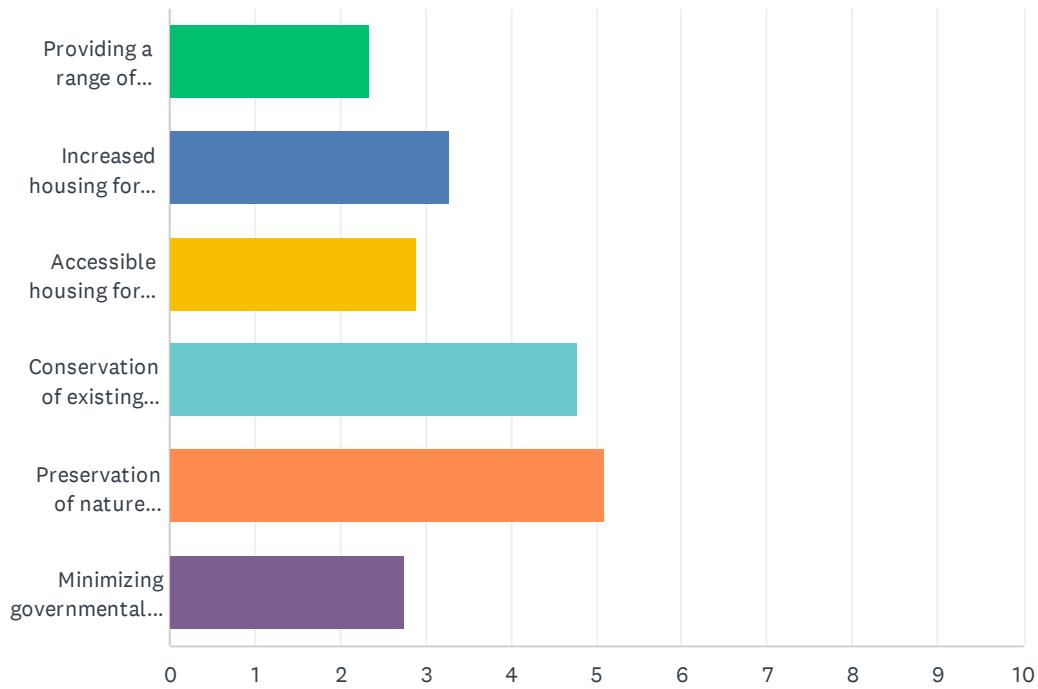

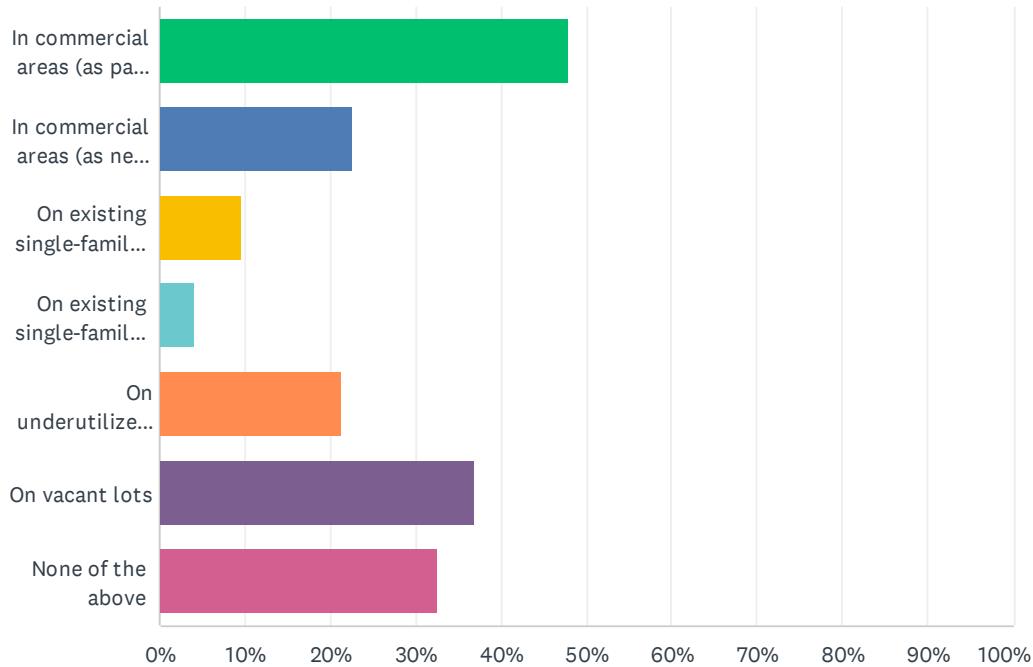
**Q10 Rank the following housing priorities by importance, with 1 being the highest priority and 6 being the lowest:**

## Q11 What areas in the City are appropriate for new Housing? Select all that apply:

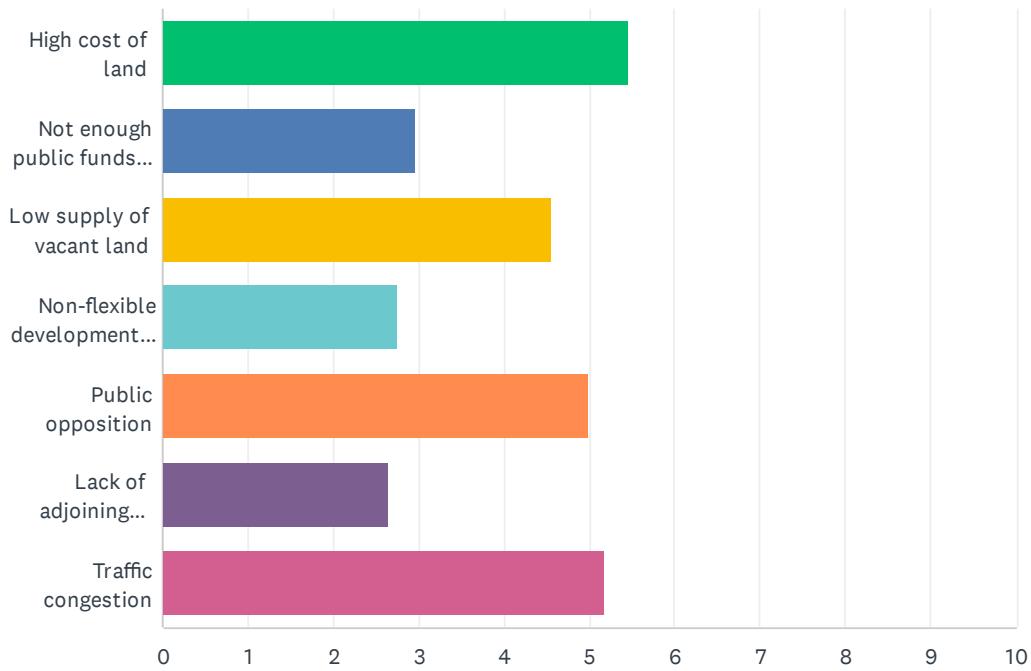

**Q12 Rank what you consider the biggest challenges to increased housing in Rancho Palos Verdes, with 1 being the most challenging and 7 being the least challenging:**

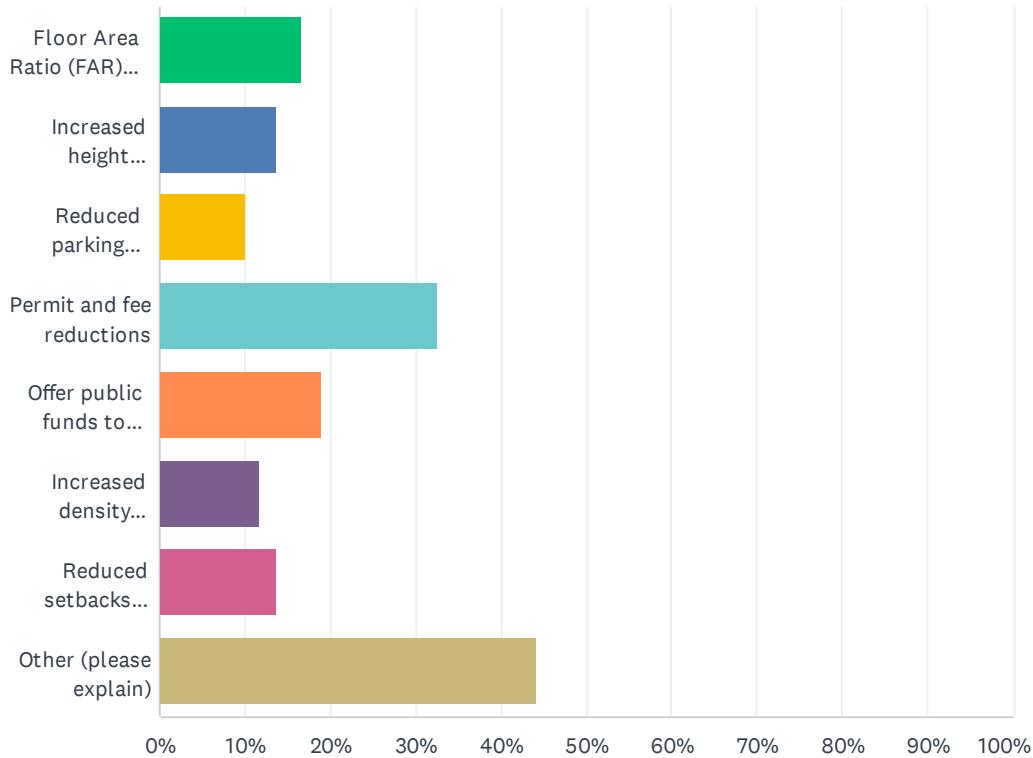

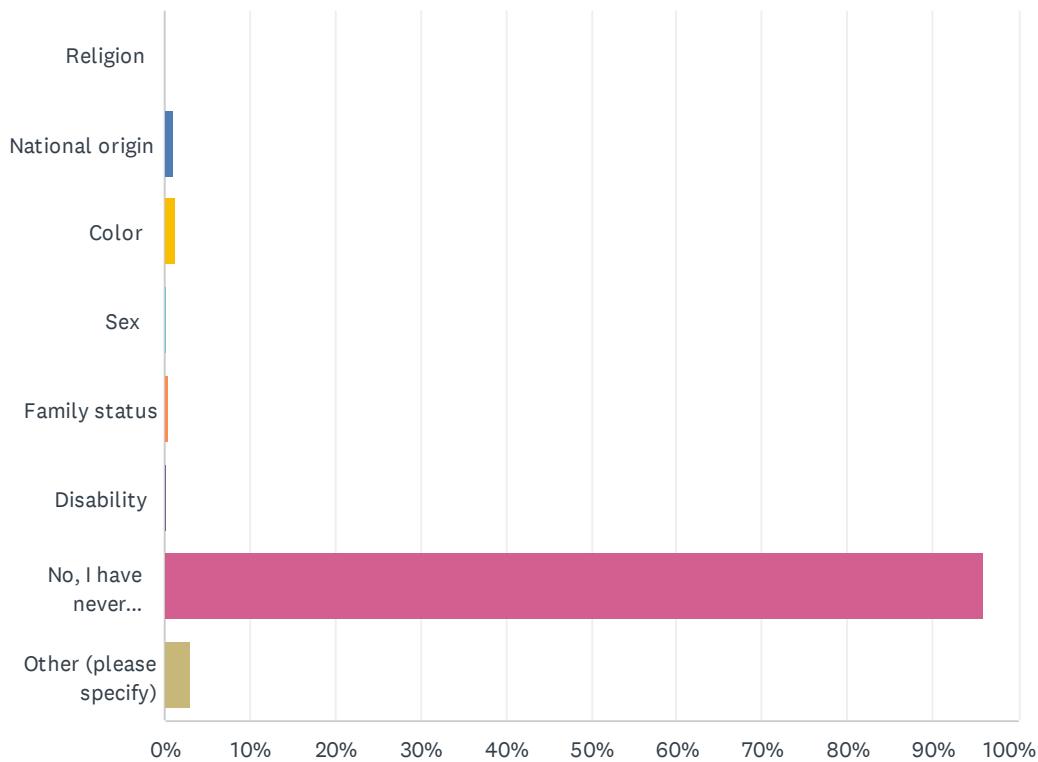

## Q20 What is your total household income (per year)?

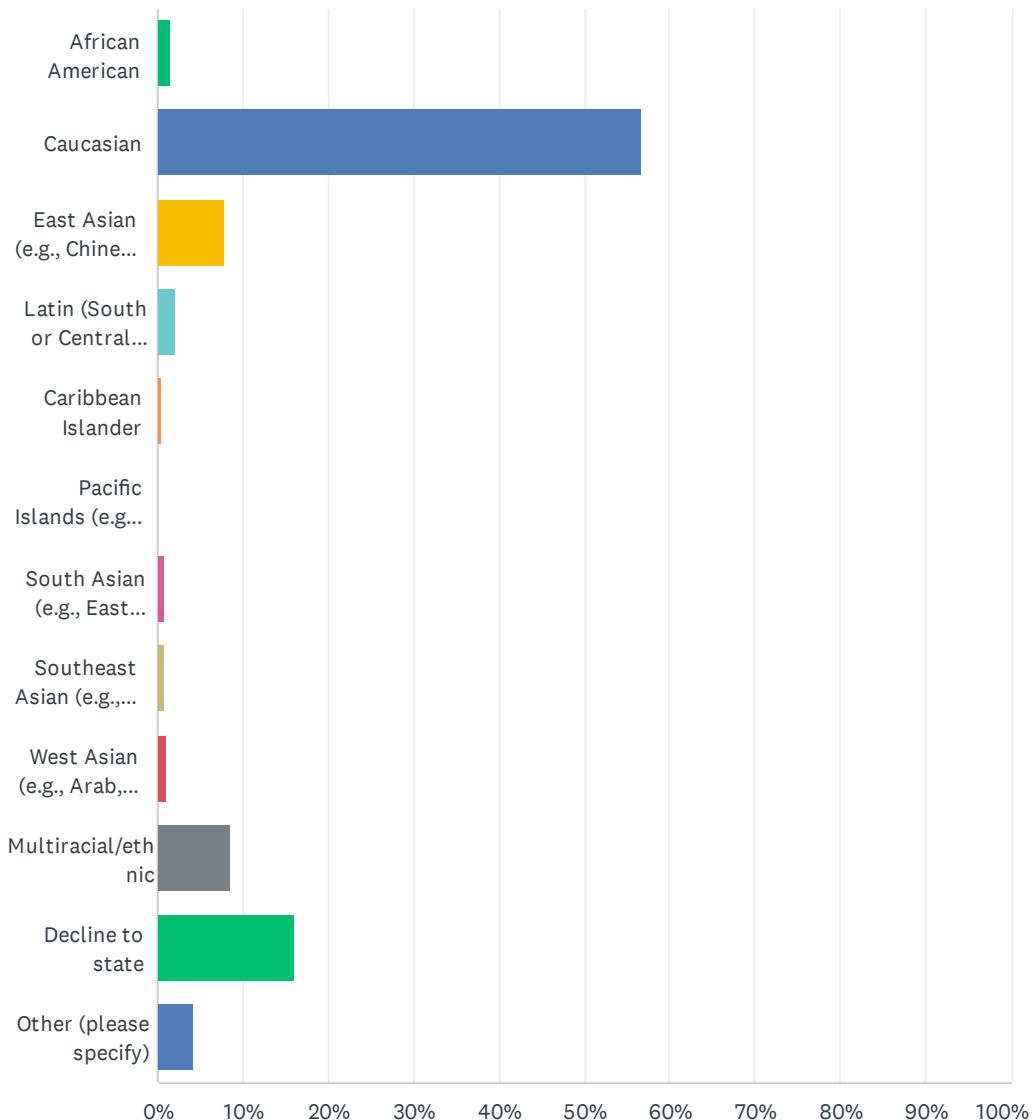

Dear Mr. Silva,

We are all aware that the State-mandated requirements for modification to the Housing Element of the City's General Plan pose a significant challenge which must be met in a very short time span. Whatever decisions the City makes at this point will shape our community for years to come.

### **Western Avenue**

Our understanding of optimal "Mixed-Use" zoning is that both housing and business uses can be accommodated in a way that facilitates convenient employment and small business opportunities as well as various community amenities for the benefit of the residents and the surrounding community. Traditionally, Mixed-Use areas have commercial uses on the street level, with residences above. Mixed-Use zoning can mitigate the problems of urban sprawl by reducing commute distances. By reducing sprawl, surrounding natural landscapes can be preserved.

But simply cramming as much dense housing as possible into a few small commercial lots on a short strip of Western Avenue in the name of Mixed-Use, without considering transportation and local employment configurations, is not good Mixed-Use design.

### **Transportation**

The section of Western Avenue being considered for a zoning change has some rather limited public transit, as do other parts of Rancho Palos Verdes, including Palos Verdes Drive South and Hawthorne Boulevard. However public transit must be frequent and reliable if it is to truly be a viable alternative to the use of private vehicles.

It is likely that many residents of the proposed 639 new housing units along Western Avenue would still opt to rely on their own cars for reliable transportation, even if they are not provided parking at home. Those additional vehicles could be expected to exacerbate both the local parking shortage and the general traffic congestion on Western Avenue.

As residents of Eastview, we already anticipate that traffic on Western Avenue will soon become increasingly worse as the new housing now being constructed at Ponte Vista is sold and occupied. To claim that CalTrans is somehow going to make traffic congestion any better in the near future, especially in the face of adding yet another major housing development on Western Avenue, seems to be wishful thinking at best.

## **Neighborhood Compatibility and Public Safety**

Hulking massive buildings up to 60 feet tall with minimal setbacks would be dramatically inconsistent with the surrounding community.

Furthermore, locating family housing on busy Western Avenue would also create significant safety risks. Where would the children living in the buildings be able to play? The consultants mention Peck Park as a wonderful nearby recreational amenity. But are young children going to be tempted to dash recklessly across Highway 213 (aka Western Avenue) to get to that park?

## **RPV needs better proximity between housing and employment**

Any revisions to the Housing Element of RPV's General Plan should simultaneously consider where the primary concentrations of jobs are within the City as well as in adjacent communities. A Goal of the Housing Element should be to locate adequate housing which is convenient to local employment opportunities. Improving public transit should be part of the Plan.

Western Avenue should not be the only focus for dense housing. We suspect that the largest employers in RPV may be Terranea, Trump National, Loyola Marymount, and perhaps even the City of RPV itself. Housing, both market rate and affordable, should be located conveniently close to these major employers.

The City of RPV currently has a very unbalanced configuration of housing reflecting economic status. Wealthier residents enjoy the more coastal locations and everyone else is pushed further inland. This pattern would be reinforced if all or most of the new affordable housing is concentrated onto Western Avenue. Any new housing developments need to have specific provisions for a mix of affordable housing and market rate housing.

## **In order to plan for housing associated with work opportunities, the City should be focusing on sites near Hawthorne Boulevard as well as Western Avenue.**

The City should also be considering the Golden Cove Shopping Center and other commercial and institutional sites including the Civic Center property as possible locations for some housing. In doing so, existing restrictions regarding properties adjacent to the Nature Preserve must continue to be respected. Furthermore, in keeping with the character of the City, as much additional natural open space as possible should be maintained.

## **No housing development should be allowed in the Palos Verdes Nature Preserve.**

The Palos Verdes Nature Preserve has been established in conjunction with State and Federal Resource Agencies to protect habitat for endangered native plants and

animals. The Preserve also provides natural recreational opportunities for people. It would be totally inappropriate to consider any part of the Nature Preserve for housing.

### **Conclusion**

We certainly do not oppose Mixed-Use zoning in general. However, any such plan needs to be fair, comprehensive and well-designed. Maximum density housing crammed into a narrow site on Western Avenue without realistic consideration of traffic, jobs or other social and environmental impacts would be just another iteration of bad urban planning causing future problems that are difficult to mitigate.

The need to plan for and allow 639 new units of housing in Rancho Palos Verdes is certainly a significant challenge. But it is also an opportunity to implement changes that will improve the quality of life for everyone in the city.
