NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, November 16, 2021, at 7:00 PM. The meeting will take place remotely in accordance with Government Code Section 54953(e) et seq. (AB 361), and Resolution 2021-53 adopted by the City Council on October 19, 2021 and will be conducted through a *hybrid combination of in-person and/or all virtual attendance of the five members of the City Council and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PVPTv channels Cox 35 and Frontier FiberOptic 39. Public participation is highly encouraged using the virtual platform as there will be very limited seating (with a combined total of 25 people between two rooms) at Hesse Park. The City Council will consider the following:

CODE AMENDMENT (CASE NO. PLCA2021-0001) – Consideration of an ordinance amending Chapter 17.48 (Lots, Setbacks, Open Space Area and Building Height) of Title 17 (Zoning) of the Rancho Palos Verdes Municipal Code to establish regulations for treehouses.
