NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, July 26, 2022, at 7:00 p.m. The meeting will take place remotely in accordance with Government Code Section 54953(e) et seq. (AB 361), and Resolution 2022-21 adopted by the City Council on June 21, 2022, and will be conducted through a hybrid combination of in-person and/or all virtual attendance of the seven members of the Planning Commission and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PVPTv channels Cox 35 and Frontier FiOS 39. The Planning Commission will consider the following proposed code amendments:

CODE AMENDMENT (CASE NO. PLCA2022-0002): A request to consider recommending to the City Council proposed code amendments to Title 17 (Zoning) of the Rancho Palos Verdes Municipal Code related to the regulation of:

- Section 17.56.040 (Outdoor Lighting for Nonresidential Uses) of Chapter 17.56 (Environmental Protection); and
- Section 17.60.050 (Findings and Conditions) of Chapter 17.60 (Conditional Use Permits).
