NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, August 9, 2022, at 7:00 p.m. The meeting will take place remotely in accordance with Government Code Section 54953(e) et seq. (AB 361), and Resolution 2022-21 adopted by the City Council on June 21, 2022, and will be conducted through a hybrid combination of in-person and/or all virtual attendance of the seven members of the Planning Commission and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at [rpvca.gov/agendas](http://rpvca.gov/agendas) and on PVPTv channels Cox 35 and Frontier FiOS 39. The Planning Commission will consider the following proposed code amendments:

**CODE AMENDMENT (CASE NO. PLCA2022-0003):** A request to consider recommending to the City Council proposed code amendments to Title 17 (Zoning) of the Rancho Palos Verdes Municipal Code to delineate the Planning Commission's role as advisory to the City Council for land use entitlements for public (city-owned) facilities to the regulations related to:

- Section 17.28.030 (Uses and development permitted by conditional use permit) of Chapter 17.28 (Cemetery (C) District);
- Section 17.32.040 (Use subject to conditional use permit) of Chapter 17.32 (Open Space Hazard (OH) District);
- Section 17.34.040 (Uses and development permitted by conditional use permit) of Chapter 17.34 (Open Space Recreation (OR) District);
- Section 17.44.030 (Uses and development permitted by conditional use permit) of Chapter 17.44 (Agriculture (A) District);
- Section 17.60.020 (Application), Section 17.60.050 (Findings and conditions), and Section 17.60.060 (Appeal) of Chapter 17.60 (Conditional Use Permits);
- Chapter 17.64 (Variances);
- Chapter 17.68 (Zone Changes and Code Amendments);
- Chapter 17.76 (Miscellaneous Permits and Standards);
- Chapter 17.80 (Hearing Notice and Appeal Procedures);
- Section 17.83.060 (Small wind energy systems) of Chapter 17.83 (Green Building Construction); and
- Chapter 17.96 (Definitions).
