NOTICE

NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, February 21, 2023, at 7:00 p.m.

The meeting will take place remotely in accordance with Government Code Section 54953(e) et seq. (AB 361) and pursuant to Resolution No. 2022-21, adopted by the City Council on June 21, 2022, and as renewed by subsequent resolution(s) thereafter. The meeting will be conducted through a *hybrid combination of in-person and/or all virtual attendance of the five members of the City Council and invited staff at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and via teleconference using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PVPTv channels Cox 35 and Frontier FiberOptic 39. Public participation is highly encouraged using the virtual platform as there will be very limited seating (with a combined total of 25 people between two rooms) at Hesse Park. The City Council will consider the following:

ANNUAL COMPLIANCE REVIEW, REVISION TO CONDITIONAL USE PERMIT NO. 155, AND MAJOR GRADING PERMIT FOR THE GREEN HILLS MEMORIAL PARK (Case No. PLCU2022-0009): Pursuant to City Council adopted Resolution No. 2021-66, the City Council will conduct an annual review of the Applicant's compliance with the Conditions of Approval associated with the Green Hills Memorial Park Master Plan. The City Council may add, delete, or modify conditions of approval as deemed necessary or appropriate based on evidence presented in the public record.

The City Council will also consider a request to revise Conditional Use Permit No. 155/Green Hills Memorial Park Master Plan to allow a new 2,800 ft² crematorium building with an overall height of 23.97 feet along with an attached 875 ft² canopy and ancillary site improvements with 91 yd³ of on-site grading. The new building will be located to the west of the existing Administration Building parking lot, as highlighted in the aerial map below.
