Los Angeles County Disaster Management AREA G <ul style="list-style-type: none"> Brandy Villanueva and Jesse Villalpando met with FEMA representatives to discuss the reimbursement program. Damage must have occurred during or have been a direct result of the storms that occurred between 2/21/2023 to 7/10/2023. The City submitted a damage report, and based on the public assistance timeline is considered a late submission. The City is currently collecting data and is estimating the proven damage total to be about \$200,000. There is an in-person follow up meeting on 1/22/2024 to present the City's request justification to FEMA. If FEMA does not approve this submittal, there is an appeals process.
