
**NOTICE**

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Rancho Palos Verdes will conduct a public hearing on April 9, 2024, at 7:00 p.m. at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes.

The meeting will take place in accordance with the requirements of the Ralph M. Brown Act, Section 54950 et seq. of the Government Code. Remote participation by any Committee/Commission member shall be in accordance with Subdivisions (b)(3) or (f) of Government Code Section 54953. The meetings are held at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and/or via teleconference for staff/consultants/participants using the Zoom platform and broadcast live on the City's website at [rpvca.gov/agendas](http://rpvca.gov/agendas) and on PVPtv channels Cox 35 and Frontier FiberOptic 39. Public participation will be in person and using the virtual platform. The Planning Commission will consider the following proposed project:

**CONDITIONAL USE PERMIT & SITE PLAN REVIEW (CASE NO. PLCU2022-0001 & PLCU2024-0002)** – A request to revise Conditional Use Permit No. 206 to allow for outdoor entertainment and operations at the Golden Cove Shopping Center in coordination with the Peninsula Tap House, as identified below:

- Outdoor entertainment including amplified music and live performances during the following days and times:
  - Monday through Friday: 5:00PM to 10:00PM;
  - Saturday: 11:00AM to 10:00PM;
  - Sunday: 11:00AM to 8:00PM; and
  - All federally observed Holidays from 11:00AM to 10:00PM
- Outdoor operations including the serving of beer, wine, and food in conjunction with the proposed outdoor entertainment.
- Utilize an approximately 750 ft<sup>2</sup> patio area with a temporary stage in front of the Peninsula Tap House for the outdoor entertainment and operations with seating up to 30 people, as highlighted in the aerial map below:

If you would like the opportunity to review the application package and the proposed plans, they are on file in the Community Development Department at 30940 Hawthorne Boulevard, Rancho Palos Verdes, and are available for review by appointment from 7:30 a.m. to 5:30 p.m. Monday through Thursday, and from 7:30 a.m. to 4:30 p.m. Friday.
