Portuguese Bend Landslide EIR, Final Engineering, and E1/E2	City	<p>Good news!!!</p> <ul style="list-style-type: none"> <li>There are four deep dewatering wells that are operating and extracting water at 450 gpm. These wells are in the PB Landslide area towards the beach west of the PB Beach Club.</li> <li>The pumps are upsized from what we started with, and they are at full capacity. The pumps may be upsized again.</li> <li>Installed GPS monitoring points near these wells. The first readings showing rate of reduction landslide movement is greater than rate of reduction is greater than the other landslide areas by 10%. This was achieved in less than 10 days of wells being operational.</li> <li>The City expected the first well to shear within a week. We are at 12 days and shearing has not yet started.</li> <li>One more well will be online this week—possibly another by the next City Council meeting.</li> <li>The City is optimistic and feel the program is working.</li> <li>The City is working on putting together some of the key data/information for the public.</li> <li>With the success of the first dewatering wells, the City will be considering the same or similar strategy in other areas, possibly including Altamira Canyon.</li> </ul>	October 2024

It will have a 20 hp motor. KCLAD expects it to pump 200-250 gpm. This week, they will install the vault, power, and pump. It should be in operation next week.</li><li>• The Pump readings at the monitoring well on Yacht Harbor shows the water dropped 2.7 feet. The lower well dropped 2.8 feet.</li><li>• Well #4, pump #3 is only pumping at 11 gpm when it used to be at 115 gpm.
