VI. OLD BUSINESS

A. UPDATE ON KNOW YOUR ZONE RENUMBERING (GENASYS)

Rolling Hills Estates (RHE) Management Analyst Slawson reported that at the last Quarterly meeting staff was directed to gain a better understanding of the evacuation numbering system that was established by Los Angeles County Office of Emergency Management (OEM) and the evacuation platform Genasys.

Upon further discussion, both of the administering office of the County and Genasys representatives have expressed the effectiveness of the current numbering system, and that no changes are needed at this time.

The four Peninsula cities have shared the numbering system with each respective community through the Know your Zone campaign. OEM is currently rolling out the Genasys system countywide, with the South Bay cities being a part of that system.

B. SCHOOL RESOURCE OFFICER (SRO) UPDATE (PVPUSD REPORT)

Palos Verdes Peninsula Unified School District (PVPUSD) Assistant Superintendent of Administrative Services Brenna M. Terrones reported that the PVPUSD submitted their monthly activity reports for April, May, and a portion of June. The balance of June and July will come in the next Quarterly meeting.

The reports delineate the number of active days in session accounting for summer session, and spring break. It also denotes day to day, and/or specific items that the School Resource Officers (SRO) assisted on during that time, including traffic investigations and daytime meetings support, and managing media crews as it related to the yearbook situation.

Ms. Terrones noted the PVPUSD tries to maintain issues within the school district utilizing the SROs and appreciates the continued support as needed from the LA County Sheriff's Department (LASD) and Palos Verdes Estates (PVE) Police Department.

Vice Chair Seo asked a question about a fight club issue, whether it was proliferating or if it had been solved.

Ms. Terrones stated that the PVUSD would like to believe that it has been solved. Administration, human resources, and legal counsel were all involved in managing some aspects of it. PVPUSD hopes that coordinated efforts with regards to scheduling and programming in the upcoming year will allow the district to maintain and manage some of those that were involved. They are focused on positive behavior and improvement while working within the parameters of existing board policies on behavior and recent law changes. The PVPUSD is trying to do everything they can to mitigate issues going into the next school year.

Vice Chair Seo expressed concerns about serious injuries and asked about working with LA County Sherriff and Torrance Police.

Ms. Terrones responded that any issues on their campuses have been small.

Vice Chair Seo asked Captain Guerrero for her input.

LASD Captain Guerrero responded that the County has seen an increase in juvenile crimes, including the fight clubs and congregation of juveniles at the malls. But specific to the areas Lomita Station services, it's not an issue and they do not see anything rising or increasing as far as juveniles. Their core team is on the PVPUSD campuses often and respond to issues right away.

C. LOS ANGELES COUNTY FIRE DEPARTMENT AND MCCORMICK UPDATE

Los Angeles County Fire Department Acting Assistant Chief Kane reported on the second quarter specific to emergency responses and related fires for the Peninsula Cities as follows:

Palace Verdes Estates -

301 calls for service

5 fire responses

207 Emergency Medical Services (EMS) responses - 138 were Advanced Life Support (ALS)

Rancho Palos Verdes -

900 calls for service

7 fire responses

680 EMS - 517 ALS

Rolling Hills -

52 calls for service

2 fire responses

27 EMS - 21 ALS

Rolling Hills Estates -

269 calls for service

3 fire responses

194 EMS - 108 ALS

Member Huff asked about a bonfire potentially on the beach in Palos Verdes Estates (PVE) and were beach fire pits allowed

Chief Kane responded that it was actually in a resident's backyard and reported by a neighbor. No beach fire pits allowed.

PVE Community Relations Officer Herrera asked about public service information related to car fires being accessible and requested clarification as to whether they were predominantly in older vehicles.

Chief Kane responded that they have been seeing an increase in electrical vehicle / hybrid incidents. Some are mechanically related where the vehicle has had recent work performed. He noted there is a seasonal effect during hotter weather as vehicles run hotter, which can lead to more car fires. Specific to public service announcements, he was unable to think of anything generic in nature that could be creating these issues.

Rancho Palos Verdes (RPV) City Manager Mihranian asked Chief Kane about a fire related to an unhoused individual, if more information could be provided and whether it was in the preserve or not. He also asked Captain Guerrero about how the cities should respond to inquiries about, or how to report unhoused individuals. He noted utilizing Los Angeles Homeless Services Authority (LAHSA) and other resources but was curious about what cities can do when they see unhoused individuals and how they can try to find them accommodations.

Chief Kane noted the reporting location of the call was La Rotunda Drive.

City Manager Mihranian noted that was right near the trail head at Trump National Golf Course.

Captain Guerrero responded that LASD has plenty of resources they utilize during calls for service or patrolling. She noted the LASD host team will always initially provide unhoused individuals with said resources and an opportunity to take advantage of them before jumping to arrests or removal from premises.

City Manager Mihranian commented that RPV has a no camping ordinance and prohibits overnight camping in the open space areas but allows it in certain areas. He noted that it predated the recent Grants Pass court decision and that the City would probably need to revisit their ordinance in light of the court rulings.

Member Wilson asked Chief Kane about the reported incident where a junction box hung on a fence caught surrounding brush on fire and whether it was legally installed.?

Chief Kane responded stating the junction boxes were related to outdoor fire sprinklers and the control boxes that were used for those said sprinkler systems. He noted that although they were a low voltage style of junction box and wiring, the proximity of the junction box to the dry plywood materials resulted in a very small fire.

Vice Chair Seo shared a neighbor's email regarding an elderly gentleman who was going to his mailbox and needed help. He tried to call on a cell phone, couldn't get reception, and ultimately passed on the sidewalk. The response time was reported as 10 to 15 minutes. Something like that. Vice Chair Seo wondered if the cities are getting any help regarding better compliance rates or more ambulances to service the peninsula. Do we have an update on that.

Chief Kane responded that he didn't have a direct update on that particular incident. He noted that the County, in general, was experiencing ambulance shortages with extended response times countywide. Since the COVID-19 pandemic, the ambulance companies have been unable to keep up with hiring and retention of Emergency Medical Technicians (EMT) which is creating a shortage. He commented that LA County Fire Department (LACFD) can put pressure on McCormick to ensure they have the necessary ambulances available for the Peninsula, and that those response times are always maintained.

Vice Chair Seo acknowledged the countywide shortage and asked if there was anything the cities could proactively do to get better service.

Chief Kane responded that putting continued direct pressure on McCormick and also go through the LACFD Medical Director Dr. Kazan to apply pressure. He noted that what can happen at times is that resources get redirected to areas with a higher call volume and create a situation where an ambulance is out of position.

Vice Chair Seo asked if the peninsula was low regarding compliance rates and how it compared to other LACFD service areas.

Chief Kane responded that the peninsula is better than average as a result of the lower call volume. Higher call volume areas suffer more with the ongoing shortages.

VII. NEW BUSINESS

A. PREPARED PENINSULA EXPO (VERBAL REPORT)

RHE Management Analyst Slawson reported that the annual Prepared Peninsula Expo will be held on October 27, 2024, from 10 a.m. to 1 p.m. in tandem with the Palos Verdes Farmers Market at Peninsula High School. This is a collaborative, four city event in partnership with local law enforcement, the fire department, school district, and many other utility partners. This community event is meant to share emergency preparedness resources with a newly added active shooter education and training component this year. Staff will meet over the next couple of months to plan the event and all cities will promote collectively.

Vice Chair Seo asked for clarification on the active shooter component.

RHE Management Analyst Slawson responded that while the Expo is held outside, the active shooter component will be held indoors in coordination with the Lomita Sheriff Station and PVE Police Department. It could be an educational and discussion-based event showing videos.

PVE Police Chief Luke Hellinga added that they are planning on having a PVE officer hold a morning session and afternoon session in conjunction with a Sheriff Deputy.

B. PVP MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN UPDATE (VERBAL REPORT)

RHE Management Analyst Slawson reported on the status of the Palos Verdes Peninsula multi-jurisdictional hazard mitigation plan update. Staff has applied for Federal Emergency Management Agency (FEMA) grant funding to support the development of the joint plan and received news that the application was currently in the FEMA funding queue and awaiting final grant award confirmation. The process can't move forward until staff receives notice of funding, but once confirmed, staff will arrange a meeting with the newly established Ad Hoc Committee to discuss next steps and bringing in a consultant.

Member Huff requested a ballpark amount for the grant.

RHE Management Analyst Slawson responded that it was approximately \$330,000

Member Huff asked if that would cover the entire amount Rolling Hills Estates had planned for in their budget.

RHE Management Analyst Slawson responded that it will cover 75%. There is a 25% local match that will be shared between the four cities using a cost-share formula.

Vice Chair Seo asked about the timeline on this project. ard.

RHE Management Analyst Slawson responded that staff was hoping that we're the funding component would be finalized within the following couple of weeks and the anticipated overall timeline for the development of this plan is estimated to be a yearlong process ending around December 2025.

RHE City Manager Grammar noted that the agenda packet had a summary of activities that the committee has either overseen or guided over the last couple of years since the committee's inception. Those include the development of a utility white paper, the establishment of ZoneHaven now known as Genasys, an evacuation platform, the PVPready.gov website, installation of the wildfire cameras, the Automatic License Plate Reader (ALPR) camera installation and update, and the just discussed Hazard Mitigation Plan (HMP) update. In the coming year, staff will be focusing on the HMP and holding a community safety drill. The report also provides a little bit of background about the committee, how it was formed, and its mission and purpose.

Vice Chair Seo asked if there was a timeline on the community safety drill and any details on how it would work.

RPV City Manager Mihranian responded that the original plan was to roll it out in conjunction with the Expo, but with staff separations and loss of the personnel who were planning it, staff estimates it could be in the second quarter of 2025.

Subject: Monthly Activity Report / August, 2024

Details: The 2024-25 school year has begun and was in session for eight days during the month of August, 2024. The end of summer vacation spilled into August for the first three weeks until the first day of school kicked off with a minimum day schedule on Wednesday, August 21, 2024.

Officer David Rozas is responsible for ten schools within the district which includes Peninsula High School, Rancho Del Mar Continuation School (Shared with Officer Watt), Miraleste Intermediate School, Ridgecrest Intermediate School, Dapplegray Elementary School, Mira Catalina Elementary School, Rancho Vista Elementary School, Silver Spur Elementary School, Soleado Elementary School and Miraleste Early Learning Academy.

Officer Robert Watt is responsible for nine schools within the district which includes Palos Verdes High School, Rancho Del Mar Continuation School (Shared with Officer Rozas), Palos Verdes Intermediate School, Lunada Bay Elementary School, Point Vicente Elementary School, Montemalaga Elementary School, Vista Grande Elementary School, Cornerstone @ Pedregal and Valmonte Early Learning Academy.

Officer Rozas and Watt provided safety and security at their respective high schools for student registration and subsequent registration make-up days that went well with nothing of any significance to report. Both SROs spent some time with their respective freshmen class who attended Freshmen Orientation and were working their way through their new campus.

Officer Rozas and Watt also attended PVPUSD training at Peninsula High School on August 19 and their on-site training on August 20.

Officer Rozas and Watt spent a good part of “Day 1” at their respective high school and greeted over 3,500 students combined as they arrived for their first day of high school. Visits at all secondary schools were conducted as well throughout the week.

Officer Watt responded to the District Office to assist staff with a disgruntled PVPUSD employee who had been suspended pending further investigation. The employee continued to loiter around the district office looking for “information” until he was re-contacted and warned/advised in regard to trespassing on all school properties.

Officer Rozas assisted the Los Angeles Sheriff’s Department with a vandalism investigation at the Peninsula Center where two students had the bicycle tires slashed.

Officer Rozas handled a traffic collision investigation at Peninsula High School involving a motor vehicle and electric bicycle. No injuries reported.

Officer Watt assisted Palos Verdes High School administrators and counselors with a child/custody dispute involving a student who was afraid to be picked up by her father after school, per court order. The student and father were interviewed and after the father was adamant about taking custody of his daughter, Palos Verdes Estates PD was contacted and responded for follow up.

Officer Watt responded the Golden Cove parking lot in regard to a traffic collision involving a PVHS student who was having trouble exchanging information with the other party involved. LASD responded as well and names and information were subsequently exchanged.

Officer Rozas and Peninsula High School administrators’ investigated a possible domestic incident on campus involving two students who were in a dating relationship. LASD responded for follow up when it was determined that this would be a criminal investigation.

Officer Rozas and Watt continue to make vehicular-related incidents a priority as school begins. Officer Rozas “tagged” 21 vehicles who were illegally parked on the Peninsula High School Campus and investigated/solved a hit-and-run traffic collision that occurred on his high school campus. Officer Watt worked with PVEPD and handled traffic control before and after school in an effort to keep the parking lots and nearby roadways safe. Officer Rozas and Watt plan to conduct safe driving lectures in selected classes to all students who either drive or will be driving this year

Officer Watt continues to work with the Palos Verdes Estates Police Department in an attempt to have 1-2 handicapped parking spots created in front of the football stadium on Epping Road. The city’s Traffic Commission is following up on the request. Restricted parking signs at isolated PVHS locations on campus is also in the works.

Officer Rozas provided safety and security at Peninsula High School's varsity football game against Alta Loma High School on Friday, August 23, 2024. Officer Watt chaperoned and provided security at a road game for the varsity PVHS football team on the Hawaiian Islands. PVPD played against Iolani, HI, on the Island of Oahu, and traveled with 72 student/athletes, 10 coaches and a large amount of parents. Nothing of any significance was reported and all 72 kids were well-behaved.

Officer Watt provided extra security at the first school board meeting of the new year on August 28, 2024. Community concern continues to be present over last spring's yearbook at PVHS, but the numbers of speakers has declined.

Officer Rozas and Officer Watt continue to meet to review crime trends at all schools as well as local and national noteworthy news that involves schools where local action on the hill may need to be taken. Officer Rozas and Watt will work with Cheryl Dawson over the next few weeks as she coordinates her annual Evacuation and Disaster Drills at each school.

Subject: Monthly Activity Report / September, 2024

Details: School was in session for 20 days during the month of September, 2024. Staff and students had one holiday off in September in observance of Labor Day.

Officer David Rozas is responsible for ten schools within the district which includes Peninsula High School, Rancho Del Mar Continuation School (Shared with Officer Watt), Miraleste Intermediate School, Ridgecrest Intermediate School, Dapplegray Elementary School, Mira Catalina Elementary School, Rancho Vista Elementary School, Silver Spur Elementary School, Soleado Elementary School and Miraleste Early Learning Academy.

Officer Robert Watt is responsible for nine schools within the district which includes Palos Verdes High School, Rancho Del Mar Continuation School (Shared with Officer Rozas), Palos Verdes Intermediate School, Lunada Bay Elementary School, Point Vicente Elementary School, Montemalaga Elementary School, Vista Grande Elementary School, Cornerstone @ Pedregal and Valmonte Early Learning Academy.

Officer Watt assisted staff in handling a report that a student in class at Palos Verdes High School had been researching a gun purchase on a school-issued chrome laptop computer. Countless hours were spent with interviews and re-interviews of students, staff and the family of the person in question. Palos Verdes Estates Police was also involved and based on our investigation, no gun research or criminal threat had occurred and the student would receive school discipline for misuse of school equipment.

Officer Rozas assisted staff in handling a report that a student had allegedly threatened to do harm on the campus of Miraleste Intermediate School. Countless hours were

spent on this investigation as well with interviews and notifications. LASD also assisted and School Resource Officers (SROs) were on campus for two days until the threat turned out to be unfounded and business at the school returned to normal.

Officer Watt assisted the principal at PVIS with a student who had recently been suspended for inappropriate comments to others and has now returned to school. The student had been struggling with behavioral issues for over three years now to the point where local PD and the Federal Government were advised of the circumstances.

Palos Verdes Estates Police, school staff and Officer Watt were involved in an incident regarding a male juvenile who lives across the street from Palos Verdes High School and frequents the campus via the wide open east side of the campus. The male juvenile was taken into custody on campus after an incident with the mother at their residence and allegedly, threatened at least one staff member. The male juvenile was placed on a psychiatric 72-hour hold by PD, and steps have now been taken at a district level to better secure the north and east side of the campus.

Officer Watt handled a child custody battle involving a father and daughter on two separate Fridays during September. The child was refusing to leave with her father, citing unsafe conditions. The father decided to let his ex-wife pick up the child after he was advised that law enforcement was going to be contacted.

Officer Rozas handled two separate incidents of domestic battery and assisted LASD on the investigation after he determined both incidents may be criminal. Further investigation revealed one incident was un-sustained and the second incident resulted in an assault/battery citation for the alleged suspect.

Officer Watt assisted staff at Rancho Del Mar Continuation School with a student that registered to attend RDM, but had missed every single day since the beginning of the school year. Officer Watt was able to make contact with the father who advised the child had been "under the weather." Officer Watt confirmed that the child was safe and the father ultimately placed his child in the district's Distance Learning Academy.

Officer Watt investigated a series of illegal dumping incidents on the Palos Verdes High School's campus involving trucks that had commonly drove onto campus all summer long and dumped what appeared to be roofing material and cement blocks in the trash bins behind the cafeteria. Officer Watt was able to identify the persons/company involved using school district resources and follow up was conducted with the associated company and District Office.

Officer Rozas investigated an incident involving a student who appeared to be impaired and had brought an alcoholic beverage on to the Peninsula High School campus. Through his investigation, Officer Rozas located a juice bottle that was partially filled

with what appeared to be beer. The intoxicated student received school discipline and counseling with a SAGE therapist.

Officer Rozas investigated an incident at Miraleste Intermediate School involving a student who had allegedly brought an edged weapon on to campus. The student was contacted and further investigation revealed the weapon that was brandished was the file end portion of nail clippers. The student received school discipline.

Officer Watt assisted the school psychologist at Pt Vicente Elementary School with a male student who was having behavior issues on campus. A threat assessment was completed on the student and more services/resources will be made available to the student and family to assist and improve behavior.

Officer Rozas assisted staff at Peninsula High School with a student who had previously been expelled from Redondo Union High School due to bringing a loaded firearm on campus and was now attending Pen. Further investigation revealed the parents had enrolled the student into the district under false pretenses and therefore, the family was advised to withdraw the student.

Officer Watt responded to Lunada Bay Elementary School to deal with a TK Aide who had an issue with Palos Verdes Estates PD and was now being disruptive on campus. The aide was advised to leave and not return and his company was notified. Officer Watt returned to the school the next morning to ensure that the aide did not show up.

Officer Watt was contacted by the owner of the Lunada Bay Market, 2201 Palos Verdes Blvd, in regard to a shoplifting incident that had occurred possibly involving Palos Verdes High School Students. The student in question was identified off camera footage and after being contacted, returned to the market with his mother to pay for the item stolen. School discipline given to the student who had left campus without permission.

Officer Rozas investigated three theft reports at Peninsula High School with two of them occurring on campus. All investigations had limited workable information and therefore, suspects could not be identified/located.

Officer Rozas investigated a series of vandalisms on the Peninsula High School campus involving three male students who were also harassing four female students.

Officer Rozas contacted two students at Peninsula High School who were in possession of vape pens. School discipline received.

Officer Watt responded to Palos Verdes Intermediate School to introduce himself to the Special Day Class and talk about making good choices.

Officer Watt assisted Cornerstone School & Pedregal with their annual Evacuation Drill and PVIS, Vista Grande Elementary and Montemalaga with their respective shelter in place/lockdown exercise.

Officer Rozas and Watt continue to make vehicular-related incidents a priority as school begins. Officer Rozas "tagged" 58 vehicles who were illegally parked on the Peninsula High School Campus and investigated/solved three traffic collisions on campus. Officer Watt continues to work with PVEPD on speeding and illegally parked vehicles involving students and parents around PVHS and also at Lunada Bay Elementary School.

Officer Rozas and Officer Watt provided safety and security at home and away varsity football games. No incidents of any significance reported.

Officer Watt provided extra security at the school board meeting on September 11 and September 25, 2025 and briefed the Board of Education on a School Safety discussion item at the September 25 meeting.

Officer Rozas and Officer Watt met to review crime trends at all our local schools as well as the recent mass shooting at a Georgia school campus. Updated and continual training for both SROs was discussed.

Busy month on the hill throughout the school district, but some great teamwork displayed involving staff and local law enforcement.

Details: School was in session for 23 days during the month of October, 2024, with no holidays or student free days

Officer David Rozas is responsible for ten schools within the district which includes Peninsula High School, Rancho Del Mar Continuation School (Shared with Officer Watt), Miraleste Intermediate School, Ridgecrest Intermediate School, Dapplegray Elementary School, Mira Catalina Elementary School, Rancho Vista Elementary School, Silver Spur Elementary School, Soleado Elementary School and Miraleste Early Learning Academy.

Officer Robert Watt is responsible for nine schools within the district which includes Palos Verdes High School, Rancho Del Mar Continuation School (Shared with Officer Rozas), Palos Verdes Intermediate School, Lunada Bay Elementary School, Point Vicente Elementary School, Montemalaga Elementary School, Vista Grande Elementary School, Cornerstone @ Pedregal and Valmonte Early Learning Academy.

Officer Watt assisted deputies with LASD at Ridgecrest Middle School on a male subject that was allegedly following a female student in his vehicle as she left school. The vehicle was gone upon our arrival and a report and Patrol Request were completed by LASD. School administrators contacted as was the parents of the student. No similar occurrences in the area and LASD advised they could not confirm a crime and would not be following up any further. Officer Watt re-contacted the student in question one week later to check up on her.

Officer Watt responded to Pt Vicente Elementary School on several occasions during the month of October to assist staff with a student who continues to threaten several members of the staff. The student continuously walks out of the classroom and is

causing a disruption that is now affecting other uninvolved students. A threat assessment was completed which showed no credible threat to himself or others. District Office administrators were updated.

Officer Rozas and school administrators investigated an incident involving a student on campus at Peninsula High School who was possibly in possession of a weapon. No weapon was found and further investigation revealed the incident had possibly occurred over two months ago.

Officer Rozas investigated an incident involving a Peninsula High School student and Miraleste student possibly having sex in the Fitting Room at Target, 43 Peninsula Center, Rolling Hills. The incident was unsubstantiated and SAGE therapists were contacted to follow up with both students.

Officer Watt and deputies from the LASD responded to Pt Vicente Elementary School in regard to a male adult who was allegedly en route to the school to confront his wife who is a Speech Therapist there. Allegedly, a series of domestic incidents had occurred at their residence over the weekend and was now possibly spilling into the school. The male half never showed up and the female was strongly encouraged to obtain a restraining order. LASD is following up with LAPD due to the fact that the initial residence in question is in the city of Los Angeles. The two also have a son attending Silver Spur Elementary School. Officer Watt met with the wife days after the event and she advised a restraining order has been served and her husband has moved out of the home and is abiding by the order. Patrol Requests by Officer Watt and Officer Rozas to continue at Silver Spur and Pt Vicente.

Officer Watt responded to Ridgecrest Middle School to assist staff with a student who was possibly under the influence of an alcoholic beverage. Officer Watt conducted a series of tests on the student and no alcohol usage/impairment was detected. Staff and parents were advised.

Officer Rozas handled a possible harassment incident at Peninsula High School involving two students with possible vehicle tampering involved. This is a complicated and on-going investigation.

Officer Rozas responded to Rancho Vista Elementary School to handle a female transient who attempted to set up an encampment on campus. The female was contacted, given information regarding resources available to her and advised to move along.

Two thefts occurred at Peninsula High School and were investigated by Officer Rozas. One involved an unlocked expensive electronic bicycle that was stolen and the other involved a stolen cellular phone.

Officer Watt investigated an incident involving a transient who was involved in an altercation with a Palos Verdes Transit bus driver while several Palos Verdes High School students were on the bus and watching the entire incident. Officer Watt contacted the transit bus management company who was not aware of the incident. Further investigation by PV Transit revealed that the transient in question was refusing to pay a fare and as he exited the bus he punched the window next to the door. Counseling, if needed, to follow up with the involved students.

Officer Watt investigated an incident involving a Door Dash driver who had to deliver food to a student at Palos Verdes High School and was adamant that he be allowed to walk through the campus and hand deliver it to the purchaser. The driver became very belligerent when contacted and advised to leave campus. Officer Watt contacted a representative at Door Dash and the driver was identified and advised he would be in violation of trespassing (602 PC) if he returned.

Officer Watt conducted follow up on a Palos Verdes High School student who had been involved in several disturbances while visiting various businesses in Lunada Bay during school hours. Officer Watt was able to obtain video of the student and through his investigation, the student was contacted and warned/advised on his poor behavior that reflects negatively on the school. School discipline also administered for leaving campus.

Officer Rozas investigated a possible vandalism to a vehicle parked on the campus at Peninsula High School. Using his district resources, video footage was obtained and no vandalism was observed at any time while the vehicle in question was parked on campus. Student was advised.

Officer Watt handled two minor traffic collisions that occurred on the campus of Palos Verdes High School on consecutive days involving students. Students were all contacted and names and information were exchanged. Parents were also contacted.

Officer Rozas handled a hit-and-run traffic collision on the campus of Peninsula High School that was witnessed and photographed by a passing taxi cab driver.

Officer Rozas and Watt continue to make vehicular-related incidents a priority as school begins. Officer Rozas "tagged" 36 vehicles that were illegally parked on the Peninsula High School Campus. Officer Watt continues to work with PVEPD on speeding vehicle involving students in and around Palos Verdes High School. No student were cited or warned on excessive speeding over the last month.

Officer Rozas and Officer Watt provided safety and security at home and away varsity football games. No incidents of any significance reported.

Officer Watt provided extra security at the school board meeting on October 9 and October 23, 2024, and attended the Electronic Bike seminar at the Red Onion and hosted by the PTA, LASD and PVEPD.

Officer Watt and school administrators conducted a campus threat assessment at Palos Verdes High School and additional fencing and defensive shrubbery was recommended and approved for installation. This will better secure the east side of the campus that is currently wide open.

Officer Rozas and Officer Watt attended several Disaster Drills during the month and also participated in the annual Great American Shake Out held on October 17, 2024.

Officer Rozas and Officer Watt made several visits to their respective assigned schools and also attended selected Halloween parade assemblies at the elementary school level.

Officer Rozas and Officer Watt continue to meet on a regular basis to review crime trends at all our local schools as well as throughout the county, region, state and country. Officer Watt attended a training class on Profiles of Active Shooters and the plan is to coordinate with the district staff to push information received from the class out at a future Principals' Meeting.

Another busy month on the hill throughout the school district, but some great teamwork continue to be displayed involving staff and local law enforcement.

BACKGROUND AND DISCUSSION

The Peninsula Public Safety Committee (PPSC) has discussed a regional approach for the purposes of the development of the Palos Verdes Peninsula (PVP) Multi-jurisdictional Hazard Mitigation Plan Update.

State and local government agencies are required to prepare comprehensive disaster mitigation plans such as a Local Hazard Mitigation Plan (LHMP) per the Federal Disaster Mitigation Act of 2000 (DMA) and to be eligible for hazard mitigation grant funding. A LHMP contains information about the type of hazards a community faces, and actions that can be taken to reduce vulnerability. Hazards identified in the Plan include Earthquake, Fire, Tsunami, Earth Movement, Hazardous Materials Event, Human-Caused Event, Utility Related Event, and Cyber Terrorism. Additional hazard considerations can include flooding and watersheds.

LHMPs are long-term strategies to reduce disaster losses and break the cycle of disaster damage, reconstruction, and repeated damage. The LHMP goes through an update every five years. Mitigation plans must be reviewed and updated, formally approved by federal and state governing bodies, and then formally adopted by the local governing body.

(City/Special District) as part of receiving approval.

City staff identified an opportunity for all four Peninsula cities to collaborate for the next LHMP update with the incorporation of the two Geologic Hazard Abatement Districts (GHAD), Klondike Canyon Land Abatement District and Abalone Cove Landslide Abatement District, in the City of Rancho Palos Verdes. The GHADs are special districts that could also benefit from this process, which would provide them with the potential to receive future grant funding from state and federal emergency management agencies such as the Governor's Office of Emergency Services (CalOES) and the Federal Emergency Management Agency (FEMA).

In preparation for the PVP Multi-jurisdictional Hazard Mitigation Plan, the City of Rolling Hills Estates, acting as the lead agency, has recently received a grant award notification through CalOES for an approved project amount of \$349,298 for the development of the joint plan through an emergency planning consultant. There is a local match of 25% of the total approved project grant award which equates to approximately \$87,324 that would be cost shared by the PVP cities according to the established cost sharing formula below.

At the May 23, 2024 PPSC meeting, an Ad Hoc Committee (one member from each city and the four City Managers) of the PPSC was appointed for purposes of meeting on an as-needed basis to help guide the process throughout the development of the Plan, including analysis of consultant proposals for the completion of the Plan. The Ad-Hoc Committee assignments are as follows: Member McGowan, Member Seo, Member Mirsch, and Member Schmitz. The PPSC will serve as a reviewing body before the Plan is presented to each respective City Council for review and adoption.

A Request for Proposal (RFP) has been released with proposals due on December 10, 2024. City staff will correspond accordingly with the Ad Hoc Committee for the consultant interview process in January 2025. After a consultant is selected and contract is negotiated, a Memorandum of Understanding Agreement outlining costs and terms for the development of the PVP Multi-jurisdictional Hazard Mitigation Plan will be presented to each respective City Councils for approval in February 2025. Project initiation is also expected to begin in February 2025.
