NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes will conduct a public hearing on Tuesday, February 18, 2025 at 7:00 p.m.

The meeting will take place in accordance with the requirements of the Ralph M. Brown Act, Section 54950 et seq. of the Government Code. Remote participation by any Committee/Commission member shall be in accordance with Subdivisions (b)(3) or (f) of Government Code Section 54953. The meetings are held at Hesse Park, McTaggart Hall, 29301 Hawthorne Boulevard and/or via teleconference for staff/consultants/participants using the Zoom platform and broadcast live on the City's website at rpvca.gov/agendas and on PV Ptv channels Cox35 and Frontier Fiber Optic39. Public participation will be in person and using the virtual platform.

The City Council will consider the following:

APPEAL (CASE NOS. PLZC2024-0002 & PLSR2024-0225) – Appeal of the Planning Commission's decision to uphold the Director of the Community Development Department's determination that the proposed project which includes 482 units (1,173,927 square feet) does not qualify for the exemption set forth in Government Code, section 65589.5(d)(5) or for SB35/423 ministerial review (Government Code, section 65913.4), therefore requiring the following entitlements: General Plan Amendment, Zone Change, Certificate of Compliance, Major Grading Permit, Variance, Environmental Review and Major Site Plan Review as required by the Rancho Palos Verdes Municipal Code. The Appeal is brought pursuant Rancho Palos Verdes Municipal Code Section 17.80.
