



Application for Fee Waiver

Pursuant to Chapter 17.78.010 of the Rancho Palos Verdes Municipal Code (attached), the City Council may, in its discretion, grant a waiver of required application filing fees if it finds:

1. The applicant or beneficiary of the use or activity proposed by the applicant is a nonprofit corporation registered with the state of California;
2. The use or activity proposed or the activities of the beneficiary of the use or activity proposed are charitable, educational or otherwise provide a substantial benefit to the public; or
3. The applicant has demonstrated a financial hardship, as determined by the city council, on a case by case basis.

The City Council may, in its discretion, grant a fee waiver without making these findings for requests dealing with administrative error, variances, and for certain penalty fees. Please consult section 17.78.010 C & D for more information.

Procedure for filing a fee waiver request:

1. Submit a zoning application and pay all associated fees.
2. Submit a Fee Waiver request application

Please refer to Chapter 17.78.010 of the City's Municipal Code for a complete discussion of the Fee Waiver limitations, exceptions, procedures and mitigation measures. Please contact a City Planner if you are not certain of the materials you must submit or if you have any questions on the process.
