V. APPROVAL OF MINUTES

A. MINUTES OF NOVEMBER 14, 2024

VI. OLD BUSINESS

A. SCHOOL RESOURCE OFFICER (SRO) UPDATE (PVPUSD REPORT)

Brenna Terrones, Assistant Superintendent of Administrative Services for the Palos Verdes Peninsula Unified School District, provided an update on recent incidents and investigations involving both students and adults on school campuses. Over the past three months, the district has addressed a range of concerning issues, including vandalism, physical altercations, vehicle traffic-related incidents, weapons, illegal dumping, missing personal property, and theft, all of which have occurred on school property. Through detailed investigations in collaboration with school staff, responsible individuals were identified, and appropriate disciplinary or corrective actions were taken to ensure student and staff safety.

The district affirmed its commitment to working closely with local law enforcement to address external threats, report incidents as necessary, and maintain a proactive approach to school safety.

All scheduled spring emergency preparedness drills, including shelter-in-place and off-site evacuations, were completed successfully. It was noted that most student altercations occur at the high school level, both on and off campus, while disruptive adult-related incidents, including those involving parents or unknown individuals, are handled accordingly across all school levels.

Ms. Terrones further explained that SROs and school principals exercise discretion in escalating incidents to local law enforcement, particularly in situations involving weapons, credible threats, or individuals who refuse to leave the campus. An uptick has been observed in investigations involving alleged weapons, such as BB guns. While most physical altercations result in only minor injuries, law enforcement is notified as needed. However, current public summaries do not routinely detail whether injuries occurred or their severity.

She noted that the district has improved its incident documentation process over the past two years, transitioning from informal or verbal updates to a structured, detailed reporting system. While internal records are comprehensive, only summarized versions are presented publicly at meetings.

Vice Chair Dieringer requested that future summaries provide greater detail, including whether injuries were sustained and their severity, the specific nature of threats (e.g., vague vs. credible), and the exact type of weapon involved. Additionally, there was emphasis on ensuring that serious incidents are formally reported to the police department for proper recordkeeping and potential inter-agency tracking.

Ms. Terrones also discussed the implementation of a district-wide e-bike safety program, set to launch in the upcoming school year. The program will include mandatory registration and the issuance of campus parking stickers for students. In partnership with three vetted training providers, including the Palos Verdes Police Department, the district will offer free and paid safety education options, some of which provide hands-on route safety training. The early rollout is intended to provide families with sufficient time to select a training course that meets their needs.

Regarding traffic and pedestrian safety, crossing guards are currently deployed at school sites where traffic studies have indicated a need. A recent addition was made at Rolling Hills Road near Dapplegray Elementary School to mitigate safety concerns. The district continues to work with city public works departments to monitor traffic conditions and implement improvements where needed.

Ms. Terrones provided a year-over-year comparison of incident data, noting that the overall incident volume remains consistent with the previous year, with a slight increase in reports involving weapons or suspected weapons. Improved recordkeeping and routine internal review have enhanced the district's ability to track safety trends and respond appropriately.

Chair Wilson concluded the discussion with appreciation for the updates and community engagement. Suggestions for clearer, more detailed reporting were well received.

B. LOS ANGELES COUNTY FIRE DEPARTMENT AND MCCORMICK UPDATE

Los Angeles County Fire Department Battalion Chief Kelsey reported on the second quarter, specifically on emergency responses and related fires for the Peninsula Cities.

Battalion Chief Wade Kelsey, filling in for Assistant Chief Brian Kane, provided an overview of fire and emergency response activity for the first quarter of the year across the four cities on the Peninsula. Community Services Liaison Rosemary Vivero explained the discrepancies in reported incident numbers, attributing them to differences in data collection methods and outlier exclusions based on national standards. Chief Kelsey reviewed incident counts and average response times for each city.

Questions were raised about categorizing fire types, the inclusion of cliff rescues in reporting, and ways to clarify incident codes. Chair Wilson requested a standardized key for incident types, trend tracking data year-over-year, and future breakdowns of incidents such as cliff rescues and brush fires for better clarity. Ms. Vivero noted additional details, such as the types of fires and property loss, and committed to compiling trend data for future meetings.

David Konieczny, Operations Manager for McCormick Ambulance, provided a quarterly update on emergency response times across several cities. He presented data broken down by month and city, highlighting both on-time and late responses. The benchmark for on-time response is 8 minutes and 59 seconds, with anything beyond considered late.

Committee members raised concerns regarding the impact of delayed responses, particularly in life-threatening situations. Vice Chair Dieringer requested more detailed data on calls over 15 minutes, including patient outcomes. Mr. Konieczny committed to providing more granular data, including on-scene times and call severity. He also addressed the issue of hospital offload delays, noting that although recent legislation was passed, it lacks enforcement mechanisms. McCormick has implemented internal protocols to facilitate faster turnaround times at hospitals by assigning one crew to monitor multiple patients when necessary.

Mr. Konieczny explained that zoning challenges hinder the establishment of a new ambulance station in Rolling Hills, contributing to longer response times. Chair Wilson suggested that the city council take up the matter due to the lack of commercially zoned space. Member Stegura proposed exploring the possibility of using space near the promenade for a new station, initiating further discussion on the topic.

VII. NEW BUSINESS

A. CAL FIRE MAPS

Karina Bañales, City Manager of Rolling Hills, introduced Chief Trevor Moore from the Los Angeles County Fire Department to present on the 2025 LRA Fire Hazard Severity Zone (FHSZ) maps.

Chief Moore, who oversees the countywide Defensible Space Program, explained that the updated FHSZ maps were released by Cal Fire in phases, beginning in February 2025, with Los Angeles County receiving its maps in March. The new maps modeled using data from 2003–2018, incorporate fire intensity, extreme weather, and wind patterns, including ember transfer, resulting in more precise zone delineations categorized as Very High, High, and Moderate.

Chief Moore clarified that local jurisdictions may increase zone designations based on substantial evidence but may not decrease them. The deadline for city adoption is July 22, 2025, with final approval due 30 days thereafter. Once adopted, the maps become effective 30 days later. Chief Moore emphasized the importance of public access to these maps and noted that a model ordinance and additional resources are available on Cal Fire's website. The maps impact building codes, insurance, real estate disclosures, and safety planning.

Map comparisons revealed that significant portions of the Palos Verdes Peninsula, previously classified as Very High, have been downgraded or removed entirely from hazard zones. Chief Moore highlighted the updated maps' alignment with historical fire perimeters and confirmed the department's recommendation that cities adopt the maps as issued. Cities still concerned about fire risk may petition Cal Fire with substantial fire history or topographic data.

Committee members expressed interest in maintaining public awareness and fire safety practices regardless of the new zoning status. The committee also requested access to the presentation slides, which Chief Moore agreed to distribute via city staff. Chief Moore concluded by encouraging cities to direct further inquiries to local assistant fire chiefs or his office.

VIII. OTHER MATTERS FROM COMMITTEE MEMBERS

Member Quinn inquired whether there is an overarching disaster preparedness plan for the entire Peninsula, specifically addressing fire hazards across all four cities. In response, Marcelle Herrera, Interim Palos Verdes Estates Community Services Officer, confirmed that a joint multi-jurisdictional Hazard Mitigation Plan is currently being developed in collaboration with the four Peninsula cities.

Rancho Palos Verdes City Manager Ara Mihranian elaborated that this plan, expected to be completed by February or March 2026, will replace the existing individual city plans and

include comprehensive mitigation strategies. Additionally, Mr. Mihranian noted that a separate plan is in progress to address evacuation routes and locations for the Peninsula.

Mrs. Bañales shared that some hazard mitigation grants are currently on hold pending completion of the hazard mitigation plan.

Vice Chair Dieringer requested a future agenda item to update the previously created white paper with current information, including utility shutoffs and fire resiliency issues in light of recent fires. Vice Chair Dieringer emphasized the need to incorporate current utility infrastructure measures aimed at reducing public safety shutoffs related to both fire and land movement.

Subject: Monthly Activity Report / May & June, 2025

Details: School was in session for 21 days during the month of May, 2025, with students and staff having one day off in honor of Memorial Day. School was in session for four days during the month of June, 2025.

Officer Robert Watt is responsible for ten schools within the district which includes Palos Verdes High School, Rancho Del Mar Continuation School (Shared with Officer Barber), Ridgecrest Middle School, Palos Verdes Intermediate School, Lunada Bay Elementary School, Point Vicente Elementary School, Montemalaga Elementary School, Vista Grande Elementary School, Cornerstone @ Pedregal and Valmonte Early Learning Academy.

Officer Steve Barber is responsible for nine schools within the district which includes Peninsula High School, Rancho Del Mar Continuation School (Shared with Officer Watt), Miraleste Intermediate School, Dapplegray Elementary School, Mira Catalina Elementary School, Rancho Vista Elementary School, Silver Spur Elementary School, Soleado Elementary School and Miraleste Early Learning Academy.

Officer Watt assisted administrators and Palos Verdes Estates Police with an alleged attempted child abduction outside of Lunada Bay Elementary School. PD detectives are following up and the community was updated. No similar incidents on the hill or surrounding cities.

Officer Barber and the staff at Miraleste Intermediate School with a student who had threatened another student and sent that student a threatening photograph.

Officer Watt investigated a series of vandalism incidents that had occurred at Vista Grande Elementary School involving young teenagers that had vandalized picnic tables and turned over a portable toilet on campus.

Officer Barber assisted administrators at Lunada Bay Elementary School and the Palos Verdes Estates Police Department with a student that had allegedly advised another student that she was going to bring a loaded firearm to school. After several interviews, personnel determined the student did not have the means to carry out the threat.

Officer Barber assisted staff with a Peninsula High School student who was under the influence of what appeared to be marijuana.

Officer Barber assisted Peninsula High School staff with a student who was posting "borderline" hate speech on a private, online social media account.

Officer Watt assisted Lunada Bay Elementary Administration with a husband and wife that had been causing a disturbance on campus.

Officer Barber assisted Peninsula High School administrators with two students who had attempted to place what appeared to be a political flag on campus.

Officer Barber contacted two subjects who were walking around the campus of Peninsula High School and were not students or staff.

Officer Watt assisted staff at PVHS with a female juvenile student who had met an 18-year-old male on line via a social media website and had made arrangements for him to pick her up after school. RBPD was contacted and located the two subjects. Per RBPD, no crime had occurred and the female was released to her parents.

Officer Watt attended the year-end musical performance at Montemalega Elementary School and also attempted to keep the peace as two families who have not been happy with each other throughout the school year.

Officer Barber handled a physical altercation between two female students at Peninsula High School.

Officer Barber handled a bullying situation at Peninsula High School involving two students who were attempting to bully several students at the Peninsula Center across the street from the school.

Officer Watt assisted staff at Rancho Del Mar Continuation High School with a student who had not been to school for weeks.

Officer Watt and staff investigated what appeared to be a "senior prank" and Palos Verdes High School involving over 30 juveniles who toilet papered a portion of the school during the night.

Officer Watt and Officer Barber investigated what appeared to be another “senior prank” at Palos Verdes High School involving three juveniles that had walked on to the campus during the middle of the school day and attempted to mount a ceramic black panther in the center of the campus

Officer Watt responded to the District Office to assist Assistant Superintendent Rick Licciardello in keeping the peace while he terminated a district employee.

Officer Watt identified and contacted a student who was doing “donuts” in his vehicle on the campus of PVHS after school.

Officer Watt investigation a traffic collision that occurred on the campus at PVHS.

Officer Watt and Officer Barber presented a student at Peninsula High School a certificate and gift card for spearheading a project to fundraise and construct a bigger and safer drop off/pick up area at the rear of Montemalega Elementary School.

Officer Watt attended the varsity baseball game at PVHS against Peninsula High School. Large crowd with nothing of any significance to report.

Officer Barber chaperoned the Peninsula High School Junior/Senior Prom at the House of Blues in Anaheim and came in contact with a student who was active belligerent and appeared to be impaired.

Officer Watt chaperoned the Palos Verdes High School Junior/Senior Prom at the Los Angeles Center Studios in downtown Los Angeles.

Officer Watt attended and participated in the traditional “Boat Race” at PVHS where Marine Biology students designed, constructed and raced “water worthy” boats made out of cardboard and duct tape.

Officer Watt helped chaperon 250 PVHS seniors on their Senior Ditch Day to Disneyland.

Officer Watt attended graduations/promotions at Lunada Bay Elementary School, PVIS, Rancho Del Mar Continuation School and PVHS.

Officer Barber attended graduations at Miraleste Intermediate School and Peninsula High School.

Officer Watt provided extra security at the school board meetings on May 14, May 28 and June 3, 2025.

During the summer, Officer Watt and Officer Barber will assist with summer school programs on five campuses on the hill, will be "de-briefing" safety and security on all campuses with the assistance of school administrators and will be conducting walk-throughs and update our threat assessments at each campus.
