Preserve Visitor Contacts

- 10 Rangers patrolled the reserves during this period

Preserve Activity

- Ocean Trails Reserve
 - Monitoring Mountain Bike Use (Catalina Trail)
 - Rarely see bikes on trail
 - Monitor Paragliding activity
 - Landing on RPV Beach | Access unauthorized trail behind lifeguard stand and off West Bluff Trail next to benches
- Three Sisters Reserve
 - Bike Jumps
 - See myTracks on email dated 7/9/13 showing spur trails
 - Needs McBride Trail on trail maps
- Filiorum Reserve
 - Needs McBride Trail on trail maps
- Portuguese Bend Reserve
 - Landslide Scarp | Toyon | Peppertree Junction
 - Field tour with PVPLC in order to make appropriate adjustments to improve wayfinding.

- Increased Equestrian usage
 - Continued use of unauthorized trails
 - Spur trail off Peppertree
 - PVPLC and Rangers continue to block with vegetation
 - Spur trail from Burma to Sandbox
 - Party spot with evidence of lewd behavior off Ishibashi Farm Trail

 - Unauthorized vehicle access from Palos Verdes Drive South (closed by Public Works)

 - Additional “NO STOPPING ANYTIME” signage needed at PVDS entrance (outside of boulders)
