NOTICE IS HEREBY GIVEN that the City Council of the City of Rancho Palos Verdes at its regularly scheduled meeting on Tuesday, February 18, 2014, at 7:00 PM at Hesse Park Community Building, 29301 Hawthorne Boulevard, Rancho Palos Verdes, will consider:

**MARYMOUNT CALIFORNIA UNIVERSITY 6 MONTH REVIEW OF THE EXPANDED PARKING LOT PROJECT / ZON2003-00317 (CONDITIONAL USE PERMIT NO. 9 REVISION "E", GRADING PERMIT, VARIANCE, and MINOR EXCEPTION PERMIT):**

Pursuant to Council Adopted Condition of Approval No. 18, the City Council will conduct a review of the operation of the recently constructed expanded parking lot project's compliance with, and the adequacy of, the conditions of approval imposed by the City Council since it has been 6 months since the Final Certificate of Compliance was issued for the parking lot. The Council's review of the parking lot will include, but is not limited to, the operation (including hours), circulation, lighting, noise, landscaping, and other concerns raised by the public. The City Council may add, delete or modify the Conditions of Approval pertinent to the expanded parking lot based on evidence presented at the hearing that demonstrates that such changes are necessary and appropriate to address impacts resulting from operation of the parking lot.
